

FILING REQUIREMENTS FOR REVENUE SHARING HANDICAPPED REGULATIONS

October 17, 1984, was the deadline for completing the "Self-Evaluation" and "Transition Plan" required by the Office of Revenue Sharing pursuant to regulations published on October 17, 1983. Additionally, those cities receiving \$25,000 or more in Revenue Sharing funds were required to have adopted grievance procedures to deal with complaints from handicapped citizens by October 17, 1984. If you have not taken these steps at this time, you should do so immediately.

There is **NO** requirement that you send these documents to the Office of Revenue Sharing. In fact, the Office of Revenue Sharing requests that you **not** send them. You should file these documents, with other Revenue Sharing documents that you must keep; for example, budgets, notices, and the like. Your auditors will check these documents during their examination of your Revenue Sharing Program.
