# 1 Introduction

---

EUROLAB is a research lab established at GESIS in 1996 and welcomes visiting researchers and research groups who want to work in one of GESIS' research fields and/or collaborate with GESIS experts. In the past 20 years, EUROLAB has proven to be a successful model for the provision of substantively, methodologically, and technically assisted access to the Data Archive for the Social Sciences in Cologne. For this reason, the scope of its tasks and activities were expanded and since October 2016, EUROLAB is part of the newly established GESIS department *Knowledge Transfer*<sup>1</sup>. Since then, EUROLAB also serves as the gateway to all research visits at GESIS, both in Cologne and Mannheim; it supports the organization of research visits, is responsible for the EUROLAB and GESIS Grant programs and documents all guest stays at GESIS. The aim is to optimize synergies between the various visiting programs as well as the visiting researchers and GESIS staff by combining all information on research stays at GESIS in one place.

Apart from the programs offered and administered directly by the EUROLAB – EUROLAB Grants, GESIS Grants, as well as self-funded research stays – guest researchers may visit GESIS through presidential and departmental invitations. EUROLAB Grants allow GESIS guests to pursue their own research projects on the basis of data stored at GESIS Data Archive. GESIS Grants enable the realization of research projects, which GESIS and its guests jointly initiate and/or which aim to further develop infrastructure projects.

The EUROLAB team currently consists of five members, including three scientific staff members and two administrative staff members. In October 2018, Marlene Mauk joined the EUROLAB as the new postdoctoral researcher following Roula Nezi's transition to the University of Surrey. In addition to team leader Ingvill C. Mochmann, Marlene Mauk (EUROLAB Grants, self-funded research stays) and Heidi Schulze (GESIS Grants) are responsible for the academic support of the guest researchers. Jasmin Arenz (Cologne) and Monika Graf (Mannheim) support all guest stays on an administrative level. In addition, Christoph Piske and Munir Adi supported the team in Cologne as student assistants.

This report gives an overview of the EUROLAB's activities including visiting programs and research stays in 2018 that lasted at least five working days. Chapter 2 offers an overview of all visiting researchers at GESIS in 2018. Chapter 3 presents the results of an ex-post survey of guest researchers. Chapter 4 highlights EUROLAB activities in 2018. Finally, Chapter 5 gives a brief introduction of the EUROLAB staff and its activities.

## 2 Visiting Researchers at GESIS in 2018

This chapter will first present a general overview of the guest researchers who worked at GESIS during 2018. Next, each subchapter will give a more detailed insight into the different guest researcher groups who were hosted in Mannheim or Cologne: GESIS Invitees (2.1.), GESIS Research Grants (2.2.), Self-funded visitors (2.3.), Third-party funded visitors (2.4), and other guest researchers (2.5).

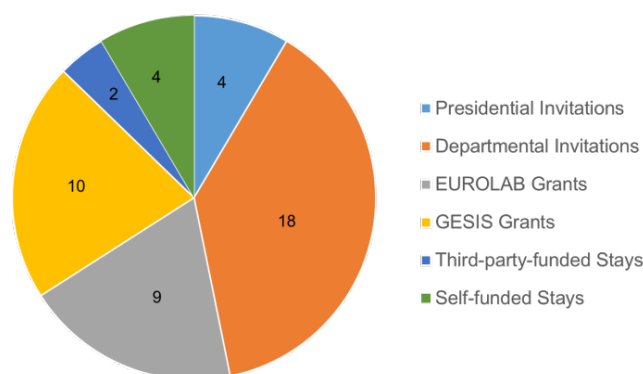


Figure 2.1: Funding Schemes of Guest Researchers (n= 47)<sup>2</sup>

In 2018, 45 guest researchers visited GESIS: four Presidential Invitations, 18 Departmental Invitations, nine EUROLAB Grant holders, 10 GESIS Grant holders, as well as four self-funded guest researchers and two guest researchers funded by third-party projects at GESIS as shown in Figure 2.1.

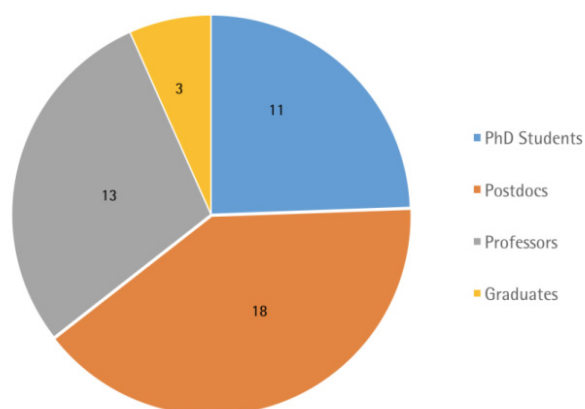


Figure 2.2: Academic Positions Held by Research Visitors (n= 45)

Figure 2.2 indicates the diversity of the academic positions taking into consideration the status and academic level of the research visitors. Overall, eleven PhD students, 18 Postdocs, 13 Professors, and three Graduates conducted research at GESIS in 2018.

With regard to gender distribution, 2018 was a rather unbalanced year: while 28 male researchers were guests at GESIS, only 17 female researchers were hosted either in Cologne or Mannheim.

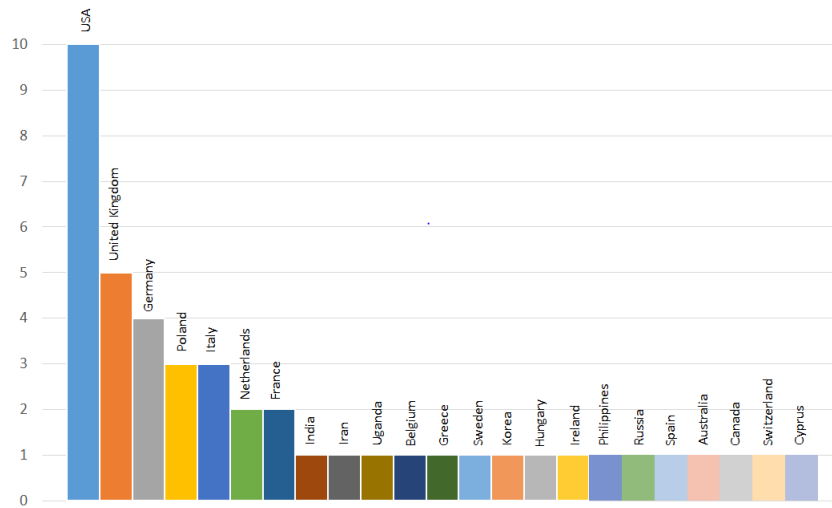


Figure 2.3: Research Visitors by Country of Home Institution (n= 45)

Figure 2.3 illustrates the international variety of guest researchers at GESIS with respect to the country of their home institution. The overarching majority of guest researchers arrived from the United States (13). In addition to Germany and various other European countries, GESIS welcomed guests from Iran, Uganda, South Korea, Russia, Australia, the Philippines, and Canada.

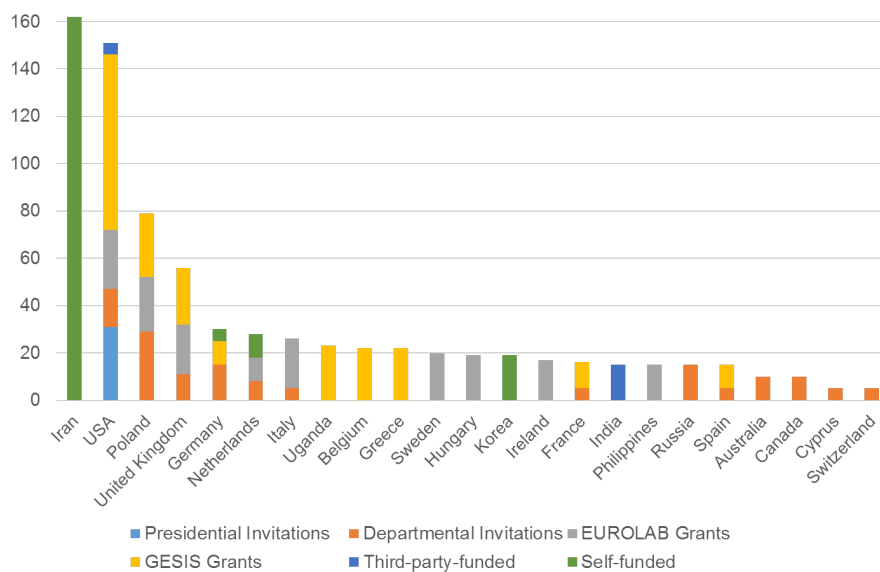


Figure 2.4: Funding of Visiting Researchers per Country of Home Institution in 2018 in Access Days (n= 780)

Figure 2.4 illustrates the number of days researchers spent at GESIS by incorporating information on the funding source and the country of their home institution. Altogether, researchers worked at GESIS for a total of 780 access days. GESIS hosted guest researchers from 23 different countries; the three most prominent countries with respect to the number of access days were Iran (one self-funded stay), USA and Poland.

Presidential Invitees from universities in the USA used GESIS facilities for a period of 31 days. Researchers who visited GESIS by departmental invitation accessed GESIS facilities for 139 days coming from research facilities in Poland, the USA, Russia, Germany, UK, Canada, Australia, the Netherlands, Cyprus, Spain, France, and Italy. EUROLAB Grant holders worked at GESIS for 171 days and at the time were based at universities in the USA, Poland, UK, Italy, Sweden, Hungary, Ireland, the Philippines and the Netherlands. GESIS Grant holders collaborated with GESIS experts on joint projects for 223 days and were affiliated with institutions located in the USA, Poland, United Kingdom, Uganda, Belgium, Greece, France, Germany and Spain. Third-party-funded researchers came from home institutions in India and the USA and accessed GESIS facilities for 20 days. The remaining 196 access days were used by self-funded researchers for their respective research projects. They came from home institutions in Iran, Korea, the Netherlands and Germany.

## 2.1 GESIS Invitees

GESIS regularly invites researchers to work on joint projects with GESIS staff. There are two forms of programs: the Presidential Invitations and the Departmental Invitations. Presidential Invitations are issued by the President of GESIS in cooperation with the Board of Directors based on suggestions by the departments. Furthermore, each department invites guests for research or infrastructure related projects on the premise of a joint collaboration.

In 2018, four Presidential Invitees worked at GESIS: Brad Edwards, Vice President of Field Services at Westat, visited GESIS from April 08 to April 15 to collaborate with Beatrice Rammstedt (SDM) on research on field management and survey operations in general. Tenko Raykov, Michigan State University, worked with Ranjit Singh (SDM) from April 13 to April 28 in order to do research within the framework of the optimal development and testing of psychometric scales. Don A. Dillman, Washington State University, collaborated with David Bretschgi (SDM) and did research on the development and testing of web-push survey methods for improving response and data quality in general public surveys in the period of June 9 until June 6. In the period from August 08 to August 15 as well as August 27 to August 31, Stephanie Eckman, RTI Washington, worked with Jessica Daikeler (SDM) on her research project "MUMS- Motivated Underreporting in Mobile Surveys; RPDQ – Can Response Propensities Predict Local and Global Data Quality?".

There were 18 Departmental Invitations lasting from five days up to six weeks in 2018. The overview of researchers supported by departmental invitations is given in Table 2.1 below.

## 2.2 GESIS Research Grants

The GESIS Research Grant Programs include the EUROLAB Grant scheme (since 1996) and the GESIS Grant scheme (since 2017):

1. EUROLAB Grants support individual research stays at GESIS for a period of one month;
2. GESIS Grants support collaboration, or the preparation of a collaboration, between GESIS employees and external researchers for a period between five working days and three months.

Both funding schemes are implemented, organized, and supervised by the EUROLAB Team. EUROLAB announced four application rounds in 2018, two per grant scheme. Applications for EUROLAB Grants are evaluated by an international selection panel on a competitive basis. The GESIS Grant applications are reviewed by the GESIS Board of Directors based on their compatibility with GESIS' mission, the expected output, and the quality of the application. Overall, 119 researchers submitted an application for both grant schemes. Regarding the country of home institution of the applicants, GESIS received applications from researchers from 35 countries and five continents. These numbers highlight the high demand for on-site access to social sciences data and support within a highly recognized research environment as well as research and experience exchange.

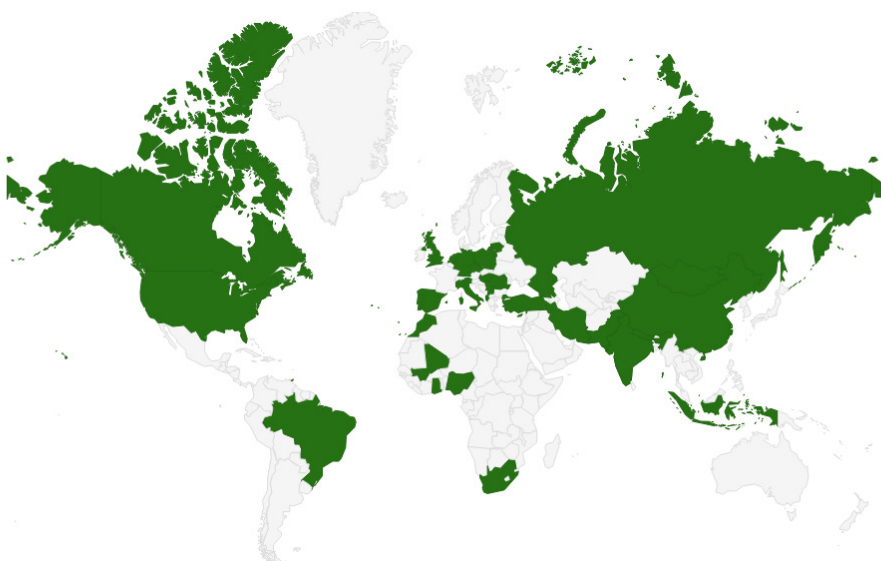


Figure 2.5: Received Applications per Region<sup>3</sup>

Altogether, 54 researchers applied for a *EUROLAB Grant* to work on their individual projects based on data stored at GESIS. Ten guest researchers were invited to work at EUROLAB, Cologne. One guest rescheduled her visit to 2019. So altogether, in 2018, GESIS supported nine EUROLAB Grant holders who worked at EUROLAB for a period of 171 access/working days as detailed in the table below.

### 2.4 Third-party Funded Stays

Some externally funded projects at GESIS enable the invitations of guest researchers. In 2018, two guest scientists were invited based on this type of funding. Vivek Kumar Singh collaborated with Philipp Mayr (WTS) within the Indian-German research project "Design of a Sciento-text Computational Framework for Retrieval and Contextual Recommendations of High Quality Scholarly Articles". Limor Peer was invited by Claudia Biniossek (DAS) as part of the DFG-funded project *X-Hub - Making Social Science More Reproducible Funded* focusing on the origin and philosophy of the ISPS Data Archive and demonstrating a new curation software powered by DDI.

### 2.5 Other Guests

Further GESIS guests regularly visit teams or staff members, for example to obtain access to official data or data that are sensitive from a data protection viewpoint, or to work with GESIS employees who are experts on social science metadata standards. Frequently, researchers are interested in working at one of the five Research Data Centers (RDC): Ailbus, Elections, German Microdata Lab (GML), International Survey Programmes, and PIAAC. In addition, the [Secure Data Center](#) (SDC) often hosts

guest researchers. SDC offers access to disclosive data sets by hosting a safe room for on-site access. Research visits at GML and SDC as well as research visits fewer than five working days are not documented in this report.

## 2.6 Presentations by GESIS guest researchers

Researchers visiting GESIS have the opportunity to present their projects to receive comments and feedback on their work. These presentations are advertised to GESIS staff to take part in the discussion. The different formats for presentations include colloquia organized by GESIS departments and brown-bag sessions organized by EUROLAB. Since 2017, the brown-bag meeting sessions take place during lunch time and allow detailed and fruitful discussions. In addition, the GESIS presentation series introduces results from final papers and research projects and talks are usually live streamed to Mannheim/Cologne. The following table provides information on the presentations of all guest researchers who stayed at GESIS for five consecutive days or longer.

### 3 Assessment of EUROLAB by Visiting Researchers

---

Since 2017, EUROLAB monitors all guest researchers' stays at GESIS, both in Cologne and Mannheim. To ensure and further improve the quality of our services, an updated evaluation scheme was adopted in 2018. All visiting researchers, excl. Presidential Invitees, listed in the previous chapter received a post-stay online survey. Apart from the online survey, all guest researchers were asked to prepare a report after completion of their stay at GESIS. These reports provide for a more general feedback as illustrated by anonymized quotes in the following chapter. Subsequently, we present the results from the online survey which was sent to all guest researchers who stayed at least five working days at GESIS.

#### 3.1 Voices of Visiting Researchers

The grant-holders commented on, for example,

##### The progress of their research projects:

- The month long stay with EUROLAB allowed me to make multiple data runs out of the SDC and collaborate with my supervisor in Sweden, and I believe that the results that I have generated are methodologically rigorous.
- During my stay, I made a series of changes to the research I had planned to conduct here, with the help of several researchers which I consulted regarding the specific issues connected to my project. Therefore, I received significant and greatly appreciated help.
- My stay at GESIS helped a lot in refining my analysis, ensuring that I proceed in the right direction.

##### Support provided by GESIS staff:

- Most of the datasets that have qualified for that purpose had a restricted access protocol and necessitated me to apply for it. However, thanks to kind help provided by GESIS staff I was able to access the data relatively quickly. The same goes for the library query.
- The continuous support received by Marlene was decisive in getting me into contact with other researchers, both in person here in Cologne and via phone call with the personnel based in Mannheim.
- In particular, I have directly collaborated with [list of several GESIS staff members]. Thanks to their suggestions, I made substantive improvements in my researches during this month.

##### (Planned) Publications and further projects started at GESIS:

- A first presentation of this study has been already accepted at GESIS Panel User conference, in March; while an abstract has also been submitted at ESRA Conference.
- In terms of project outputs, within the next months, me and my co-author will come forward with a draft article that will be presented at the annual conference of the European Social Policy Analysis Network. Additionally, the article manuscript will be submitted for publication

to an international peer-reviewed journal. I also aim to present the project at the 6th EU-Microdata User Conference in Mannheim in March 2019.

- My host and I successfully wrote our primary paper on the impact of changes in governmental coalitions on citizens' policy preferences in Germany.
- The research stay has enhanced envisioning an idea of a summer school program for Africa.

#### **The opportunity to give presentations and share results:**

- The audience feedback after my presentation has been constructive and helpful
- In addition, the presentation of my work represented an important chance to receive a feedback from several researchers who I had not previously contacted.

#### **Data(sets) and Services Used:**

- Online access to data is excellent, enabling me to do preliminary work prior to my EUROLAB stay and subsequent work after. Computer facilities are available and well-functioning. The library is another helpful resource; access to the GESIS-EUROLAB publications has enabled me to situate my current work within the thrust of GESIS-EUROLAB
- Using a part of the Children of Immigrants Longitudinal Survey in Four European Countries (CILS4EU) data set with access provided in the Secure Data Center at GESIS, I created growth curves with clustered longitudinal multilevel analysis and was able to show that state level contextual factors have influence over individuals' attitudes during the crucial time in adolescence when attitudes are the most subject to change.

#### **Suggestions for Improvements:**

- It would be good if EUROLAB guest researchers would be automatically added to one of the internal mailing lists in order to hear about events and workshops at GESIS.
- Sometimes, it is not possible to carry or complete a new project entirely within a month time. A consideration for increasing duration of grant more than one month may be given.
- The only thing that I can think of that would have been helpful in the Secure Data Center would be an English Keyboard. Writing R code with many special characters on a German keyboard was cumbersome.
- My stay in general was a great experience and there was a high level of flexibility. However, a little bit more information about the practicalities of Mannheim (places to stay), the approximate amount of the grant would have been extremely useful.
- More information about the library services.

### 3.2 Results from the EUROLAB Survey

The following graphs and numbers are based on the responses to the post-stay online survey. In 2018, 19 researchers hosted by GESIS in both Cologne and Mannheim have completed this survey. Most of the researchers who participated in the survey visited GESIS with one of the GESIS Research Grants. The survey covers, among other topics, how they had heard about possibilities to visit GESIS, the most frequently used services during their research stay, and the satisfaction with services offered by GESIS. This applies to scientific related and technical support as well as logistical and administrative support both before and during the research stay.

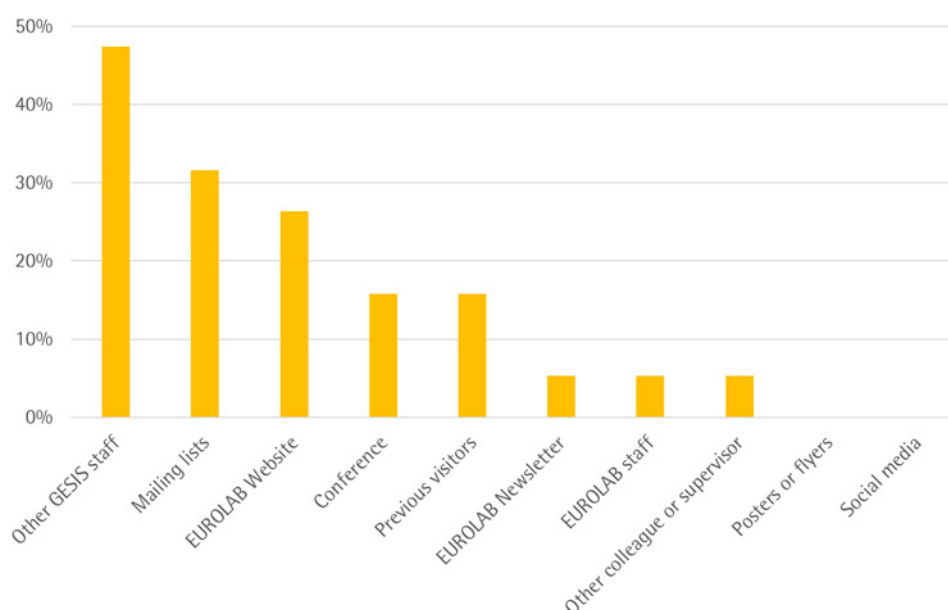


Figure 3.1: How visitors heard about the possibilities to visit at GESIS (n=19), multiple answers possible

There are different sources from which visitors hear about research opportunities at GESIS, as Figure 3.1 demonstrates.

Most respondents have become aware of the possibility to do research at GESIS through other GESIS staff members. In second place, mailing lists drew the attention of various researchers to the possibilities to work at GESIS. While more than a quarter of the respondents were reached via the EUROLAB website, personal contacts with former visitors who spread their experiences at EUROLAB at their home institutions and among their academic networks as well as contacts established at conferences still play an important role. Finally, some guests became aware of GESIS via the EUROLAB Newsletter, EUROLAB staff or other colleagues, or their supervisor. None of the respondents have heard about opportunities at GESIS via a poster or flyer or via social media.

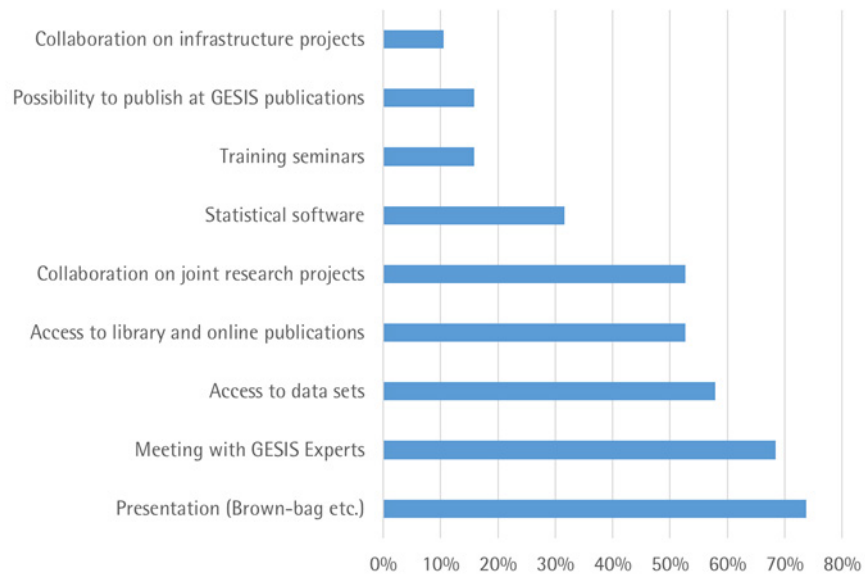


Figure 3.2: Kinds of Services used in % (n= 19); multiple choices possible

Figure 3.2 presents the relevance of the services to guest researchers by its frequency of usage, which may be an indication for understanding the main motivation of guest researchers to work at GESIS.

Most scholars who visited GESIS in 2018 used the opportunity to meet with GESIS experts in order to discuss their projects and to present their projects at, for example, one of EUROLAB's brown-bag meetings or as part of the GESIS Lecture Series. The access to datasets archived at GESIS is also one of the central services used by guests. More than 50 percent of guest researchers who participated in the survey accessed the GESIS library and online publications. Joint research projects were also conducted by more than half of all respondents. Further, guests frequently used access to statistical software. Some of the visitors also used the opportunity to attend GESIS training seminars or made use of the possibility to publish at GESIS publications. Finally, some visitors collaborated on infrastructure projects.

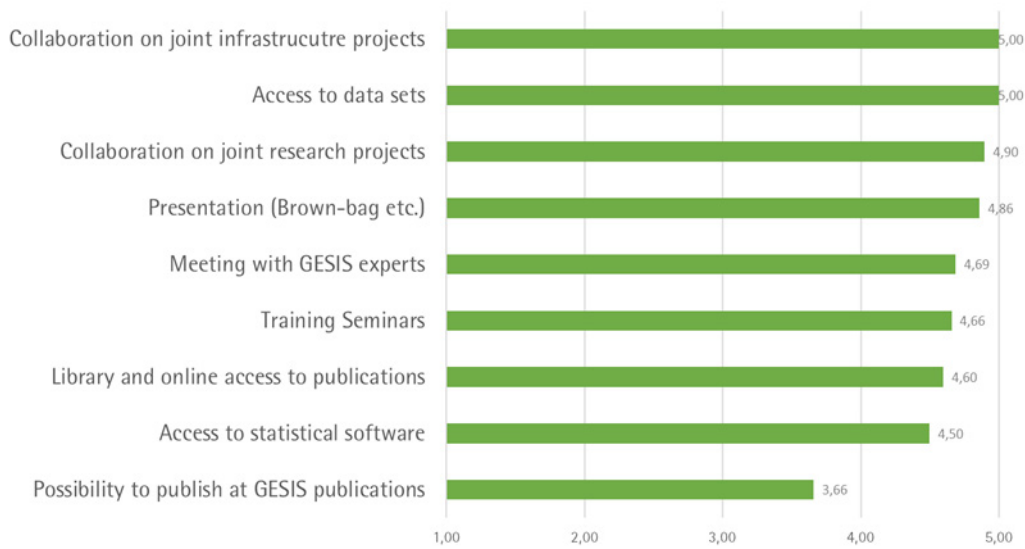


Figure 3.3: Satisfaction with Services (n= 19); mean values from scales with 1= very poor to 5= very good

In addition to the evaluation of the services used, the evaluation of the satisfaction of these services is also of crucial importance. As shown in Figure 3.3, visitors were in fact very satisfied with the services used, especially with the possibility to collaborate on joint infrastructure projects and the access to data sets. The only area where visitors saw some room for improvement was the possibility to publish at GESIS publications.

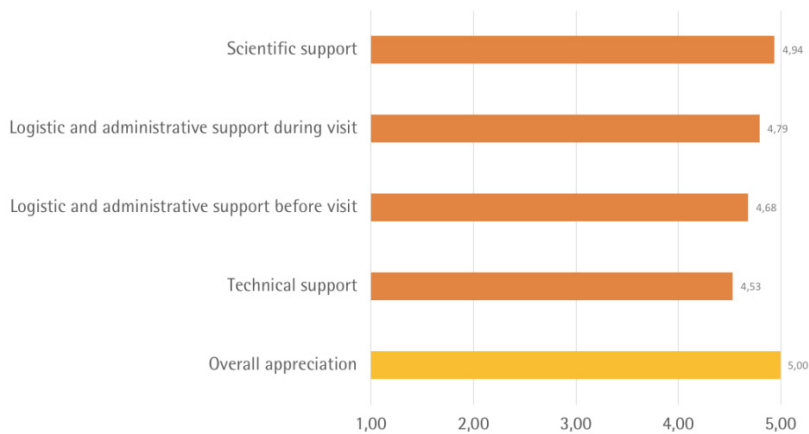


Figure 3.4: Satisfaction with support (n= 19); mean values from scales with 1= very poor to 5= very good

Figure 3.4 provides information regarding the overall level of appreciation of the visiting researchers as well as the level of satisfaction for the support of each service individually.

All EUROLAB services were evaluated as very good and, consequently, this is reflected in the high overall appreciation of the research visit (Figure 3.4). All participants evaluated their GESIS stay as very good (5.0). Especially the scientific support (4.94) plays an important role in the high evaluation. Also of great importance is the high evaluation of the logistic and administrative support, both during and before the stay and finally the high evaluation of the technical support.

## 4 EUROLAB Activities

---

### 4.1 Capacity Building and Research Cooperations

In addition to the academic and administrative support of guest researchers, one central task of the EUROLAB is capacity building. To this end, EUROLAB encourages cooperation on both research and infrastructure projects. In 2018, the focus was primarily on sub-Saharan Africa. Several co-operations were initiated, especially with Uganda, where Norman Mukasa, one of the 2018 GESIS Grant holders, is setting up a Research Data Lab in the Social Sciences based on the EUROLAB model. Several funding proposals in the fields of research, infrastructure and training were submitted in 2018 under the leadership of the head of the Knowledge Transfer department.

### 4.2 RDA

Comprehensive international and interdisciplinary cooperation with other infrastructure facilities also takes place within the framework of the Research Data Alliance (RDA). Several sessions took place in cooperation with other RDA Interest Groups in 2018; the session "Ethics in FAIR Data: Ethical and practical issues of data sharing and usage within and across disciplines" at the 11<sup>th</sup> RDA, Plenary, Berlin, was a collaboration between IG Data for Development, IG Ethics and Social Aspects of Data, IG Small Unmanned Aircraft Systems' Data, IG Health Data, and IG RDA/NISO Privacy Implications of Research Data Sets and several sessions took place at the 12<sup>th</sup> RDA Plenary/SciDataCon in Botswana in co-operation with partners such as "Capacity Building for Data Management and Participation in International Surveys in Africa", "African Universities Response to the Challenges of the Data Revolution", " Sustainable Development Goals (SDG) Data at the Subnational Level".
