Constitution.

ARTICLE 1 — The name of this Club shall be THE HARRIET TAYLOR UPTON STUDY CLUB, being a strictly independent suffrage club, members of other suffrage clubs not being eligible.

ART. 2 — The object of this Club shall be the study of Civic Interests and Institutions.

ART. 3 — The officers shall be President, three Vice-Presidents, Secretary, Corresponding Secretary, Treasurer, Auditor and Advisory. The officers shall constitute an Executive Board, in whom shall be vested power of action in emergency.

ART. 4 — The duties of the officers shall be as usual to such functions.

ART. 5 — There shall be a Standing Committee of Membership with a Chairman in the several suburbs, who shall have power to add another to her aid by endorsement of the executive.

ART. 6 — Upon recommendation of Committee a vote shall be taken by ballot, and upon acceptance, the new member shall be formally introduced.

ART. 7 — The membership of the Club shall be men and women, but officers shall be chiefly women; the Auditor or Treasurer may be a man.

ART. 8 — There shall be an Associate Membership on payment of double fee. Honorary Membership shall be upon vote of majority of active members.

ART. 9 — There shall be two meetings monthly, the first to be held afternoons, for discussion of papers and

business; the second, evenings, for lectures and social recreations at places designated by Program.

ART. 10 -- The colors of this Club shall be White and Yellow, the badge a small enameled scale in form of pin.

ART. 11 -- The motto: "Political Progress for Righteous Rule."

ART. 12 -- This Constitution may be changed by two-thirds vote of those present at a second meeting after the desired change has been submitted to the Club in writing.
