**Order Granting in Part Motion to Dismiss
4Internet's Counterclaims**

[ECF No. 36]

11 Photographer Robert Miller contends that he holds the exclusive rights to a photograph
12 that he took of a goat, which originally appeared in an article published by the New York Post.¹
13 Miller sues 4Internet, LLC for federal copyright infringement, alleging that company was not
14 authorized to use the goat photo but did when it re-posted the Post's article on its own website.²
15 4Internet contends that it operates a search engine and Miller and his attorney crashed its
16 Georgia-located server when they engaged non-party Copypants, Inc.'s bot to search the internet
17 for potentially infringing uses of the goat photo and other photographs.³ 4Internet countersues
18 Miller, another photographer Christopher Sadowski, Miller's attorney Mathew Higbee, and
19 Higbee's law firm Higbee & Associates, APC ("H&A") for violating the federal Computer Fraud
20 and Abuse Act (CFAA) and Georgia's Computer Systems Protection Act (CSPA).⁴ 4Internet

1 also countersues Sadowski for a declaration that it did not infringe any rights that he might hold
2 to two photographs that 4Internet displayed on its website.⁵

3 The counterclaim defendants move to dismiss all three of 4Internet’s counterclaims.⁶
4 They raise two defenses to the counterclaims under the CFAA and the CSPA. The counterclaim
5 defendants first argue that dismissal is warranted under Rule 12(b)(1) of the Federal Rules of
6 Civil Procedure because 4Internet lacks constitutional standing as it has not shown that its injury
7 is plausibly traceable to their alleged conduct. They next contend that the counterclaims must be
8 dismissed under Rule 12(b)(6) because 4Internet’s factual allegations are far too thin to state a
9 claim upon which relief can be granted against any of them. Although I address only the
10 jurisdictional arguments, the pleading deficiencies that I identify below merit dismissal under
11 both rules. But I am not satisfied that those deficiencies cannot be cured by amendment, so I
12 dismiss the counterclaims under the CFAA and the CSPA without prejudice and with leave to
13 amend if 4Internet can plead true facts to show that its injury was plausibly caused by the
14 counterclaim defendants’ conduct.

15 Sadowski argues that the counterclaim for a declaration of non-infringement fails because
16 a counterclaim cannot be asserted “entirely against a solely third or new party” like him.⁷
17 Sadowski misunderstands the counter-complaint: the other two counterclaims are brought against
18 him, too. Because I dismiss the first two counterclaims without prejudice and with leave to
19 amend, I deny as premature the motion to dismiss the third counterclaim. But I grant Sadowski’s

1 alternative motion for a more definite statement as to whom each counterclaim is brought
2 against, because that fact is not entirely clear from the face of the counter-complaint.

3 **Background**

4 4Internet alleges that it operates a search engine.⁸ It contends that Miller, Sadowski,
5 Higbee, and H&A are “copyright trolls” who “use a program or service called Copypants” to
6 “identify infringing uses of photographs on the internet” and force settlements or meritless
7 lawsuits on persons who use the photos on their websites.⁹ 4Internet asserts that the
8 counterclaim defendants caused Copypants’s bot to visit 4Internet’s search engine, which is
9 housed on a server in Georgia and was at that time “developmental and intended only to be used
10 for relatively minimal internet traffic.”¹⁰ Copypants’s visits allegedly “overwhelmed 4Internet’s
11 server[,] causing [it] to be offline and unavailable for legitimate traffic.”¹¹

12 4Internet claims that Copypants visited its server 365 times “between April 30 and
13 October 4, 2018.”¹² 4Internet also alleges that “IP addresses associated with [H&A] visited [the]
14 server 308 times between May 2 and November 18, 2018.”¹³ It alleges that H&A’s visits
15 included viewing 4Internet’s terms-of-use page, which stated that “all visitors must only access
16 the webpages using the system interface.”¹⁴ According to 4Internet, this term means that

1 “[u]sing the Copypants bot to access and obtain information from the 4Internet server exceeded
2 the authority or permission granted to users of the site.”¹⁵

3 4Internet alleges that, on September 25, 2018, its “counsel specifically notified Mathew
4 Higbee that . . . the technology you seem to be using to search the internet for potentially
5 infringing images draws significant system resources, and which is believed to have caused a
6 recent temporary server outage. Since this access exceeds the authorization, your clients should
7 expect a counterclaim under 18 U.S.C. § 1030(a)(5)(c) in the event an action is filed.”¹⁶

8 4Internet asserts that, despite this “notice and warning, the Copypants bot continued to visit [its]
9 server.”¹⁷

10 Based on these facts, 4Internet contends that the counterclaim defendants “knowingly
11 caused the Copypants bot to intentionally access the 4Internet server on multiple occasions” and
12 thus violated § 1030(a)(5) of the CFAA.¹⁸ It further contends that the counterclaim defendants
13 “conspired and did knowingly and intentionally use a computer network to cause a malfunction
14 of the 4Internet server in violation” of § 16-9-93(b)(3) of the CSPA.¹⁹

1 **Discussion**

2 **A. Counterclaims under the CFAA and CSPA**

3 **1. Legal standard for dismissal under Rule 12(b)(1)**

4 The Ninth Circuit explained in *Safe Air for Everyone v. Meyer* that motions to dismiss
5 under Rule 12(b)(1) for lack of subject-matter jurisdiction “may be facial or factual.”²⁰ “In a
6 facial attack, the challenger asserts that the allegations contained in a complaint are insufficient
7 on their face to invoke federal jurisdiction.”²¹ But “in a factual attack, the challenger disputes
8 the truth of the allegations that, by themselves, would otherwise invoke federal jurisdiction.”²²
9 “In resolving a factual attack on jurisdiction, the district court may review evidence beyond the
10 complaint without converting the motion to dismiss into a motion for summary judgment.”²³
11 The court also “need not presume the truthfulness of the plaintiff’s allegations.”²⁴ When the
12 moving party has successfully “converted the motion to dismiss into a factual motion by
13 presenting affidavits or other evidence properly brought before the court, the party opposing the
14 motion must furnish affidavits or other evidence necessary to satisfy its burden of establishing
15 subject[-]matter jurisdiction.”²⁵

16 “Ordinarily, where a jurisdictional issue is separable from the merits of a case, the court
17 may determine jurisdiction by the standards of a Rule 12(b)(1) motion to dismiss for lack of

1 jurisdiction.”²⁶ In that situation, “the district court is free to hear evidence regarding jurisdiction
2 and to rule on that issue prior to trial, resolving factual disputes where necessary.”²⁷ But “[t]he
3 relatively expansive standards of a [Rule] 12(b)(1) motion are not appropriate for determining
4 jurisdiction in a case . . . where issues of jurisdiction and substance intertwined.”²⁸ That is
5 because “[a] court may not resolve genuinely disputed facts where ‘the question of jurisdiction is
6 dependent on the resolution of factual issues going to the merits.’”²⁹ In cases where
7 jurisdictional and substantive issues are intertwined, “the district court assumes the truth of
8 allegations in a complaint . . . unless [they are] controverted by undisputed in the record.”³⁰

9 More “‘exceptional’” are “‘jurisdictional dismissals in cases premised on federal-
10 question jurisdiction[,]’” which are warranted only in limited circumstances.³¹ The Supreme
11 Court cautioned in *Bell v. Hood* that when the facts about “‘the jurisdictional issue and
12 substantive issues are so intertwined that the question of jurisdiction . . . depend[s] on the
13 resolution of factual issues going to the merits of an action[,]’”³² then dismissal under FRCP
14 12(b)(1) is appropriate only when the claim that raises federal-question jurisdiction “clearly

1 appears to be immaterial and made solely for the purpose of obtaining federal jurisdiction or
2 such claim is wholly insubstantial and frivolous.”³³

3 **2. Constitutional standing is required for subject-matter jurisdiction**

4 “[T]hose who seek to invoke the jurisdiction of the federal courts must satisfy the
5 threshold requirement imposed by Article III of the Constitution by alleging an actual case or
6 controversy.”³⁴ The plaintiff must satisfy Article III’s standing requirements for each claim it
7 “seeks to press and for each form of relief that is sought.”³⁵ A plaintiff satisfies Article III’s
8 requirements by showing that “(1) it has suffered an ‘injury in fact’ that is (a) concrete and
9 particularized and (b) actual or imminent, not conjectural or hypothetical; (2) the injury is fairly
10 traceable to the challenged action of the defendant; and (3) it is likely, as opposed to merely
11 speculative, that the injury will be redressed by a favorable decision.”³⁶ “[L]ack of Article III
12 standing requires dismissal for lack of subject[-]matter jurisdiction under Federal Rule of Civil
13 Procedure 12(b)(1).”³⁷

14 **3. Factual attack of allegations necessary for constitutional standing**

15 4Internet theorizes that the counterclaim defendants’ conduct of causing Copypants to
16 search its server for infringing uses of photographs temporarily crippled its server and, thus,
17 violated provisions of the CFAA and the CSPA. The counterclaim defendants mount a factual

1 attack on subject-matter jurisdiction, arguing that 12(b)(1) dismissal is warranted because
2 4Internet does not have constitutional standing to bring a claim under either the CFAA or the
3 CSPA as it cannot show that its alleged injury is fairly traceable to the counterclaim defendants'
4 challenged conduct.³⁸ The counterclaim defendants base their argument that 4Internet cannot
5 show causation on their belief that their evidence shows that none of them used Copypants to
6 search for the goat photo. The counterclaim defendants' factual attack fails for several reasons.

7 The first problem is that the counterclaim defendants concede in their reply that the
8 “jurisdictional issue and substantive issues are intertwined” here,³⁹ but they don't argue that
9 4Internet's claim under the CFAA is immaterial, made solely for the purpose of obtaining federal
10 jurisdiction, or wholly insubstantial and frivolous. As the Ninth Circuit explained in *Safe Air for*
11 *Everyone*, it is error to dismiss a complaint under Rule 12(b)(1) in cases like this where the
12 “jurisdictional issue and the substantive issues . . . are so intertwined that the question of
13 jurisdiction is dependent on the resolution of factual issues going to the merits.”⁴⁰

14 The second problem with the counterclaim defendants' factual attack is that their
15 evidence does not truly refute 4Internet's allegation that they caused Copypants to search
16 4Internet's server for infringing photographs. The counterclaim defendants provide declarations
17 from Higbee and non-party Eugene Sadowski. Eugene declares that he's an agent for Miller and
18 the named Sadowski and he “assist[s] photographers with keeping track of their intellectual

1 property by discovering unauthorized uses of their photographs.”⁴¹ To that end, Eugene declares
2 that, “[o]n or about August, 31, 2008, [he] discovered the alleged infringing use” of the goat
3 photo on two of 4Internet’s websites.⁴² Confusingly, Eugene declares that he discovered the
4 allegedly infringing use of the goat photo “through a manual image search using Google reverse
5 image search. No reverse image search services such as Copypants or any others were used to
6 discover these uses.”⁴³ But Eugene’s testimony about how he discovered the allegedly
7 infringing uses of the goat photo doesn’t refute 4Internet’s allegations that Higbee and H&A, as
8 attorneys for Miller, Sadowski, and other photographers, caused Copypants to search its server
9 for allegedly infringing uses of their clients’ photographs. Eugene does not (because he cannot)
10 speak to what any of the named counterclaim defendants did or did not do. This evidence is
11 irrelevant.

12 Higbee’s testimony is slightly more relevant but he, too, fails to truly refute 4Internet’s
13 factual allegations. Higbee declares that his law firm H&A hired Copypants “to conduct reverse
14 image searches for a few clients.”⁴⁴ He declares that H&A “ended its relationship with
15 Copypants on or about May 2018,” which is before the goat photo was even taken or
16 published.⁴⁵ And he declares that “[a]s of September 1, 2018, Copypants . . . no longer provides
17 its freelance services and its website is currently down.”⁴⁶ But the slim facts that Higbee provides
18 are merely distinctions without a difference at this stage because it is not clear from either the
19

1 face of the complaint or 4Internet’s evidence in response to the dismissal motion when its server
2 was crippled. I’ll return to this critical pleading deficiency in a moment.

3 The final problem with the facial attack is that 4Internet responds with a declaration from
4 its managing member, Michael Levy, and documentary evidence that he explains, which directly
5 refute or casts doubt on the counterclaim defendants’ facts.⁴⁷ In sum, the counterclaim
6 defendants do not truly dispute that they caused Copypants to search 4Internet’s server for
7 infringing photographs, 4Internet’s evidence controverts the few relevant facts that the
8 counterclaim defendants raise, but I cannot resolve any disputed facts because the question of
9 jurisdiction here is dependent on the resolution of factual issues going to the merits of 4Internet’s
10 counterclaims. What this all means is that the counterclaim defendants’ factual attack on
11 4Internet’s standing to bring counterclaims under the CFAA and the CSPA fails. But this does
12 not end my analysis under Rule 12(b)(1) because I construe these same arguments as also
13 mounting a facial attack on 4Internet’s causation allegations.

14 **4. Facial attack of causation allegations necessary for constitutional standing**

15 The Ninth Circuit explained the standard for determining constitutional standing at the
16 dismissal stage in *Maya v. Centex Corporation*. “For purposes of ruling on a motion to dismiss
17 for want of standing, both the trial and reviewing courts must accept as true all material
18 allegations of the complaint and must construe the complaint in favor of the complaining
19 party.”⁴⁸ “At the pleading stage, general factual allegations of injury resulting from the

1 defendant’s conduct may suffice, for on a motion to dismiss we presume that general allegations
2 embrace those specific facts that are necessary to support the claim.”⁴⁹

3 Under *Maya*, my task is to determine if 4Internet has alleged enough facts to show that it
4 has constitutional standing to assert its claims under the CFAA and the CSPA. The counterclaim
5 defendants concede that 4Internet has plausibly alleged the first element of standing—that it
6 suffered an actual injury in fact that is concrete and particularized.⁵⁰ Thus, I need determine only
7 whether, for each counterclaim, 4Internet has shown that its alleged injury is fairly traceable to
8 the counterclaim defendants’ challenged conduct and if it is likely, as opposed to merely
9 speculative, that its injury can be redressed by a favorable court decision.⁵¹ I begin with
10 4Internet’s counterclaim under the CFAA.

11 **a. Counterclaim under the CFAA**

12 The CFAA “states that ‘[w]hoever . . . intentionally accesses a computer without
13 authorization or exceeds authorized access, and thereby obtains . . . information from any
14 protected computer . . . shall be punished’ by fine or imprisonment.”⁵² The CFAA further
15 provides that “[a]ny person who suffers damage or loss by reason of a violation’ of that

1 provision may bring a civil suit ‘against the violator to obtain compensatory damages and
2 injunctive relief or other equitable relief.’”⁵³ The term “protected computer” essentially means
3 “any computer connected to the internet, including servers, computers that manage network
4 resources and provide data to other computers.”⁵⁴ The Ninth Circuit has interpreted the phrase
5 “without authorization” to prohibit conduct that is analogous to “breaking and entering” and
6 has applied it to only “information [that is] delineated as private through use of a permission
7 requirement of some sort.”⁵⁵ It has interpreted the phrase “exceeds authorized access” to exclude
8 from liability any conduct that merely exceeds a website’s terms of service or use.⁵⁶ This means
9 that “a violation of the terms of use of a website—without more—cannot establish liability under
10 the CFAA.”⁵⁷ According to the Ninth Circuit, “a defendant can run afoul of the CFAA when he
11 or she has no permission to access a computer or when such permission has been revoked
12 explicitly.”⁵⁸

13 4Internet’s theory of liability appears to be that the counterclaim defendants ran afoul of
14 the CFAA when they caused Copypants to visit 4Internet’s server, i.e., use its search engine,
15 after 4Internet had revoked explicitly their permission to do so. The counterclaim defendants
16 argue that 4Internet lacks constitutional standing to assert this claim because it has not shown
17 that its injury was plausibly caused by their alleged conduct.

1 “To survive a motion to dismiss for lack of constitutional standing, [4Internet] must
2 establish a ‘line of causation’ between defendants’ action and [its] alleged harm that is more than
3 ‘attenuated.’”⁵⁹ 4Internet does not allege when its server was crippled, and it is not clear from
4 this record whether that occurred only once or more than once. 4Internet does not allege what
5 steps it took, if any, to protect its fledgling search engine from more than “minimal internet
6 traffic.” 4Internet does allege that Copypants visited its server hundreds of times over a six-
7 month period. But it also alleges that H&A visited the server directly, i.e., not using Copypants,
8 hundreds of times in roughly the same six-month period and yet does not allege facts to show
9 that there was a pattern to these visits, e.g., H&A visited webpages closely on the heels of
10 Copypants’s visits to the same pages. Nor does it allege facts to show that the counterclaim
11 defendants exclusively or typically used Copypants to search for infringing photographs or were
12 the exclusive or majority users of Copypants’s service whenever the server was disabled.

13 Despite construing the facts in the light most favorable to 4Internet and drawing all
14 inferences in its favor, I cannot conclude on this record that 4Internet has shown that its harm
15 was plausibly caused by the counterclaim defendants’ alleged conduct.⁶⁰ The facts alleged here
16 show that Higbee and H&A have used Copypants to search the internet for potentially infringing
17 uses of their clients’ photographs. But the facts show at best that it is merely possible that
18 Higbee and H&A’s use of Copypants, as opposed to a third party’s use, is what took down

plaintiffs’ neighborhoods, and were thus able to dictate the terms of a large number of loans and
plausibly create demand that would not otherwise have existed,” and that “the neighborhoods
were new developments, so there was no independent economic baseline against which to assess
the neighborhoods’ value”).

1 4Internet’s server. The facts alleged do not show or permit me to infer that (1) Miller or
2 Sadowski possibly used Copypants at all, let alone whenever 4Internet’s server was temporarily
3 crippled, or (2) 4Internet revoked explicitly anyone’s permission to access the server other than
4 maybe Higbee’s permission.

5 These pleading defects require dismissal under Rule 12(b)(1) for lack of constitutional
6 standing and under Rule 12(b)(6) for failing to state a claim upon which relief can be granted.
7 But it is not yet clear that these defects cannot be cured by amendment, so 4Internet’s
8 counterclaim under the CFAA is dismissed without prejudice and with leave to amend.

9 ***b. Counterclaim under the CSPA***

10 4Internet’s second counterclaim arises under Georgia’s Computer Systems Protection
11 Act, which provides that

12 Any person who uses a computer or computer network with
13 knowledge that such a use is without authority and with the
14 intention of . . . [a]ltering, damaging, or in any way causing the
15 malfunction of a computer, computer network, or computer
program regardless of how long the alteration, damage, or
malfunction persists shall be guilty of the crime of computer
trespass.⁶¹

16 In addition to criminal penalties, the CSPA authorizes “[a]ny person whose property or person
17 [has been] injured by reason of a violation of any provision” of that Act to “sue therefore and
18 recover for any damages sustained and the costs of suit.”⁶²

19 4Internet theorizes that the counterclaim defendants violated the CSPA when they caused
20 Copypants to visit 4Internet’s server, i.e., use its search engine, after 4Internet revoked explicitly
21 their permission to do so. The factual allegations supporting this counterclaim are the same ones

1 that support the counterclaim under the CFAA. The counterclaim defendants argue that these
2 allegations are insufficient to show that 4Internet’s injury is fairly traceable to their conduct.⁶³
3 Indeed, the facts alleged show that it is merely possible that Higbee and H&A’s use of
4 Copypants is what crippled 4Internet’s server. Because 4Internet has not plead enough facts to
5 plausibly state that its injury was caused by the conduct of any counterclaim defendant, I dismiss
6 its CSPA counterclaim under Rule 12(b)(1) and Rule 12(b)(6). But it is not yet clear that this
7 pleading deficiency cannot be corrected with amendment, so this counterclaim is dismissed
8 without prejudice and with leave to amend.

9 **B. Counterclaim for declaration of non-infringement against Sadowski**

10 Sadowski argues that 4Internet’s counterclaim against him for a declaration of non-
11 infringement must be dismissed because “a counterclaim cannot be asserted entirely against
12 solely third parties or new parties” like him.⁶⁴ Sadowski misreads the counter-complaint as
13 alleging only the third counterclaim against him. 4Internet clarified in its response to the
14 dismissal motion that the first and second counterclaims are also brought against Sadowski.⁶⁵
15 This changes the calculus of Sadowski’s argument to dismiss this counterclaim; he currently
16 focuses on whether his joinder is required under Rule 19 or can be permitted under Rule 20 for a
17 single counterclaim that is not connected to any other counterclaim or Miller’s copyright-
18 infringement claim. Because I dismiss the first and second counterclaims without prejudice and
19 with leave to amend, I deny as premature the motion to dismiss the third counterclaim. But like
20 Sadowski, the court was not certain that the first and second counterclaims were alleged against

1 him until 4Internet clarified in its response that they were. I therefore grant Sadowski's
2 alternative motion for a more definite statement as to whom each counterclaim targets.

3 **Conclusion**

4 Accordingly, IT IS HEREBY ORDERED that the counterclaim defendants' dismissal
5 motion [ECF No. 25] is **GRANTED in part**. 4Internet's first and second counterclaims are
6 **DISMISSED** without prejudice to its ability to amend and reassert those counterclaims if it can
7 plead true facts to show that the counterclaim defendants' conduct plausibly caused its injury.
8 4Internet must also clearly allege whom each counterclaim is brought against. The motion is
9 **DENIED** as premature in all other respects. 4Internet has **until January 20, 2020**, to file its
10 amended counter-complaint correcting the deficiencies identified in this order.
