# CSC 598.66 Senior Project I: Lecture

#### **Overview:**

A survey and analysis of ethical issues and cases, as well as an introduction to related concepts such as leadership, decision-making, communication, managing projects and teamwork. The course is organized around the text (see below), handouts, lectures and selected readings. The content of the course will provide a basic knowledge of ethics, ethical behavior, and ethical dilemmas that a computer engineer or computer science major would likely encounter during his/her career. Contents include a discussion of legal and ethical issues faced by today's engineers and managers.

### **Course Goals, Objectives, and Outcomes:**

The course will provide an understanding of professional, ethical, legal, security, and social issues and responsibilities. The course will generate the ability to recognize conflicts of interests issues and intellectual property concerns and act in accordance with professional, ethical, and legal standards. The course will build the ability to treat others with respect, and refrain from discriminating on the basis of gender, race, religion, sexual orientation or physical disability and other attributes not related to academic or research performance.

Method: The course will review major theories of ethics that will form a general background in commercial transactions The legal principles presented are in the form of basic principles generally accepted by the courts or expressed in statutes.
