Make provision to end rights to free movement of persons under retained EU law and to repeal other retained EU law relating to immigration; to confer power to modify retained direct EU legislation relating to social security coordination; and for connected purposes.

B E IT ENACTED by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

(2) In sub-paragraph (1), "the Swiss free movement agreement" means the Agreement between the European Community and its Member States, of the one part, and the Swiss Confederation, of the other, on the free movement of persons (done at Luxembourg on 21 June 1999). 15 (1) Any other EU-derived rights, powers, liabilities, obligations, restrictions, 6 remedies and procedures cease to be recognised and available in domestic law so far as they are inconsistent with, or are otherwise capable of affecting the interpretation, application or operation of, any provision made by or 20 under the Immigration Acts (including, and as amended by, this they are otherwise capable of affecting the exercise of functions in connection with immigration. Combination of instruments

- (5) Sub-paragraphs (1) to (3) apply in relation to a statutory instrument containing regulations under section 5 which is subject to a procedure before the Scottish Parliament or the Northern Ireland Assembly as well as a procedure before Parliament as they apply to a statutory instrument containing regulations under section 5 which is subject to a procedure before Parliament but as if the references to Parliament were references to Parliament and the Scottish Parliament or, as the case may be, the Northern Ireland Assembly.
- (6) This paragraph does not prevent the inclusion of other regulations in a statutory instrument or statutory rule which contains regulations under section 5 (and, accordingly, references in this Schedule to an instrument containing regulations are to be read as references to an instrument containing (whether alone or with other provision) regulations).

To make provision to end rights to free movement of persons under retained EU law and to repeal other retained EU law relating to immigration; to confer power to modify retained direct EU legislation relating to social security co-ordination; and for connected purposes.
