DEAR MR. PRESIDENT:

THE HIGHEST STATE OF HEAT AND TENSION PREVAILS IN MISSISSIPPI. IT IS SPREADING TO OTHER STATES LIKE A FLAMING BRUSH FIRE. IT IS BROUGHT ABOUT BY ONE PERSON OSTENSIBLY TO GET AN EDUCATION. IT IS APPARENT THIS IS NOT HIS REAL OBJECTIVE. THIS IS OBVIOUS TO ALL. UNDER PREVAILING CIRCUMSTANCES AND THOSE THAT WILL FOLLOW FOR THE REMAINDER OF THE SCHOOL YEAR, PROBABLY MUCH LONGER, IT WILL BE IMPOSSIBLE FOR EITHER THE SUBJECT APPLICANT OR THE 5,000 STUDENTS TO OBTAIN ANY EDUCATIONAL ADVANTAGES. WE RESPECTFULLY SUBMIT, MR. PRESIDENT, THE SUCCESSFUL REGISTRATION COULD NOT BE WORTH THE PRICE.

WE URGE YOU TO WITHDRAW SUCH TROOPS AS HAVE ALREADY BEEN DEPLOYED
IN AND NEAR MEMPHIS AND TO SET AT REST ALL REPORTS AND RUMORS THAT
OTHER TROOPS ARE TO FOLLOW. THE USE OF MILITARY FORCE IN A PREVIOUS
INSTANCE WAS UNIVERSALLY REGRETTED AND DEPLORED. THE POWER TO SAVE
HUMAN BLOOD, EVEN HUMAN LIVES, IS IN YOUR HANDS, MR. PRESIDENT. WE
RESPECTFULLY APPEAL TO AND URGE YOU TO STOP THIS DEMONSTRATION OF
FEDERAL MIGHT WHICH HAS MOVED THE PEOPLE OF OUR STATE AND IS NOW
MOVING THOSE OF OTHER STATES TO THE HIGHEST DEGREE OF HEAT AND
TENSION. A HOLOCAUST IS IN THE MAKING. YOU ARE THE ONLY PERSON WHO
CAN STOP IT. THIS APPEAL IS MADE IN EARNEST. MR. PRESIDENT, THE
OBJECTIVE COULD NOT BE WORTH THE PRICE. WE BESEECH YOU TO ACT BEFORE
IT IS TOO LATE. RESPECTFULLY,
