Dear Sir:

In view of the fact that the Seminar. History class in which I am enrolled will not meet for two weeks, I am writing you as an individual. It is my belief that most, probably all, of this class of Dr. Silver's feel as I do--- that to suggest removing Dr. Silver from his position at Ole Miss will prove to the bilt just what he has been saving about hilt just what he has been saying about the closed society in our state.

Do not misunderstand me. I am one of this class which has disagreed with Dr. Silver with perhaps more vigor than anyone, and it is my opinion that most of the class disagree with at least a portion of his opinions. But we do believe that we are not children who have to be protected from listening to professors with protected from listening to professors with whom we disagree, and certainly in Dr. Silver's class no one is prevented from expressing his opinion and disagreeing with the instructor.

I am much more concerned about classes --- I have one --- in which the instructor lectures with no opportunity for discussion or questioning by students, and in which the opinions of the instructor are given didactically and these must be accepted as correct if a student wishes to pass the course.

If Ole Miss and the state of Mississippi take the position that a professor must be silenced if his views are unpopular we are in worse shape than even our worst enemies wish. Students at Ole Miss have a right to hear what dissidents say and they are mature enough to decide what they believe

For a Congressman suggest by inuenddo that Dr. Silver is teaching "foreign ideologies" is a vicious libel on a professor who knows his subject (history) thoroughly and who has chosen to remain at Ole Miss when hundreds of other professors have left becasue of the attitude of Mississippi politicians who have not the slightest conception of the freedom of meaning of speech and freedom of ideas.
