PREFACE

This is the twenty eighth outcome of the Joint Study Project for Economic Development Policies in ASEAN and Neighbouring Areas initiated by the Institute of Developing Economies (IDE) in Tokyo. As far as Malaysia is concerned, this is the fifth volume in the series of the project. And for the present coordinator cum editor, this is the second and the last one.

Last year, five Malaysian scholars, namely, Dr. Stephen Leong, Dr. Mansor Md. Isa, Dr. Pang Teck Wai, Dr. Abdul Aziz and Mrs. Irene Sia participated in the project and its outcome was published in a book titled "Formation and Restructuring of Business Groups in Malaysia". Of these five scholars, to my regret, Dr. Stephen Leong has not been able to participate this year due to other commitments. Instead, to my relief and great honour, another two prominent scholars have contributed to this year's project. They are Dr. Toh Kin Woon of Socio-Economic Research &Systems Consultants Sdn.
