Section 244. Cases in which jury must be kept together. On the trial of offenses which are or may be punished capitally or by life imprisonment the jurors after they are accepted, if all of same sex, shall not be permitted to separate, but shall be kept together, in charge of the proper officers. But if the jury consists of both male and female, then the sexes of such jury may be permitted to separate during the trial and when necessary after final submission of the case, each sex being kept together in charge of an officer of like sex, as if two separate juries. On the trial of other felonies the jurors before the case is submitted to them, may be permitted to separate, in the discretion of the court, but after the case is submitted they shall be kept together in charge of officers. On the trial of misdemeanors the jurors may be permitted to separate, or the court may order them to be kept together.

CHAPTER 10.

AN ACT to provide for the establishment of two Normal Schools for the training of white elementary teachers, and appropriating moneys for the maintenance and operation thereof.

Whereas, the greatest need of common schools is trained elementary teachers, and

Whereas, the State Normal Schools already established can neither reach nor train all the elementary teachers needed for the common schools; therefore,

Be it enacted by the General Assembly of the Commonwealth of Kentucky:

§ 1. That a Commission is hereby created, to be known as the State Normal School Commission, consisting of eight members who are citizens of the State of Kentucky and over the age of twenty-one years, to be appointed as follows: Five by the Speaker of the House of Representatives and three by the President of the Senate, which is hereby authorized and empowered to establish two new Normal Schools for the training of white elementary teachers, one to be located in the western part of the State and one to be located in the eastern part of the State. The said Commission is hereby authorized to receive gifts of land, buildings or money for the establishment of these two normal schools for white elementary teachers:

- § 2. The management and control of these two normal schools, when established, shall be and is hereby vested in the State Board of Education.
- § 3. There is hereby appropriated, out of the general funds of the State, to each of these two normal schools, for maintenance and operation, the sum of thirty thousand dollars annually. The Auditor of the Commonwealth is directed to draw his warrants for said sums, above appropriated, upon requisitions signed by the Chairman and Secretary of the State Board of Education. Provided, that the above appropriation for maintenance and operation shall not become available for said Normal Schools until the said Commission has received for each of said schools gifts of land suitable to the purposes of each school, and also gifts of buildings or money, or both, equivalent in value to at least one hundred thousand dollars. Provided, further, that if gifts and donations are made, sufficient to establish one of said schools, then the sum of thirty thousand dollars shall be available for the maintenance and operation of said school.
- § 4. All laws and parts of laws in conflict with the provisions of this Act are hereby repealed.
- § 5. If any section of this Act shall be held un-

constitutional the remainder of the Act shall not be affected thereby.

CHAPTER 11.

AN ACT to amend Section 3 of an act entitled, "An Act to create the Kentucky Library Commission, to define its powers and duties and to provide for its expenses," which act was approved March 17, 1910, and to re-enact in lieu thereof the section as amended.

Be it enacted by the General Assembly of the Commonwealth of Kentucky:

That Section 3 of Chapter 27, Acts 1910, entitled, "An Act to create the Kentucky Library Commission, to define its powers and duties, and to provide for its expenses," which Act was approved March 17, 1910, be amended by striking out the words "not exceeding \$1,500 annually," so that when said section is amended and re-enacted it will read as follows:

The officers of the commission shall be a chairman, elected from the members thereof, for a term of one year, and a secretary, who shall be a person trained in modern library methods, not a member of the commission. The secretary shall be appointed by the commission and shall serve at the will of the commission under such conditions and for such compensation as to it shall seem adequate.

Said secretary shall keep a record of the proceedings of the commission; keep accurate accounts of its financial transactions; have charge of its work in organizing new libraries, and improving those already established; supervise the work of the traveling libraries, and in general perform such duties as
