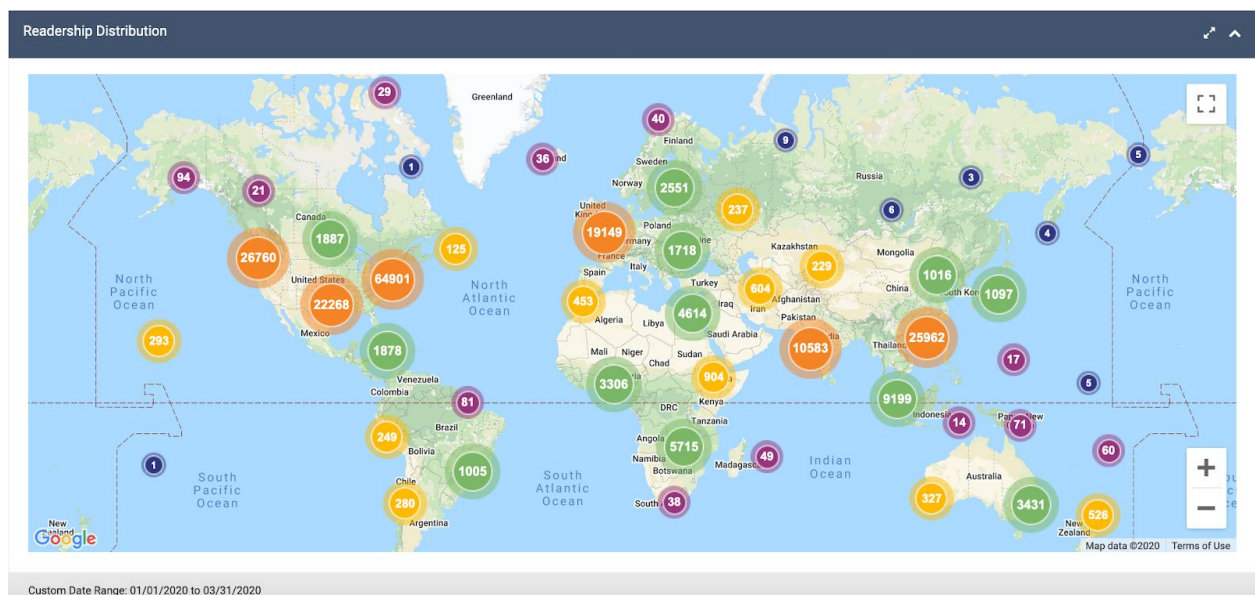

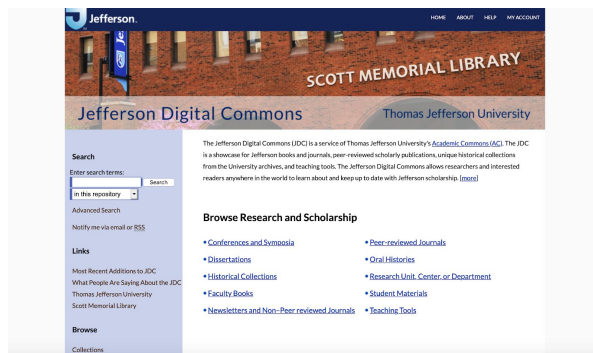

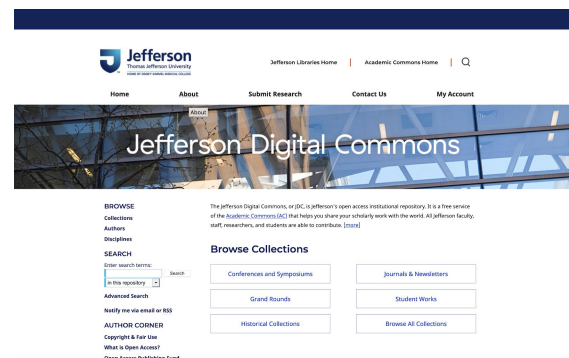
New Look for the Jefferson Digital Commons
