# **Please Carefully Read all Instructions Below**

#### • How To Reach The Conference Venue

This Radisson Blu Hotel in the Chaoyang District sits inside Beijing's dynamic CBD (central business district) and diplomatic area. It is conveniently adjacent to the China International Exhibition Centre (CIEC). Guests enjoy a short walk to the light rail station, multiple subway lines and bus stops. The hotel is a 20-minute drive to Beijing Capital International Airport, where taxis await.

#### From the airport by taxi:

Please note that it is recommended that you only board taxis which have number plates with a prefix of letter B. Please do not get into any unmarked taxis. It is highly recommended for safety reasons that you pre-book a transfer from your hotel to the airport (please call your hotel to arrange this). If you are staying at the Radisson Blu Hotel where the conference is being held, then you can pre-book the airport transfer for 450 Yuans each way by calling the hotel. They will send a representative who will hold your name card at the arrival hall and safely transfer you to the hotel.

#### From the airport by car:

Take the Airport Expressway to the city for approximately 20 kilometres. Exit at SanYuanQiao and turn west to SanYuanXiQiao toward CIEC. Turn left from SanYuanXiQiao and find the hotel on the right.

#### From the airport by subway:

The Airport Express of the Beijing Subway leaves from terminals 2 and 3 and makes two stops in urban Beijing (Dongzhimen and Sanyuanqiao), from which travellers can walk or take connecting transportation.

#### From the airport by bus:

An airport shuttle bus runs several lines into the city. Travellers can take Line 4 Gongzhufen, which makes a stop at the China International Exhibition Centre adjacent to the hotel.

The name of the winners will be announced via email 2-3 weeks after the conference. Papers selected as "Best Papers" will be published in the Journal of Business and Policy Research. The winners will receive an award certificate and fellowship certificate from WBI.

# • Paper Evaluation Report (PER) and Editorial Review Report (ERR)

If your invitation and acceptance letter does not mention any journal name, it means that your paper was not accepted for any of our journals, However, if you improve your paper according to the feedback you receive at the conference and/or via review report, we can reconsider the paper for journal publication at that stage. Please note that it is not guaranteed that your paper will be selected for a journal even after the revisions.

If you have already paid publication fee, you must indicate in red ink the new or additional materials you have added or inserted in compliance to written feedback and/or comments at the time of revision. We will endeavour, though not guaranteed, to publish your paper within six-nine months after the conference if you comply fully to all requirements and requests. No reminder notice will be sent. If you do not send your revised paper by the deadline or if you failed to comply in full to the review reports within the due time set by us and do not comply to our any request for reorganising the paper as per journals' guidelines or fail to make the paper camera-ready or do not respond to our emails within 6 months after the conference, your paper will not be published and no money or fee will be refunded.

If your paper has already been accepted for our journal and you have not paid any publication fees but are interested to publish can make cash payment at the registration desk.
