This research outlines the analysis of income generation basing on agro-cultural tourism of homestays under the purview of Ministry of Tourism and Culture of Malaysia. Using a case study of Kelantan and Terengganu, the research elaborates on the levels of income generated from agro-tourism, distributions, administrations, factors leading to the success of homestays in generating additional income and strategies of infrastructural improvements of homestay.
