A community is a particular group of people that are bound by a similar cultural practice and activities. The continuation of the practising the local culture developed an identity for the community. Through time, the identity is strengthened by the level of community involvement in response to their participation in preserving the culture. The lack of community involvement would result to decreasing number of cultural practices. Eventually, the process contributed to a negative impact on the local identity.
