# ACCEPTABILITY OF THE CONCEPT OF SHARIAH COMPLIANT PROCUREMENT IN THE MALAYSIAN CONSTRUCTION INDUSTRY

#### **Abstract**

Construction procurement is a process of acquiring a construction project. The procurement process is very crucial for the success of any projects. In the past and present, majority practice of procuring projects in Malaysia are involving riba (interest), gharar (uncertainties), maysir (gambling) and some other prohibited matters. Therefore, the concept of Shariah compliant procurement has been introduced as a new paradigm in the construction industry to overcome those prohibitions as well as fulfilling other Shariah requirements. However, the Malaysian construction industry has not fully adopted the concept of Shariah-compliant in construction procurement. Currently, the Shariah compliant has been already infused in certain parts of the process like in funding and insurance and there is a potential for the concept to be fully adopted as it is happening in various industries like banking, tourism, medical and others. In spite of that, there is always a question whether the Shariah Compliant can be fully embraced in the Malaysian construction industry. Therefore, the aim of the study is to investigate the acceptability of the Malaysian construction industry players on the concept of Shariah-compliant construction procurement. The study is being conducted by a combination of literature review and survey with the players in the construction industry. The outcome of the study indicates the assertion on the acceptability of the concept of Shariah-compliant construction procurement. The result is also significant to show the extent of the concept to be applied in the construction industry.

# Shariah Compliant

Shariah is a familiar term that known by most of the people in the world regardless of their religious background. Normally, it can be heard through news in various channels where the Shariah is being related to crime, politics, civilisation and feminism and many people from both Muslims and Non-Muslims are still not understand what is Shariah is all about (BBC News, 2009). Actually, Shariah is "overall way of life, as people understand it according to traditional, early interpretations" (Abdullah Ahmed, 2015, p.1). Fundamentally, Shariah can be divided into several components as




Figure 1: Components of Shariah, Categories of Fiqh & Key Principles of Muamalat (Khairuddin, 2017; Muhammad Rawwas Qal' ahji, 2005)

Meanwhile, Shariah compliant also known as halal is rapidly being practiced in many industries. Some people are off the opinion that Halal is only referred to food, clothing, conduct, speech and attitude (Carrie, Muitaba, Fatima & Nouman, 2017). However, the term Halal or Shariah compliant is beyond that where it can be referred as "transactions or activities which are performed according to the rules and standards under the Shari'ah" (Khairuddin, 2018, p.7). 
