ABSTRACT

Andre Khudri, (2014): The Effect of Using Breaking Habits of Seeing Strategy on Students' Ability in Writing a

Descriptive Paragraph at SMPN 2 Tembilahan.

Based on the writer's preliminary research, it was found that the students could not express their ideas in writing descriptive paragraph at school. The problem could be seen that some of the students could not write descriptive paragraph by using language features. So. The writer was interested in carrying out the research about this problem.

The research was administered at SMPN 2 Tembilahan. The subject of the research was the second year students at State junior High School 2 Temblahan and the object of this research was the effect of using breaking habits of seeing strategy toward students' writing ability. The desaign of this research was quasi-experimental design. The population of this research was the second year students. The total number of population was 200 students. The writer used two classes as sample that consisted of 40 students The writer used cluster sampling as a technique of taking sample and finally the writer got two classes as sample of this research. They are class VIII 8 as a experimental class that consist of 20 students and VIII 9 as a control class that consist of 20 students. To analyze the data, the writer adopted Independent sample T-test formula by using SPSS 17.0 version.

After analyzing the data, the writer found that $t_{observed}$ Was higher than t_{table} . The degree of freedom from the data was 38, that is 2.00 6.053 2.65. Thus, Null Hypothesis (Ho) was rejected and Altenative Hypothesis (Ha) was accepted. So, there is a significant effect of using Breaking Habits of seeing strategy toward students' ability in writing a descriptive paragraph at junior high school 2 Tembilahan.

Negeri 2 Tembilahan.

Berdasarkan penelitian pendahuluan penulis, ditemukan bahwa, siswa belum mampu menulis paragraf descriptive di sekolah .Masalahi ni disebabkan oleh beberapa faktor. Misalnya, sebagian siswa kurang mampu menulis paragraf dengan penggunaan bahasa yang benar dan karakteristik paragraf. Jadi, peneliti tertarik untuk mengadakan penelitian tentang masalah tersebut.

Penelitian ini diadakan di SMP Negeri 2 Tembilahan. Subjek dari penelitian ini adalah siswa kelas VIII SMP Negeri 2 Tembilahan, dan objek dari penelitian ini adalah dampak dari penggunaan strategi Breaking Habits. Adapun jenis penelitiannya adalah quasi-experiment. Sampel dari penelitian ini adalah siswa kelas VIII yaitu kelas VIII 8 dan VIII 9. Keseluruhan dari jumlah sampel adalah 200 siswa. Penulis Menggunakan dua kelas sebagai sampel yang terdiri dari 40 Siswa. Penulis menggunakan cluster sampling sebagai tehnik pengambilan sampel dan terpilihlah kelasVIII 8 sebagai kelas eksperimen dengan jumlah siswa 20 siswa dan kelas VIII 9 sebagai kelas kontrol dengan jumlah 20 siswa. Untuk data analisisnya, penulis menggunakan Independent sample T-test melalui SPSS 17.0 Version.

Setelah data dianalisis, penulis menemukan, dimanat _{observed} lebih besar dari padat _{table} dengan df = 38, yaitu 2.00 6.053 2.65. Maka, Null Hypothesis (Ho) ditolak, dan Alternative Hypothesis (Ha) diterima. Jadi, terdapat pengaruh yang signifikan dari penggunaan strategi Breaking habits terhadap kemampuan menulis siswa di SMP Negeri 2 Tembilahan.
