This issue completes the two-issue series on Information Technology Global Services and Sourcing articles with two applications and practice papers.

In the paper "Unraveling the Success of India's IT-ITES Industry: Can India Sustain this Success?" Chakraborty and Kumar (2013) examine the success of India's information technology – information technology enabled services (IT-ITES) industry from multiple lenses to present a holistic view. Research frameworks from information systems and international business literature contribute to an understanding of the factors that led to the success of Indian IT-ITES industry.

Hodosi and Rusu (2013), in their paper, "How do Critical Success Factors Contribute to a Successful IT Outsourcing: A Study of Large Multinational Companies," provide guidance to practitioners by presenting a set of best practices for firms that are engaged in global sourcing.
