ABSTRACT

Online education has evolved throughout the years as new technologies are developed to make education more accessible. More traditional universities have also entered the virtual campus space, offering multiple options for students to earn their degree remotely. In a 2015 report conducted by the Online Learning Consortium, reflected more than one-quarter of all adult students were identified as e-learners.
