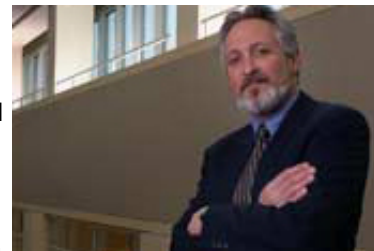

A Nance Benchmark Primer, Part III

For the past several months in UpFront, I have been reviewing the figures that characterize and describe the Nance College of Business. We highlighted our enrollment success and the growth of our extended campuses. This month, I want to focus on the grants and contracts that the Nance College has received in recent years that have contributed to this recent success. With these funds, sound financial stability is achieved to help ensure that our students are experiencing the highest quality education. External support is very important to our growth and advancement as a college and as a university. Here are some important numbers, which highlight the most significant recent grants and contracts.

U.S. Department of Education Title VI-B grants are grants received for our international business programs and outreach initiatives. Since 2003 they totaled approximately \$750,000. Grant funded initiatives have included:

- A portfolio of undergraduate, graduate and doctoral programs in global business
- International business internships
- Global E-commerce Certificate program
- Nance Global Innovation Lab at the Beachwood Business Development Center (BBDC)

Additional federal, state and local grants for more than \$500,000 have included:

- USAID: Building a Sustainable Center of Excellence for Computer Science and Engineering at the Copperbelt University in Zambia
- Cleveland Foundation grant for the High Performance Building initiative
- Cuyahoga Innovation Zone grant to further the economic development activities of the BBDC
- Key Foundation grant to establish the Student Managed Investment Fund, allowing students to gain experience in investments and portfolio management using real money
- Cleveland Foundation grant to examine the commercial opportunities for hydrogen technology in Northeast Ohio

Industry-based contracts for special programs, applied research and consulting totaled over \$500,000 over the past four years. Outcomes have included:

- Establishment of the GlobalTarget flagship program to help regional businesses expand their global markets
- Becoming the lead provider in Northeast Ohio for the SHRM Learning System
- Providing on-site, customized preparation course for the Certified Management Accountant exam
- Facilitating the Corporate Roundtable, a group comprised of 40 key business leaders who meet monthly for peer learning and to share best practices in corporate and community sustainability.

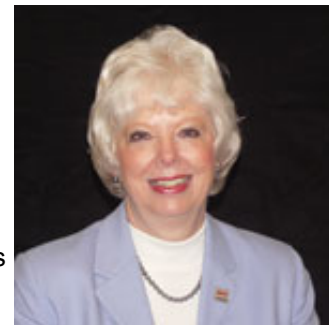

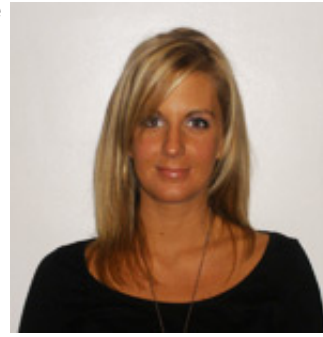

Advancing Sustainable Business Practices

If the next generation of business leaders is to excel at managing enterprises for greater competitiveness, it will need the knowledge and skills to tackle not only the financial but also the social and environmental challenges faced by today's corporations. There are a growing number of universities that have begun to incorporate social and environmental content into core business courses and a few universities that have even elevated the study of social and environmental management from separate disciplines into an interdisciplinary area of study. Those universities that are able to fill this gap are being recognized for their cutting edge programs and are playing an instrumental role in developing individuals who can effectively manage the interrelationship of financial, social and environmental factors inherent in our global marketplace.

The Nance College of Business is committed to addressing this gap over the next three years and will continue to develop and provide practitioner-based research, education and outreach focused on sustainable business practices and models for mainstream business through its Center for Sustainable Business Practices. Recent and ongoing efforts include:

- Obtained \$233,000 from the Cleveland Foundation for the High Performance Building Technology Initiative. The intent of the initiative is to capitalize on the national push towards high performance building by supporting a developing market demand within Northeast Ohio.
- Partnered with Sustainable Cleveland to establish the Corporate Round Table on Sustainability. The

Corporate Roundtable is a forum for major companies in Northeast Ohio to discuss sustainable business models and practices that affect their competitive advantage.

- Established a Net Impact Student Chapter, which is a global membership organization for students and professionals committed to using business to improve the world.
- Member of Corporate Sustainability Network, a group focused on promoting economic development by helping to integrate sustainable business practices and innovation in Northeast Ohio's 150 largest corporate citizens.
- Developed a product innovation initiative with Lubrizol Corporation to drive product development ideas to market through integrated teams of CSU faculty, students and Lubrizol staff. The initiative will stage gate product ideas through interactive course work designed to provide students with "real world" product innovation and launch experience. The process will allow students to take into account the "triple bottom line" measuring the economic, social and environmental impact of the product ideas they research.
- Create a "Hydrogen Energy Roadmap" that will help to establish a better understanding of the potential use of hydrogen as an economic driver in Northeast Ohio. To this end, the Nance College of Business will work in tandem with the development of the renewably-generated-hydrogen fueling station to begin to assess and define the supporting and inhibiting factors that will frame and shape the future of a hydrogen economy in Northeast Ohio.
- Commit to engage and incorporate United Nations Global Compact Principles for Responsible Management Education (PRME) into and across the academic activities and curricula in the Nance College of Business to provide our students with the skills to positively affect a firm's bottom line and the society in which it operates.
- Working within the PRME framework, the Nance College of Business will develop a graduate level concentration in Global Sustainable Management in partnership with Groupe ESC Clermont Graduate School of Management located in France. A team of faculty is currently working on the curriculum for the program, which will include a practicum or international study component.

The concentration in Global Sustainable Management will serve as a working model for the Nance College of Business to learn from and further develop curriculum in global sustainable business development and practices.

Associate Dean Dr. Benoy Joseph, EMBA program director Dr. Elad Granot and EMBA faculty member Dr. Oya Tukul accompanied the students to the event that took place as part of the Distinguished Speaker Series sponsored by the EMBA program. Special speakers periodically come to the Nance College of Business to share with the EMBA students different thoughts and

trends in the business world. It helps to keep the students engaged and informed and also keeps them involved in the community.

Professor Kanter spoke about leadership and how "good companies with good leadership are the companies surviving today."

Leadership is one of the many qualities stressed in the EMBA program. There were 40 total students who were able to take part in the event. "Professor Kanter proved a very engaging and entertaining speaker, who gave some very insightful views on what constitutes 21st century leadership," said Stephan Uijtewaal, an EMBA student. Stephan also enjoyed the chance to spend some time outside of the classroom with his fellow EMBA students. "Listening to their experiences in the program to date was a great stimulus for me."

Professor Kanter holds the Ernest L. Ar buckle Professorship at Harvard Business School, where she specializes in strategy, innovation and leadership for change. A former Editor of Harvard Business Review, she has been named to list of the "50 most powerful women in the world" by the *Times of London* and the list of "50 most influential business thinkers in the world" by Accenture and Thinkers 50 Research.
