ABSTRACT

We study the generalized Abel transform for $SL(2, \mathbb{C})$ in the case of equal left and right, fixed K-type. We rewrite this transform as an integral transform of classical type. Then it involves a double integration with kernel expressed in terms of a Chebyshev polynomial of the second kind. We obtain the inversion formula in a similar form and we completely characterize the image in the C^{∞} -case. As a corollary we prove the subquotient theorem for $SL(2,\mathbb{C})$ by a global approach.

0. INTRODUCTION

In earlier papers [13], [14] the second author formulated a program for a global approach to the representation theory of noncompact semisimple Lie groups G and he carried it out for $SL(2,\mathbb{R})$. "Global" means that no use of the Lie algebra and universal enveloping algebra of G is made. Instead, the analysis is based on a more or less explicit knowledge of the canonical matrix elements of the principal series representations of G with respect to a K-basis, K being a maximal compact subgroup of G. Furthermore, in the case of $SL(2,\mathbb{R})$ it turned out that the subquotient theorem (i.e. the Naimark equivalence of K-finite irreducible representations of G to subquotients of principal series representations) can be proved by use of the generalized Abel transform.

It is the purpose of the present paper to give a global proof of the subquotient theorem for $G = SL(2, \mathbb{C})$ by use of the generalized Abel transform. Let $I_{c,\delta}^{\infty}(G)$ be the commutative topological convolution algebra of K-central C° -functions with compact support on G which behave as the irreducible representation δ of K under left or right action of K. Then the generalized Abel transform is an algebra isomorphism of $I_{c,\delta}^{\circ}(G)$ onto a convolution algebra of certain vector-valued C° -functions with compact support on \mathbb{R} . The subquotient theorem follows from a knowledge of all continuous characters on this image algebra. So we have to know this image algebra. This method was earlier used by NAIMARK [19] and the characterization of the image algebra follows from WANG's [26] Paley-Wiener theorem. However, we will give a probably new proof with side results of independent interest. Namely, we write the generalized Abel transform as an integral transform of "classical" type and we obtain the inversion formula in a similar form:

$$f(\phi,w) = (4\pi sh 2w)^{-1} \int_{0}^{2\pi} \int_{w}^{\infty} \left(\frac{\partial^{2}}{\partial \tau^{2}} + \frac{\partial^{2}}{\partial t^{2}}\right) F(\tau,t) \cdot U_{2\ell}\left(\frac{ch t}{ch w} \cos\phi \cos\tau + \frac{sh t}{sh w} \sin\phi \sin\tau\right) d\tau dt.$$

In this integral transform pair, ℓ is in $\{0, \frac{1}{2}, 1, \frac{3}{2}, \ldots\}$, $U_{2\ell}$ is a Chebyshev polynomial of the second kind, and f and F are C -functions with compact support, $f(\psi, x)$ and $F(\psi, x)$ both having the form

$$\sum_{m \in \{-\ell, -\ell+1, \ldots, \ell\}} c_m(x) e^{-2im\psi},$$

with certain additional conditions.

Let us summarize the contents of the paper. In section 1 we give basic results about the global approach to finding irreducible subquotients and proving Naimark relatedness. Section 2 contains general theorems for the generalized Abel transform on a semisimple Lie group, section 3 a discussion of earlier results for $SL(2, \mathbb{C})$ and $SL(2, \mathbb{R})$. Section 4 gives preliminaries on $SL(2, \mathbb{C})$ and the representation theory of SU(2) which will be needed. The main work of the paper is done in sections 5,6,7: the derivation of (0.1) and an integral representation for related spherical functions of type δ in §5, the derivation of the inversion formula (0.2) (also leading to a new proof of the Plancherel formula for $SL(2,\mathbb{C})$) in §6, a characterization of the image algebra in §7. Finally, the subquotient theorem is derived in §8 and we state without proof some further results in §9.

Notation. rep means representation, irr. means irreducible.

1. IRREDUCIBLE SUBQUOTIENTS, NAIMARK RELATEDNESS AND THE ALGEBRAS $I_{c,\delta}(G)$

In this section we collect some results which are relevant for the global approach to the representation theory of a general locally compact group.

Let G be a locally compact group satisfying the second axiom of countability and let K be a compact subgroup of G. Let τ be a K-unitary Hilbert rep of G, i.e. a strongly continuous rep τ of G on a separable Hilbert space $H(\tau)$ such that $\tau|_{K}$ is a unitary rep of K on $H(\tau)$. Then

(1.1)
$$\tau |_{K} = \bigoplus_{\delta \in \widehat{K}} m_{\delta} \delta,$$

where the multiplicity m_{δ} equals 0,1,2,... or ω (countably infinite). Let $\mathcal{H}_{\delta}(\tau)$ be the closed subspace of $\mathcal{H}(\tau)$ which is the representation space of m_{δ} δ in (1.1) and let P_{δ} be the orthogonal projection of $\mathcal{H}(\tau)$ onto $\mathcal{H}_{\delta}(\tau)$. For γ, δ in $\mathcal{M}(\tau)$ define the canonical matrix elements $\tau_{\gamma\delta}$ of τ :

(1.2)
$$\tau_{\gamma\delta}(g) := P_{\gamma}\tau(g) |_{\mathcal{H}_{\delta}(\tau)}, g \in G.$$

Then $\tau_{\gamma\delta}(g)$ is a linear operator of $H_{\delta}(\tau)$ to $H_{\gamma}(\tau)$. The operator $\tau(g)$ can be written as a (usually infinite) block matrix with blocks $\tau_{\gamma\delta}(g)$. Define the *K-content* $M(\tau)$ of τ by

(1.3)
$$M(\tau) := \{ \delta \in \widehat{K} \mid m_{\delta} \neq 0 \}.$$

The rep τ is called K-finite if $m_{\delta} < \infty$ for all δ in \hat{K} and τ is called K-multiplicity free if $m_{\delta} = 0$ or 1 for all δ in \hat{K} .

<u>DEFINITION 1.1</u>. Let τ be a Hilbert rep of G, H_0 a closed subspace of $H(\tau)$ and P_0 the orthogonal projection of $H(\tau)$ onto H_0 . Let $\tau_0(g) := P_0 \tau(g) |_{H_0}$ $(g \in G)$. If $\tau_0(g_1g_2) = \tau_0(g_1)\tau_0(g_2)(g_1,g_2 \in G)$ then τ_0 is called a subquotient rep of τ on H_0 .

THEOREM 1.2 (cf.[13,§3.2]). Let τ be a K-multiplicity free rep of G. For γ, δ in $M(\tau)$ write $\gamma \sim \delta$ iff $\tau_{\gamma\delta} \neq 0$ and $\tau_{\delta\gamma} \neq 0$. Then \sim is an equivalence relation on $M(\tau)$ and τ_0 is an irr. subquotient rep of τ iff $\tau_0|_{K} = \bigoplus_{\gamma \mid \gamma \sim \delta} \gamma$ for some δ in $M(\tau)$.

<u>DEFINITION 1.3</u>. Two Hilbert reps σ and τ of G are called *Naimark related* if there is a closed (possibly unbounded) injective linear operator A of $H(\sigma)$ to $H(\tau)$ with domain $\mathcal{D}(A)$ dense in $H(\sigma)$ and range $\mathcal{R}(A)$ dense in $H(\tau)$ such that $\mathcal{D}(A)$ is σ -invariant and $A\sigma(g)v = \tau(g)Av(v \in \mathcal{D}(A), g \in G)$. Notation: $\sigma \simeq \tau$ or $\sigma \stackrel{A}{\simeq} \tau$. Naimark relatedness is an equivalence relation (called *Naimark equivalence*) on the class of K-finite Hilbert reps of G (cf.[13, Theorem 4.4]).

<u>LEMMA 1.4</u>. Let σ and τ be irr. Hilbert reps of G. If, for certain nonzero v in $H(\sigma)$ and w in $H(\tau)$, $(\sigma(g)v,v) = (\tau(g)w,w)$ for all g in G, then $\sigma \simeq \tau$.

<u>PROOF</u>. Define $\tilde{\sigma}(g) := (\sigma(g^{-1}))^* (g \in G)$, and similarly $\tilde{\tau}(g)$. Then $\tilde{\sigma}$ and $\tilde{\tau}$ are also irr. Hilbert reps of G. Define a linear operator A with $\mathcal{D}(A) := \operatorname{Span}\{\sigma(g)v | g \in G\}$ and $\mathcal{R}(A) := \operatorname{Span}\{\tau(g)w | g \in G\}$ by

$$A\left(\sum_{j=1}^{n} \alpha_{j}\sigma(g_{j})v\right) := \sum_{j=1}^{n} \alpha_{j}\tau(g_{j})w$$

for arbitrary n in \mathbb{N} , $\alpha_1, \ldots, \alpha_n$ in \mathbb{C} and g_1, \ldots, g_n in G. By irreducibility of σ and τ , $\mathcal{D}(A)$ is dense in $\mathcal{H}(\sigma)$ and $\mathcal{R}(A)$ is dense in $\mathcal{H}(\tau)$. For the proof that A is one-valued and injective note that the following equalities are equivalent:

$$\sum_{j=1}^{n} \alpha_{j}\sigma(g_{j})v = 0,$$

$$\left(\sum_{j=1}^{n} \alpha_{j}\sigma(g_{j})v, \widetilde{\sigma}(g)v\right) = 0 \quad \forall g \in G,$$

$$\left(\sum_{j=1}^{n} \alpha_{j}\sigma(g^{-1}g_{j})v, v\right) = 0 \quad \forall g \in G,$$

$$\left(\sum_{j=1}^{n} \alpha_{j}\tau(g^{-1}g_{j})w, w\right) = 0 \quad \forall g \in G,$$

$$\left(\sum_{j=1}^{n} \alpha_{j}\tau(g_{j})w, \widetilde{\tau}(g)w) = 0 \quad \forall g \in G,$$

$$\left(\sum_{j=1}^{n} \alpha_{j}\tau(g_{j})w, \widetilde{\tau}(g)w) = 0,$$

Clearly, $\mathcal{D}(A)$ is σ -invariant and $A\sigma(g) = \tau(g)A$ on $\mathcal{D}(G)$ for g in G. For the proof that the closure \overline{A} of A is one-valued and injective let

$$\sum_{j=1}^{n(k)} \alpha_{j,k} \sigma(g_{j,k}) v \rightarrow v_0 \text{ and}$$

n(k)

$$\sum_{\substack{j=1\\j=k}}^{\infty} \alpha_{j,k} \tau(g_{j,k}) w \to w_{0} \text{ as } k \to \infty.$$

Then $v_0 = 0$ iff $w_0 = 0$, by a similar argument as above. Finally apply [13, Lemma 4.3]. \Box

THEOREM 1.5. Let σ and τ be irr. K-unitary reps and let some δ in \hat{K} have multiplicity 1 in both σ and τ . Then σ and τ are Naimark related iff

(1.4)
$$\operatorname{tr} \sigma_{\delta\delta}(g) = \operatorname{tr} \tau_{\delta\delta}(g)$$
 for all g in G.

<u>PROOF</u>. If $\sigma \simeq \tau$ and $I_{\delta} : H_{\delta}(\sigma) \rightarrow H_{\delta}(\tau)$ is a K-intertwining isometry then

$$\tau_{\delta\delta}(g) = I_{\delta}\sigma_{\delta\delta}(g)I_{\delta}^{-1}$$

(cf.[13, Theorem 4.5]). This proves (1.4). Conversely assume (1.4) and choose orthonormal bases $e_1, \ldots, e_{d_{\delta}}$ for $\mathcal{H}_{\delta}(\tau)$ and $f_1, \ldots, f_{d_{\delta}}$ for $\mathcal{H}_{\delta}(\tau)$ such that

$$\delta_{ij}(k) := (\sigma(k)e_j, e_i) = (\tau(k)f_j, f_i), \quad k \in K.$$

In (1.4) replace g by $gk(g \in G, k \in K)$. Then we obtain:

$$\sum_{i,j=1}^{d} \delta_{ij}(k) (\sigma(g)e_i,e_j) = \sum_{i,j=1}^{d} \delta_{ij}(k) (\tau(g)f_i,f_j).$$

Hence $(\sigma(g)e_1, e_1) = (\tau(g)f_1, f_1)(g \in G)$ and $\sigma \simeq \tau$ by Lemma 1.4.

The spaces C(G) and, if G is a Lie group, $C_{c}^{\infty}(G)$ are algebras under convolution and, provided with the usual inductive limit topology, they become topological algebras. Consider the following closed subalgebras $I_{c}^{\infty}(G)$, $I_{c,\delta}(G)(\delta \in \widehat{K})$ of $C_{c}(G)$ and $I_{c}^{\infty}(G)$, $I_{c,\delta}(G)(\delta \in \widehat{K})$ of $C_{c}^{\infty}(G)$:

(1.5)
$$I_{c}^{(\infty)}(G) := \{f \in C_{c}^{(\infty)}(G) | f(kgk^{-1}) = f(g), g \in G, k \in K\},\$$

(1.6)
$$I_{c,\delta}^{(\infty)}(G) := \{ f \in I_{c}^{(\infty)}(G) | d_{\delta} \int_{K} f(gk)\chi_{\delta}(k) dk = f(g), g \in G, k \in K \}.$$

The present definition of $I_{c,\delta}^{(\infty)}(G)$ corresponds to the definition of $I_{c,\delta}^{(\infty)}(\delta)$ being contragredient to δ) in [13, p.43]. Here we follow the definition in WARNER [27,§4.5.1].

PROPOSITION 1.6. (cf. WARNER [27, Theor. 6.1.1.2, Prop. 6.1.1.6]). Let $\delta \in \hat{K}$ and let the algebra $I_{c,\delta}(G)$ be commutative. Let τ be an irr. K-unitary rep of G in which δ occurs with finite nonzero multiplicity m_{δ} . Then $m_{\delta} = 1$ and the linear functional

(1.7)
$$f \mapsto d_{\delta}^{-1} \int_{G} f(g) tr \tau_{\delta\delta}(g) dg$$

is a nonzero continuous character on $I_{c,\delta}(G)$. Furthermore, this character completely determines $tr\tau_{\delta\delta}(.)$ as a function on G.

<u>PROOF.</u> By [3, Lemma 5.1] $m_{\delta} = 1$ iff the rep 1 of

(1.8)
$$K^* := \{(k,k) \in G \times K \mid k \in K\}$$

has multiplicity 1 in the rep $\tau \otimes \overset{\vee}{\delta}$ of G × K. By restriction to G × {e} the algebra $C_{c}(K^{*}(G\times K/K^{*}))$ is mapped isomorphically onto $I_{c}(G)$. Under this mapping the algebra

$$A := \{f \in C_{c}(K^{*} \setminus G \times K/K^{*}) |$$
$$d_{\delta} \int_{K} f(g,k)\chi_{\delta}(k^{-1}) dk = f(g,e), g \in G, k \in K\}$$

corresponds to $I_{c,\delta}(G)$. For f in C_c(G×K) define f[#] by

$$f^{\#}(g,k) := d_{\delta} \iint_{K} \iint_{K} f(k_{1}gk_{2},k_{1}kk_{3}k_{2}) \chi_{\delta}(k_{3}^{-1})dk_{1} dk_{2} dk_{3}, g \in G,$$

, $k \in K.$

Then $f \mapsto f^{\#}$ is a projection of $C_{c}(G \times K)$ onto A. Let P_{1} be the orthogonal projection of $H(\tau \otimes \delta)$ onto $H_{1}(\tau \otimes \delta)$. One easily verifies that, for \forall in $H_{1}(\tau \otimes \delta)$, $f \in C_{c}(G \times K)$:

$$(\tau \otimes \delta)(f^{\#}) v = P_1(\tau \otimes \delta)(f) v.$$

By irreducibility of τ , $(\tau \otimes \delta)(C_c(G \times K))$ v is a dense subspace of $H(\tau \otimes \delta)$. Hence, since $H_1(\tau \otimes \delta)$ is finite dimensional,

$$(\tau \otimes \delta)(A) v = P_1(\tau \otimes \delta)(C_c(G \times K)) v = H_1(\tau \otimes \delta).$$

Thus $\tau \otimes \overset{\vee}{\delta}$ is an irr. rep of the commutative algebra A on $\mathcal{H}_1(\tau \otimes \overset{\vee}{\delta})$, so $\mathcal{H}_1(\tau \otimes \overset{\vee}{\delta})$ has dimension 1.

For the proof of the second statement note that, for f in $C_c(G \times K)$ and v in $H_1(\tau \otimes \delta)$ with $\|v\| = 1$, we have

$$\int_{G} \int_{K} f(g,k)((\tau \otimes \delta)(g,k)v,v) dg dk = d_{\delta}^{-1} \int_{G} f^{\#}(g,e) \operatorname{tr} \tau_{\delta\delta}(g) dg.$$

Finally the third statement follows from the observation that

$$\int_{G} f(g) \operatorname{tr} \tau_{\delta\delta}(g) dg = d_{\delta} \int_{G} \left[\iint_{KK} f(k_{1}gk_{2}k_{1}^{-1})\chi_{\delta}(k_{2}) dk_{1} dk_{2} \right] \operatorname{tr} \tau_{\delta\delta}(g) dg,$$

$$f \in C_{C}(G). \square$$

The function tr $\tau_{\delta\delta}(.)$ is called a spherical trace function of type δ . The theory of these functions goes back to GODEMENT [5].

<u>COROLLARY 1.7.</u> Let $\delta \in \widehat{K}$ and let $I_{c,\delta}(G)$ be commutative. Let σ and τ be irr. K-unitary reps of G in which δ has finite nonzero multiplicity. Then $\sigma \approx \tau$ iff the corresponding characters on $I_{c,\delta}(G)$ (or $I_{c,\delta}^{\infty}(G)$ if G is a Lie group) defined by (1.7) coincide.

PROOF. Use Theorem 1.5 and Prop. 1.6.

The pair (G,K) is called a Gelfand pair if the algebra $C_{c}(K\setminus G(K))$ is commutative.

<u>COROLLARY 1.8.</u> If $(G \times K, K^*)$ is a Gelfand pair then each irr. K-finite Hilbert rep of G is K-multiplicity free.

<u>PROOF.</u> Use Prop. 1.6 and the correspondence between $C_c(K^* \setminus G \times K/K^*)$ and $I_c(G)$.

2. THE GENERALIZED ABEL TRANSFORM

Let us restrict attention now to the case that G is a noncompact connected real semisimple Lie group with finite center and that K is a maximal compact subgroup of G. Choose subgroups A and N of G such that G = KAN is an Iwasawa decomposition of G and let g in G be accordingly factorized as

(2.1)
$$g = u(g)e^{H(g)}n(g),$$

where $H(g) \in a$, the Lie algebra of A. Let M be the centralizer of A in K. For ξ in \widehat{M} and λ in a_c^* (the complex linear dual of a) we define the principal series rep $\pi_{\xi,\lambda}$ as the rep of G induced by the rep

man
$$\mapsto e^{\lambda(\log a)} \xi(m), m \in M, a \in A, n \in \mathbb{N},$$

of the subgroup MAN of G. Let *n* be the Lie algebra of N and let ρ in *a* be defined by $\rho(H) := \frac{1}{2} \operatorname{tr}(\operatorname{adH}|_{n})$, $H \in a$. In the *compact picture* the rep $\pi_{\xi,\lambda}$ is realized on the Hilbert space $L^{2}_{\xi}(K;H(\xi))$ consisting of all $H(\xi)$ -valued L^{2} - functions f on K such that $f(km) = \xi(m^{-1})f(k)$, $k \in K$, $m \in M$. Then

(2.2)
$$(\pi_{\xi,\lambda}(g)f)(K) = e^{-(\rho+\lambda)H(g^{-1}k)}f(u(g^{-1}k)),$$

, g \epsilon G, k \epsilon K, f \epsilon L_{\xi}^{2}(K;H(\xi)).

The rep $\pi_{\xi,\lambda}$ is a K-finite Hilbert rep of G.

We would like to attempt a global approach to HARISH-CHANDRA's [7, Theorem 4], [8, Theorem 4] subquotient theorem:

THEOREM 2.1. Every K-finite irr. Hilbert rep of G is Naimark equivalent to some irr. subquotient rep of some principal series rep.

Choose a Haar measure dn on N. For f in $I_{C,\delta}^{\infty}(G)$ ($\delta \in \hat{K}$) define

(2.3)
$$F_{f}(k,a) := e^{\rho (\log a)} \int_{N} f(kan) dn, k \in K, a \in A,$$

(2.4)
$$F_{f}^{\delta}(a) := e^{\rho(\log a)} \int_{K} \int_{K} f(kan) \overset{\vee}{\delta}(k^{-1}) dk dn =$$
$$= \int_{K} F_{f}(k,a) \overset{\vee}{\delta} (k^{-1}) dk, a \in A,$$

the latter function F_{f}^{δ} being $L(\mathcal{H}(\overset{\vee}{\delta}))$ -valued. For some choice of an orthonormal basis of $\mathcal{H}(\overset{\vee}{\delta})$, F_{f} can be expressed in terms of F_{f}^{δ} by

(2.5)
$$F_{f}(k,a) = d_{\delta} \sum_{i,j=1}^{d_{\delta}} i_{j} (k) (F_{f}^{\infty}(a))_{ji}, f \in I_{c,\delta}^{\infty}(G).$$

The transform $f \mapsto F_f$ or $f \mapsto F_f^{\delta}$ is called the generalized Abel transform (cf. WARNER [27, §6.2.2]).

From now on assume that δ is M-multiplicity free. Then $\stackrel{\vee}{\delta}$ is also M-multiplicity free. Let $M_{M}(\stackrel{\vee}{\delta})$ denote the M-content of $\stackrel{\vee}{\delta}$. Note that

$$F_{f}^{\delta}(a) = F_{f}^{\delta}(mam^{-1}) = \delta'(m)F_{f}^{\delta}(a)\delta'(m^{-1}), a \in A, m \in M.$$

Hence,

$$(\mathbb{F}_{f}^{\delta}(a))_{\xi,\eta} = \xi(m)(\mathbb{F}_{f}^{\delta}(a))_{\xi,\eta} \eta(m^{-1}), \xi, \eta \in M_{M}(\delta)$$

(where $(F_{f}^{\delta}(a))_{\xi,\eta}$ is the matrix block of $F_{f}^{\delta}(a)$ corresponding to (ξ,η)). Since δ is M-multiplicity free, this implies

$$(F_{f}^{\delta}(a))_{\xi,\eta} = \begin{cases} 0 & \text{if } \xi \neq \eta, \\ F_{f,\xi}^{\delta}(a) & \text{id if } \xi = \eta \end{cases}$$

for certain functions $F_{f,\xi}^{\delta}(\xi \in M_{M}(\overset{\vee}{\delta}))$ in $C_{c}^{\infty}(A)$. Combining this with (2.5) we get

(2.6)
$$F_{f}(k,a) = d_{\delta} \sum_{\xi \in M_{M}(\delta)} tr \delta_{\xi\xi}(k) F_{f,\xi}^{\delta}(a), f \in I_{c,\delta}^{\infty}(G).$$

It can easily be proved that for fin $I_{c,\delta}^{\infty}(G)$ we have a similar formula: there exist functions $f_{\xi} in C_{c}^{\infty}(A)$ such that

(2.7)
$$f(k_1ak_2) = d_{\delta} \sum_{\xi \in M_M} tr \delta_{\xi\xi}(k_2k_1)f_{\xi}(a), k_1, k_2 \in K, a \in A.$$

Note that f and $F_f(f \in I_{c,\delta}^{\infty}(G))$ are completely determined by their restrictions to M × A.

Choose a Haar measure da on A and normalize the Haar measure dg on G such that

(2.8)
$$\int_{G} f(g) dg = \int_{K \times A \times N} f(kan) e^{2\rho (\log a)} dk \ da \ dn, \ f \in C_{c}(G).$$

THEOREM 2.2. Let $\delta \in \widehat{K}$ such that δ is M-multiplicity free. Then the transform

has the following properties:

(i) it is continuous;

(ii) it is injective if G is a linear Lie group;

(iii) it is an algebra homomorphism, i.e.

$$f_{1}, f_{2} \in I_{c,\delta}^{\infty}(G);$$

(iv) for each f in $I_{c,\delta}^{\infty}(G),\ \xi$ in $M_{M}(\delta)$ and λ in a_{c}^{\star} we have

(2.10)
$$d_{\delta}^{-1} \int_{G} f(g) \operatorname{tr} \pi_{\xi,\lambda;\delta,\delta}(g) dg = \int_{A} F_{f,\xi}^{\delta}(a) e^{\lambda(\log a)} da;$$

(v) $I_{c,\delta}^{\infty}(G)$ is a commutative algebra.

PROOF. The proof of (i) is straightgorward. See [13, Theorem 5.17]for the proof of (ii) and WARNER [27, §6.2.2] for the proof of (iii). Combination of (ii) and (iii) proves (v). Let us prove (iv). From WALLACH [25, Lemma 8.3.11] we have

Choose an orthonormal basis e_1, \ldots, e_d_δ of $H(\check{\delta})$ such that e_1, \ldots, e_d_ξ is an orthonormal basis of $H_{\check{\xi}}(\check{\delta})$. Realize $\pi_{\xi,\lambda}$ on the Hilbert space $H(\pi_{\xi,\lambda}) = L^2(K; H(\xi))$. Then the vector-valued functions $f_1(i=1,\ldots,d_\delta)$ defined by

$$f_{i}(k) := \left(\frac{d_{\delta}}{d_{\xi}}\right)^{\frac{1}{2}} \left(\overset{\vee}{\delta}_{i1}(k), \dots, \overset{\vee}{\delta}_{id_{\xi}}(k) \right), k \in K,$$

form an orthonormal basis for $\mathcal{H}_{\delta}(\pi_{\xi,\lambda})$. It follows from (2.2) that

$$\begin{aligned} & \stackrel{a_{\delta}}{\underset{i=1}{\sum}} (\pi_{\xi,\lambda}(g)f_{i},f_{i}) = \\ & = \frac{d_{\delta}}{d_{\xi}} \sum_{i=1}^{d_{\delta}} \sum_{j=1}^{d_{\delta}} \int_{K} e^{-(\rho+\lambda)H(g^{-1}k)} \bigvee_{\delta_{ij}(u(g^{-1}k))} \overline{\bigvee_{\delta_{ij}(k)}^{\vee}dk}. \end{aligned}$$

Hence

(2.11)
$$\operatorname{tr} \pi_{\xi,\lambda;\delta,\delta}(g) = \\ = d_{\delta} d_{\xi}^{-1} \int_{K} e^{-(\rho+\lambda)H(g^{-1}k)} \operatorname{tr} \delta_{\xi\xi}((u(g^{-1}k))^{-1}k)dk.$$

Combination of (*) and (2.11) yields:

$$d_{\delta}^{-1} \int_{G} f(g) \operatorname{tr} \pi_{\xi,\lambda;\delta,\delta}(g) dg =$$

= $d_{\xi}^{-1} \int_{G} \int_{K} f(g) e^{(\lambda-\rho)H(gk)} \operatorname{tr} \delta_{\xi\xi}(k^{-1}u(gk)) dg dk.$

Next make the transformation of variables $g \mapsto gk^{-1}$ and substitute (2.8) into the right hand side:

In view of (2.4) this yields (2.10). \Box

<u>CORALLARY 2.3.</u> If $(K \times M, M^*)$ is a Gelfand pair then $(G \times K, K^*)$ is a Gelfand pair, $I_{c,\delta}^{\infty}(G)$ is a commutative algebra and δ is M-multiplicity free for each δ in \hat{K} , and each irr. K-finite Hilbert rep of G is K-multiplicity free.

PROOF. Use Cor. 1.8 and Theorem 2.2 (v).

In the following examples $(K \times M, M^*)$ and (hence) $(G \times K, K^*)$ are Gelfand pairs:

G	К	М
SL(2,ℝ)	SO(2)	0(1)
SL(2,€)	SU(2)	U(1)
SO(n,1)	SO(n)	SO(n-1)
SU [°] (n,1)	U(n)	U(n-1)

Note that the cases $G = SL(2,\mathbb{R})$, $SO_{o}(2,1)$, SU(1,1) are locally isomorphic and also $G = SL(2,\mathbb{C})$, $SO_{o}(3,1)$. Since, under the assumption that $(G \times K, K^{*})$ is a Gelfand pair, each finite-dimensional irr. rep of G is K-multiplicity free, it follows from KRÄMER [17] that almost all cases with $(K \times M, M^{*})$ being a simple linear Lie group occur is the above table.

We can now formulate the program for a global approach to Harish-Chandra's subquotient theorem:

(a) Let $\delta \in \widehat{K}$ such that δ is M-multiplicity free. Let A_{δ} be the image of $I_{c,\delta}^{\infty}(G)$ under $f \mapsto \{F_{f,\xi}^{\delta}\}$ and provide A_{δ} with the topology which makes this transform an homeomorphism. Determine A_{δ} completely, also topolog-ically, and prove that each continuous character on A_{δ} has the form

$$F \mapsto \int_{A} F_{\bigvee_{\xi}}(a) e^{\lambda(\log a)} da$$

for some ξ in $M_{M}(\delta)$, λ in a_{c}^{*} . Then in view of (2.10) and Cor. 1.7, we conclude that each irr. K-unitary rep τ in which δ has finite nonzero multiplicity is Naimark related to an irr. subquotient rep (namely the

one containing δ) of some $\pi_{\xi,\lambda}$.

(b) In particular, study f|_{MA}→F_f|_{M×A} (f∈I[∞]_{c,δ}(G)) as a "classical" integral transform (i.e., as an integral transform given in analytic form without group variables) and determine its inversion formula.

Clearly, δ is M-multiplicity free if $\delta = 1$ (the spherical case). Then $I_{c,\delta}^{\infty}(G) = C_{c}^{\infty}(K \setminus G/K)$. Its image under the generalized Abel transform is known by GANGOLLI's [3] Paley-Wiener theorem: the space of all Weyl group invariant C^{∞} -functions on A with compact support. However, part (b) of the above program in the spherical case has been done only in the rank one case. Then $f \mapsto F_{f}$ can be written as a Weyl type fractional integral transform or a composition of two such transforms (cf. KOORNWINDER [11]).

The above programs has been completed for all δ in the case G = SL(2, \mathbb{R}) (cf. KOORNWINDER [13], [14], TAKAHASHI [20]). Then A = $\left\{a_t := \begin{pmatrix} e^t & 0 \\ 0 & e^{-t} \end{pmatrix}\right\}$,

$$K = \left\{ u_{\theta} := \left(\begin{array}{ccc} \cos \theta & -\sin \theta \\ \sin \theta & \cos \theta \end{array} \right) \right\}.$$

 \hat{K} consists of the reps $\delta_n(n \in \mathbb{Z})$, where $\delta_n(u_{\theta}) := e^{in\theta}$. In considering the transform $f \mapsto F_f$ for fin $I_{c,\delta_n}^{\infty}(G)$, we can restrict f and F_f to A and we obtain

(2.12)

where $T_{|n|}$ is the Chebyshev polynomial of degree |n|:

The inversion formula to (2.12) is

The correspondences $f \leftrightarrow f_{|_A} \leftrightarrow F_f$ identify the spaces $I_{c,\delta}^{\infty}$ (G), \mathcal{D}_{even} (R) and \mathcal{D}_{even} (R), respectively, with each other. Note that in the spherical case (n=0) the pair (2.12), (2.14) becomes the classical Abel transform together with its inversion formula (cf. GODEMENT [6]). There are three different proofs that (2.14) is the inversion formula to (2.12).

- (i) by Mellin transform techniques (cf. MATSUSHITA [18]);
- (ii) by specializing the inversion formula for the Euclidean Radon transform on \mathbb{R}^2 to functions which behave according to rep δ_n of SO(2)(cf. DEANS [2]);

(iii) by using generalized fractional integrals (cf. KOORNWINDER [13, §5.9]).

3. SL(2,C), DISCUSSION OF EARLIER RESULTS

Let us now try to deal with the generalized Abel transform for SL(2,C) in the same spirit as for $SL(2,\mathbb{R})$ above. A global approach to the representation theory of SL(2,C) can already be found in NAIMARK [19]. He determined irreducibility properties of principal series reps by using Theorem 1.2 (cf. [19, Ch. 3, §9, no. 15]) and he used the generalized Abel transform for proving the subquotient theorem 2.1 (ibidem, no. 16). (In fact, he considered the generalized Abel transform not on the algebras $I_{c,\delta}^{\infty}(G)$ but on cer-tain algebras denoted by X_{j}^{k} which are isomorphic to them (ibidem, no. 6).) However, there are certain unsatisfactory points in his approach: (i) the formula for the generalized Abel transform is not very explicit (cf. ibidem, no. 10, formula (1)), with integration variables defined in an implicit way; (ii) the inversion formula (ibidem, no. 10, formula (9)) is derived by using the Plancherel formula; (iii) the image under the generalized Abel transform is not completely characterized (ibidem, no. 10, IV) but a subalgebra of the image is obtained which is big enough to prove that the characters on it have the desired form. See BRUMMELHUIS [1] for a more detailed discussion of Naimark's approach.

KOSTERS [16] studied irreducibility, Naimark equivalence and unitarizability for subquotients of the principal series of SL(2,C) by using the global methods developed in [13], but he did not give a global approach to the subquotient theorem 2.1.

Finally, a helpful reference to us was WANG [26], who derived a Paley-Wiener theorem characterizing the image of the algebras $I_{c,\delta}^{\infty}(SL(2, \mathfrak{C}))$ under the group Fourier transform. Indeed, his result is equivalent to characterizing the image under the generalized Abel transform.

4. SL(2,C), PRELIMINARIES

Let us fix an Iwasawa decomposition G = KAN for $G = SL(2, \mathbb{C})$ with

(4.1)
$$K = SU(2) = \left\{ k_{\alpha,\beta} := \begin{pmatrix} \alpha & \beta \\ -\overline{\beta} & \overline{\alpha} \end{pmatrix} \mid \alpha, \beta \in \mathbb{C}, |\alpha|^2 + |\beta|^2 = 1 \right\},$$

(4.2)
$$A = \left\{ a_{t} := \begin{pmatrix} e & 0 \\ 0 & e^{-t} \end{pmatrix} \mid t \in \mathbb{R} \right\},$$

(4.3)
$$N = \left\{ n_{x+iy} := \begin{pmatrix} 1 & x+iy \\ 0 & 1 \end{pmatrix} \mid x, y \in \mathbb{R} \right\}.$$

Then

(4.4)
$$M = \left\{ m_{\phi} := \begin{pmatrix} e^{i\phi} & 0 \\ 0 & e^{-i\phi} \end{pmatrix} \mid 0 \le \phi < 2 \pi \right\}.$$

We will also use special elements of K given by

(4.5)
$$u_{\theta} := \begin{pmatrix} \cos \theta & -\sin \theta \\ \\ \sin \theta & \cos \theta \end{pmatrix}$$
.

 \hat{K} consists of the reps T^{ℓ} ($\ell=0,\frac{1}{2},1,\ldots$) of dimension $2\ell+1$. A model for the representation space of T^{ℓ} is given by the space H_{ℓ} of homogeneous polynomials of degree 2ℓ in two complex variables with orthonormal basis consisting of the functions ψ_{n}^{ℓ} (n=- ℓ ,- $\ell+1,\ldots,\ell$):

(4.6)
$$\psi_n^{\ell}(x,y) := \left(\frac{2\ell}{\ell-n}\right)^{\frac{1}{2}} x^{\ell-n} y^{\ell+n}.$$

Then

$$(T^{\ell}(k_{\alpha,\beta})f)(x,y) := f(\alpha x - \overline{\beta}y, \beta x + \overline{\alpha}y)$$

defines an irr. unitary rep of K on \mathcal{H}_{ℓ} . Note that the orthonormal basis is an M-basis:

Let

denote the matrix elements of $T^{\ell}(k)$ with respect to this basis. From (4.6), (4.7) and (4.9) one obtains a generating function for these matrix elements:

From this one can obtain an explicit expression for $t_{mn}^{\ell}(k)$ in terms of Jacobi polynomials A more detailed account of the representation theory of SU(2) is, for instance, given in VILENKIN [24, Ch. III].

We will need two special functions associated with the reps $T_{j\ell}.$ First, for the character $\chi_{j\ell}$ of $T_{j\ell}$ we have

and $P_n^{(\alpha,\beta)}(x)$ denotes a Jacobi polynomial. $R_{m,n}(x+iy)$ is an orthogonal polynomial in the two variables x,y, a so-called *disk polynomial*. It can be completely characterized by the three conditions

See KOORNWINDER [12]. It follows from (4.11) and (4.13) that

 \hat{M} consists of the reps $\xi_i(j \in \frac{1}{2}\mathbb{Z})$ defined by

(4.17)
$$\xi_{j}(m_{\phi}) := e^{-2ij\phi}.$$

Let $\pi_{1,\lambda}$ $(j \in \frac{1}{2}\mathbb{Z}, \lambda \in \mathbb{C})$ denote the principal series rep of G induced by the rep

$${}^{m} \phi^{a} t^{n} x + iy$$
 $\Rightarrow e^{-2ij\phi} e^{2\lambda t}$

of MAN. Since T_{ℓ} has M-content $\{\xi_j | j=-\ell, -\ell+1, \ldots, \ell\}$, we obtain by Frobenius reciprocity that $\pi_{j,\lambda}$ has K-content $\{T_{\ell} | \ell=|j|, |j|+1, \ldots\}$.

For ρ we obtain:

5. THE GENERALIZED ABEL TRANSFORM FOR SL(2,C)

Write $I_{c,\ell}^{\infty}(G)$ instead of $I_{c,T_{\ell}}^{\infty}(G)$, $d_{\ell} := 2\ell + 1$. Note that $\check{T}_{\ell} = T_{\ell}$. Nor-malize the Haar measure on N by $dn_{x+iy}^{\ell} := (2\pi)^{-1} dx dy$. Specialization of (2.3) to G = SL(2, C) yields

$$F_{f}(k,a_{t}) = (2\pi)^{-1}e^{2t}\int_{-\infty}^{\infty}\int_{-\infty}^{\infty}f(ka_{t}n_{x+iy})dx dy, f \in I_{c,\ell}^{\infty}(G).$$

Formulas (2.7) and (2.6) can be written as

for f in $I_{c,\ell}^{\infty}(G)$. From now on we fix ℓ and Σ_m will mean a sum with m running through the set $\{-\ell, -\ell+1, \ldots, \ell\}$. Let us use the notation

Note that, for $f \in I_{c,\ell}^{\infty}(G)$, the f_m 's and F_j 's are in $C_c^{\infty}(\mathbb{R})$. The function f satisfies an obvious symmetry because of the Weyl group action:

Indeed, if $f \in I_c^{\infty}(G)$ then

Next we want to rewrite (5.1) as a "classical" integral transform. An intermediate stage (essentially the same as in NAIMARK [19, Ch. 3, §9, no. 10]) is as follows:

$$= (2\pi)^{-1} e^{2t} \int_{K} \int_{0}^{\infty} \int_{0}^{2\pi} f(m_{-\psi/2}km_{\psi/2}a_{t}n_{z}) t_{jj}^{\ell}(k^{-1}) dk zdz d\psi$$

$$= e^{2t} \int_{K} \int_{0}^{\infty} f(ka_{t}n_{z}) t_{jj}^{\ell}(k^{-1}) dk zdz$$

$$= e^{2t} \int_{K} \int_{0}^{\infty} f(u_{-\theta_{2}}ku_{\theta_{1}}a_{w}) t_{jj}^{\ell}(k^{-1}) dk zdz$$

$$= d_{\ell} e^{2t} \int_{K} \int_{0}^{\infty} \sum_{m} f_{m}(w) t_{mm}^{\ell}(u_{-\theta_{2}}ku_{\theta_{1}}) t_{jj}^{\ell}(k^{-1}) dk zdz$$

$$= e^{2t} \int_{0}^{\infty} \sum_{m} f_{m}(w) t_{jm}^{\ell}(u_{\theta_{1}}) t_{mj}^{\ell}(u_{-\theta_{2}}) zdz. \Box$$

A straightforward calculation shows that (5.8) is equivalent to

and that it implies

The final version of our Abel transform is given in the following theorem:

PROOF. By (5.7), (5.4) and (4.8) we obtain:

There is some similarity of formula (6.3) with the formula in MATSUSHITA [18, p. 115] which is obtained by taking Mellin transforms at both sides of (2.12). Matsushita could invert his formula and thus, by taking inverse Mellin transforms, obtain (2.14). We did not succeed in inverting (6.3). However, we can prove:

The above corollary immediately implies the Plancherel formula for $SL(2,\mathbb{C})$. This formula was first obtained by GELFAND & NAIMARK [4], see also the very readable proof (for $SO_{o}(3,1)$) in TAKAHASHI [21].

7. CHARACTERIZATION OF THE IMAGE OF THE GENERALIZED ABEL TRANSFORM

Let A_{ℓ} denote the image of $I_{c,\ell}^{\infty}(G)$ under the transform $f \mapsto F$. We already know that all F in A_{ℓ} have the form (5.5) with F_{i} in $C_{c}^{\infty}(\mathbb{R})$ and that

F satisfies the symmetry (5.12). Now we will derive an additional condition satisfied by each F in ${\rm A}_{\not L}.$

$$ch(t+i\tau)f_{p,q}(\tau,t) = \frac{1}{2}(f_{p+\frac{1}{2},q-\frac{1}{2}}(\tau,t) + f_{p-\frac{1}{2},q+\frac{1}{2}}(\tau,t))$$
$$ch(t-i\tau)f_{p,q}(\tau,t) = \frac{1}{2}(f_{p+\frac{1}{2},q+\frac{1}{2}}(\tau,t) + f_{p-\frac{1}{2},q-\frac{1}{2}}(\tau,t),$$

together with

$$ch(t+i\tau) = x ch w + iy sh w,$$

 $ch(t-i\tau) = x ch w - iy sh w,$

we conclude that f is a polynomial in x,y of degree $2|p|\vee|q|-1$. Now use the orthogonality property of the disk polynomials $R_{\ell+m,\ell-m}(x+iy)$.

DEFINITION 7.2. Let \mathcal{B}_{ℓ} be the space of all functions F on $[0, 2\pi] \times \mathbb{R}$ of the form

$$F(\tau,t) = \sum_{j} e^{-2ij\tau} F_{j}(t),$$

with $F_{j} \in C_{c}^{\infty}(\mathbb{R})$ $(j \in \{-\ell, -\ell+1, \dots, \ell\})$, such that

(i) $F(\tau,t) = F(-\tau,-t),$

(ii)
$$\hat{F}(2p,2q) = \hat{F}(2q,2p) (p,q \in \{-\ell,-\ell+1,\ldots,\ell\}).$$

Clearly, $A_{\ell} \subset B_{\ell}$ (cf. (5.5), (5.12), (7.1)). If $F \in B_{\ell}$ then define the function E_{F} on $[0, 2\pi] \times \mathbb{R}$ by

(7.3)
$$E_{F}(\phi, w) := RHS \text{ of } (6.7).$$

Thus, if $f \in I_{c,\ell}^{\infty}(G)$ and $F := F_f$ then $E_F = f|_{M \times A^{\bullet}}$. We will show that the mapping $F \mapsto E_F$ is a bijection of \mathcal{B}_{ℓ} onto $I_{c,\ell}^{\infty}(G)$ (restricted to M×A). Thus it will turn out that $A_{\ell} = \mathcal{B}_{\ell}$.

<u>PROPOSITION 7.3.</u> Let $F \in B_{\ell}$, $f := E_{F}$. Then

(7.4)
$$f(\phi,w) = \frac{1}{2sh2w} \frac{1}{2\pi} \int_{0}^{2\pi} \int_{w}^{\infty} \left(\frac{\partial^{2}}{\partial\tau^{2}} + \frac{\partial^{2}}{\partial\tau^{2}}\right) F(\tau,t).$$

$$U_{2\ell}\left(\frac{\operatorname{ch} t}{\operatorname{ch} w} \cos \phi \, \cot \, + \, \frac{\operatorname{sh} t}{\operatorname{sh} w} \, \sin \phi \, \sin \tau\right) d\tau \, dt,$$

and f is the restriction to $M \times A$ of a function f on G belonging to $I_{c,\ell}^{\infty}(G)$ and given by

(7.5)
$$f(g) = \frac{1}{d\ell^{\pi}} \sum_{j=0}^{\infty} \widehat{F}(2j,2i\lambda) \operatorname{tr} \pi_{j,i\lambda;\ell,\ell}(g)(\lambda^{2}+j^{2})d\lambda.$$

<u>PROOF.</u> (7.4) follows from (7.3) because of condition (i) of Definition 7.2 and because

$$\int_{0-\infty}^{2\pi} \int_{-\infty}^{\infty} \left(\frac{\partial^2}{\partial \tau^2} + \frac{\partial^2}{\partial t^2} \right) F(\tau, t) U_{2\ell} \left(\frac{\operatorname{ch} t}{\operatorname{ch} w} \cos \phi \cos \tau + \frac{\operatorname{sh} t}{\operatorname{sh} w} \sin \phi \sin \tau \right) d\tau \, dt = 0.$$

To prove this identity, observe that

$$\frac{ch t}{ch w} \cos\phi \cos\tau + \frac{sh t}{sh w} \sin\phi \sin\tau$$

is invariant under $(t,\tau) \rightarrow (i\tau,-it)$ and that $U_{2\ell}(-x) = (-1)^{2\ell}U_{2\ell}(x)$, so $U_{2\ell}(\ldots)$ is multiplied by $(-1)^{2\ell}$ under $\tau \rightarrow \tau + \pi$. Hence $U_{2\ell}(\ldots)$ is a finite linear combination of terms $e^{2ip\tau}e^{2qt} + e^{2iq\tau}e^{2pt}(p,q \in \{-\ell,-\ell+1,\ldots,\ell\})$ with coefficients depending on ϕ, w . Now if we write

$$\left(\frac{\partial^2}{\partial \tau^2} + \frac{\partial^2}{\partial t^2}\right) F(\tau, t) = \sum_{m} H_m(t) e^{-2im\tau},$$

then condition (ii) of Def. 7.2 implies:

$$\int_{\mathbb{R}} H_{p}(t)e^{2qt}dt = -\int_{\mathbb{R}} H_{q}(t)e^{2pt}dt,$$

and our claim is clear.

Formula (7.5) is proved for $g \in MA$ by substituting (5.16) into (7.3) and next combining this with (5.20). Now observe that $\lambda \rightarrow \hat{F}(2j,2i\lambda)$ is rapidly decreasing $(j \in \{-\ell,-\ell+1,\ldots,\ell\})$, since $F \in C_c^{\infty}([0,2\pi] \times \mathbb{R})$, and that, by (2.11), all partial derivatives w.r.t. g of the function $(\lambda,g) \mapsto \operatorname{tr} \pi_{j,i\lambda;\ell,\ell}(g)$ exist and are of polynomial growth in λ . Hence (7.5) defines a function f in $C^{\infty}(G)$. Next, f is invariant under K-conjugation and behaves like the rep T_{ℓ} of K because of similar properties of the

function $g \rightarrow tr \pi_{j,i\lambda;\ell,\ell}(g)$. Thus f will have the form (5.2). Finally, since $f|_{MA}$ has compact support because of (7.4), we conclude that f has compact support on G. Hence $f \in I_{c,\ell}^{\infty}(G)$.

Next we want to prove that $F \rightarrow E_F$ is injective on \mathcal{B}_{ρ} . For this we need:

THEOREM 7.4.

(a) If $|\lambda| - |j| \notin \mathbb{N}$ then $\pi_{j,\lambda}$ is irr. If $|\lambda| - |j| \in \mathbb{N}$ then $\pi_{j,\lambda}$ has two irr. subquotient reps $\sigma_{i,\lambda}$ and $\tau_{i,\lambda}$, with

$$M(\sigma_{j,\lambda}) = \{T_{|j|}, T_{|j|+1}, \dots, T_{|\lambda|-1}\},$$
$$M(\tau_{j,\lambda}) = \{T_{|\lambda|}, T_{|\lambda|+1}, \dots\}.$$

(b) There exist precisely the following nontrivial Naimark equivalences between the above irr. reps:

$$\pi_{\mathbf{j},\lambda} \approx \pi_{-\mathbf{j},-\lambda} (|\lambda| - |\mathbf{j}| \notin \mathbb{N}),$$

$$\sigma_{\mathbf{j},\lambda} \approx \sigma_{-\mathbf{j},-\lambda} \tau_{\mathbf{j},\lambda} \approx \tau_{-\mathbf{j},-\lambda} (|\lambda| - |\mathbf{j}| \in \mathbb{N}),$$

$$\pi_{\mathbf{j},\lambda} \approx \tau_{\lambda,\mathbf{j}}, \pi_{\mathbf{j},\lambda} \approx \tau_{-\lambda,-\mathbf{j}} (|\mathbf{j}| - |\lambda| \in \mathbb{N}).$$

<u>PROOF.</u> The matrix element $\pi_{j,\lambda}; \ell_1, \ell_2; \ell_2, \ell_2$ (at) $(\ell_1 \ge \ell_2)$ can be easily evaluated in terms of a_2F_1 hypergeometric function (cf. KOSTERS [16, (3.11)]). This shows that, if $\pi_{j,\lambda}; \ell_1, \ell_2 = 0$ then $|\lambda| - |j| \in \mathbb{N}$ and $\ell_1 \ge |\lambda|, \ell_2 < |\lambda|$ or $\ell_1 < |\lambda|, \ell_2 \ge |\lambda|$. Thus, by Theorem 1.2, $\pi_{j,\lambda}$ is irr. if $|\lambda| - |j| \notin \mathbb{N}$ and $\pi_{j,\lambda}$ has at most the irr. subquotient reps $\sigma_{j,\lambda}$ and $\tau_{j,\lambda}$ if $|\lambda| - |j| \in \mathbb{N}$. However, by (7.2) and Theorem 1.5 it follows that $\tau_{j,\lambda}(|\lambda|-|j|\in\mathbb{N})$ is indeed an irr. rep being Naimark equivalent to the irr. rep $\pi_{\lambda,j}$. This settles (a). The other equivalences in (b) follow from the evident identity

tr
$$\pi_{j,\lambda;\ell,\ell}(m_{\phi}a_{w}) = tr \pi_{-j,-\lambda;\ell,\ell}(m_{\phi}a_{w}),$$

together with Theorem 1.5. Finally, to prove that this exhausts the possible Naimark equivalences, observe:

$$\pi_{j_1,\lambda_1;\ell,\ell;\ell,\ell} = \pi_{j_2,\lambda_2;\ell,\ell;\ell,\ell} \Rightarrow \lambda_1 j_1 = \lambda_2 j_2$$

(cf. KOSTERS [16, p. 16]).

The above proof simplifies the proof by KOSTERS [16] because of our new proof of (7.2). The above proof that $\pi_{j,\lambda}$ is irr. if $|\lambda| - |j| \notin \mathbb{N}$ also occurs in NAIMARK [19, Ch. 3, §9, no. 15].

<u>PROPOSITION 7.5.</u> The mapping $F \mapsto E_F \colon \mathcal{B}_{\ell} \to I_{c,\ell}^{\infty}(G)$ is injective.

PROOF. Suppose
$$F_1 \in \mathcal{B}_{\ell}$$
, $f_1 := E_{F_1} = 0$, $f_2 \in I_{c,\ell}^{\infty}(G)$, $F_2 := F_{f_2}$ then
$$\int_{0}^{2\pi} \int_{0}^{\infty} \left(\frac{\partial^2}{\partial \tau^2} + \frac{\partial^2}{\partial t^2}\right) F_1(\tau, t) F_2(\tau, t) d\tau dt = 0.$$

To see this, substitute formula (5.11) with $f = f_2$ into the left hand side for F_2 and interchange the order of integration. Substitution of (5.16) into the above formula and application of (5.12) yields:

$$\sum_{j=0}^{\infty} \int_{0}^{\infty} \widehat{F}_{1}(2j,2i\lambda) \widehat{F}_{2}(2j,2i\lambda) (\lambda^{2}+j^{2}) d\lambda = 0.$$

Let \hat{A}_{ℓ} denote the set of functions \hat{F} on $\{-2\ell, -2\ell+2, \dots, 2\ell\} \times i[0, \infty)$ for which $F \in A_{\ell}$. One easily verifies that \hat{A}_{ℓ} is an algebra under pointwise multiplication, consisting of continuous functions \hat{F} which satisfy $\hat{F}(2j, 2i\lambda) \leftrightarrow 0$ as $\lambda \to \infty$, and that \hat{A}_{ℓ} is closed under complex conjugation. Next, \hat{A}_{ℓ} separates points. Indeed, if $\hat{F}(2j_1, 2i\lambda_1) = \hat{F}(2j_2, 2i\lambda_2)$ for all $\hat{F} \in \hat{A}_{\ell}$ then

$$\operatorname{tr} \pi_{j_1,i\lambda_1;\ell,\ell}(g) = \operatorname{tr} \pi_{j_2,i\lambda_2;\ell,\ell}(g)$$

because of (5.17) and Lemmas 5.3, 5.4, so $(j_1, i\lambda_1) = (j_2, i\lambda_2)$ by Theorems 7.4 (b) and 1.2. Finally, another application of (5.17) and Lemmas 5.3, 5.4 shows that no (2j,2i λ) is annihilated by all $\hat{F} \in \hat{A}_{\ell}$. Thus, by the version of the Stone-Weierstrass theorem for a locally compact Hausdorff space (cf. SIMMONS [23, §38, Theorem B]), each continuous function on $\{-2\ell,\ldots,2\ell\}$ × i[0,∞) vanishing at ∞ can be uniformly approximated by functions in \hat{A}_{ℓ} . In particular, the (rapidly decreasing) function $\overline{\hat{F}}_1$ can be uniformly approximated by functions $\hat{F}_2 \in \hat{A}_{\ell}$, so

$$\sum_{j} \int_{0} |\widehat{F}_{1}(2j,2i\lambda)|^{2} (\lambda^{2}+j^{2}) d\lambda = 0.$$

This shows that $F_1 = 0$.

Define \widetilde{B}_{ℓ} to be the algebra of all functions in $\mathcal{D}(\mathbb{R};\mathbb{C}^{2\ell+1})$ such that (i) $F_{j}(-t) = F_{-j}(t)$, $j = -\ell, -\ell+1, \dots, \ell$, (ii) $\int_{-\infty}^{\infty} F_{j}(t) e^{-2kt} dt = \int_{-\infty}^{\infty} F_{k}(t) e^{-2jt} dt$, $j,k = -\ell, -\ell+1, \dots, \ell$,

with componentwise convolution as multiplication, and the topology inherited from $\mathcal{D}(\mathbb{R}; \mathbb{C}^{2\ell+1})$. Note: $\widetilde{\mathcal{B}}_{\ell}$ and \mathcal{B}_{ℓ} are isomorphic as vector spaces under the mapping $F \mapsto \{F_i\}$ defined by (5.5). From (5.1) and (5.3) we have:

(7.6)
$$F_{f,j}^{\ell}(t) := (2\pi)^{-1} e^{2t} \int_{K \mathbb{R} \mathbb{R}} \int f(ka_t n_{x+iy}) t_{jj}^{\ell}(k^{-1}) dk dx dy.$$

Now we arrive at the main theorem:

<u>THEOREM 7.6.</u> The mapping $f \leftrightarrow \{F_{f,j}^{\ell}\}: I_{c,\ell}^{\infty}(G) \to \widetilde{B}_{\ell}$ is an isomorphism of topological algebras.

<u>PROOF.</u> The mapping is an injective continuous algebra homomorphism by Theorem 2.2 and it is surjective by Proposition 7.3 and 7.5. The only thing left to prove is that the inverse E: $B_{\ell} \mapsto I_{c,\ell}^{\infty}(G)$ is continuous. This is done as follows. Denote by $\|g\| (g \in SL(2, \mathbb{C}))$ the operator norm of g acting on the Hilbert space \mathbb{C}^2 . The elements of K(=SU(2)) have norm 1, so, if $g = k_1 a_t k_2$ then $\|g\| = \|a_t\| = \max\{e^t, e^{-t}\}$. If R > 0 then let $I_{c,\ell;R}^{\infty}(G)$ denote the space of functions in $I_{c,\ell}^{\infty}(G)$ which vanish on all g in G with log $\|g\| > R$; similary, let $B_{\ell;R}$ consist of all functions in B_{ℓ} with support included in $[0, 2\pi) \times [-R, R]$. Let $f \in I_{c,\ell}^{\infty}(G)$, R > 0. In view of (5.2), (5.11) and (7.4) we have:

$$f \in I_{c,\ell;R}^{\infty}(G) \Leftrightarrow Suppf_{|M \times A} \subset [0,2\pi) \times [-R,R] \Leftrightarrow F_{f} \in \mathcal{B}_{\ell;R}$$

so $f \mapsto F_f: I_{c,\ell;R}^{\infty}(G) \to B_{\ell;R}$ is a continuous linear bijection with inverse $E|_{\mathcal{B}_{\ell;R}}$. Because of the open mapping theorem for Fréchet spaces (cf. RUDIN [22, Gor. 2.12(b)]), $E: B_{\ell;R}(G) \to I_{c,\ell;R}^{\infty}(G)$ is also continuous. Since $I_{c,\ell}^{\infty}(G) = \bigcup_{R>0} I_{c,\ell;R}^{\infty}(G)$, endowed with inductive limit topology, and similary for B_{ℓ} , we conclude that $E: I_{c,\ell}^{\infty}(G) \to B_{\ell}$ is continuous. \Box

8. THE SUBQUOTIENT THEOREM FOR SL(2,C).

In order to derive the subquitient theorem from Theorem 7.6 we have to find all continuous characters on $\widetilde{B}_{\ell^{q}}$ As a preparation we need two lemmas. Identify $\{F_{j}\}$ in \widetilde{B}_{ℓ} with F in B_{ℓ} by means of (5.5). Thus (5.15) can be rewritten as

(8.1)
$$\widehat{F}(2j,2\lambda) = d_{\ell} \int_{-\infty}^{\infty} F_j(t) e^{-2\lambda t} dt$$

and $F \mapsto d_{\ell}^{-1} \widehat{F}(2j,2\lambda)$ defines a continuous character on \widetilde{B}_{ℓ} for each j j in $\{-\ell, -\ell+1, \ldots, \ell\}, \lambda$ in C.

LEMMA 8.1. Let

$$\widetilde{\mathcal{B}}_{\ell,0} := \{ F \in \widetilde{\mathcal{B}}_{\ell} | \widehat{F}(2p,2q) = 0 \text{ for } p,q = -\ell, -\ell+1, \ldots, \ell \}.$$

Then $\widetilde{B}_{\ell,0}$ is a closed subalgebra of \widetilde{B}_{ℓ} and every nonzero continuous character on $\widetilde{B}_{\ell,0}$ has the form $F \mapsto d_{\ell}^{-1} \widehat{F}(2j,2\lambda)$ for some j in $\{-\ell,\ldots,\ell\}, \lambda$ in C.

<u>PROOF.</u> See NAIMARK [19, Ch. 3, §9, no. 13]. The lemma is easily reduced to the two problems of finding all nonzero continuous characters on the convolution algebras $\mathcal{D}(\mathbb{R})$ and $\mathcal{D}_{even}(\mathbb{R})$, respectively. In both cases these are of the form $f \mapsto \int_{\mathbb{R}} f(t)e^{-\lambda t} dt$ for some λ in \mathbb{C} (see also [13, Prop. 5.6]).

The next lemma is also given by NAIMARK, see [19, Ch. 3, §9, no. 14], but there is an error in his proof, so we will give here the full correct proof.

<u>LEMMA 8.2.</u> Let A be an algebra, f,g, f_1, \ldots, f_n multiplicative linear functionals on A, $A_0 := \{x \in A | f_1(x) = \ldots = f_n(x) = 0\}, f|_{A_0} = g|_{A_0}$. Then

 $f = g \text{ or } f = f_k \text{ for some } k \text{ in } \{1, \dots, n\} \text{ or } f = 0.$

<u>PROOF.</u> Without loss of generality we may assume that the f_i 's are linearly independent. By a simple inductive argument we can find x_k in A $(1 \le k \le n)$ such that $f_j(x_k) = \delta_{jk}(1 \le j, k \le n)$. If $x \in A$ then $x - \sum_{j=1}^n f_j(x) x_j \in A_0$, so

$$f(x) - \sum_{j=1}^{n} f_j(x)f(x_j) = g(x) - \sum_{j=1}^{n} f_j(x)g(x_j).$$

On putting $\alpha_j := f(x_j) - g(x_j)$ we see that

(*)
$$f(x) = g(x) + \sum_{j=1}^{n} \alpha_{j} f_{j}(x).$$

Substitution of $x = yx_k$ with y in A_0 yields,

$$f(y) \alpha_{k} = 0 \quad (y \in A_{0}, l \le k \le n).$$

Now there are two possibilities:

(i) $\alpha_k = 0$ for all k. Then f = g by (*). (ii) $\alpha_k \neq 0$ for some k. Then $f|_{A_0} = 0$ and (**) $f(x) = \sum_j f_j(x)f(x_j)$.

If $f \neq 0$ then $f(x_{\ell}) \neq 0$ for some ℓ and (**) with $x = x_{\ell}x_i$ will yield $f(x_{\ell})f(x_i) = \delta_{\ell i}f(x_{\ell})$. So $f(x_i) = \delta_{i\ell}$ and $f = f_{\ell}$. \Box

PROPOSITION 8.3. Each nonzero continuous character on \widetilde{B}_{ℓ} has the form $F \mapsto d_{\ell}^{-1} \widehat{F}(2j,2\lambda)$ for some j in $\{-\ell,-\ell+1,\ldots,\ell\}$ and some λ in C.

<u>PROOF.</u> Let χ be a nonzero continuous character on $\widetilde{\mathcal{B}}_{\ell}$. Then $\chi_0 := \chi|_{\widetilde{\mathcal{B}}_{\ell,0}}$ is a continuous character on $\widetilde{\mathcal{B}}_{\ell,0}$. It follows from Lemma 8.1 that $\chi_0 = 0$ of $\chi_0(F) = d_{\ell}^{-1} \widehat{F}(2j,2\lambda)$ ($F \in \widetilde{\mathcal{B}}_{\ell,0}$) for some j in $\{-\ell, -\ell+1, \ldots, \ell\}$ λ in \mathfrak{C} . Now apply Lemma 8.2 with $f = \chi_0$ and g: $F \mapsto d_{\ell}^{-1} \widehat{F}(2j,2\lambda)$, Then

$$\chi(\mathbf{F}) = \mathbf{d}_{\ell}^{-1} \ \widehat{\mathbf{F}}(2\mathbf{j}, 2\lambda) \ (\mathbf{F} \in \widetilde{\mathcal{B}}_{\ell}) \ \text{or} \ \chi(\mathbf{F}) = \mathbf{d}_{\ell}^{-1} \ \widehat{\mathbf{F}}(2\mathbf{p}, 2\mathbf{q})$$
$$(\mathbf{F} \in \widetilde{\mathcal{B}}_{\ell}) \ \text{for some p,q in } \{-\ell, -\ell+1, \dots, \ell\}. \quad \Box$$

THEOREM 8.4 (subquotient theorem for $SL(2, \mathbb{C})$).

Let $G = SL(2, \mathbb{C})$, K = SU(2). Then every K-finite irr. Hilbert rep of G is Naimark equivalent with an irr. subquotient rep of a principal series rep.

PROOF. Use Theorems 1.5, 2.2 (iv), 7.6 and Propositions 1.6 and 8.3.

9. FURTHER REMARKS

Obviously, Theorem 7.6 together with (5.17) and the Paley-Wiener theorem for the classical Fourier transform yields a characterization of the image of $I_{c,\ell}^{\infty}(G)$ under the group Fourier transform. This provides a new proof of the Paley-Wiener theorem in WANG [26, Prop. 4.5].

Next we state without proof a characterization of functions f in $I_{c,\ell}^{\infty}(G)$ in terms of functions f_m.

PROPOSITION 9.1. Formula (5.2) together with

(9.1)
$$\phi_{n}(w)(sh w)^{\ell+n}(ch w)^{\ell-n} = \sum_{m} \frac{t_{mn}^{\ell}(u_{\pi/4})f_{m}(w)}{(\ell-m)!(\ell+m)!)^{\frac{1}{2}}}$$

defines a one - to - one correspondence $f \leftrightarrow (\phi_{-\ell}, \phi_{-\ell+1}, \dots, \phi_{\ell})$ between $I_{c,\ell}^{\infty}(G)$ and $(C_{c,even}^{\infty}(\mathbb{R}))^{2\ell+1}$.

Finally, we would like to remark that similar results as in this paper for SL(2,C) can be derived for the corresponding Cartan motion group SU(2) $\circ \mathbb{R}^3$. Let G be a noncompact connected real semisimple Lie group with finite center, K a maximal compact subgroups, g and k the corresponding Lie algebras, and g = k + p a Cartan decomposition of g. Consider the semidirect product K \circ p, where K acts on p by Ad. Let a be a maximal abelian subspace of p, a^{\perp} the orthoplement of a in p w.r.t. the Killing form B on g. For δ in \hat{K} let $I_{c,\delta}^{\infty}(G)$ be defined as in (2.3), (2.4). Then the analogue for K \circ p of the generalized Abel transform (2.3) becomes

(9.2)
$$F_{f}(k,H) := \int f(k,H+Y) dY, k \in K, H \in a, f \in I_{c,\delta}^{\infty}(G).$$

Now it can be proved that, if $G = SL(2,\mathbb{C})$, $f \in I_{c,\ell}^{\infty}(K \circ p)$ and $a = \mathbb{R} H_0$ then

(9.3)
$$F_{f}(m_{\tau}, tH_{0}) = \text{const.} \int_{0}^{2\pi \infty} \int_{t}^{\infty} f(m_{\phi}, wH_{0}).$$
$$U_{2\ell}\left(\cos\phi \cos\tau + \sin\phi \sin\tau \frac{t}{w}\right) d\phi wdw.$$

Compare this formula with (5.11).
