## ABSTRACT

We study the generalized Abel transform for $\operatorname{SL}(2, \mathbb{C})$ in the case of equal left and right, fixed $K$-type. We rewrite this transform as an integral transform of classical type. Then it involves a double integration with kernel expressed in terms of a Chebyshev polynomial of the second kind. We obtain the inversion formula in a similar form and we completely characterize the image in the $\mathrm{C}^{\infty}$-case. As a corollary we prove the subquotient theorem for $\operatorname{SL}(2, \mathbb{C})$ by a global approach.

## 0. INTRODUCTION

In earlier papers [13], [14] the second author formulated a program for a global approach to the representation theory of noncompact semisimple Lie groups $G$ and he carried it out for $\operatorname{SL}(2, \mathbb{R})$. "Global" means that no use of the Lie algebra and universal enveloping algebra of $G$ is made. Instead, the analysis is based on a more or less explicit knowledge of the canonical matrix elements of the principal series representations of $G$ with respect to a K-basis, $K$ being a maximal compact subgroup of $G$. Furthermore, in the case of $\operatorname{SL}(2, \mathbb{R})$ it turned out that the subquotient theorem (i.e. the Naimark equivalence of $K$-finite irreducible representations of $G$ to subquotients of principal series representations) can be proved by use of the generalized Abel transform.

It is the purpose of the present paper to give a global proof of the subquotient theorem for $G=S L(2, \mathbb{C})$ by use of the generalized Abel transform. Let $I_{c, \delta}^{\infty}(G)$ be the commutative topological convolution algebra of Kcentral $C^{\infty}$-functions with compact support on $G$ which behave as the irreducible representation $\delta$ of $K$ under left or right action of $K$. Then the generalized Abel transform is an algebra isomorphism of $I_{c, \delta}^{\infty}$ (G) onto a convolution algebra of certain vector-valued $C^{\infty}$-functions with compact support on $\mathbb{R}$. The subquotient theorem follows from a knowledge of all continuous characters on this image algebra. So we have to know this image algebra. This method was earlier used by NAIMARK [19] and the characterization of the image algebra follows from WANG's [26] Paley-Wiener theorem. However, we will give a probably new proof with side results of independent interest. Namely, we write the generalized Abel transform as an integral transform of "classical" type and we obtain the inversion formula in a similar form:

In this integral transform pair, $\ell$ is in $\left\{0, \frac{1}{2}, 1, \frac{3}{2}, \ldots\right\}, U_{2 \ell}$ is a Chebyshev polynomial of the second kind, and $f$ and $F$ are $C^{\infty}$-functions with compact support, $\mathrm{f}(\psi, \mathrm{x})$ and $\mathrm{F}(\psi, x)$ both having the form

with certain additional conditions.
Let us summarize the contents of the paper. In section 1 we give basic results about the global approach to finding irreducible subquotients and proving Naimark relatedness. Section 2 contains general theorems for the generalized Abel transform on a semisimple Lie group, section 3 a discussion of earlier results for $\operatorname{SL}(2, \mathbb{C})$ and $\operatorname{SL}(2, \mathbb{R})$. Section 4 gives preliminaries on $\operatorname{SL}(2, \mathbb{C})$ and the representation theory of $S U(2)$ which will be needed. The main work of the paper is done in sections 5,6,7: the derivation of (0.1) and an integral representation for related spherical functions of type $\delta$ in $\S 5$, the derivation of the inversion formula (0.2) (also leading to a new proof of the Plancherel formula for $\operatorname{SL}(2, \mathbb{C})$ ) in $\S 6$, a characterization of the image algebra in §7. Finally, the subquotient theorem is derived in §8 and we state without proof some further results in $\S 9$.

Notation. rep means representation, irr. means irreducible.

1. IRREDUCIBLE SUBQUOTIENTS, NAIMARK RELATEDNESS AND THE ALGEBRAS $I_{c, \delta}(G)$

In this section we collect some results which are relevant for the global approach to the representation theory of a general locally compact group.

Let $G$ be a locally compact group satisfying the second axiom of countability and let $K$ be a compact subgroup of $G$. Let $\tau$ be a K-unitary Hilbert rep of $G$, i.e. a strongly continuous rep $\tau$ of $G$ on a separable Hilbert
space $H(\tau)$ such that $\left.\tau\right|_{K}$ is a unitary rep of $K$ on $H(\tau)$. Then

\left.\tau\right|_{K}=\underset{\delta \in \hat{K}}{\oplus} \mathrm{~m}_{\delta} \delta, \tag{1.1}
\end{equation*}
$$

where the multiplicity $\mathrm{m}_{\delta}$ equals $0,1,2, \ldots$ or $\omega$ (countably infinite). Let $H_{\delta}(\tau)$ be the closed subspace of $H(\tau)$ which is the representation space of $m_{\delta} \delta$ in (1.1) and let $P_{\delta}$ be the orthogonal projection of $H(\tau)$ onto $H_{\delta}(\tau)$. For $\gamma, \delta$ in $M(\tau)$ define the canonical matrix elements $\tau_{\gamma \delta}$ of $\tau$ :

Then $\tau_{\gamma \delta}(g)$ is a linear operator of $H_{\delta}(\tau)$ to $H_{\gamma}(\tau)$. The operator $\tau(g)$ can be written as a (usually infinite) block matrix with blocks $\tau_{\gamma \delta}(g)$. Define the $K$-content $M(\tau)$ of $\tau$ by

\end{equation*}

The rep $\tau$ is called K-finite if $\mathrm{m}_{\delta}<\infty$ for all $\delta$ in $\hat{K}$ and $\tau$ is called $K-$ multiplicity free if $\mathrm{m}_{\delta}=0$ or 1 for all $\delta$ in $\hat{K}$.

DEFINITION 1.1. Let $\tau$ be a Hilbert rep of $G$, $H_{0}$ a closed subspace of $H(\tau)$ and $P_{0}$ the orthogonal projection of $\underset{H}{ }(\tau)$ onto $H_{0}$. Let $\tau_{0}(g):=\left.P_{0} \tau(g)\right|_{H_{0}}$ ( $g \in G)$. If $\tau_{0}\left(g_{1} g_{2}\right)=\tau_{0}\left(g_{1}\right) \tau_{0}\left(g_{2}\right)\left(g_{1}, g_{2} \in G\right)$ then $\tau_{0}$ is called a subquotient rep of $\tau$ on $H_{0}$.

THEOREM 1.2 (cf.[13,§3.2]). Let $\tau$ be a K-multiplicity free rep of G. For $\gamma, \delta$ in $M(\tau)$ write $\gamma \sim \delta$ iff $\tau_{\gamma \delta} \neq 0$ and $\tau_{\delta \gamma} \neq 0$. Then $\sim$ is an equivalence relation on $M(\tau)$ and $\tau_{0}$ is an irr. subquotient rep of $\tau$ iff $\left.\tau_{0}\right|_{K}=\underset{\gamma \mid \gamma \sim \delta}{\oplus} \gamma$ for some $\delta$ in $M(\tau)$.

DEFINITION 1.3. Two Hilbert reps $\sigma$ and $\tau$ of $G$ are called Naimark related if there is a closed (possibly unbounded) injective linear operator A of $H(\sigma)$ to $H(\tau)$ with domain $D(A)$ dense in $H(\sigma)$ and range $R(A)$ dense in $H(\tau)$ such that $D(A)$ is $\sigma$-invariant and $A \sigma(g) v=\tau(g) A v(v \in D(A), g \in G)$. Notation: $\sigma \simeq \tau$ or $\sigma \stackrel{A}{\sim} \tau$.

Naimark relatedness is an equivalence relation (called Naimark equivalence) on the class of K -finite Hilbert reps of G (cf.[13, Theorem 4.4]).

LEMMA 1.4. Let $\sigma$ and $\tau$ be irr. Hilbert reps of $G$. If, for certain nonzero $v$ in $H(\sigma)$ and $w i n H(\tau),(\sigma(g) v, v)=(\tau(g) w, w)$ for all $g$ in $G$, then $\sigma \simeq \tau$.

PROOF. Define $\tilde{\sigma}(\mathrm{g}):=\left(\sigma\left(\mathrm{g}^{-1}\right)\right)^{*}(\mathrm{~g} \in \mathrm{G})$, and similarly $\tilde{\tau}(\mathrm{g})$. Then $\tilde{\sigma}$ and $\tilde{\tau}$ are also irr. Hilbert reps of $G$. Define a linear operator A with $D(\mathrm{~A}):=\operatorname{Span}\{\sigma(\mathrm{g}) \mathrm{v} \mid \mathrm{g} \in \mathrm{G}\}$ and $R(\mathrm{~A}):=\operatorname{Span}\{\tau(\mathrm{g}) \mathrm{w} \mid \mathrm{g} \in \mathrm{G}\}$ by

A\left(\sum_{j=1}^{n} \alpha_{j} \sigma\left(g_{j}\right) v\right):=\sum_{j=1}^{n} \alpha_{j} \tau\left(g_{j}\right) w
$$

for arbitrary $n$ in $\mathbb{N}, \alpha_{1}, \ldots, \alpha_{n}$ in $\mathbb{C}$ and $g_{1}, \ldots, g_{n}$ in $G$. By irreducibility of $\sigma$ and $\tau, \mathcal{D}(\mathrm{A})$ is dense in $H(\sigma)$ and $R(A)$ is dense in $H(\tau)$. For the proof that $A$ is one-valued and injective note that the following equalities are equivalent:

\left(\sum_{j=1}^{n} \alpha_{j} \tau\left(g^{-1} g_{j}\right) w, w\right)=0 & \forall g \in G, \\
\left(\sum_{j=1}^{n} \alpha_{j} \tau\left(g_{j}\right) w, \tilde{\tau}(g) w\right)=0 & \forall g \in G, \\
\sum_{j=1}^{n} \alpha_{j}^{\tau}\left(g_{j}\right) w=0 .
\end{array}
$$

Clearly, $\mathcal{D}(\mathrm{A})$ is $\sigma$-invariant and $\mathrm{A} \sigma(\mathrm{g})=\tau(\mathrm{g}) \mathrm{A}$ on $\mathcal{D}(\mathrm{G})$ for g in G . For the proof that the closure $\bar{A}$ of $A$ is one-valued and injective let

Then $\mathrm{v}_{0}=0$ iff $\mathrm{w}_{0}=0$, by a similar argument as above. Finally apply [13, Lemma 4.3].

THEOREM 1.5. Let $\sigma$ and $\tau$ be irr. K-unitary reps and let some $\delta$ in $\hat{\mathrm{K}}$ have multiplicity 1 in both $\sigma$ and $\tau$. Then $\sigma$ and $\tau$ are Naimark related iff

\operatorname{tr} \sigma_{\delta \delta}(\mathrm{g})=\operatorname{tr} \tau_{\delta \delta}(\mathrm{g}) \quad \text { for all } \mathrm{g} \text { in } \mathrm{G} \tag{1.4}
\end{equation*}

PROOF. If $\sigma \simeq \tau$ and $I_{\delta}: H_{\delta}(\sigma) \rightarrow H_{\delta}(\tau)$ is a $K$-intertwining isometry then

\tau_{\delta \delta}(\mathrm{g})=\mathrm{I}_{\delta} \sigma_{\delta \delta}(\mathrm{g}) \mathrm{I}_{\delta}^{-1}
$$

(cf.[13, Theorem 4.5]). This proves (1.4). Conversely assume (1.4) and choose orthonormal bases $e_{1}, \ldots, e_{d_{\delta}}$ for $H_{\delta}(\tau)$ and $f_{1}, \ldots, f_{d_{\delta}}$ for $H_{\delta}(\tau)$ such that

\delta_{i j}(k):=\left(\sigma(k) e_{j}, e_{i}\right)=\left(\tau(k) f_{j}, f_{i}\right), \quad k \in K .
$$

In (1.4) replace $g$ by $g k(g \in G, k \in K)$. Then we obtain:

\sum_{i, j=1}^{d} \delta_{i j}(k)\left(\sigma(g) e_{i}, e_{j}\right)=\sum_{i, j=1}^{d} \delta_{i j}(k)\left(\tau(g) f_{i}, f_{j}\right) .
$$

Hence $\left(\sigma(\mathrm{g}) \mathrm{e}_{1}, \mathrm{e}_{1}\right)=\left(\tau(\mathrm{g}) \mathrm{f}_{1}, \mathrm{f}_{1}\right)(\mathrm{g} \in \mathrm{G})$ and $\sigma \simeq \tau$ by Lemma 1.4 .

The spaces $C(G)$ and, if $G$ is a Lie group, $C_{c}^{\infty}(G)$ are algebras under convolution and, provided with the usual inductive limit topology, they become topological algebras. Consider the following closed subalgebras $I_{c}^{\infty}(G), I_{c, \delta}(G)(\delta \in \hat{K})$ of $C_{c}(G)$ and $I_{c}^{\infty}(G), I_{c, \delta}(G)(\delta \in \hat{K})$ of $C_{c}^{\infty}(G)$ :

& I_{c}^{(\infty)}(G):=\left\{f \in C_{c}^{(\infty)}(G) \mid f\left(k g k^{-1}\right)=f(g), g \in G, k \in K\right\},  \tag{1.5}\\
& I_{c, \delta}^{(\infty)}(G):=\left\{f \in I_{c}^{(\infty)}(G) \mid d_{\delta} \int_{K} f(g k) x_{\delta}(k) d k=f(g), g \in G, k \in K\right\} . \tag{1.6}
\end{align*}

The present definition of $I_{c, \delta}^{(\infty)}(G)$ corresponds to the definition of $I_{c, \delta}^{(\infty)}$ ( $\delta$ being contragredient to $\delta$ ) in [13, p.43]. Here we follow the definition in WARNER [27,§4.5.1].

PROPOSITION 1.6. (cf. WARNER [27, Theor. 6.1.1.2, Prop. 6.1.1.6]). Let $\delta \in \widehat{K}$ and let the algebra $I_{c, \delta}(G)$ be commutative. Let $\tau$ be an irr. K-unitary rep of $G$ in which $\delta$ occurs with finite nonzero multiplicity $\mathrm{m}_{\delta}$. Then $m_{\delta}=1$ and the Iinear functional

\mathrm{f} \mapsto \mathrm{~d}_{\delta}^{-1} \int_{\mathrm{G}} \mathrm{f}(\mathrm{~g}) \operatorname{tr} \tau_{\delta \delta}(\mathrm{g}) \mathrm{dg} \tag{1.7}
\end{equation*}
$$

is a nonzero continuous character on $\mathrm{I}_{\mathrm{c}, \delta}(\mathrm{G})$. Furthermore, this character completely determines $\operatorname{trt}_{\delta \delta}($.$) as a function on G$.

PROOF. By $\left[3\right.$, Lemma 5.1] $\mathrm{m}_{\delta}=1$ iff the rep 1 of

\begin{equation*}
K^{*}:=\{(k, k) \in G \times K \mid k \in K\} \tag{1.8}
\end{equation*}
$$

has multiplicity 1 in the rep $\tau \otimes \hat{V}$ of $G \times K$. By restriction to $G \times\{e\}$ the algebra $C_{C}\left(K^{*} \backslash G \times K / K^{*}\right)$ is mapped isomorphically onto $I_{C}(G)$. Under this mapping the algebra

\begin{aligned}
A:= & \left\{f \in C_{c}\left(K^{\star} \backslash G \times K / K^{*}\right) \mid\right. \\
& \left.d_{\delta} \int_{K} f(g, k) x_{\delta}\left(k^{-1}\right) d k=f(g, e), g \in G, k \in K\right\}
\end{aligned}
$$

corresponds to $I_{c, \delta}(G)$.
For $f$ in $C_{c}(G \times K)$ define $f \#$ by

$$
\begin{gathered}
f^{\#}(g, k):=d_{\delta} \int_{K} \int_{\mathrm{K}} \int_{\mathrm{K}} \mathrm{f}\left(\mathrm{k}_{1} \mathrm{gk}_{2}, \mathrm{k}_{1} \mathrm{kk}_{3} \mathrm{k}_{2}\right) \mathrm{x}_{\delta}\left(\mathrm{k}_{3}^{-1}\right) \mathrm{dk}_{1} \mathrm{dk}_{2} \mathrm{dk}_{3}, \mathrm{~g} \in \mathrm{G}, \\
, \mathrm{k} \in \mathrm{~K} .
\end{gathered}
$$

Then $f \mapsto f^{\#}$ is a projection of $C_{C}(G \times K)$ onto A. Let $P_{1}$ be the orthogonal projection of $H(\tau \otimes \delta)$ onto $H_{1}(\tau \otimes \delta)$. One easily verifies that, for $v$ in $H_{1}(\tau \otimes \delta)$, $\mathrm{f} \in \mathrm{C}_{\mathrm{c}}(\mathrm{G} \times \mathrm{K}):$

(\tau \otimes \delta)(f \#) \quad v=P_{1}(\tau \otimes \delta)(f) \quad v
$$

By irreducibility of $\tau,(\tau \otimes \delta)\left(C_{c}(G \times K)\right) \quad v$ is a dense subspace of $H(\tau \otimes \delta)$. Hence, since $H_{1}(\tau \otimes \delta)$ is finite dimensional,

(\tau \otimes \delta)(A) v=P_{1}(\tau \otimes \delta)\left(C_{c}(G \times K)\right) v=H_{1}(\tau \otimes \delta)
$$

Thus $\tau \otimes \stackrel{\vee}{\delta}$ is an irr. rep of the commutative algebra $A$ on $H_{1}(\tau \otimes \hat{\delta})$, so $H_{1}(\tau \otimes \vee)$ has dimension 1.

For the proof of the second statement note that, for $f$ in $C_{c}(G \times K)$ and $v$ in $H_{1}(\tau \otimes \delta)$ with $\|v\|=1$, we have

$$

Finally the third statement follows from the observation that

f \in C_{c}(G)
\end{array}

The function $\operatorname{tr} \tau_{\delta \delta}($.$) is called a spherical trace function of type \delta$. The theory of these functions goes back to GODEMENT [5].

COROLLARY 1.7. Let $\delta \in \hat{K}$ and Let $I_{c, \delta}(G)$ be commutative. Let $\sigma$ and $\tau$ be irr. $K$-unitary reps of $G$ in which $\delta$ has finite nonzero multiplicity. Then $\sigma \approx \tau$ iff the corresponding characters on $I_{c, \delta}(G)$ (or $I_{c, \delta}^{\infty}(G)$ if $G$ is a Lie group) defined by (1.7) coincide.

PROOF. Use Theorem 1.5 and Prop. 1.6.
The pair ( $G, K$ ) is called a Gelfand pair if the algebra $C_{c}(K \backslash G(K)$ is commutative.

COROLLARY 1.8. If $\left(G \times K, K^{*}\right)$ is a Gelfand pair then each irr. K-finite Hilbert rep of $G$ is K-multiplicity free.

PROOF. Use Prop. 1.6 and the correspondence between $C_{c}\left(K^{*} \backslash G * K / K^{*}\right)$ and $I_{c}(G)$.

## 2. THE GENERALIZED ABEL TRANSFORM

Let us restrict attention now to the case that $G$ is a noncompact connected real semisimple Lie group with finite center and that $K$ is a maximal compact subgroup of $G$. Choose subgroups $A$ and $N$ of $G$ such that $G=$ KAN is an Iwasawa decomposition of $G$ and let $g$ in $G$ be accordingly factorized as

\mathrm{g}=\mathrm{u}(\mathrm{~g}) \mathrm{e}^{\mathrm{H}(\mathrm{~g})_{\mathrm{n}}(\mathrm{~g})} \tag{2.1}
\end{equation*}
$$

where $H(g) \in a$, the Lie algebra of $A$. Let $M$ be the centralizer of $A$ in $K$. For $\xi$ in $\hat{M}$ and $\lambda$ in $a_{c}^{*}$ (the complex linear dual of $a$ ) we define the principal series rep $\pi_{\xi, \lambda}$ as the rep of $G$ induced by the rep

$$
\operatorname{man} \mapsto e^{\lambda(\log a)} \xi(m), m \in M, a \in A, n \in N
$$

of the subgroup MAN of $G$. Let $n$ be the Lie algebra of $N$ and let $\rho$ in $a$ be defined by $\rho(H):=\frac{1}{2} \operatorname{tr}\left(\left.\operatorname{adH}\right|_{n}\right), H \in a$. In the compact picture the rep $\pi_{\xi, \lambda}$ is realized on the Hilbert space $L_{\xi}^{2}(K ; H(\xi))$ consisting of all $H(\xi)$-valued $L^{2}$ - functions $f$ on $K$ such that $f(k m)=\xi\left(m^{-1}\right) f(k), k \in K, m \in M$. Then

$$
\begin{align*}

The rep $\pi_{\xi, \lambda}$ is a $K$-finite Hilbert rep of $G$.
We would like to attempt a global approach to HARISH-CHANDRA's [7, Theorem 4], [8, Theorem 4] subquotient theorem:

THEOREM 2.1. Every K-finite irr. Hilbert rep of $G$ is Naimark equivalent to some irr. subquotient rep of some principal series rep.

Choose a Haar measure dn on N. For $f$ in $I_{c, \delta}^{\infty}(G)(\delta \in \hat{K})$ define

PROOF. The proof of (i) is straightgorward. See [13, Theorem 5.17]for the proof of (ii) and WARNER [27, §6.2.2] for the proof of (iii). Combination of (ii) and (iii) proves (v). Let us prove (iv). From WALLACH [25, Lemma 8.3.11] we have

CORALLARY 2.3. If $\left(\mathrm{K} \times \mathrm{M}, \mathrm{M}^{\star}\right)$ is a Gelfand pair then ( $\mathrm{G} \times \mathrm{K}, \mathrm{K}^{*}$ ) is a Gelfand pair, $\mathrm{I}_{\mathrm{c}, \delta}^{\infty}(\mathrm{G})$ is a commutative algebra and $\delta$ is $M-m u z t i p l i c i t y$ free for each $\delta$ in $\hat{K}$, and each irr. K-finite Hilbert rep of $G$ is K-multiplicity free.

PROOF. Use Cor. 1.8 and Theorem 2.2 (v).
In the following examples $\left(K \times M, M^{*}\right)$ and (hence) ( $G \times K, K^{*}$ ) are Gelfand pairs:

Note that the cases $G=S L(2, \mathbb{R})$, $S_{0}(2,1), S U(1,1)$ are locally isomorphic and also $G=\operatorname{SL}(2, \mathbb{C}), S O_{o}(3,1)$. Since, under the assumption that $\left(G \times K, K^{*}\right)$ is a Gelfand pair, each finite-dimensional irr. rep of $G$ is $K-m u l t i p l i c i t y ~$ free, it follows from KRÄMER [17] that almost all cases with ( $\mathrm{K} \times \mathrm{M}, \mathrm{M}^{*}$ ) being a simple linear Lie group occur is the above table.

We can now formulate the program for a global approach to HarishChandra's subquotient theorem:
(a) Let $\delta \in \hat{K}$ such that $\delta$ is $M$-multiplicity free. Let $A_{\delta}$ be the image of $\mathrm{I}_{\mathrm{c}, \delta}^{\infty}(\mathrm{G})$ under $\mathrm{f} \rightarrow\left\{\mathrm{F}_{\mathrm{f}, \xi}^{\delta}\right\}$ and provide $A_{\delta}$ with the topology which makes this transform an homeomorphism. Determine $A_{\delta}$ completely, also topologically, and prove that each continuous character on $A_{\delta}$ has the form

for some $\xi$ in $M_{M}(\delta), \lambda$ in $a_{c}^{*}$. Then in view of (2.10) and Cor. 1.7, we conclude that each irr. K-unitary rep $\tau$ in which $\delta$ has finite nonzero multiplicity is Naimark related to an irr. subquotient rep (namely the
one containing $\delta$ ) of some $\pi_{\xi, \lambda}$ •
(b) In particular, study $\left.\left.f\right|_{M A} ^{\leftrightarrow F_{f}}\right|_{M \times A}\left(f \in I_{c, \delta}^{\infty}(G)\right)$ as a "classical" integral transform (i.e., as an integral transform given in analytic form without group variables) and determine its inversion formula.

Clearly, $\delta$ is M-multiplicity free if $\delta=1$ (the spherical case). Then $I_{c, \delta}^{\infty}(G)=C_{c}^{\infty}(K \lambda G / K)$. Its image under the generalized Abel transform is known by GANGOLLI's [3] Paley-Wiener theorem: the space of all Weyl group invariant $C^{\infty}$-functions on $A$ with compact support. However, part (b) of the above program in the spherical case has been done only in the rank one case. Then $\mathrm{f} \mapsto \mathrm{F}_{\mathrm{f}}$ can be written as a Weyl type fractional integral transform or a composition of two such transforms (cf. KOORNWINDER [11]).

The above programs has been completed for all $\delta$ in the case $G=\operatorname{SL}(2, \mathbb{R})$ (cf. KOORNWINDER [13], [14], TAKAHASHI [20]). Then $A=\left\{a_{t}:=\left(\begin{array}{ll}e^{t} & 0 \\ 0 & e^{-t}\end{array}\right)\right\}$,

The correspondences $\mathrm{f} \leftrightarrow \mathrm{f}]_{\mathrm{A}} \leftrightarrow \mathrm{F}_{\mathrm{f}}$ identify the spaces $\mathrm{I}_{\mathrm{c}, \delta}^{\infty}(\mathrm{G}), \mathcal{D}_{\text {even }}(\mathbb{R})$ and $\mathcal{D}_{\text {even }}(\mathbb{R})$, respectively, with each other. Note that in ${ }^{n}$ the spherical case ( $n=0$ ) the pair (2.12), (2.14) becomes the classical Abel transform together with its inversion formula (cf. GODEMENT [6]). There are three dif-
ferent proofs that (2.14) is the inversion formula to (2.12).
(i) by Me1lin transform techniques (cf. MATSUSHITA [18]);
(ii) by specializing the inversion formula for the Euclidean Radon transform on $\mathbb{R}^{2}$ to functions which behave according to rep $\delta_{n}$ of $S O(2)$ (cf. DEANS [2]);
(iii) by using generalized fractional integrals (cf. KOORNWINDER [13, §5.9]).
3. SL $(2, \mathbb{C})$, DISCUSSION OF EARLIER RESULTS

Let us now try to deal with the generalized Abel transform for $\operatorname{SL}(2, \mathbb{C})$ in the same spirit as for $S L(2, \mathbb{R})$ above. A global approach to the representation theory of $\operatorname{SL}(2, \mathbb{C})$ can already be found in NAIMARK [19]. He determined irreducibility properties of principal series reps by using Theorem 1.2 (cf. [19, Ch. 3, §9, no. 15]) and he used the generalized Abel transform for proving the subquotient theorem 2.1 (ibidem, no. 16). (In fact, he considered the generalized Abel transform not on the algebras $I_{c, \delta}^{\infty}$ (G) but on certain algebras denoted by $X_{j}^{k}$ which are isomorphic to them (ibidem, no. 6).) However, there are certain unsatisfactory points in his approach: (i) the formula for the generalized Abel transform is not very explicit (cf. ibidem, no. 10, formula (1)), with integration variables defined in an implicit way; (ii) the inversion formula (ibidem, no. 10, formula (9)) is derived by using the Plancherel formula; (iii) the image under the generalized Abel transform is not completely characterized (ibidem, no. 10, IV) but a subalgebra of the image is obtained which is big enough to prove that the characters on it have the desired form. See BRUMMELHUIS [1] for a more detailed discussion of Naimark's approach.

KOSTERS [16] studied irreducibility, Naimark equivalence and unitarizability for subquotients of the principal series of $\operatorname{SL}(2, \mathbb{C})$ by using the global methods developed in [13], but he did not give a global approach to the subquotient theorem 2.1.

Finally, a helpful reference to us was WANG [26], who derived a PaleyWiener theorem characterizing the image of the algebras $I_{c, \delta}^{\infty}(S L(2, \mathbb{C}))$ under the group Fourier transform. Indeed, his result is equivalent to characterizing the image under the generalized Abel transform.
4. $\operatorname{SL}(2, \mathbb{C})$, PRELIMINARIES

Let us fix an Iwasawa decomposition $G=\operatorname{KAN}$ for $G=\operatorname{SL}(2, \mathbb{C})$ with

A model for the representation space of $T^{\ell}$ is given by the space $H_{\ell}$ of homogeneous polynomials of degree $2 \ell$ in two complex variables with orthonormal basis consisting of the functions $\psi_{n}^{\ell}(n=-\ell,-\ell+1, \ldots, \ell)$ :

From this one can obtain an explicit expression for $t_{m n}^{\ell}(k)$ in terms of Jacobi polynomials A more detailed account of the representation theory of SU(2) is, for instance, given in VILENKIN [24, Ch. III].

We will need two special functions associated with the reps $\mathrm{T}_{\ell}$. First, for the character $X_{\ell}$ of $T_{\ell}$ we have

There is some similarity of formula (6.3) with the formula in MATSUSHITA [18, p. 115] which is obtained by taking Mellin transforms at both sides of (2.12). Matsushita could invert his formula and thus, by taking inverse Mellin transforms, obtain (2.14). We did not succeed in inverting (6.3). However, we can prove:

REMARK 6.6. The proof of the inversion formula (6.7) uses the group theoretic property that the generalized Abel transform is an homomorphism with respect to convolution. We did not succeed in finding a direct analytic proof for the inversion formula.

REMARK 6.7. Prop. 6.4 implies that $f \mapsto \mathrm{~F}_{\mathrm{f}}$ is injective on $\mathrm{I}_{\mathrm{c}, \ell}^{\infty}(\mathrm{G})$, which we already knew from Theorem 2.2 (ii).

COROLLARY 6.8. If $\mathrm{f} \in \mathrm{I}_{\mathrm{c}, \ell}^{\infty}(\mathrm{G})$ then

The above corollary immediately implies the Plancherel formula for SL( $2, \mathbb{C}$ ). This formula was first obtained by GELFAND \& NAIMARK [4], see also the very readable proof (for $\mathrm{SO}_{\mathrm{o}}(3,1)$ ) in TAKAHASHI [21].

## 7. CHARACTERIZATION OF THE IMAGE OF THE GENERALIZED ABEL TRANSFORM

Let $A_{l}$ denote the image of $I_{c, \ell}^{\infty}(G)$ under the transform $\underset{\infty}{f} \leftrightarrow F$. We already know that all $F$ in $A_{l}$ have the form (5.5) with $F_{j}$ in $C_{c}^{\infty}(\mathbb{R})$ and that

F satisfies the symmetry (5.12). Now we will derive an additional condition satisfied by each $F$ in $A_{\ell}$.

PROPOSITION 7.1. If $F \in A_{l}$ then

Now observe that $\lambda \rightarrow \hat{\mathrm{F}}(2 \mathrm{j}, 2 i \lambda)$ is rapidly decreasing $(j \in\{-\ell,-\ell+1, \ldots, \ell\})$, since $F \in C_{c}^{\infty}([0,2 \pi] \times \mathbb{R})$, and that, by (2.11), all partial derivatives w.r.t. $g$ of the function
$(\lambda, g) \mapsto \operatorname{tr} \pi_{j}, i \lambda ; \ell, \ell(g)$ exist and are of polynomial growth in $\lambda$. Hence (7.5) defines a function $f$ in $C^{\infty}(G)$. Next, $f$ is invariant under K-conjugation and behaves like the rep $\mathrm{T}_{\ell}$ of K because of similar properties of the
function $g \rightarrow \operatorname{tr} \pi_{j, i \lambda ; \ell, \ell}(\mathrm{g})$. Thus f will have the form (5.2). Finally, since ${ }_{\mid}{ }_{\text {MA }}$ has compact support because of (7.4), we conclude that $f$ has compact support on G. Hence $f \in I_{c, \ell}^{\infty}(G)$.

Next we want to prove that $F \rightarrow E_{F}$ is injective on $B_{\ell}$. For this we need: THEOREM 7.4.

& \pi_{j, \lambda} \simeq \tau_{\lambda, j}, \pi_{j, \lambda} \simeq \tau_{-\lambda,-j}(|j|-|\lambda| \in \mathbb{N}) .
\end{aligned}
$$

PROOF. The matrix element $\pi_{j, \lambda} ; \ell_{1}, \ell_{2} ; \ell_{2}, \ell_{2}\left(a_{t}\right)\left(\ell_{1} \geq \ell_{2}\right)$ can be easily evaluated in terms of $a_{2} F_{1}$ hypergeometric function (cf. KOSTERS [16, (3.11)]). This shows that, if $\pi_{j, \lambda ; \ell_{1}, \ell_{2}}=0$ then $|\lambda|-|j| \in \mathbb{N}$ and $\ell_{1} \geq|\lambda|, \ell_{2}<|\lambda|$ or $\ell_{1}<|\lambda|, \ell_{2} \geq|\lambda|$. Thus, by Theorem $1.2, \pi_{j, \lambda}$ is irr. if $|\lambda|-|j| \notin \mathbb{N}$ and $\pi_{j, \lambda}$ has at most the irr. subquotient reps $\sigma_{j, \lambda}$ and ${ }^{\tau_{j, \lambda}}$ if $|\lambda|-|j| \in \mathbb{N}$. However, by (7.2) and Theorem 1.5 it follows that ${ }^{\tau}{ }_{j, \lambda}(|\lambda|-|j| \in \mathbb{N})$ is indeed an irr. rep being Naimark equivalent to the irr. rep $\pi_{\lambda, j}$. This settles (a). The other equivalences in (b) follow from the evident identity

$$
\operatorname{tr} \pi_{j, \lambda ; \ell, \ell}\left(m_{\phi}{ }_{w}\right)=\operatorname{tr} \pi_{-j,-\lambda ; \ell, \ell}{ }^{\left(m_{\phi} a_{w}\right)},
$$

together with Theorem 1.5. Finally, to prove that this exhausts the possible Naimark equivalences, observe:

$$
\pi_{j_{1}}, \lambda_{1} ; \ell, \ell ; \ell, \ell=\pi_{j_{2}}, \lambda_{2} ; \ell, \ell ; \ell, \ell \Rightarrow \lambda_{1} j_{1}=\lambda_{2} j_{2}
$$

(cf. KOSTERS [16, p. 16]).

The above proof simplifies the proof by KOSTERS [16] because of our new proof of (7.2). The above proof that $\pi_{j, \lambda}$ is irr. if $|\lambda|-|j| \notin \mathbb{N}$ also occurs in NAIMARK [19, Ch. 3, §9, no. 15].

PROPOSITION 7.5. The mapping $\mathrm{F} \rightarrow \mathrm{E}_{\mathrm{F}}: \mathrm{B}_{\ell} \rightarrow \mathrm{I}_{\mathrm{c}, \ell}^{\infty}(\mathrm{G})$ is injective.
PROOF. Suppose $\mathrm{F}_{1} \in \mathrm{~B}_{\ell}, \mathrm{f}_{1}:=\mathrm{E}_{\mathrm{F}_{1}}=0, \mathrm{f}_{2} \in \mathrm{I}_{\mathrm{c}, \ell}^{\infty}(\mathrm{G}), \mathrm{F}_{2}:=\mathrm{F}_{\mathrm{f}_{2}}$ then

$$
\int_{0}^{2 \pi} \int_{-\infty}^{\infty}\left(\frac{\partial^{2}}{\partial \tau^{2}}+\frac{\partial^{2}}{\partial t^{2}}\right) F_{1}(\tau, t) F_{2}(\tau, t) d \tau d t=0
$$

To see this, substitute formula (5.11) with $f=f_{2}$ into the left hand side for $\mathrm{F}_{2}$ and interchange the order of integration. Substitution of (5.16) into the above formula and application of (5.12) yields:

$$
\sum_{j} \int_{0}^{\infty} \hat{F}_{1}(2 j, 2 i \lambda) \hat{F}_{2}(2 j, 2 i \lambda)\left(\lambda^{2}+j^{2}\right) d \lambda=0
$$

Let $\hat{A}_{\ell}$ denote the set of functions $\hat{F}$ on $\{-2 \ell,-2 \ell+2, \ldots, 2 \ell\} \times i[0, \infty)$ for which $F \in A_{l}$. One easily verifies that $\hat{A}_{\ell}$ is an algebra under pointwise multiplication, consisting of continuous functions $\hat{F} w h i c h$ satisfy $\hat{F}(2 j, 2 i \lambda) \rightarrow 0$ as $\lambda \rightarrow \infty$, and that $\hat{A}_{\ell}$ is closed under complex conjugation. Next, $\hat{A}_{\ell}$ separates points. Indeed, if $\widehat{F}\left(2 j_{1}, 2 i \lambda_{1}\right)=\widehat{F}\left(2 j_{2}, 2 i \lambda_{2}\right)$ for all $\hat{F} \in \hat{A}_{\ell}$ then

$$
\operatorname{tr} \pi_{j_{1}, i \lambda_{1}} ; \ell, \ell(g)=\operatorname{tr} \pi_{j_{2}, i \lambda_{2}} ; \ell, \ell(\mathrm{g})
$$

because of (5.17) and Lemmas $5.3,5.4$, so $\left(j_{1}, i \lambda_{1}\right)=\left(j_{2}, i \lambda_{2}\right)$ by Theorems 7.4 (b) and 1.2. Finally, another application of (5.17) and Lemmas 5.3, 5.4 shows that no $(2 j, 2 i \lambda)$ is annihilated by all $\hat{F} \in \hat{A}_{l}$. Thus, by the version of the Stone-Weierstrass theorem for a locally compact Hausdorff space (cf. SIMMONS [23, §38, Theorem B]), each continuous function on
$\{-2 \ell, \ldots, 2 \ell\} \times i[0, \infty)$ vanishing at $\infty$ can be uniformly approximated by functions in $\hat{A}_{\ell}$. In particular, the (rapidly decreasing) function $\hat{\mathrm{F}}_{1}$ can be uniformly approximated by functions $\hat{\mathrm{F}}_{2} \in \hat{\mathrm{~A}}_{\ell}$, so

$$
\sum_{j} \int_{0}^{\infty}\left|\hat{F}_{1}(2 j, 2 i \lambda)\right|^{2}\left(\lambda^{2}+j^{2}\right) d \lambda=0 .
$$

This shows that $\mathrm{F}_{1}=0$ 。
Define $\widetilde{B}_{\ell}$ to be the algebra of all functions in $\mathcal{D}\left(\mathbb{R} ; \mathbb{C}^{2 \ell+1}\right)$ such that
(i) $F_{j}(-t)=F_{-j}(t), j=-\ell,-\ell+1, \ldots, \ell$,
(ii) $\int_{-\infty}^{\infty} F_{j}(t) e^{-2 k t} d t=\int_{-\infty}^{\infty} F_{k}(t) e^{-2 j t} d t, j, k=-\ell,-\ell+1, \ldots, \ell$,
with componentwise convolution as multiplication, and the topology inherited from $D\left(\mathbb{R} ; \mathbb{C}^{2 \ell+1}\right)$. Note: $\widetilde{B}_{\ell}$ and $B_{l}$ are isomorphic as vector spaces under the mapping $F \mapsto\left\{F_{j}\right\}$ defined by (5.5). From (5.1) and (5.3) we have:

$$
\begin{equation*}
F_{f, j}^{\ell}(t):=(2 \pi)^{-1} e^{2 t} \int_{K} \int_{\mathbb{R}} \int_{\mathbb{R}} f\left(k a_{t^{n}}{ }_{x+i y}\right) t_{j j}^{\ell}\left(k^{-1}\right) d k d x d y \tag{7.6}
\end{equation*}
$$

Now we arrive at the main theorem:
THEOREM 7.6. The mapping $\mathrm{f} \rightarrow\left\{\mathrm{F}_{\mathrm{f}, \mathrm{j}}^{\ell}\right\}: \mathrm{I}_{\mathrm{c}, \ell}^{\infty}(\mathrm{G}) \rightarrow \widetilde{\mathrm{B}}_{\ell}$ is an isomorphism of topoZogical algebras.

PROOF. The mapping is an injective continuous algebra homomorphism by Theorem 2.2 and it is surjective by Proposition 7.3 and 7.5. The only thing left to prove is that the inverse $E: B_{\ell} \rightarrow^{\rightarrow} I_{c, \ell}^{\infty}(G)$ is continuous. This is done as follows. Denote by $\|g\|(g \in S L(2, \mathbb{C}))$ the operator norm of $g$ acting on the Hilbert space $\mathbb{C}^{2}$. The elements of $K(=S U(2))$ have norm 1 , so, if $g=k_{1} a_{t} k_{2}$ then $\|g\|=\left\|a_{t}\right\|=\max \left\{e^{t}, e^{-t}\right\}$. If $R>0$ then let $I_{c, \ell ; R}^{\infty}(G)$ denote the space of functions in $I_{c, \ell}^{\infty}(G)$ which vanish on all $g$ in $G$ with logll $g \|>R$; similary, let $B_{l ; R}$ consist of all functions in $B_{l}$ with support included in $[0,2 \pi) \times[-R, R]$. Let $f \in I_{c, \ell}^{\infty}(G), R>0$. In view of (5.2), (5.11) and (7.4) we have:

$$
f \in I_{c, \ell ; R}^{\infty}(G) \Longleftrightarrow \operatorname{Suppf}_{\mid M \times A} \subset[0,2 \pi) \times[-R, R] \Longleftrightarrow F_{f} \in B_{\ell ; R}
$$

so $f \mapsto F_{f}: I_{c, \ell ; R}^{\infty}(G) \rightarrow B_{\ell ; R}$ is a continuous linear bijection with inverse $\left.E\right|_{B_{l ; R}}$. Because of the open mapping theorem for Fréchet spaces (cf. RUDIN $\left[22 ; R_{\infty}\right.$ Cor. 2.12(b)]), $E: B_{\ell ; R}(G) \rightarrow I_{c, \ell ; R}^{\infty}(G)$ is also continuous. Since $I_{c, \ell}^{\infty}(G)=$ $\mathrm{U}_{\mathrm{R}>0} \mathrm{I}_{\mathrm{c}, \ell ; \mathrm{R}}^{\infty}(G)$, endowed with inductive limit topology, and similary for $B_{\ell}$, we conclude that $E: I_{c, ~}^{\infty}{ }^{(G)} \rightarrow B_{\ell}$ is continuous.
8. THE SUBQUOTIENT THEOREM FOR $\operatorname{SL}(2, \mathbb{C})$.

In order to derive the subqoutient theorem from Theorem 7.6 we have to find all continuous characters on $\widetilde{B}_{\ell^{a}}$ As a preparation we need two lemmas. Identify $\left\{F_{j}\right\}$ in $\widetilde{B}_{l}$ with $F$ in $B_{l}$ by means of (5.5). Thus (5.15) can be rewritten as

$$
\begin{equation*}
\hat{F}(2 j, 2 \lambda)=d_{\ell} \int_{-\infty}^{\infty} F_{j}(t) e^{-2 \lambda t} d t \tag{8.1}
\end{equation*}
$$

and $\mathrm{F} \mapsto \mathrm{d}_{\ell}^{-1} \widehat{\mathrm{~F}}(2 j, 2 \lambda)$ defines a continuous character on $\widetilde{B}_{\ell}$ for each $j$ $j$ in $\{-\ell,-\ell+1, \ldots, \ell\}, \lambda$ in $\mathbb{C}$.

LEMMA 8.1. Let

$$
\widetilde{B}_{\ell, 0}:=\left\{F \in \widetilde{B}_{\ell} \mid \hat{F}(2 p, 2 q)=0 \text { for } p, q=-\ell,-\ell+1, \ldots, \ell\right\}
$$

Then $\widetilde{B}_{\ell_{j} 0}$ is a closed subalgebra of $\widetilde{B}_{\ell}$ and every nonzero continuous character on $\widetilde{B}_{\ell, 0}$ has the form $F \mapsto d_{\ell}^{-1} \widehat{F}(2 j, 2 \lambda)$ for some $j$ in $\{-\ell, \ldots, \ell\}, \lambda$ in $\mathbb{C}$.

PROOF. See NAIMARK [19, Ch. 3, §9, no. 13]. The lemma is easily reduced to the two problems of finding all nonzero continuous characters on the convolution algebras $\mathcal{D}(\mathbb{R})$ and $D_{\text {even }}(\mathbb{R})$, respectively. In both cases these are of the form $f \mapsto \int_{\mathbb{R}} f(t) e^{-\lambda t} d t$ for some $\lambda$ in $\mathbb{C}$ (see also [13, Prop. 5.6]).

The next lemma is also given by NAIMARK, see [19, Ch. 3, §9, no. 14], but there is an error in his proof, so we will give here the full correct proof.

LEMMA 8.2. Let $A$ be an algebra, $f, g, f_{1}, \ldots, f_{n}$ multiplicative Zinear functionals on $A, A_{0}:=\left\{x \in A \mid f_{1}(x)=\ldots=f_{n}(x)=0\right\},\left.f\right|_{A_{0}}=\left.g\right|_{A_{0}}$. Then
$\mathrm{f}=\mathrm{g}$ or $\mathrm{f}=\mathrm{f}_{\mathrm{k}}$ for some k in $\{1, \ldots, \mathrm{n}\}$ or $\mathrm{f}=0$.

PROOF. Without loss of generality we may assume that the $f_{i}$ 's are linearly independent. By a simple inductive argument we can find $x_{k}$ in $A(1 \leq k \leq n)$ such that $f_{j}\left(x_{k}\right)=\delta_{j k}(1 \leq j, k \leq n)$. If $x \in A$ then $x-\sum_{j=1}^{n} f_{j}(x) x_{j} \in A_{0}$, so

$$
f(x)-\sum_{j=1}^{n} f_{j}(x) f\left(x_{j}\right)=g(x)-\sum_{j=1}^{n} f_{j}(x) g\left(x_{j}\right)
$$

On putting $\alpha_{j}:=f\left(x_{j}\right)-g\left(x_{j}\right)$ we see that

$$
\begin{equation*}
f(x)=g(x)+\sum_{j=1}^{n} \alpha_{j}{ }^{f}(x) \tag{*}
\end{equation*}
$$

Substitution of $x=y x_{k}$ with $y$ in $A_{0}$ yields,

$$
f(y) \alpha_{k}=0 \quad\left(y \in A_{0}, 1 \leq k \leq n\right)
$$

Now there are two possibilities:
(i) $\alpha_{k}=0$ for a11 $k$. Then $f=g$ by ( $*$ ).
(ii) $\alpha_{k} \neq 0$ for some $k$. Then $\left.f\right|_{A_{0}}=0$ and
$(* *) f(x)=\Sigma_{j} f_{j}(x) f\left(x_{j}\right)$.
If $f \neq 0$ then $f\left(x_{\ell}\right) \neq 0$ for some $\ell$ and (**) with $x=x_{\ell} x_{i}$ will yield $f\left(x_{\ell}\right) f\left(x_{i}\right)=\delta_{\ell i} f\left(x_{\ell}\right)$. So $f\left(x_{i}\right)=\delta_{i \ell}$ and $f=f_{\ell}$.

PROPOSITION 8.3. Each nonzero continuous character on $\tilde{B}_{l}$ has the form $\mathrm{F} \mapsto \mathrm{d}_{\ell}^{-1} \hat{\mathrm{~F}}(2 j, 2 \lambda)$ for some $j$ in $\{-\ell,-\ell+1, \ldots, \ell\}$ and some $\lambda$ in $\mathbb{C}$.

PROOF. Let $x$ be a nonzero continuous character on $\widetilde{B}_{\ell}$. Then $\chi_{0}:=\left.\chi\right|_{\widetilde{B}_{\ell, 0}}$ is a continuous character on $\widetilde{B}_{\ell, 0^{\circ}}$. It follows from Lemma 8.1 that $x_{0}=0{ }_{0} \ell_{0} 0$ $x_{0}(F)=d_{\ell}^{-1} \widehat{F}(2 j, 2 \lambda)\left(F \in \widetilde{B}_{\ell, 0}\right)$ for some $j$ in $\{-\ell,-\ell+1, \ldots, \ell\} \lambda$ in $\mathbb{C}$. Now apply Lemma 8.2 with $f=x_{0}$ and $g: F \mapsto d_{l}^{-1} \hat{F}(2 j, 2 \lambda)$, Then

$$
\begin{aligned}
& x(F)=d_{\ell}^{-1} \widehat{F}(2 j, 2 \lambda)\left(F \in \widetilde{B}_{\ell}\right) \text { or } \chi(F)=d_{\ell}^{-1} \widehat{F}(2 p, 2 q) \\
& \left(F \in \widetilde{B}_{\ell}\right) \text { for some } p, q \text { in }\{-\ell,-\ell+1, \ldots, \ell\}
\end{aligned}
$$

THEOREM 8.4 (subquotient theorem for $\operatorname{SL}(2, \mathbb{C})$ ).
Let $\mathrm{G}=\mathrm{SL}(2, \mathbb{C}), \mathrm{K}=\mathrm{SU}(2)$. Then every K -finite irr. Hilbert rep of G is Naimark equivalent with an irr. subquotient rep of a principal series rep. PROOF. Use Theorems 1.5, 2.2 (iv), 7.6 and Propositions 1.6 and 8.3.

## 9. FURTHER REMARKS

Obviously, Theorem 7.6 together with (5.17) and the Paley-Wiener theorem for the classical Fourier transform yields a characterization of the image of $I_{c, \ell}^{\infty}(G)$ under the group Fourier transform. This provides a new proof of the Paley-Wiener theorem in WANG [26, Prop. 4.5].

Next we state without proof a characterization of functions $f$ in $I_{c, \ell^{\infty}}^{(G)}$ in terms of functions $f_{m}$.

PROPOSITION 9.1. Formula (5.2) together with

$$
\begin{equation*}
\phi_{\mathrm{n}}(\mathrm{w})(\mathrm{sh} w)^{\ell+\mathrm{n}}(\mathrm{ch} w)^{\ell-\mathrm{n}}=\sum_{\mathrm{m}} \frac{\mathrm{t}_{\mathrm{mn}}^{\ell}\left(\mathrm{u}_{\pi / 4}\right) \mathrm{f}_{\mathrm{m}}(\mathrm{w})}{(\ell-\mathrm{m})!(\ell+\mathrm{m})!)^{\frac{1}{2}}} \tag{9.1}
\end{equation*}
$$

defines a one - to - one correspondence $\mathrm{f} \leftrightarrow\left(\phi_{-\ell}, \phi_{-\ell+1}, \ldots, \phi_{\ell}\right)$ between $I_{c, \ell}^{\infty}(G)$ and $\left(C_{c, \text { even }}^{\infty}(\mathbb{R})\right)^{2 \ell+1}$.

Finally, we would like to remark that similar results as in this paper for $\operatorname{SL}(2, \mathbb{C})$ can be derived for the corresponding Cartan motion group $\operatorname{SU}(2) \circ \mathbb{R}^{3}$. Let $G$ be a noncompact connected real semisimple Lie group with finite center, $K$ a maximal compact subgroups, $g$ and $k$ the corresponding Lie algebras, and $g=k+p$ a Cartan decomposition of $g$. Consider the semidirect product $K \circ p$, where $K$ acts on $p$ by Ad. Let $a$ be a maximal abelian subspace of $p, a^{\perp}$ the orthoplement of $a$ in $p$ w.r.t. the Killing form $B$ on $g$. For $\delta$ in $\hat{K}$ let $I_{c, \delta}^{\infty}(G)$ be defined as in (2.3), (2.4). Then the analogue for $K \circ p$ of the generalized Abel transform (2.3) becomes

$$
\begin{equation*}
\mathrm{F}_{\mathrm{f}}(\mathrm{k}, \mathrm{H}):=\int_{a^{\perp}} \mathrm{f}(\mathrm{k}, \mathrm{H}+\mathrm{Y}) \mathrm{dY}, \mathrm{k} \in \mathrm{~K}, \mathrm{H} \in a, \mathrm{f} \in \mathrm{I}_{\mathrm{c}, \delta}^{\infty}(\mathrm{G}) \text {. } \tag{9.2}
\end{equation*}
$$

Now it can be proved that, if $G=S L(2, \mathbb{C}), f \in I_{c, \ell}^{\infty}(K \circ p)$ and $a=\mathbb{R} H_{0}$ then

$$
\begin{align*}
& \mathrm{F}_{\mathrm{f}}\left(\mathrm{~m}_{\tau}, \mathrm{tH} \mathrm{H}_{0}\right)=\text { const } \cdot \int_{0}^{2 \pi} \int_{\mathrm{t}}^{\infty} \mathrm{f}\left(\mathrm{~m}_{\phi}, \mathrm{wH}_{0}\right)  \tag{9.3}\\
& \cdot \mathrm{U}_{2 \ell}\left(\cos \phi \cos \tau+\sin \phi \sin \tau \frac{\mathrm{t}}{\mathrm{w}}\right) \mathrm{d} \phi \mathrm{wdw}
\end{align*}
$$

Compare this formula with (5.11).
