Near Mr. Johnson: I have been here for a week, taking care of a man whom I found here injured while at work on a bridge and unable to help how self. Yesterday I went to the Valley for mail, and recid your note of the 3d. I also found that a Mr. newsham, a representative by the Interior Dept, had arrived on Sunday, coming to the Valley with Henry Washbern in the latter's private buggy. In fact, on my way down to the Valley, I met Mr. newsham coming up the trail with Galen Clark. The latter introduced me to the visitor, but said nothing of his official condition. I learned, however, in The Valley who the stranger was, and Henry Washburn told me that newshain had been inquiring for me. Consequently, as I had to come back here yesterday, I timed myself so that I cought the gentleman at The foot of the trail. I told him that I understood he was from the Interior Defit and that he wanted to speak with me. He said that there was nothing in particular for which he wished to talk with me, but that he had only wanted to make acquaintry

with the people here. I then told him that I would be happy to accompany him around the Valley, and would place myself at his disposal, for a day or a week or whatever time he had at command. He hesitated momentarily and then said that he was going to the Beg Irees today with Mr. Washbeern, That he possibly might come back, and if he should return he would send me word Thirough the. Clark! With that we parted. I had half a mind to go down again to the Valley Kust evening and ask Mr. Newshare waitly what he came here to do or to learn. If he came to see the condition of the Valley he went about it in a queer way. Here arrived on Sunday - The exact hour I have not get learned. Le has left (Ssuppose) This morning He came in with Washburn, could only have had an hour or two on Sunday to see he Valley and yesterday was spent in coming up here, as his return to the Valley was too late to leave him time for any other trep. I at first thought that he might have come about the Little yosenite business, but the young man whom I have been nursing here tells me that Clark and the other could not have gone up he trail further han The head

of the hevada Fall. I will find out about hat today from Clark himself.

Perhaps Mr. newsham's business is not in connection with Josemile mismanagement. Stowever, he gave it out freely in the Valley, and told he young man here, that he had come from The Secretary of the Suterior himself" to see about the national Park. augusy I hink it right that you should know just how he came and whom he was "steered" while here. To me it looks very suspecious that The first representative of the Departmet who shows himself should let hunself be "skeng". by Washburn, The head-center of the ring, and by Clark, The ring's subservent tool. It is suspicious, too, Mar Mr. newshaw did not take a look at sistle yosemete, after the Department's promise to you that that busi ness should be investigated at the carliers practicable moment. Any day now may brug a storm that will prevent approach T ditte yosenick. I hope that you have preserved your correspondence with the Dept on that point. If I get the least ground for believing that The Defit intends to yield to the influence of the yosenite

ring I will tell the story in fruit, and charge hobbe with being a party to the fraud. I would Therefore like to know what you wrote to the Defit and what, and from whom, you were auswered. Of course I don't jump to the conclusion that anything is wrong, but it is well. to be ready for any thing wrong. I heard yesterday that The Canniner has published a letter from me. As I have written none to hear paper, I do not know what the letter can be. I hope to see a copy today. I would have left here last week, had I not found the injured man at his place. as it a week more. I will not go The ranch of which I spoke before, and an therefore wholly uncertain as to my movements. I have no money to take me to any town, but will slift along down either to the Raymend country, where shere is a little house that I can use, or go down to Oakdale. But if you have occasion to unte, address me here until I send other word. Before I leave I hope to finish some writing that will bring in some of The sinews of war. Yours very druly Georgie.

I will write about it to some papier, and send copy to you, so that you can understand. _ hewsham left This afternoon, having visited Clacier Porist with Clark this morning. They could be not have accepted my offer to show him around The Valley? The Ming doesn't look right - that is, if newshaw came to investigate and not on a mere pleasure trip. He told Clark heat he was a particular friend of hobbe, &c. &c. The Examiner's article (referred & above) was a degraphic condensation of my letter & hobbe, The Examiner has an arti coletoral on it, but my words are greatly misnepresented and The whole effect weakened.
