#### I. Minutes.

II. Dr. Kathlene Shank, representing the Teacher Education Steering Committee, discussed tuition-by-the-hour in the context of student teaching. While COTE has approved the requirement that students must complete a semester-long student teaching experience, the number of hours comprised by that semester has not been fixed. At the November 10 COTE meeting, the Steering Committee will present a proposal intended to clarify the number of semester hours required during the student teaching semester and to eliminate inconsistent references in the *Undergraduate Catalog*.
