CURRICULUM COMMITTEE MEETING
March 1, 2000**

The LCBAS Curriculum Committee met on March 1, 2000, at 11:00 a.m. in the Dean's Conference Room.

Members Present: T. Boldrey, M. Brown, S. Farris, K. Ketler, and R. Kopel
Guests: M. Izadi, K. Nantz, and M. Wilkins

The meeting was called to order by M. Brown.

MINUTES

S. Farris (Kopel) moved to approve the minutes of February 16, 2000, as published. Motion carried unanimously.

COMPUTER INFORMATION SYSTEMS MAJOR AND MINOR

M. Wilkins presented the Computer Information Systems (CIS) Major and Minor proposal. This proposal will merge the Administrative Information Systems and Computer Management majors into one major, Computer Information Systems, with four concentrations: Corporate Systems Development, User Systems Management, Telecommunications Systems, and Client/Server Systems. The proposal also includes a CIS Minor. Recruiters, business firms, and alumni were surveyed, and an independent consultant reviewed both programs and made recommendations. This proposal has also been discussed with various campus constituents. The proposed effective date of the CIS program is Fall 2001. After much discussion, a few editorial suggestions were made. M. Izadi stated that the School of Technology is excited about the CIS proposal, especially the CIS Minor and how it will benefit students. He said there is some overlap with Technology courses, but opportunities exist for INT courses to work in with the minor. Technology is planning a concentration in Networking, but their program is different and their concerns have been addressed. The committee commended the faculty in AIS and COM for the excellent job they did in putting forth this proposal. R. Kopel (Farris) moved to place the CIS proposal on the agenda for vote at the next meeting. Motion carried unanimously.
