

Jubel Vincent, 90 years and six months old, died at the home of his daughter, Mrs, Herman Williams, of the Vernal Grove community, at 8 o'clock Monday evening of pneumonia. A funeral service for Mr. Vincent was held at Earlington at 2 o'clock Wednesday afternoon, and burial was in the cemetery at Earlington.

Surviving Mr. Vincent are two daughters, Mrs. Herman Williams of the Vernal Grove community, and Mrs. Leonard Jessup, of Depoy; three sons, Wallace Vincent of Central City; A. L. Vincent, of Pascagoula, Miss., and Peter Vincent, of Pochuta, Miss. Two sons, Lum Vincent and Marcus Vincent, died several years ago.

Mr. Vincent, who served in the Union army in the War Between the States, married Miss Mary Lewis, who died March 7, 1892.

Five Killed in Explosion (Source: The Record Greenville 1-25-1912)

Central City last Wednesday experienced its first serious mine explosion, when five men were killed and the property of the

Central Coal & Iron Co. seriously injured. About 4:30 o'clock, soon after the shot-firers had began their work, the explosion occurred supposedly from the ignition of dust that had been raised by the succession of shots fired in knocking down the coal. This or a "windy shot" is the only thing that could have caused the accident. As every man who was in the mine was killed, it wil never be known just the cause. A fortunate thing was that about 223 men had left the mines a short while before, or the calamity would have been the worst that ever occurred in the state. The dead:

David Doss, unmarried. Ira Allen, widow and two children. Wm. Matthews, widow and two children. Eric Lundquist, a Swede, widow and three children George Ruby, widow and three children.

The deaths caused the greatest sorrow, and the attendance atthe burials was large, and composed of people from all parts of the county.

> Mrs. Emma W. Eades Dies At Age 68 (Source: The Record Greenville 1-11-1912)

Mrs. Emma W. Eades, in her 68th year, died at the home of her husband, Mr. M. L. Eades, about midnight Sunday, following an apoplectic stroke which she suffered about 9:30 o'clock Sunday morning. She did not regain consciousness, and there no hope of recovery from the first. Some Thoughts On Doing Early Muhlenberg County Research

There were pioneers who established temporary or permanent homes in western Kentucky in the 1780s. This being the case, you should direct your efforts backwards in time as you exhaust the records. Proceed in this order because it follows the chronological order of the formation of the depositories of the records:

Muhlenberg County (1798) - Christian County (1796) - Logan County (1792) - Lincoln County (1780) - Kentucky County, Virginia (1777)

Your ancestors could have lived in the same place in Muhlenberg County, but the formation of the counties make it appear they moved around during the 1780s and 1790s. Read what Otto Rothert has to say about early western Kentucky:

"Under the heads of the various counties bordering on Muhlenberg I gather, from *Collins' History of Kentucky*, the data here given relative to their first settlements. About a half-dozen stations were established between 1780 and 1784 in what is now Logan County. Among them was one that, later, became Russellville. In Ohio County the first settlements were Hartford and Barnett's Station, both of which were settled "before 1790." As early as 1794 a trading-post had been established at Berry's Lick, in Butler County. "Hopkinsville was laid out in 1799." The beginning of Madisonville, Morgantown, and Elkton dates back to the first years of the Nineteenth Century. Under the head of McLean County, Collins says: "The first fort or station was built, where Calhoon now stands, in 1788 by Solomon Rhoads, and called Vienna. In 1790 James Inman build Pond Station, a few miles southeast of Calhoon." That Caney Station was what might be regarded as the first settlement in what is now Muhlenberg County is only parenthetically stated by Collins, and without the date of its beginning, which tradition says was about 1795: "One mile north of Greenville, near old Caney Station - which was the first settlement in the county - are several mounds."

From the foregoing statements it will be seen that a few settlements were made in this part of the State as early as 1780, and that most of the places which became permanent settlements were begun during the last few years of the Eighteenth of the first part of the Nineteenth Century.

Tradition does not say who were the first white people to come into what is now Muhlenberg County. It is, however, probable that the first men who made this locality their home were Revolutionary soldiers who wandered westward immediately after that war. Tradition goes no further back than about 1784, to which time a few of the families in the county can trace the arrival of their ancestors.

After Pond Station had been started and after Henry Rhoads began inducing more German-Americans to locate near that station and in other sections of the country, and while Caney Station was being built by Virginians, the inflow of newcomers began to increase rapidly. A number of pioneers from North Carolina and Virginia settled along Pond River. John Dennis and a few other North Carolinians, some of whom probably came as early as 1785, settled in the Pond Creek country. Kincheloe's Bluff or Lewisburg, on Green River, was settled and made a "port of entry" before the close of the Eighteenth Century. It was there that Thomas Irvin and his party of stone-cutters landed about 1797 and helped open up the Nelson Creek country. Stum's Landing, now Paradise, was also a well-known river point as early as 1798. It was during this period of the country's history that the outlaw, Big Harpe, was killed near what has ever since been known as Harpe's Hill.

Jesse McPherson was one of the earliest settlers in the Clifty Creek country. John Hunt and James Wood were among the influential first-comers in the Mud River country. Among the first to settle in the Long Creek country were the Drake, Duke, Welborn, and Wells families.

The first of the early settlers of whom we have any tradition or history were Henry Rhoads and his brothers, who settle Rhoadsville, which later became Calhoun. Of the original party who began this station only a few remained permanently in the immediate neighborhood. Henry Roads was probably the first to leave it. After living a few years near what later became Hartford, Ohio County, he settled in the neighborhood of what is now Browder, Muhlenberg County. In 1790 James Inman left Rhoasville and moved five miles south, where he built Pond Station in the territory which in 1798, became a part of Muhlenberg County, and in 1854, when McLean County was organized, became in turn a part of that county." (Otto A. Rothert, *A History Of Muhlenberg County*, Louisville, KY, 1913)

A Double Dose of Doss

Both of my Grandmothers were born with the same name in Muhlenberg County - yes they were cousins. My grandmothers, Daisy Doss and Ethel Doss, were some kind of cousin but they did not know how they were related. Nathan and I discovered they were both descended through Azariah and Lydia Ayres Doss of Virginia. You see, this makes me my **own cousin** - not an infrequent occurrence in Muhlenberg County. This simplifies my genealogical research somewhat because some of the same ancestors that are on my Dad's side of the family are the same people on my Mother's side of the family! Now it really gets complicated. I am a cousin to my Mother and a cousin to My Father. Wow! That makes me a cousin to my two sisters and they are a cousin to each other. What's more, not only were my Grandmothers cousins to each other, but I am a cousin to each of my Grandmothers. And we didn't even have to leave the county to accomplish this!

When I was twenty two years old I worked for a carpenter and house painter. One week in 1970 we were painting an elderly gentleman's house in Nelson Creek and he asked me how old I was. When I responded I was twenty two he asked if I was married, to which I replied, "no." He then said, "You're twenty two years old and not married. Son, you may have to go out of the county to find a wife." And so I did! The following pedigree charts show how I got a double dose of Doss - my Father is half Doss and my Mother is half Doss - that makes me half Doss. And this is a good place to end this issue.
