Welcome to the November 2015 issue of the KBH Center's Newsletter.

As the fall semester concludes, I am writing to tell you about our many activities. We convened 14 distinguished lectures, seminars, and student networking events. We released the Fall 2015 UT Energy Poll. The poll, now in its fifth year, received extensive media coverage across the country. Students

In addition to offering [law](#) and [business](#) courses in energy, the KBH Center organizes networking events and facilitates mentoring opportunities to help students prepare for future energy careers. In September, Professors Rod Wetsel and Ernest Smith organized a networking event for their students in Texas Wind Law to connect with local wind industry attorneys and professionals. Energy Management students also got the opportunity to network at [Summer NAPE 2015](#) and at [Energy Management Program Industry](#)

Night. On September 23, the McCombs Energy Management Program welcomed 12 companies to its annual Industry Night, where more than 30 company representatives and 50 Energy Management students were able to discuss internship and job opportunities.

The center also organizes field visits for its law and business students to promote active learning. On October 3, McCombs Energy Management students, Masters of Science in Finance students, and Masters of Energy and Earth Resources students participated in a [Student Trek to Dallas](#), where they met with representatives from Hunt Oil Company, Prudential Capital, and Wells Fargo. Next spring, students in the center's [LL.M. Concentration in Energy Law, International Arbitration, and Environmental Law](#) (11 students from 7 different countries) will visit the Sweetwater Wind Farm, one of the largest wind farms in the United States.
