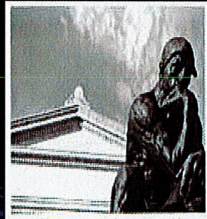

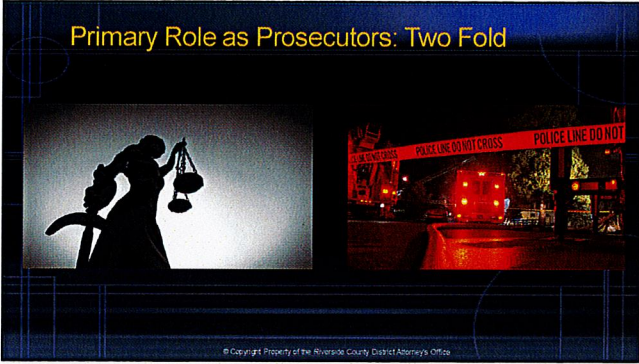

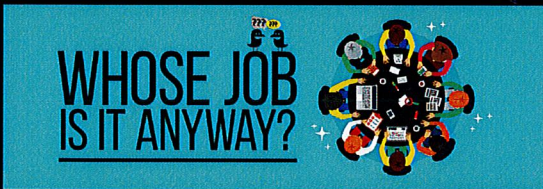

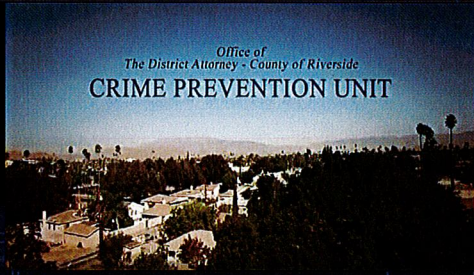
Crime P & I: Not Only Saving People's Lives

Saving People's \$\$\$

- CA Legislative Analyst's Office
 - Each Youth deterred from incarceration in CA
 - Saves **\$180,000** per child in annual incarceration costs
- 1998 Vanderbilt University Study
 - Each teen prevented from adopting a life of crime (including future adult offenses)
 - Saves the public between **1.7 million and 2.3 million** per youth.
