I. INTRODUCTION

Historians, bar officials, and relatives conducting genealogical research frequently ask for pictures of former bar leaders or attorneys. The *North Dakota Law Review* and its predecessors, *Bar Briefs* and *North Dakota Bar Briefs*, have occasionally published photographs within their pages, but no index that allows a searcher to readily find these pictures has ever existed. Traditionally, these photographs were part of the *Law Review's* coverage of State Bar Association of North Dakota (SBAND) events and have been photographs of bar leaders, annual meeting speakers, and judges. Photographs of *Law Review* staff members have also sometimes been included. No photographs, except for ones that accompanied dedications, have been published in the *Law Review* since 1972; photographs of bar leaders and SBAND events now regularly appear in the *Gavel*.

A few issues of the *North Dakota Law Review* have been dedicated to special individuals and these individuals' photographs have been included with the dedications. Issues have been dedicated to one United States Supreme Court Justice, two North Dakota Supreme Court justices, one North Dakota Supreme Court clerk, and ten University of North Dakota School of Law faculty or staff members, including three from the University of North Dakota Thormodsgard Law Library.

The first table contains the names of all individuals with photographs and the location of the photograph. The next is a listing of group photographs and the individuals in those photographs. A table listing all photographs that accompanied dedications follows this. The last table is a listing of photographs of out-of-state speakers at SBAND annual meetings. Names are used as they appear with the photographs, unless there were variations between photographs.
