**Objectives of Presentation:** 

*Recognize* the occupational injustices experienced by survivors of human trafficking and the effect on occupational participation

*Describe* the role of the occupational therapy practitioner in enhancing occupational participation of survivors of human trafficking

Discuss evidence-based interventions within the scope of occupational therapy practice for survivors of human trafficking

PICO: What occupational therapy interventions enhance the occupational engagement for survivors of human trafficking?

## Methods:

- Databases used: PubMed, CINAHL, PsychNet
  - Limits: 2009-2020, peer-reviewed, English only, all levels of evidence
    - P: Human Trafficking, Crime victims, enslavement, modern slavery.
    - I: Occupational therap\*, Trauma and stressor related disorders, professional role, health services needs and demand
    - O: Well-being, activities of daily living, mental health recovery, quality of life, function, participation, community re-integration, independence
- Search yielded 931 articles, after eliminating duplicates, screening was narrowed to 7 articles for the critical review

<u>Results:</u> There is an overall low level of evidence for all themes and articles presented
