## **MANUSCRIPT TITLE:**

UTILITY OF THE ANTERIOR REACH Y-BALANCE TEST AS AN INJURY RISK SCREENING TOOL IN ELITE MALE YOUTH SOCCER PLAYERS

## ABSTRACT

**Objectives:** Examine growth and maturation trends in dynamic balance using the anterior reach Y-Balance test, and its utility as an injury risk screening tool.

Design: Cross sectional and prospective cohort.

Setting: Elite male youth soccer players.

Participants: 346 players grouped as pre, circa or post peak height velocity (PHV).

**Main outcome measures:** Pre-season anterior reach absolute and relative Y-Balance test scores and seasonal prospective lower extremity injury monitoring.

**Results:** Absolute reach distances were greatest post-PHV (p < 0.05). Relative to leg length, pre-PHV achieved the highest scores and increased between-limb differences. Significant associations between injury and anterior reach scores were present in pre (OR: 0.94, CI: 0.91 - 0.98, p < 0.05) and circa-PHV (OR: 1.05, 95% CI: 1.05 - 1.10, p < 0.05). Increased age (OR: 1.49, 95% CI: 1.04 - 2.13, p < 0.05) and height (OR: 1.06, 95% CI: .99 - 1.13, p = 0.82) were risk factors post-PHV. No differences in injury occurrence were shown between players with absolute reach difference > 4 cm in any group.

**Conclusions:** Anterior reach scores increased injury risk, but associations were small and inconsistent. The Y-Balance should be used with caution as a screening tool in this cohort.

## **INTRODUCTION**

Injury rates increase linearly with age in male youth soccer players (26), while heightened risk may also be present during periods associated with accelerated growth (28,38). Research has shown an increase in overall season incidence (1.56 vs. 1.32 injuries per player) and severe injury (0.42) rate for players during developmental stages corresponding to peak height velocity (PHV) (28), defined as the period in which a child experiences their fastest upward growth in stature (15). In addition, these athletes experienced the longest time-loss per injury (~26 days) (28). Rapid changes in stature and mass can result in aberrant movement patterns and momentary disruptions in motor control (1,23). However, analysis of injury risk factors in elite male youth soccer players is sparse (27,32), despite the frequency of injuries (10,26).

Non-contact injuries occur most frequently in male youth soccer players, with the knee and ankle most susceptible (28). A range of assessments are available to examine lower-limb performance and movement control in male youth soccer players (34); however, these tests often demonstrate poor sensitivity for the identification of individuals at elevated risk of injury (7,8). Reduced dynamic balance scores have been associated with lower extremity injuries, most frequently occurring at the knee and ankle (24). Specifically, the sum of three out of eight reach directions in the star excursion balance test (anterior, posteromedial, and posterolateral) and asymmetrical anterior reach distances have shown associations with injury in male youth athletes (8,24). Thus, a modified version of the original star excursion balance test comprising only these three reach directions has been developed, the Y-Balance test (3,25). One available study in recreational school children reported the reliability of this method showing moderate to strong test re-test correlations (ICC range = 0.71 - 0.88) (3); however, these were not elite youth athletes who participate regularly in sport-specific training and competition.

The Y-Balance test has been suggested to measure dynamic balance due to the need to maintain the position of the body's centre of mass during dynamic actions (25). Improving dynamic balance through training has reduced the risk of knee and ankle sprains in youth soccer (12,14) and ankle injuries in basketball players (14). When assessing and characterising balance abilities of non-injured soccer players, youth display greater postural sway than adults (21,22); however, only adolescents were included in the youth sample which does not account for changes seen due to growth and maturation. Variation in performance tests such as jumping and hopping are evident across different chronological age groups (11,23,29,30,31,33), indicating performance may be affected by the stage of maturation. There is a paucity of

research to examine dynamic balance in male youth soccer players at different stages of their growth and development.

When a large number of players must be screened and there are obvious time constraints, the inclusion of multiple movement screens may not be possible. Of those available, the Y-Balance test, and in particular the anterior reach direction may, be considered important given its association with injury risk (24,36). In male youth basketball players, an anterior right-left reach difference > 4 cm displayed a 2.5 times greater risk of lower extremity injury (24). Currently there is a lack of research to examine dynamic balance and y-balance anterior reach right-left differences in elite male youth soccer players at different maturity stages. These data are required to identify sensitive periods during a player's development and can assist in the design of targeted interventions for injury risk reduction. Prospective cohort studies are also warranted to examine the clinical utility of the Y-Balance anterior reach test in this cohort to establish if similar between-limb differences are associated with heightened risk of injury.

This study was separated into two experiments and had two aims: 1) to screen elite male youth soccer players from a range of maturity groups and identify cross-sectional trends in dynamic balance using the Y-Balance test; and 2) to investigate the clinical utility of the Y-Balance test to identify associations with future injury.

#### **METHODS**

#### **Experimental design**

# *Experiment 1: Reliability and cross-sectional analysis of anterior reach Y-Balance test by maturity status*

Initially the test-retest reliability of the anterior reach Y-Balance test was examined using a repeated measures design in a sub-sample of 50 participants, including 25 pre-peak height velocity (PHV) (age  $11.9 \pm 0.4$  years; height  $151.4 \pm 4.8$  cm; body mass  $41.1 \pm 5.6$  kg; maturity offset  $-2.3 \pm 0.4$  years) and 25 post-PHV players (age  $17.3 \pm 0.7$  years; height  $178.2 \pm 5.5$  cm; body mass  $72.3 \pm 6.9$  kg; maturity offset  $2.9 \pm 0.8$  years). Participants were required to attend their respective club's training ground at the same time (pm) on three occasions separated by a period of seven days. The first occasion was used for familiarization prior to data collection in the second and third sessions. All procedures were replicated at each test session and the data were collected by the same individual.

A cross-sectional design was used to examine the effects of stage of maturation on anterior reach Y-Balance performance. 346 players from six clubs attended their respective club training grounds on two occasions, familiarization and testing, separated by a period of seven days. All testing occurred in pre-season (July) spread across a two-week period to ensure all players from the different clubs could be tested. Descriptive statistics are provided for each group in table 1. All tests were conducted by the same researcher and a 10-minute standardized warm up was completed prior to each session. Participants were asked to refrain from strenuous exercise at least 48 hours prior to testing and avoid eating and drinking substances other than water one hour prior to each test session.

# *Experiment 2: Prospective study examining associations between anterior reach Y-Balance test with future injury occurrence*

Following baseline Y-Balance anterior reach injury risk screening occurring during pre-season (July), these players were then tracked for the remainder of the season to prospectively record all injuries sustained in soccer training and competitions at their respective clubs.

## **Participants**

Elite male youth soccer players from the academies of professional soccer clubs volunteered to take part. None of the players reported injuries at the time of baseline screening and all were participating regularly in soccer training and competitions. The included sample were most frequently (78%) right limb dominant as defined by their preferred kicking limb. Parental consent and participant assent were collected prior to the commencement of testing. Ethical approval was granted by the institutional ethics committee in accordance with the declaration of Helsinki.

#### Procedures

#### Anthropometry

Body mass (kg) was measured on a calibrated physician scale (Seca 786 Culta, Milan, Italy). Standing and sitting height (cm) were recorded on a measurement platform (Seca 274, Milan, Italy). Leg length was also measured to the nearest 0.1 cm as the distance between the anterior superior iliac spine and the medial malleolus using a standard tape measure. Stage of biological maturation was assessed using a previously validated regression equation comprising measures of age, body mass, standing height and sitting height (15). Using this method, maturity offset (calculation of years from PHV) was completed using the following equation:

Maturity offset =

-9.236 + [0.0002708 x leg length and sitting height interaction]

- [0.001663 x age and leg length interaction]
- + [0.007216 x age and sitting height interaction] + [0.02292 x weight by height ratio]

#### Anterior reach Y-Balance test

Participants placed their hands on their hips and began in a unilateral stance with the most distal aspect of their great toe behind the line on the centre of the Y-Balance test kit<sup>TM</sup> (Move2Perform, Evansville, IN). The commercially available device is comprised of a central stance platform with three pieces of polyvinylchloride piping attached displaying incremental measurements of 0.5 cm complete with a reach indicator for each pipe. Distances were recorded by pushing the target reach indicator in the anterior direction only due to the heightened associations with injury of this specified direction for youth athletes (24,36).

Four practice trials were provided to reduce learning effects as previously stated (16), with technical competency observed by the principle investigator defined as meeting all the previously stated test requirements (25). Due to the large subject numbers and to ensure time-efficiency in an elite sports setting, three of the specified practice trials were performed in a group setting away from the instrumented device in accordance with previous research (3), with an additional practice trial conducted on the Y-Balance kit. Tests were performed on both legs with the order randomized to eliminate an order effect. Throughout, no visible kicking of the target reach indicator was permitted, the heel of the non-reach leg was required to remain on the testing platform with the toe behind the start line, balance was to be maintained in a single leg stance, and the reach foot was required to return back to the platform (35). Maximal reach distances were recorded and normalized to leg length. Absolute anterior reach difference scores between limbs were also recorded (right minus left). Three trials were performed on each leg with the mean score reported.

#### Injury reporting

Non-contact, lower extremity injuries were diagnosed, classified and prospectively recorded by respective medical personnel at each club for the duration of an entire soccer season (July – May inclusive) in accordance with methods outlined previously and the regulations set out by the competitive league organizers (28). Injuries were documented if they occurred during soccer-related activities and if the player was subsequently unable to participate in training or competition for a minimum of 48 hours following the incident, not including the day of injury. Players were classified as injured until the medical staff (chartered physiotherapists) of their respective clubs deemed they were fit to resume full training. Due to the confounding effects of previous injuries, only the first incident experienced by each player during the season was used in the subsequent analysis.

#### Statistical analysis

Within-subject variation was determined using typical error of estimates, 95% confidence intervals (95% CI) and mean coefficients of variation (CV %). All data were computed through Microsoft Excel<sup>®</sup> 2010 using a freely-available spread sheet to compute all reliability statistics (9). Players were grouped by their stage of maturation (pre-, circa- or post-PHV). To account for the reported error (approx. 6 months) in the regression equation used (15), players were grouped into discrete bands based on their maturational offset (pre -PHV = < -1, circa-PHV = - 0.5 to 0.5, post-PHV = >1) in accordance with previous research (29,30,31). Players tested who recorded a maturational offset between -1 to -0.5 and 0.5 to 1 were subsequently removed from the data set.

To perform the cross sectional analysis, descriptive statistics were calculated for each maturity group (mean  $\pm$  SD). A one-way analysis of variance was performed to determine the existence of any between group differences. The level of significance was set at alpha level  $p \leq 0.05$ . Homogeneity of variance was tested by Levene's statistic, and where violated Welch's adjustment was used to calculate the F-ratio. Post-hoc analysis was assessed using Gabriel's test when equal variance was assumed, and Games-Howell tests when this assumption was violated. Cohen's *d* effect sizes (ES) were calculated to interpret the magnitude of between group differences using the following classifications: standardized mean differences of 0.2, 0.5, and 0.8 for small, medium, and large effect sizes, respectively. Paired samples t-tests were also used to examine differences in performance between limbs. One-way analysis of variance and paired samples t-tests were processed using SPSS<sup>®</sup> (V.21. Chicago Illinois).

The first step of the injury risk analysis involved completion of an independent samples t-test to examine mean differences in age, anthropometry, and Y-Balance performance among players who sustained an injury and those who were not injured during the study period. This step was adopted to reduce the number of outcome variables and the error degree of freedom. Variables that displayed a *p*-value < 0.1 were considered for further regression analysis. Odds ratios (OR) were then calculated using stepwise backwards multivariate binary logistic regression with 95% confidence intervals (CI). An alpha value of *p* < 0.05 was indicative of a significant association. Chi-squared ( $\chi^2$ ) was used to compare association of injury status with a previously suggested injury threshold (> 4 cm between limb anterior reach difference) (24,36), with statistical significance set at an alpha level of *p* < 0.05. Logistic regression and Chi-squared tests were processed using SPSS<sup>®</sup> (V.21. Chicago Illinois).

## RESULTS

## Experiment 1: Cross-sectional analysis

Reliability statistics are displayed in table 2. Typical error between test-sessions and the CV% were consistent with those of previous research and were deemed acceptable (< 10%) (3) in both pre and post-PHV players. Mean ( $\pm$  standard deviation) Y-Balance absolute anterior reach distances and distances normalized to leg length for each limb and maturity group are displayed in figures 1a and 1b respectively. Absolute reach distances were greatest in post-PHV players (right = 64.3  $\pm$  12.3 cm; left = 63.3  $\pm$  11.5), although these differences were only significant when compared to the pre-PHV group with moderate effect sizes (right = 58.0  $\pm$  9.5 cm; left = 57.2  $\pm$  9.6 cm) (p < 0.001; d = 0.57-0.58). Pre-PHV players recorded the greatest reach differences relative to leg length (right = 74.2  $\pm$  12.7 cm; left = 73.1  $\pm$  12.6), although significant differences were present only when compared to post-PHV players, corresponding to a small effect size (right = 69.9  $\pm$  13.8 cm; left = 68.8  $\pm$  12.8), (p < 0.05; d = 0.32 - 0.34) (figure 1b). No significant inter-limb reach differences were observed between pre (3.6  $\pm$  2.8 cm), circa (3.2  $\pm$  3.1 cm) and post-PHV (3.4  $\pm$  2.8 cm) players. Significantly greater reach distances were shown on the right leg (p < 0.001),

## Experiment 2: Injury analysis

Of the 346 players included, 99 sustained a non-contact lower extremity injury. The knee was the most frequently injured anatomical site (31%), followed by the ankle (19%). There were a high proportion of strain type injuries (32%), with ligament (19%) and growth/overuse (14%) the most prevalent diagnosis thereafter. Half of the injuries (50%) were moderate (1-4 weeks); however, severe injuries (> 4 weeks absent) were also frequently reported (32%). Descriptive statistics for injured and non-injured players in each maturity group are displayed in tables 3-5. The distribution of Y-Balance anterior reach absolute between-limb difference scores for injured and non-injured players in each maturity group is also shown in figure 2.

## **Pre-PHV** injury risk factor associations

Injured players were significantly older, more physically mature, and had lower Y-Balance performance on both legs. The prevalence of injury in players with absolute reach difference > 4 cm (27.8%) was not statistically different compared to players with absolute reach distance <4 cm (29.3%) (p = 0.87). Multivariate analysis indicated lower relative scores on the left limb were the only variable associated with injury, such that for each unit reduction in relative left limb reach, the odds of experiencing an injury increased by 6% (OR: 0.94, CI: 0.91 - 0.98, p < 0.05) (table 6). The model predicted 97.5% and 15.6% of non-injured and injured players respectively, with an overall prediction accuracy of 73.9% ( $R^2 = .124$ ).

## Circa-PHV injury risk factor associations

Injured players showed significantly greater Y-Balance scores than non-injured players on both legs. The prevalence of injury in players with absolute reach difference > 4 cm (30%) was not statistically different compared to players with absolute reach distance < 4 cm (24.4%) (p = 0.61). Multivariate analysis indicated greater absolute scores on the right limb were the only variable significantly associated with injury (OR: 1.06, 95% CI: 1.05 – 1.10, p < 0.05), where a one-unit increase in y-balance scores on the right leg increased the odds of injury by 6% (table 6). The model predicted 98.6% and 1% of non-injured and injured players respectively, with an overall prediction accuracy of 73.4% ( $R^2 = .069$ ).

## Post-PHV injury risk factor associations

Injured players were older, taller, heavier and showed significantly greater Y-Balance scores than non-injured players on both legs. The prevalence of injury in players with absolute reach difference > 4 cm (31.8%) was not statistically different compared to players with absolute

reach distance < 4 cm (27.8%) (p = 0.63). The multivariate model consisted of age (OR: 1.49, 95% CI: 1.04 – 2.13, p < 0.05) and height (OR: 1.06, 95% CI: .99 – 1.13, p = 0.82) (table 6); thus after adjusting for height, for each 1 year increase in age, there was a 1.5 times greater risk of injury. The model predicted 96% and 9.8% of non-injured and injured players respectively, with an overall prediction accuracy of 70.9% ( $R^2 = .104$ ).

### DISCUSSION

The aim of this study was to examine differences in the anterior reach Y-Balance test in elite male youth soccer players at different stages of maturity and its utility as an injury risk screening tool. Cross sectional data showed that absolute anterior reach distances were greatest in those who were post-PHV. Relative to leg length, pre-PHV players achieved the highest reach distances. Significant associations with future injury and y-balance anterior reach scores were present in pre and circa-PHV players; however, the strength of these relationships was low. Furthermore, no significant differences in the frequency of injury occurrence were shown between players breaching a pre-determined injury risk threshold (absolute reach difference > 4 cm) (24,36), indicating that the Y-Balance anterior reach should be used with caution as an injury risk screening tool in elite male youth soccer players.

Absolute Y-Balance reach distances were highest in post-PHV players and this can be attributed to greater standing height and leg length (see table 1). This is expected as more mature (and subsequently taller) children have displayed better functional reach scores, and therefore, adjustments should be made for leg length (5). Previous research has reported age-related improvements in balance and reduced postural sway in recreationally active youths (2,18), and elite soccer players (21,22). Also, as children mature, they display improvements in postural control and the magnitude of centre of pressure excursions reduces (35). With maturation, the ability to use visual, vestibular and somatosensory information improves, and they learn to adapt to changes in body configurations and proportions, resulting in more controlled and accurate movement strategies (5,35).

Normalization of reach scores relative to leg length identified that the pre-PHV players displayed the greatest reach distances. This could be attributed to heightened ranges of motion occurring via reductions in passive stiffness associated with younger ages (19). Thus,

performance on this test may be determined more by mobility (predominantly at the ankle) as opposed to dynamic balance as shown previously in young adults (20). It is also plausible that to determine maturity-related changes in balance performance, alternative measures such as postural sway, or the dynamic postural stability index may be required (39).

Reductions in normalized reach distances were evident between each consecutive maturity group; however, these differences were significant only when comparing pre to post-PHV players. A plateau or decline in flexibility has been associated with the onset of the adolescent growth spurt (23). This may be related to heightened musculotendinous stiffness resulting from increased restriction of titin filaments (19), collagen filaments, and cross linking (13). Specifically, structural changes to the ligaments and tendons may be present elevating stiffness of the tissues with the onset of adolescence (13). Bone growth occurring in the absence of muscle length changes may result in momentary decreases in flexibility. In addition, bony adaptations have been shown to develop from recurrent ball impact in soccer players (37) which could reduce ankle dorsiflexion range of motion. Cumulatively, these maturational and sport specific adaptations could provide a plausible explanation for the reductions seen in normalized reach distance. Thus, it would appear prudent to target flexibility and range of motion control to offset these growth-related reductions in mobility.

Previous research has indicated an anterior right-left reach difference > 4 cm increases the risk of lower extremity injury (24). This has been confirmed more recently where anterior reach asymmetry was the only Y-Balance variable significantly associated with non-contact injury in collegiate athletes (36). In the current study, cross sectional analysis showed no significant between group differences were present in absolute right/left reach differences and mean scores indicated that none of the maturity groups exceeded the 4 cm threshold. Furthermore, the injury analysis showed a wide distribution of scores (figure 2) and did not identify any significant differences between injured and non-injured players. There were also no differences in the frequency of injury occurrence between players breaching this threshold in any maturity group versus those who did not. The aforementioned research included a sample of youth basketball players (24) and division I collegiate athletes from multiple sports (36) which in part may explain the disparate findings in the current study. Furthermore, large standard deviations were reported for most maturity groups indicating a wide dispersion of scores are likely in elite male youth soccer players. Our results suggest that absolute reach differences measured during the anterior reach of the Y-Balance test and specifically a threshold of > 4 cm should be used with caution for the purposes of injury risk screening in elite male youth soccer players.

In this study, significant differences between injured and non-injured players were shown for combinations of anthropometric and Y-Balance anterior reach distances although variation was evident across the different maturity groups. Greater reach distances were observed on the right leg (when the stance leg was the left) in comparison to the left (when the stance leg was the right) in injured versus non-injured players regardless of maturity group (tables 3-5). Furthermore, multivariate analysis indicated that significant associations with injury were present in pre and circa-PHV players. These data suggest that when the task is performed with the limb controlling the movement of what is typically their dominant kicking leg, reduced absolute reach scores are more important to monitor than absolute right-left differences. However, the odds ratio and thus, the strength of these associations could be required to meaningfully increase injury risk. Furthermore, the prediction accuracy of each model was low and no associations between Y-Balance anterior reach distances and injury risk were identified in post-PHV players. Advanced chronological age was the only variable to remain significant in the multivariate model.

Previous research has shown no association between Y-Balance composite scores and injury risk in elite female youth soccer players (17). Effective performance during dynamic stability tasks requires the integration of visual, vestibular and proprioceptive inputs, which provide an efferent response to control the body's centre of mass within its base of support (4). Thus, a weak association between y-balance anterior reach scores and injury risk in the current study could be explained in part by the multifactorial nature of injuries in soccer and the complex interaction of factors that comprise dynamic balance. Consequently, it may not be possible to accurately assess all of these constructs in a single field-based assessment (17).

When interpreting the data from the current study, practitioners should also be cognizant of some limitations. Firstly, previous injury, which has been reported as a risk factor for future injury occurrence (6), was not accounted for in this study. Due to the frequency with which players move between clubs in academy soccer, to record this information would have required the use of retrospective analysis which is subject to recall bias. Secondly, in the current study, all non-contact, lower extremity injuries were included. Future research should aim to

investigate the clinical utility of this test in elite male youth soccer players with a focus on key anatomical locations and injury types such as knee and ankle ligament injuries.

## CONCLUSIONS

The current study examined the utility of the anterior reach Y-Balance test in elite male youth soccer players. The key findings indicate the following: 1) the test displays acceptable typical error and can differentiate between maturity groups with a trend of reductions in relative reach scores as players mature and; 2) absolute reach scores on what is typically the dominant kicking leg display some small association with future injury. However, a large change in reach distances would be required to meaningfully increase injury risk and applying previously identified between-limb symmetry thresholds (> 4 cm) could not differentiate between injured and non-injured players.

Cumulatively, these data provide evidence that the anterior reach of the Y-Balance test should be used with caution as an injury risk screening tool in elite male youth soccer players. In addition, the youngest and least mature players achieved the highest reach distances relative to leg length. This suggests that anterior reach scores are determined more by mobility, as opposed to dynamic balance. Given that the greatest reductions in reach distance/mobility were shown between pre and post-PHV players, it could be inferred that training programs should incorporate appropriate training to offset these likely growth-related reductions in mobility.
