The study was carried out at four villages in Pulau Indah, Klang between December 2005 to March 2006. The data was collected by using a structured questionnaire. The purpose of this research is to identify the constraining factors affecting participation in outdoor recreational activities among Malay females. The objectives are to determine interpersonal, intrapersonal and structural constraining factors affecting Malay females level of participation in outdoor recreational activities at Pulau Indah, Klang, to identify the type of recreation activities Malay females are willing to participate in and to identify elements that would facilitate Malay females to participate in outdoor recreational activities based on their demographics profile and constraints. Interest in outdoor recreation and physical ability are the major factors in intrapersonal. Meanwhile for interpersonal constraints, the factors include friend's participation, friend's knowledge on the benefits of outdoor recreation and the respondent's concern on accidents or injuries with the involvement of incompetent friends. Busy with commitment, do not have own transportation, do not have strong financial support and

knowledge about the type of facilities provided which suit their preference are among the structural constraints for which the Malay females in Pulau Indah do not participate in outdoor recreation. The most serious constraint for Malay females in Pulau Indah is intrapersonal constraints. Respondents in Pulau Indah, Klang generally have the desire to participate in outdoor recreational activities, which are adventurous, challenging, and nature based such as rock climbing, trekking, jet skiing, sight-seeing and traveling. The different age group, occupation, marital status and education level provided the different types of outdoor recreation activity preferences. Malay females in Pulau Indah, reported that the key measure needed to encourage Malay females participation in outdoor recreational activities is through the dissemination of information concerning the benefits and importance of outdoor recreation. Activities offered should also be suitable with the Malay custom and culture, and that parks should provide good and comfortable facilities. Besides that, the parks also need to provide complete and proper equipments. Fitness, physical ability, the availability of time and safety also influence their participation in outdoor recreational activities. Respondents also suggested that Majlis Perbandaran Klang (MPK) provide quality recreational parks to attract their participation in outdoor recreational activities.

Kajian ini dijalankan di empat kampung di Pulau Indah pada Disember 2005 hingga Mac 2006. Data dikumpulkan dengan menggunakan borang soal selidik. Tujuan kajian ini adalah untuk mengenalpasti faktor-faktor yang menghalang wanita Melayu melibatkan diri dalam rekreasi luar. Objektif kajian ini adalah untuk menentukan faktor-faktor 'intrapersonal', 'interpersonal' dan 'structural' yang menghalang penglibatan di kalangan wanita Melayu di Pulau Indah, Klang, mengenalpasti jenis rekreasi luar yang ingin disertai oleh wanita Melayu dan mengenalpasti elemen-elemen yang membolehkan wanita Melayu melibatkan diri dalam rekreasi luar berdasarkan profil demografi dan faktor penghalang yang dikenalpasti. Minat di dalam rekreasi luar dan kemampuan fizikal adalah antara faktor utama dalam 'intrapersonal'. Sementara itu, dalam 'interpersonal' ianya merangkumi penglibatan kawan, pengetahuan kawan tentang kebaikan rekreasi luar dan kerisauan responden sekiranya berlaku kecederaan atau kemalangan apabila terlibat dengan kawan yang kompeten dalam rekreasi luar. Sibuk dengan komitmen, tidak mempunyai kenderaan sendiri, tidak mempunyai

kewangan yang kukuh dan tidak mengetahui tentang jenis kemudahan yang disediakan bersesuaian dengan kehendak responden adalah antara faktor 'structural' yang menghalang penglibatan wanita Melayu di Pulau Indah. 'Intrapersonal' adalah faktor utama yang menghalang penglibatan wanita Melayu di Pulau Indah dalam aktiviti rekreasi luar. Secara umumnya, responden ingin melibatkan diri dalam aktiviti rekreasi luar yang berbentuk lasak, mencabar dan berasaskan alam semulajadi seperti 'rock climbing', trekking, bermain jet-ski, bersiar-siar dan melancong. Perbezaan dalam kumpulan umur, pekerjaan, taraf perkahwinan dan taraf pendidikan menimbulkan keinginan jenis aktiviti yang pelbagai. Wanita Melayu di Pulau Indah, menyatakan aspek yang penting untuk megalakkan penglibatan wanita Melayu adalah melalui penyebaran maklumat mengenai kebaikan dan kepentingan rekreasi luar. Aktiviti yang ditawarkan perlulah bersesuaian dengan adat dan budaya orang Melayu selain menyediakan kemudahan yang baik dan selesa. Selain itu, responden memerlukan peralatan yang lengkap disamping mempunyai kecerdasan fizikal, kelapangan masa dan keselamatan terjamin untuk mempengaruhi penglibatan responden dalam rekreasi luar. Responden juga telah mencadangkan pada Majlis Perbandaran Klang (MPK) untuk menyediakan taman rekreasi yang berkualiti bagi menarik minat mereka untuk menyertai aktiviti rekreasi luar.
