A CASE OF HAEMORRHAGIC OVARIAN CYST CURED WITH HOMOEOPATHIC SIMILIMUM

ABSTRACT

Haemorrhage in an ovarian cyst is very common. These cyst are known as haemorrhagic ovarian cysts (HOCs). Most of the cyst disappears spontaneously, but certain cyst requires surgical intervention. HOCs are formed because of occurrence of bleeding into a follicular or corpus luteum cyst. Allopathic system of medicine Prescribes various hormonal pills for its management which may have adverse drug reactions. Homoeopathic medicines are very helpful to manage such conditions. This article is about a case of 27 years old female who was suffering from haemorrhagic cyst. Homoeopathic medicine was given on the basis of totality of symptoms and patient cured within three months of treatment. Patient's consent has been taken for the publication of this case report.

INTRODUCTION

When internal hemorrhage occurs into functional cvsts of the ovary it is called hemorrhagic ovarian cvst^[1] When a graffian follicle ruptures to release an oocyte, it is transformed into corpus luteum. The corpus luteum is lined by a layer of granulose cells which rapidly becomes vascularized, some of these thin walled vessels may rupture, which causes bleeding into corpus luteum, resulting in formation of a hemorrhagic cyst of the ovary. Pain is the presenting symptoms of the patient which may be very severe, other minor symptom include menstrual irregularities. Large cyst greater than 5centimeter may rupture and may cause acute abdomen. Diagnosis of hemorrhagic cyst is made chiefly on the basis of clinical symptoms and ultrasonography. [1]

Homoeopathy is an alternative system of medicine, founded by Dr. Samuel Hahnemann (1755-1843), based on the therapeutic law "Similia Similibus Curenter" means" let likes be treated by likes'. The successful application of law of similar depends entirely on the concept of individualization and susceptible constitution ^[2] which is pillar of homoeopathic practice. CASE REPORT

Presenting complaints

Location- Left ovarian fossa

Sensation- cutting pain

Modalities-

Aggravation- motion, touch, pressure

Amelioration- rest

Concomitant- white coated tongue

History of Presented complaints

Age 27 years old married female presented with complaints of severe pain in abdomen on left ovarian fossa since morning. Patient was suffering from similar type of pain since 1 year. Initially it was treated with analgesics at home. But pain reoccurred again and again near each menstrual period. Sometime pain also occurs during intermenstrual period. On ultrasonogarphical examination there was presence of single hemorrhagic cyst of size 35 mm in left ovary. IJRAPS, 2020:4(1):385-387

Uterus-Bulky in size, 100m X 50mm and appears normal in echo texture.

A cyst measuring 35mm is seen in left ovary with thin internal septation seen within it.

Impression- Mild bulky uterus with hemorrhagic left ovarian cyst.

Totality of symptoms

Mind- Fear - animals, of - snakes, of Mind- Delusions, imaginations - die -about to-he is Mind - Sensitive, oversensitive - general - pain, to Perspiration - Staining the linen - yellow Female - Tumors - general - cysts - ovaries

Miasmatic evaluation

Psoro- sycotic predominance

Final drug selection with reason

On the basis of totality of symptoms and after consulting material medica ^[6] *Lachesis* 200, single dose was prescribed.

Follow up

Patient was prescribed placebo for next three months. After three months ultrasonography report showed no abnormality. Her cyst was resolved completely. Her pain was also cured with this similimum. There was no episode of pain in between.

Reportorial totality




Figure 1: Repertorization done using RADAR software.[5]

Large ovarian cysts are difficult to cure. Usually surgery is recommended if not managed with hormonal therapy.
