Abstract: The summary is a cataloged listing of TIR's that have been issued to date and indicates present status. The PCO is an office established by the Lincoln Director's Office to serve as the contact point at Lincoln in connection with the SAGE System, and to formally release Lincoln documents covering system specifications and requirements.

The Lincoln Production Coordination Office (PCO) was established by the Director's Office of Lincoln Laboratory to serve as the contact point at Lincoln for outside agencies on production matters relating to the SAGE System and to facilitate coordination of such matters within the Laboratory. Information and data to be issued as official Lincoln Laboratory documents are processed: (1) to coordinate and obtain approval from all interested Lincoln groups and/or divisions, (2) to obtain concurrence from the interested organizations outside Lincoln, and (3) subsequently to be formally issued with a Technical Information Release (TIR). The TIR form also briefly summarizes the background, indicates extent of coordination, action to be taken and indicates any qualifications regarding the use of the data being released. When changes are made to information which has been previously released by a Lincoln TIR, the changed information is processed in the same manner as the original release, and a new TIR is released superseding the previous TIR(s).

The attached Summary of Technical Information Releases, Appendix A, was prepared to provide an up-to-date summary of active T.I.R.'s issued. Items are grouped into categories according to subject matter.


