# MULTIPLE POSITIVE SOLUTIONS TO THE FRACTIONAL KIRCHHOFF PROBLEM WITH CRITICAL INDEFINITE NONLINEARITIES

#### Abstract

This article concerns the existence and multiplicity of positive solutions to the fractional Kirchhoff equation with critical indefinite nonlinearities by applying the Nehari manifold approach and fibering maps.


## 1. Introduction and statement of results

In this paper, we study the existence and multiplicity of positive solutions to the fractional Kirchhoff type problem

$$
\begin{gather*}
M\left(\int_{\mathbb{R}^{2 N}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{N+2 s}} d x d y\right)(-\Delta)^{s} u=f_{\lambda}(x)|u|^{q-2} u+g(x)|u|^{2_{s}^{*}-2} u, \quad \text { in } \Omega, \\
u=0, \quad \text { in } \mathbb{R}^{N} \backslash \Omega \tag{1.1}
\end{gather*}
$$

where $\Omega \subset \mathbb{R}^{N}$ is an open bounded domain with the Lipschitz boundary $\partial \Omega$, dimension $N>2 s$ with $s \in(0,1), 2_{s}^{*}=\frac{2 N}{N-2 s}$ is the fractional critical Sobolev exponent and $0<s<1<q<\min \left\{2, \frac{N}{N-2 s}\right\}<\infty$. Here, $M(t)=a+b t^{m-1}$ with $m>1$, $a, b>0, f_{\lambda} \in L^{q^{*}}(\Omega), q^{*}=\frac{2_{s}^{*}}{2_{s}^{*}-q}, f_{\lambda}=\lambda f_{+}-f_{-}$with $\lambda>0$, and $f_{ \pm}=\max \{ \pm f, 0\}$ and $g \in L^{\infty}(\Omega)$. Furthermore, $g$ satisfies the condition
(A1) $g(x)=\max _{x \in \bar{\Omega}} g(x) \equiv 1$ in $B_{\rho}(0)$ for some $\rho>0$.
We denote by $(-\Delta)^{s}$ the usual fractional Laplacian operator which is defined (up to normalization factors) as follows (see for instance [18] and the references therein for further details on the fractional Laplacian) by

(-\Delta)^{s} u(x)=2 \mathrm{P} \cdot \mathrm{~V} \cdot \int_{\mathbb{R}^{N}} \frac{u(x)-u(y)}{|x-y|^{N+2 s}} d y \tag{1.2}
\end{equation*}
$$

where P.V. stands for the principle value.
When $M(t) \equiv 1, \lambda=1$ and $s=1$, equation (1.1) can be reduced to the semilinear elliptic problem

\begin{gather*}
-\Delta u=f(x)|u|^{q-2}+g(x)|u|^{2^{*}-2} u, \quad x \in \Omega  \tag{1.3}\\
u=0, \quad x \in \partial \Omega
\end{gather*}
$$

where $\Omega$ is a smooth bounded domain in $\mathbb{R}^{N}(N \geq 3), 1<q<2$, and the weight functions $f, g$ are continuous and sign-changing. By using the Nehari manifold, fibering maps and Ljusternik-Schnirelmann category, Wu [25] proved that there existed at least three positive solutions of (1.3). Xie-Chen [26] presented a multiplicity result on the Kirchhoff-type problems in the bounded domain by using a similar strategy. A number of works dealt with the fractional differential equations [3, 6, 7, 11, 21] and some recent results on problem (1.3) can be seen in [4, 5, 10, 12, 13, 14, 15, 16, 22, 23, 27] and the references therein.

As we know, the variational problems involving fractional and nonlocal operators are much more complicated and challenging. In the last decade, considerable attention focused on the fractional Laplacian operator and nonlocal operator. We refer to [19] for the Brezis-Nirenberg type results for the following elliptic equation involving the fractional Laplacian $(-\Delta)^{s}(0<s<1)$ in a bounded domain,

\begin{gathered}
(-\Delta)^{s} u=\lambda u+|u|^{2_{s}^{*}-2} u, \quad x \in \Omega, \\
u=0, \quad x \in \partial \Omega
\end{gathered}
$$

where $\lambda>0, s \in(0,1)$ is fixed, $2_{s}^{*}=\frac{2 N}{N-2 s}, \Omega \subset \mathbb{R}^{N}(N>2 s)$ is open, bounded and with the Lipschitz boundary, and $(-\Delta)^{s}$ is the fractional Laplace operator. The classical Brezis-Nirenberg result was generalized to the case of nonlocal fractional operators through variational techniques. The existence of multiple solutions to the fractional Laplacian equations of Kirchhoff type was considered in [17] and two positive solutions for proper selection of positive parameter $\lambda$ was obtained.

The main purpose of this article is to establish the existence and multiplicity of positive solutions to problem with the critical growth and sign-changing weight functions. Our results encompass and improve the corresponding results presented in [26] for the fractional Kirchhoff type equations involving the critical growth.

The energy functional associated with problem (1.1) is

\begin{aligned}
I_{\lambda}(u)= & \frac{a}{2} \int_{\mathbb{R}^{2 N}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{N+2 s}} d x d y+\frac{b}{2 m}\left(\int_{\mathbb{R}^{2 N}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{N+2 s}} d x d y\right)^{m} \\
& -\frac{1}{q} \int_{\Omega} f_{\lambda}(x)|u|^{q} d x-\frac{1}{2_{s}^{*}} \int_{\Omega} g(x)|u|^{2_{s}^{*}} d x
\end{aligned}
$$

for $u \in H_{0}^{s}(\Omega)$. We can prove that $I_{\lambda} \in C^{1}\left(H_{0}^{s}(\Omega), \mathbb{R}\right)$ and a critical point of $I_{\lambda}$ in $H_{0}^{s}(\Omega)$ corresponds to a weak solution of problem 1.1). We summarize our main results as follows.

Theorem 1.1. Assume that $m<\frac{N}{N-2 s}, f_{ \pm} \not \equiv 0$ and condition (A1) holds. Then there exist $0<\Lambda_{*} \leq \Lambda_{0}$ and $\bar{b}>0$ such that
(i) for any $\lambda \in\left(0, \Lambda_{0}\right)$, problem (1.1) admits at least one positive solution $u_{1}$ with $I_{\lambda}\left(u_{1}\right)<0$, and $u_{1}$ is a ground state solution;
(ii) for any $\lambda \in\left(0, \Lambda_{*}\right)$ and $b \in(0, \bar{b})$, problem (1.1) admits at least two positive solutions $u_{1}$ and $u_{2}$ satisfying $I_{\lambda}\left(u_{1}\right)<0<I_{\lambda}\left(u_{2}\right)$, and $u_{1}$ is a ground state solution.

Theorem 1.2. Assume that $m=\frac{N}{N-2 s}, f_{ \pm} \not \equiv 0$ and condition (A1) holds. Then the following two statements hold:
(i) For $b \geq 1 / S^{m}$ and any $\lambda>0$, problem (1.1) admits at least one positive solution.
(ii) For $b<1 / S^{m}$, there exist $0<\tilde{\Lambda}_{*} \leq \Lambda_{0}$ and $\tilde{b}>0$ such that
(1) for any $\lambda \in\left(0, \Lambda_{0}\right)$, problem (1.1) admits at least one positive solution;
(2) for any $\lambda \in\left(0, \tilde{\Lambda}_{*}\right)$ and $b \in(0, b)$, problem 1.1) admits at least two positive solutions $u_{1}$ and $u_{2}$ satisfying $I_{\lambda}\left(u_{1}\right)<0<I_{\lambda}\left(u_{2}\right)$, and $u_{1}$ is a ground state solution.

Theorem 1.3. Assume that $m>\frac{N}{N-2 s}, f_{-} \equiv 0$, and condition (A1) holds. Then there exist $b^{*}, \Lambda^{*}>0$ such that for any $b \in\left(0, b^{*}\right)$ and $\lambda \in\left(0, \Lambda^{*}\right)$, problem 1.1) admits at least three positive solutions $u_{b}, u_{\lambda}, u_{\lambda, b}$ with

$$
I_{\lambda}\left(u_{\lambda}\right)<I_{\lambda}\left(u_{b}\right)<0<I_{\lambda}\left(u_{\lambda, b}\right)
$$

and $u_{\lambda}$ is a ground state solution.
Note that the corresponding results in [26] are generalized to the nonlocal fractional Kirchhoff problem and the existence results are extended in the sense that the restriction on the Kirchhoff coefficient $M$ is eliminated.

When $g(x) \equiv 1$, by Theorems 1.1 and 1.2 , we obtain the existence and multiplicity of positive solutions to the problem

$$
\begin{gathered}
M\left(\int_{\mathbb{R}^{2 N}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{N+2 s}} d x d y\right)(-\Delta)^{s} u=f_{\lambda}(x)|u|^{q-2} u+|u|^{2_{s}^{*}-2} u, \quad \text { in } \Omega \\
u=0, \quad \text { in } \mathbb{R}^{N} \backslash \Omega
\end{gathered}
$$

where $M(t)=a+b t^{m-1}$ with $a, b>0$ for $t \geq 0$ and $m \in\left[1,2_{s}^{*} / 2\right]$, which generalizes [17. Theorem 1.1].

In view of [2, 5], problem (1.1) appears more complicated because of the lack of compactness and the nonlocal nature of the fractional Laplacian. Theorems 1.1 1.3 can be regarded as generalizations of [26] for fractional Laplacian operators.

The rest of this paper is organized as follows. In Section 2, we present mathematical notation and technical lemmas. We prove Theorems 1.1 and 1.2 in Section 3 , and prove Theorem 1.3 in Section 4.

## 2. Preliminary Results

In this section, we introduce some notation, definitions and useful lemmas which will be used in the proofs of main results. We define the Hilbert space $H^{s}\left(\mathbb{R}^{N}\right)$ by

H^{s}\left(\mathbb{R}^{N}\right):=\left\{u \in L^{2}\left(\mathbb{R}^{N}\right): \frac{|u(x)-u(y)|}{|x-y|^{\frac{N+2 s}{2}}} \in L^{2}\left(\mathbb{R}^{N} \times \mathbb{R}^{N}\right)\right\}
$$

endowed with the norm

$$
\begin{equation*}
\|u\|_{H^{s}\left(\mathbb{R}^{N}\right)}=\left(\int_{\mathbb{R}^{N}}|u|^{2} d x+\int_{\mathbb{R}^{2 N}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{N+2 s}} d x d y\right)^{1 / 2} \tag{2.1}
\end{equation*}
$$

where the term

$$
[u]_{s}=\left(\int_{\mathbb{R}^{2 N}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{N+2 s}} d x d y\right)^{1 / 2}
$$

is the so-called Gagliardo semi-norm of $u$. In view of (1.2) and [18, Proposition 3.6], we have

$$
\left\|(-\Delta)^{s / 2} u\right\|_{2}^{2}=\frac{1}{C_{s}} \int_{\mathbb{R}^{2 N}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{N+2 s}} d x d y
$$

where $C_{s}$ is a positive constant depending on $s$. We define $\mathcal{D}^{s, 2}\left(\mathbb{R}^{N}\right)$ as the closure of $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ with the norm

$$
\|u\|_{\mathcal{D}^{s, 2}}=\left(\int_{\mathbb{R}^{N}}\left|(-\Delta)^{s / 2} u\right|^{2} d x\right)^{1 / 2}
$$

Then $\mathcal{D}^{s, 2}\left(\mathbb{R}^{N}\right)$ is continuously embedded into $L^{2_{s}^{*}}\left(\mathbb{R}^{N}\right)$. As in [7, Theorem 1.1], let $S$ be the best constant of the fractional Sobolev embedding $\mathcal{D}^{s, 2}\left(\mathbb{R}^{N}\right) \hookrightarrow L^{2_{s}^{*}}\left(\mathbb{R}^{N}\right)$ defined by

\begin{equation*}
S=\inf _{u \in \mathcal{D}^{s, 2}\left(\mathbb{R}^{N}\right) \backslash\{0\}} \frac{\int_{\mathbb{R}^{2 N}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{N+2 s}} d x d y}{\left(\int_{\mathbb{R}^{N}}|u|^{2_{s}^{*}} d x\right)^{2 / 2_{s}^{*}}} \tag{2.2}
\end{equation*}
$$

which is well-defined and strictly positive.
We define

$$
E_{0}=\left\{u \in H^{s}\left(\mathbb{R}^{N}\right): u=0 \quad \text { a.e. in } \mathbb{R}^{N} \backslash \Omega\right\}
$$

with the norm

$$
\|u\|_{E_{0}}=\left(\int_{\mathbb{R}^{2 N}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{N+2 s}} d x d y\right)^{1 / 2}
$$

which is equivalent to (2.1) 19, 20. The embedding $E_{0} \hookrightarrow L^{r}(\Omega)$ is continuous for any $r \in\left[1,2_{s}^{*}\right]$ and compact whenever $r \in\left[1,2_{s}^{*}\right)$. We recall that $\left(E_{0},\|\cdot\|_{E_{0}}\right)$ is a Hilbert space with the inner product defined by

$$
\langle u, v\rangle=\int_{\mathbb{R}^{2 N}} \frac{(u(x)-u(y))(v(x)-v(y))}{|x-y|^{N+2 s}} d x d y
$$

For simplicity, we will just denote $\|\cdot\|_{E_{0}}$ and $\|\cdot\|_{L^{p}(\Omega)}$ by $\|\cdot\|$ and $|\cdot|_{p}$, respectively. Throughout this paper, the letters $C, C_{i}, i=1,2, \ldots$ denote positive constants which may vary from line to line but independent of the associated terms and parameters.

As we see, $I_{\lambda}$ is of class $C^{1}$ in $E_{0}$ and for any $v \in E_{0}$ it holds

$$
\begin{aligned}
\left\langle I_{\lambda}^{\prime}(u), v\right\rangle= & M\left(\|u\|^{2}\right) \int_{\mathbb{R}^{2 N}} \frac{(u(x)-u(y))(v(x)-v(y))}{|x-y|^{N+2 s}} d x d y \\
& -\int_{\Omega} f_{\lambda}(x)|u|^{q-2} u v d x-\int_{\Omega} g(x)|u|^{2_{s}^{*}-2} u v d x
\end{aligned}
$$

Define the Nehari manifold associated with $I_{\lambda}$ by

$$
N_{\lambda}=\left\{u \in E_{0} \backslash\{0\}:\left\langle I_{\lambda}^{\prime}(u), u\right\rangle=0\right\} .
$$

It is well-known that the Nehari manifold is closely related to the behavior of the fibering $\operatorname{map} \phi_{u}: t \in \mathbb{R}^{+} \rightarrow I_{\lambda}(t u)$ [2, 8]. Thus, we have

$$
\begin{aligned}
& \phi_{u}^{\prime}(t)=a t\|u\|^{2}+b t^{2 m-1}\|u\|^{2 m}-t^{q-1} \int_{\Omega} f_{\lambda}(x)|u|^{q} d x-t^{2_{s}^{*}-1} \int_{\Omega} g(x)|u|^{2_{s}^{*}} d x \\
& \phi_{u}^{\prime \prime}(t)= a\|u\|^{2}+(2 m-1) b t^{2 m-2}\|u\|^{2 m} \\
& \quad-(q-1) t^{q-2} \int_{\Omega} f_{\lambda}(x)|u|^{q} d x-\left(2_{s}^{*}-1\right) t^{2_{s}^{*}-2} \int_{\Omega} g(x)|u|^{2_{s}^{*}} d x
\end{aligned}
$$

Then $u \in N_{\lambda}$ if and only if $\phi_{u}^{\prime}(1)=0$. Moreover, for $u \in N_{\lambda}$ we have

\begin{equation*}
\phi_{u}^{\prime \prime}(1)=a(2-q)\|u\|^{2}+b(2 m-q)\|u\|^{2 m}-\left(2_{s}^{*}-q\right) \int_{\Omega} g(x)|u|^{2_{s}^{*}} d x \tag{2.3}
\end{equation*}
$$

or

$$
\begin{equation*}
\phi_{u}^{\prime \prime}(1)=a\left(2-2_{s}^{*}\right)\|u\|^{2}+b\left(2 m-2_{s}^{*}\right)\|u\|^{2 m}-\left(q-2_{s}^{*}\right) \int_{\Omega} f_{\lambda}(x)|u|^{q} d x . \tag{2.4}
\end{equation*}
$$

We split $N_{\lambda}$ into three parts:

$$
\begin{aligned}
& N_{\lambda}^{+}=\left\{u \in N_{\lambda} \mid \phi_{u}^{\prime \prime}(1)>0\right\}, \\
& N_{\lambda}^{-}=\left\{u \in N_{\lambda} \mid \phi_{u}^{\prime \prime}(1)<0\right\}, \\
& N_{\lambda}^{0}=\left\{u \in N_{\lambda} \mid \phi_{u}^{\prime \prime}(1)=0\right\},
\end{aligned}
$$

and define

$$
\begin{aligned}
H^{+} & =\left\{\left.u \in E_{0}\left|\int_{\Omega} f_{\lambda}(x)\right| u\right|^{q} d x>0\right\}, & H^{-}=\left\{\left.u \in E_{0}\left|\int_{\Omega} f_{\lambda}(x)\right| u\right|^{q} d x \leq 0\right\}, \\
G^{+} & =\left\{\left.u \in E_{0}\left|\int_{\Omega} g(x)\right| u\right|^{2_{s}^{*}} d x>0\right\}, & G^{-}=\left\{\left.u \in E_{0}\left|\int_{\Omega} g(x)\right| u\right|^{2_{s}^{*}} d x \leq 0\right\} .
\end{aligned}
$$

In view of $m \leq \frac{N}{N-2 s}$ and following [17, Lemma 3.2], we can derive the following lemma immediately.
Lemma 2.1. If $u$ is a minimizer of $I_{\lambda}$ on $N_{\lambda}$ such that $u \notin N_{\lambda}^{0}$, then $I_{\lambda}^{\prime}(u)=0$ in $E_{0}^{-1}$.

Lemma 2.2. For any $\lambda>0$, the functional $I_{\lambda}$ is coercive and bounded below on $N_{\lambda}$.
Proof. For $u \in N_{\lambda}$, from (2.2) and Hölder's inequality, we have

\begin{aligned}
I_{\lambda}(u) & =I_{\lambda}(u)-\frac{1}{2_{s}^{*}}\left\langle I_{\lambda}^{\prime}(u), u\right\rangle \\
& =\left(\frac{1}{2}-\frac{1}{2_{s}^{*}}\right) a\|u\|^{2}+\left(\frac{1}{2 m}-\frac{1}{2_{s}^{*}}\right) b\|u\|^{2 m}-\left(\frac{1}{q}-\frac{1}{2_{s}^{*}}\right) \int_{\Omega} f_{\lambda}(x)|u|^{q} d x \\
& \geq\left(\frac{1}{2}-\frac{1}{2_{s}^{*}}\right) a\|u\|^{2}-\left(\frac{1}{q}-\frac{1}{2_{s}^{*}}\right) \lambda\left|f_{+}\right|_{q^{*}} S^{-q / 2}\|u\|^{q} .
\end{aligned}
$$

Recalling that $1<q<2$, we obtain that $I_{\lambda}$ is coercive and bounded below on $N_{\lambda}$.

Let

$$
\begin{equation*}
\lambda_{1}=\left[\frac{a(2-q)}{2_{s}^{*}-q}\right]^{\frac{2-q}{2_{s}^{*}-2}} \frac{a\left(2_{s}^{*}-2\right) S^{\frac{2^{*}-q}{2_{s}^{*}-2}}}{\left(2_{s}^{*}-q\right)\left|f_{+}\right|_{q^{*}}^{*}} . \tag{2.5}
\end{equation*}
$$

Lemma 2.3. There exists $\lambda_{1}>0$ such that $N_{\lambda}^{0}=\emptyset$ for $\lambda \in\left(0, \lambda_{1}\right)$.
Proof. By contradiction assume that for some $\lambda \in\left(0, \lambda_{1}\right)$, there is a function $u \in$ $N_{\lambda}^{0}$. Then from (2.3) and (2.4), we have

$$
\begin{array}{r}
a(2-q)\|u\|^{2}+b(2 m-q)\|u\|^{2 m}-\left(2_{s}^{*}-q\right) \int_{\Omega} g(x)|u|^{2_{s}^{*}} d x=0, \\
a\left(2-2_{s}^{*}\right)\|u\|^{2}+b\left(2 m-2_{s}^{*}\right)\|u\|^{2 m}-\left(q-2_{s}^{*}\right) \int_{\Omega} f_{\lambda}(x)|u|^{q} d x=0 . \tag{2.7}
\end{array}
$$

It follows from (A1), 2.6) and 2.2) that

$$
\begin{equation*}
\|u\|^{2} \leq \frac{2_{s}^{*}-q}{a(2-q)}|u|_{2_{s}^{*}}^{2_{s}^{*}} \leq \frac{2_{s}^{*}-q}{a(2-q)} S^{-\frac{2_{s}^{*}}{2}}\|u\|^{\|_{s}^{*}} \tag{2.8}
\end{equation*}
$$

Similarly, from 2.2, 2.7 and Hölder's inequality, we can deduce that

$$
\begin{equation*}
\|u\|^{2} \leq \frac{2_{s}^{*}-q}{a\left(2_{s}^{*}-2\right)} \lambda \int_{\Omega} f_{+}|u|^{q} d x \leq \frac{2_{s}^{*}-q}{a\left(2_{s}^{*}-2\right)} \lambda\left|f_{+}\right|_{q^{*}} S^{-q / 2}\|u\|^{q} \tag{2.9}
\end{equation*}
$$

Combining (2.8) and 2.9 yields

$$
\left[\frac{a(2-q)}{2_{s}^{*}-q} S^{\frac{2_{s}^{*}}{2}}\right]^{\frac{1}{2_{s}^{*}-2}} \leq\|u\| \leq\left[\frac{\left(2_{s}^{*}-q\right) \lambda\left|f_{+}\right|_{q^{*}} S^{-q / 2}}{a\left(2_{s}^{*}-2\right)}\right]^{\frac{1}{2-q}}
$$

Therefore,

$$
\lambda \geq\left[\frac{a(2-q)}{2_{s}^{*}-q}\right]^{\frac{2-q}{2_{s}^{*}-2}} \frac{a\left(2_{s}^{*}-2\right) S^{\frac{2_{s}^{*}-q}{2_{s}^{*}-2}}}{\left(2_{s}^{*}-q\right)\left|f_{+}\right|_{q^{*}}}=\lambda_{1} .
$$

This is a contradiction.
We define

$$
\lambda_{2}= \begin{cases}\lambda_{1}, & m<\frac{N}{N-2 s},  \tag{2.10}\\ \left(\frac{1}{1-b S^{m}}\right)^{\frac{2-q}{2-2}} \lambda_{1}, & m=\frac{N}{N-2 s}, b<1 / S^{m} .\end{cases}
$$

The lemma below shows that the component sets $N_{\lambda}^{+}$and $N_{\lambda}^{-}$are nonempty.
Lemma 2.4. Assume $m<\frac{N}{N-2 s}$. Then the following two statements are true.
(i) For any $u \in G^{+} \cap H^{+}$and $\lambda \in\left(0, \lambda_{2}\right)$, there exist $0<t^{+}=t^{+}(u)<t_{\max }<$ $t^{-}=t^{-}(u)$ such that $t^{+} u \in N_{\lambda}^{+}, t^{-} u \in N_{\lambda}^{-}$and

$$
I_{\lambda}\left(t^{+} u\right)=\inf _{0 \leq t \leq t^{-}} I_{\lambda}(t u), \quad I_{\lambda}\left(t^{-} u\right)=\sup _{t \geq t_{\max }} I_{\lambda}(t u)
$$

(ii) For any $u \in G^{+} \cap H^{-}$and $\lambda>0$, there exists a unique $t^{-}=t^{-}(u)>t_{\max }$ such that $t^{-} u \in N_{\lambda}^{-}$and

I_{\lambda}\left(t^{-} u\right)=\sup _{t \geq 0} I_{\lambda}(t u)
$$

Proof. Fix $u \in E_{0} \backslash\{0\}$ and define $\psi_{u}(t): \mathbb{R}^{+} \rightarrow \mathbb{R}$ by

We remark that $t u \in N_{\lambda}$ if and only if $\psi_{u}(t)=\int_{\Omega} f_{\lambda}|u|^{q} d x$.
(i) Let $u \in G^{+} \cap H^{+}$. From 2.11, it is easy to check that

Define $\psi_{u}^{\prime}(t)=t^{1-q} h_{u}(t)$, where

Then, there exists a unique $t_{0}>0$ such that $h_{u}^{\prime}\left(t_{0}\right)=0$, where

t_{0}=\left(\frac{(2 m-q)(2 m-2) b\|u\|^{2 m}}{\left(2_{s}^{*}-q\right)\left(2_{s}^{*}-2\right) \int_{\Omega} g(x)|u|^{2_{s}^{*}} d x}\right)^{\frac{1}{2_{s}^{*}-2 m}}
$$

From $m<\frac{N}{N-2 s}$ it follows that $\lim _{t \rightarrow 0^{+}} h_{u}(t)>0$ and $\lim _{t \rightarrow \infty} h_{u}(t)=-\infty$. This implies that there is a unique $t_{\max }>t_{0}$ such that $h_{u}\left(t_{\max }\right)=0$. Hence, $\psi_{u}^{\prime}(t)>$

0 for $t \in\left(0, t_{\max }\right), \psi_{u}^{\prime}(t)<0$ for $t \in\left(t_{\max }, \infty\right)$ and $\psi_{u}^{\prime}\left(t_{\max }\right)=0$. Moreover, $\psi_{u}\left(t_{\max }\right)=\max _{t>0} \psi_{u}(t) \geq \max _{t>0} \bar{\psi}_{u}(t)$, where

From 2.2 it follows that

\max _{t>0} \bar{\psi}_{u}(t) & =\|u\|^{q} \frac{a\left(2_{s}^{*}-2\right)}{2_{s}^{*}-q}\left(\frac{(2-q) a\|u\|^{2_{s}^{*}}}{\left(2_{s}^{*}-q\right) \int_{\Omega} g(x)|u|^{2_{s}^{*}} d x}\right)^{\frac{2-q}{2_{s}^{*}-2}} \\
& \geq\|u\|^{q} \frac{a\left(2_{s}^{*}-2\right)}{2_{s}^{*}-q}\left(\frac{(2-q) a S^{\frac{2_{s}^{*}}{2}}}{2_{s}^{*}-q}\right)^{\frac{2-q}{2_{s}^{*}-2}}
\end{aligned}
$$

For $u \in H^{+}$, it holds

$$
\psi_{u}(0)=0<\int_{\Omega} f_{\lambda}(x)|u|^{q} d x \leq \lambda \int_{\Omega} f_{+}|u|^{q} d x \leq \lambda\left|f_{+}\right|_{q^{*}} S^{-q / 2}\|u\|^{q}
$$

So, if

\lambda<\lambda_{1}=\frac{a\left(2_{s}^{*}-2\right) S^{\frac{2_{s}^{*}-q}{2_{s}^{*}-2}}}{\left(2_{s}^{*}-q\right)\left|f_{+}\right|_{q^{*}}}\left(\frac{(2-q) a}{2_{s}^{*}-q}\right)^{\frac{2-q}{2_{s}^{2}-2}},
$$

there exist unique $t^{+}=t^{+}(u)<t_{\text {max }}$ and $t^{-}=t^{-}(u)>t_{\max }$ such that

$$
\psi_{u}\left(t^{+}\right)=\int_{\Omega} f_{\lambda}(x)|u|^{q} d x=\psi_{u}\left(t^{-}\right), \quad \psi_{u}^{\prime}\left(t^{+}\right)>0, \quad \psi_{u}^{\prime}\left(t^{-}\right)<0
$$

which implies $t^{+} u, t^{-} u \in N_{\lambda}$. According to $\phi_{u}^{\prime \prime}(1)=t^{q+1} \psi_{u}^{\prime}(t)$, we can deduce that $t^{+} u \in N_{\lambda}^{+}$and $t^{-} u \in N_{\lambda}^{-}$. Since $\phi_{u}^{\prime}(t)=t^{q-1}\left(\psi_{u}(t)-\int_{\Omega} f_{\lambda}(x)|u|^{q} d x\right)$, it is clear that $\phi_{u}^{\prime}(t)<0$ for $t \in\left[0, t^{+}\right)$and $\phi_{u}^{\prime}(t)>0$ for $t \in\left(t^{+}, t^{-}\right)$. This indicates that $I_{\lambda}\left(t^{+} u\right)=\inf _{0 \leq t \leq t^{-}} I_{\lambda}(t u)$.

Similarly, from $\phi_{u}^{\prime}(t)>0$ for $t \in\left(t^{+}, t^{-}\right)$and $\phi_{u}^{\prime}(t)<0$ for $t \in\left(t^{-}, \infty\right)$, we can obtain $I_{\lambda}\left(t^{-} u\right)=\sup _{t \geq t_{\text {max }}} I_{\lambda}(t u)$.
(ii) The proof is essentially the same as that in Part (i), so we omit it.

As in Lemma 2.4 we can deduce the following two lemmas.
Lemma 2.5. Assume that $m=\frac{N}{N-2 s}$ and $b \geq 1 / S^{m}$. Then for any $u \in H^{+}$, there exists a unique $0<t^{+}<t_{\max }$ such that $t^{+} u \in N_{\lambda}$ and $I_{\lambda}\left(t^{+} u\right)=\inf _{t \geq 0} I_{\lambda}(t u)$.

Lemma 2.6. Assume that $m=\frac{N}{N-2 s}$ and $b<1 / S^{m}$. Then the following two statements are true.
(i) For any $u \in H^{+}$and $\lambda \in\left(0, \lambda_{2}\right)$, there exist $0<t^{+}=t^{+}(u)<t_{\max }<t^{-}=$ $t^{-}(u)$ such that $t^{+} u \in N_{\lambda}^{+}, t^{-} u \in N_{\lambda}^{-}$and

$$
I_{\lambda}\left(t^{+} u\right)=\inf _{0 \leq t \leq t^{-}} I_{\lambda}(t u), \quad I_{\lambda}\left(t^{-} u\right)=\sup _{t \geq t_{\max }} I_{\lambda}(t u)
$$

(ii) For any $u \in H^{-}$and $\lambda>0$, there exists a unique $t^{-}=t^{-}(u)>t_{\max }$ such that $t^{-} u \in N_{\lambda}^{-}$and

I_{\lambda}\left(t^{-} u\right)=\sup _{t \geq 0} I_{\lambda}(t u)
$$

Lemma 2.7. Assume $\lambda \in\left(0, \lambda_{1}\right)$. Then for any $u \in N_{\lambda}^{+}$and $v \in N_{\lambda}^{-}$, there exist $B_{0}>B_{\lambda}>0$ such that $\|v\|>B_{0}>B_{\lambda}>\|u\|$.

Proof. Let $u \in N_{\lambda}^{+} \subset N_{\lambda}$. In view of 2.2 and 2.4, it follows from Hölder's inequality that

By a direct calculation, we can verify that $B_{0}>B_{\lambda}$ for $\lambda \in\left(0, \lambda_{1}\right)$, where $\lambda_{1}$ is given in 2.5.

Corollary $2.8\left([11)\right.$. For any $\lambda \in\left(0, \lambda_{1}\right), N_{\lambda}^{-}$is a closed set in $E_{0}$ topology.

## 3. Proof of Theorems 1.1 and 1.2

In this section, we discuss the existence and multiplicity of solutions to problem (1.1) when $m \leq \frac{N}{N-2 s}$. From Lemmas 2.3, 2.4 and 2.6. if $m<\frac{N}{N-2 s}$ or $m=\frac{N}{N-2 s}$, and $b<1 / S^{m}$ holds for any $\lambda \in\left(0, \lambda_{1}\right)$, then $N_{\lambda}=N_{\lambda}^{+} \cup N_{\lambda}^{-}$. Now, we study the infimum of $I_{\lambda}$ on the $N_{\lambda}^{ \pm}$by defining $c_{\lambda}^{ \pm}=\inf _{N_{\lambda}^{ \pm}} I_{\lambda}(u)$ and $\lambda_{3}=\frac{q}{2} \lambda_{1}$.

Lemma 3.1. Assume that $m<\frac{N}{N-2 s}$ or $m=\frac{N}{N-2 s}$, and $b<1 / S^{m}$. Then
(i) for any $\lambda \in\left(0, \lambda_{1}\right)$, we have $c_{\lambda}^{+}=\inf _{u \in N_{\lambda}^{+}} I_{\lambda}(u)<0$;
(ii) for any $\lambda \in\left(0, \lambda_{3}\right)$, we have $c_{\lambda}^{-} \geq \alpha>0$. In particular, if $\lambda \in\left(0, \lambda_{1}\right)$, then

c_{\lambda}^{+}=\inf _{u \in N_{\lambda}} I_{\lambda}(u)
$$

Proof. (i) For $u \in N_{\lambda}^{+}$, it follows from (2.4) that

& =\left(\frac{1}{2}-\frac{1}{2_{s}^{*}}\right) a\|u\|^{2}+\left(\frac{1}{2 m}-\frac{1}{2_{s}^{*}}\right) b\|u\|^{2 m}-\left(\frac{1}{q}-\frac{1}{2_{s}^{*}}\right) \int_{\Omega} f_{\lambda}(x)|u|^{q} d x \\
& \leq-\left(\frac{1}{q}-\frac{1}{2}\right)\left(1-\frac{2}{2_{s}^{*}}\right) a\|u\|^{2}-\left(\frac{1}{q}-\frac{1}{2 m}\right)\left(1-\frac{2 m}{2_{s}^{*}}\right) b\|u\|^{2 m} \\
& <0 .
\end{aligned}
$$

(ii) For $u \in N_{\lambda}^{-}$, applying Lemma 2.7 and $\lambda \in\left(0, \lambda_{3}\right)$, we deduce

I_{\lambda}(u)=\left(\frac{1}{2}-\frac{1}{2_{s}^{*}}\right) a\|u\|^{2}+\left(\frac{1}{2 m}-\frac{1}{2_{s}^{*}}\right) b\|u\|^{2 m}-\left(\frac{1}{q}-\frac{1}{2_{s}^{*}}\right) \int_{\Omega} f_{\lambda}(x)|u|^{q} d x
$$

$$
\begin{aligned}
& \geq\|u\|^{q}\left[\frac{a s}{N}\left(\frac{a(2-q)}{2_{s}^{*}-q} S^{\frac{2_{s}^{*}}{2}}\right)^{\frac{2-q}{2_{s}^{*}-2}}-\lambda\left(\frac{1}{q}-\frac{1}{2_{s}^{*}}\right)\left|f_{+}\right|_{q^{*}} S^{-q / 2}\right] \\
& \geq \frac{\left(2_{s}^{*}-q\right)\left|f_{+}\right|_{q^{*}}\|u\|^{q}}{2_{s}^{*} q S^{\frac{q}{2}}}\left(\lambda_{3}-\lambda\right) \\
& \geq \alpha>0
\end{aligned}
$$

Lemma 3.2. For each $u \in N_{\lambda}^{ \pm}$and $\lambda \in\left(0, \lambda_{1}\right)$, there is a number $\epsilon$ and $a$ differentiable function $\zeta: B(0, \epsilon) \subseteq E \rightarrow \mathbb{R}$ such that $\zeta(0)=1$, the function $\zeta(v)(u-v) \in N_{\lambda}^{ \pm}$, and

\begin{aligned}
& \left\langle\zeta^{\prime}(0), v\right\rangle \\
& =\frac{2 a\langle u, v\rangle+2 m b\|u\|^{2(m-1)}\langle u, v\rangle-q \int_{\Omega} f_{\lambda}|u|^{q-2} u v d x-2_{s}^{*} \int_{\Omega} g|u|^{2_{s}^{*}-2} u v d x}{(2-q) a\|u\|^{2}+(2 m-q) b\|u\|^{2 m}-\left(2_{s}^{*}-q\right) \int_{\Omega} g|u|^{2_{s}^{*}} d x},
\end{aligned}
$$

where

\langle u, v\rangle=\int_{\mathbb{R}^{2 N}} \frac{(u(x)-u(y))(v(x)-v(y))}{|x-y|^{N+2 s}} d x d y
$$

for $v \in B_{\epsilon}(0)=\left\{v \in E_{0}:\|v\| \leq \epsilon\right\}$.
The proof of the above lemma is similar to that of [11, Lemma 3.4], we omit it here.

Lemma 3.3. Assume that $\lambda \in\left(0, \lambda_{1}\right)$. Then there exists a minimizing sequence $\left\{u_{k}\right\} \subset N_{\lambda}$ such that

\end{equation*}
$$

with $c_{\lambda}=\inf _{u \in N_{\lambda}} I_{\lambda}(u)$.
Proof. It follows form Lemma 2.2 and the Ekeland's variational principle [9] that there exists a minimizing sequence $\left\{u_{k}\right\} \subset N_{\lambda}$ such that

From (3.3) and Lemma 2.2, we have $\sup _{k}\left\|u_{k}\right\|<\infty$. Now, we claim that $\left\|I_{\lambda}^{\prime}\left(u_{k}\right)\right\|_{E_{0}^{-1}} \rightarrow$ 0 as $k \rightarrow \infty$. From Lemma 3.2 , we know the differentiable functions $\zeta_{k}: B_{\epsilon_{k}}(0) \rightarrow \mathbb{R}$ for some $\epsilon_{k}>0$ such that $\zeta_{k}(v)\left(u_{k}-v\right) \in N_{\lambda}$ for $v \in B_{\epsilon_{k}}(0)$. For a fixed $k$, we take $0<\varrho<\epsilon_{k}$ and define $v_{\varrho}=\varrho u /\|u\|$ with $u \in E_{0}, u \not \equiv 0$ and $\omega_{\varrho}=\zeta_{k}\left(v_{\varrho}\right)\left(u_{k}-v_{\varrho}\right)$. Then it is easy to see that $\omega_{\varrho} \in N_{\lambda}$. By (3.4), we can deduce that

I_{\lambda}\left(\omega_{\varrho}\right)-I_{\lambda}\left(u_{k}\right) \geq-\frac{1}{k}\left\|\omega_{\varrho}-u_{k}\right\|

which implies

\left\langle I_{\lambda}^{\prime}\left(u_{k}\right), \omega_{\varrho}-u_{k}\right\rangle+o_{k}\left(\left\|\omega_{\varrho}-u_{k}\right\|\right) \geq-\frac{1}{k}\left\|\omega_{\varrho}-u_{k}\right\| .

Then $\left\langle I_{\lambda}^{\prime}\left(\omega_{\varrho}\right), u_{k}-v_{\varrho}\right\rangle=0$ yields

& -\varrho\left\langle I_{\lambda}^{\prime}\left(u_{k}\right), \frac{u}{\|u\|}\right\rangle+\left(\zeta_{k}\left(v_{\varrho}\right)-1\right)\left\langle I_{\lambda}^{\prime}\left(u_{k}\right)-I_{\lambda}^{\prime}\left(\omega_{\varrho}\right), u_{k}-v_{\varrho}\right\rangle \\
& \geq-\frac{1}{k}\left\|\omega_{\varrho}-u_{k}\right\|+o_{k}\left(\left\|\omega_{\varrho}-u_{k}\right\|\right) .
\end{aligned}
$$

That is,

\left\langle I_{\lambda}^{\prime}\left(u_{k}\right), \frac{u}{\|u\|}\right\rangle \leq & \frac{1}{k \varrho}\left\|\omega_{\varrho}-u_{k}\right\|+\frac{o_{k}\left(\left\|\omega_{\varrho}-u_{k}\right\|\right)}{\varrho}  \tag{3.5}\\
& +\frac{\left(\zeta_{k}\left(v_{\varrho}\right)-1\right)}{\varrho}\left\langle I_{\lambda}^{\prime}\left(u_{k}\right)-I_{\lambda}^{\prime}\left(\omega_{\varrho}\right), u_{k}-v_{\varrho}\right\rangle
\end{align*}
$$

Since $\left\|\omega_{\varrho}-u_{k}\right\| \leq \rho\left|\zeta_{k}\left(v_{\varrho}\right)\right|+\left|\zeta_{k}\left(v_{\varrho}\right)-1\right|\left\|u_{k}\right\|$ and $\lim _{\varrho \rightarrow 0} \frac{\left|\zeta_{k}\left(v_{\varrho}\right)-1\right|}{\varrho} \leq\left\|\zeta_{k}^{\prime}(0)\right\|$, taking the limit $\varrho \rightarrow 0^{+}$in (3.5), we obtain

\left\langle I_{\lambda}^{\prime}\left(u_{k}\right), \frac{u}{\|u\|}\right\rangle \leq \frac{C}{k}\left(1+\left\|\zeta_{k}^{\prime}(0)\right\|\right)
$$

for some $C>0$ independent of $u$.
It suffices to show that $\left\|\zeta_{k}^{\prime}(0)\right\|$ is bounded. Assume by contradiction that $\left\langle\zeta^{\prime}(0), v\right\rangle=\infty$. It follows from Lemma 3.2 and Hölder's inequality that

for some $C>0$, which implies that there exists a subsequence $\left\{u_{k}\right\}$ such that

(2-q) a\left\|u_{k}\right\|^{2}+(2 m-q) b\left\|u_{k}\right\|^{2 m}-\left(2_{s}^{*}-q\right) \int_{\Omega} g(x)\left|u_{k}\right|^{2_{s}^{*}} d x=o_{k}(1) \tag{3.6}
\end{equation*}
$$

Analogously, we can obtain

\end{equation*}

From (3.6) and (3.7), as in the proof of Lemma 2.3 , we can see that $\lambda \geq \lambda_{1}$, which is impossible.

We define

D=\frac{(2-q)\left(2_{s}^{*}-q\right)\left|f_{+}\right|_{q^{*}}^{\frac{2}{2-q}}}{2 q 2_{s}^{*}}\left(\frac{2_{s}^{*}-q}{\left(2_{s}^{*}-2\right) S}\right)^{\frac{q}{2-q}}
$$

Lemma 3.4. Assume that $m \leq \frac{N}{N-2 s}$. Then $I_{\lambda}$ satisfies the $(P S)$ condition at the level $c_{\lambda}<c_{\lambda}^{*}$, where $c_{\lambda}^{*}$ is given in (3.8).
Proof. Let $\left\{u_{n}\right\}$ be a $(P S)_{c_{\lambda}}$ sequence satisfying 3.2 . It follows from Lemma 2.2 that $\left\{u_{n}\right\}$ is bounded in $E_{0}$. Hence, we may assume that, up to a subsequence, there exists $u \in E_{0}$ such that

We can assume that $\lim _{n \rightarrow \infty}\left\|v_{n}\right\|=d_{1}>0$. Otherwise, the conclusion follows. From [1, Lemma 2.7], 3.9) and condition (A1), we have

Hence, from Lemma 2.4 we can infer that there exist $t^{-}\left(u_{1}\right)>t^{+}\left(u_{1}\right)>0$ such that $t^{-} u_{1} \in N_{\lambda}^{-}$and $t^{+} u_{1} \in N_{\lambda}^{+}$. This implies $t^{-}=1$ and $t^{+}<1$. Therefore, there exists $\tilde{t} \in\left(t^{+}, t^{-}\right)$such that

Then, we prove that $u_{1}$ is a local minimizer of $I_{\lambda}$ in $E_{0}$. From Lemmas 2.4 and 2.6. we have $t^{+}\left(u_{1}\right)=1<t_{\max }\left(u_{1}\right)$. From continuity of $u \mapsto t_{\max }(u)$, for the fixed $\epsilon>0$, there exists $\delta_{1}=\delta_{1}(\epsilon)>0$ such that $t_{\max }\left(u_{1}-u\right)>1+\epsilon$ for all $\|u\|<\delta_{1}$. Meanwhile, by Lemma 3.2, we can see that for a given $\delta_{2}>0$, there exists a $C^{1}$ $\operatorname{map} \zeta: B_{\delta_{2}}(0) \rightarrow \mathbb{R}^{+}$such that $\zeta(u)\left(u_{1}-u\right) \in N_{\lambda}^{+}$and $\zeta(0)=1$. Hence, taking into account $0<\delta=\min \left\{\delta_{1}, \delta_{2}\right\}$ and the uniqueness of zeros of fibering map, we have $t^{+}\left(u_{1}-u\right)=\zeta(u)<1+\epsilon<t_{\max }\left(u_{1}-u\right)$ for all $\|u\|<\delta$. By $t_{\max }\left(u_{1}-u\right)>1$, we obtain $I_{\lambda}\left(u_{1}\right) \leq I_{\lambda}\left(t^{+}\left(u_{1}-u\right)\left(u_{1}-u\right)\right) \leq I_{\lambda}\left(u_{1}-u\right)$, which implies that $u_{1}$ is a local minimizer of $I_{\lambda}$ in $E_{0}$.

Proof. We just prove the case of $m=\frac{N}{N-2 s}$ and $b<1 / S^{m}$, since the case of $m<\frac{N}{N-2 s}$ can be processed in a similar manner.

We claim that there exists a constant $\tilde{c}>0$ such that $0<t^{-}\left(\frac{u_{1}+t u_{\epsilon, \eta}}{\left\|u_{1}+t u_{\epsilon, \eta}\right\|}\right)<\tilde{c}$ for $m=\frac{N}{N-2 s}$ and $b<1 / S^{m}$. Otherwise, there is a sequence $\left\{t_{n}\right\} \subset \mathbb{R}^{+}$such that $t_{n} \rightarrow \infty$ and $t^{-}\left(\frac{u_{1}+t_{n} u_{\epsilon, \eta}}{\left\|u_{1}+t_{n} u_{\epsilon, \eta}\right\|}\right) \rightarrow \infty$ as $n \rightarrow \infty$. Let $v_{n}=\frac{u_{1}+t_{n} u_{\epsilon, \eta}}{\left\|u_{1}+t_{n} u_{\epsilon, \eta}\right\|}$. From 3.19, we deduce that

& \leq I_{\lambda}\left(u_{1}\right)+\frac{a}{2}\left\|t u_{\epsilon, \eta}\right\|^{2}+b C_{m}\left\|u_{1}\right\|^{2 m}+b D_{m}\left\|t u_{\epsilon, \eta}\right\|^{2 m} \\
&-\frac{1}{q} \int_{B_{\rho}(0)} f_{\lambda}\left(\int_{0}^{t u_{\epsilon, \eta}}\left[\left|u_{1}+s\right|^{q-1}-\left|u_{1}\right|^{q-1}\right] d s\right) d x  \tag{3.22}\\

Since $\gamma(0) \in A_{1}$ and $\gamma(1) \in A_{2}$, there exists $s \in(0,1)$ such that $u_{1}+s t_{1} u_{\epsilon, \eta} \in N_{\lambda}^{-}$, which implies $c_{\lambda}^{-} \leq \sup _{t \geq 0} I_{\lambda}\left(u_{1}+\right.$ $\left.t u_{\epsilon, \eta}\right)$. According to Lemma 3.8, we obtain $c_{\lambda}^{-}<c_{\lambda}^{*}$ for any $\lambda \in\left(0, \Lambda_{*}\right)$ and $b \in(0, \bar{b})$. In view of Corollary $2.8, N_{\lambda}^{-}$is a closed set. By Proposition 3.5, there exists $u_{2} \in N_{\lambda}^{-}$such that $I_{\lambda}^{\prime}\left(u_{2}\right)=0$ and $I_{\lambda}\left(u_{2}\right)=c_{\lambda}^{-}$. This indicates that $u_{2}$ is also a positive solution to problem (1.1).

Proof of Theorem 1.2. (i) From Lemma 2.5, we obtain $N_{\lambda}^{+}=N_{\lambda}$ and define $c_{\lambda}=$ $\inf _{u \in N_{\lambda}} I_{\lambda}(u)$. It is clear that $c_{\lambda}<0$. By Proposition 3.5 , there exists a $(P S)_{c_{\lambda}}$ sequence $\left\{u_{n}\right\} \subset N_{\lambda}^{+}$for $I_{\lambda}$. It follows from Lemma 2.2 that $\left\{u_{n}\right\}$ is bounded in $E_{0}$. Hence, up to a subsequence, there is $u \in E_{0}$ satisfying (3.9). Denote $v_{n}=u_{n}-u$, for $b \geq 1 / S^{m}$. Then

In this section, we assume that $m>\frac{N}{N-2 s}, f_{-} \equiv 0$ and condition (A1) holds. Let us start with a compactness result.

Proof. If $b=0$, we consider the functional $I_{\lambda}$ denoted by

\bar{m}_{\lambda} \leq I_{\lambda}\left(u_{0, b}\right)=I_{0}\left(u_{0, b}\right)-\lambda \int_{\Omega} f\left|u_{0, b}\right|^{q} d x=m_{0}-\lambda \int_{\Omega} f\left|u_{0, b}\right|^{q} d x \leq m_{0} \tag{4.4}
\end{equation*}
$$

In view of Lemma 4.2 and 4.2 , we have $m_{\lambda} \rightarrow 0$ as $\lambda \rightarrow 0$. Then, there exists $0<\lambda_{7} \leq \lambda_{6}$ such that $m_{0}<m_{\lambda}$ for any $b \in\left(0, b_{2}\right)$ and $\lambda \in\left(0, \lambda_{7}\right)$. Combining this and 4.4, we arrive at the desired result.

It follows from Lemmas 4.2 and 4.4 that $I_{\lambda}$ has the mountain pass geometry. Using the mountain pass theorem [24], there exists a $(P S)_{c_{\lambda, b}}$ sequence $\left\{u_{n}\right\} \subset E_{0}$, that is

$$
I_{\lambda}\left(u_{n}\right) \rightarrow c_{\lambda, b}, \quad\left\|I_{\lambda}^{\prime}\left(u_{n}\right)\right\|_{E_{0}^{-1}} \rightarrow 0
$$

We note that $c_{\lambda, b}$ has the characteristic property

$$
c=\inf _{\gamma \in \Gamma} \max _{t \in[0,1]} I(\gamma(t))
$$

where

$$
\Gamma:=\left\{\gamma \in \mathcal{C}\left([0,1], E_{0}\right): \gamma(0)=u_{b}, \gamma(1)=u_{b}+T u_{\epsilon, \eta}\right\}
$$

Similar to Lemma 3.8, we can obtain the following lemma.
Lemma 4.7. There exist $0<\Lambda^{*} \leq \lambda_{7}$ and $0<b^{*} \leq b_{2}$ such that for any $\lambda \in\left(0, \Lambda^{*}\right)$ and $b \in\left(0, b^{*}\right)$ it holds

$$
c_{\lambda, b} \leq \sup _{t \geq 0} I_{\lambda}\left(u_{b}+t u_{\epsilon, \eta}\right)<c_{\lambda, b}^{*}
$$

Proof of Theorem 1.3. By Lemmas 4.2 and 4.4, it is easy to see that $I_{\lambda}$ has the mountain pass geometry. i.e. there exists a bounded $(P S)_{c_{\lambda, b}}$ sequence $\left\{u_{n}\right\}$. It follows from Lemmas 4.1 and 4.7 that, up to a subsequence, there exists $u_{\lambda, b} \in E_{0}$ such that $I_{\lambda}\left(u_{\lambda, b}\right)=c_{\lambda, b}>0$. By Lemmas 4.3 and 4.5 and 4.6 problem 1.1) admits three positive solutions $u_{b}, u_{\lambda}$ and $u_{\lambda, b}$.
