<ul> <li>Research Title: Civil Affairs Framework for Executing Governance</li> <li>Authors: MAJ Melanie Collins and MAJ Jennifer Jantzi</li> <li>Research Question: What are the best methods and procedures for advising partner nation governments on performing governance responsibilities that can be applied to a CA instructional manual which CA teams can use as they deploy to guide them when advising, assisting and assessing local governance?</li> </ul>	<ul> <li>Research Design:</li> <li>Analyze how other USG organizations educate/train personnel on governance and what frameworks they utilize</li> <li>Analyze how civilian institutions teach governance</li> <li>Consult governance scholars, academics and SMEs</li> <li>Compile relevant practices that are applicable to CA</li> <li>Endstate:</li> <li>Develop an instructional manual that outlines the best methods and procedures for advising, assisting and assessing local governments that CA teams can use as they train and deploy</li> </ul>
<ul> <li>Background:</li> <li>The CA branch lacks adequate training to educate its Soldiers on how to execute governance.</li> <li>Governance proficiency is emphasized throughout CA doctrine as a foundation of the CA branch, specifically in DA Pamphlet 600-3, <i>Commissioned Officer Professional Development and Career Management</i>, and FM 3-57, <i>Civil Military Operations</i>.</li> <li>Despite the emphasis on governance proficiency, it is not covered in the Civil Affairs Qualification Course (CAQC), and there are no other opportunities for further professional development.</li> </ul>	<ul> <li>USASOC Benefits:</li> <li>Increased CA capability in executing governance responsibilites</li> <li>Universal understanding of CA methods and procedures to advise, assist and assess local governments</li> <li>Better understanding and ability to nest TTPs with interagency partners</li> <li>Fulfill 1<sup>st</sup> SFC 16-17 command training guidance objective of developing "governance formations that master the full spectrum of CA core activities"</li> </ul>
