Introduction

The Department of Human Resources (DHR) Georgia Oral Health Prevention Program (GOHPP) is located within the Division of Public Health. The mission of the GOHPP is to prevent dental disease for Georgia's children through education, prevention and early treatment. By using portable dental equipment (1-2 in each health district) or mobile dental trailers and vans (FY2006: 11 trailers in 10 health districts and 2 vans in Fulton) to provide school based prevention services on a regional basis, Public Health (PH) is effective in reaching low and middle-income children statewide and throughout each district/region.

The Georgia Health Policy Center (GHPC) was established in 1995 as a nonpartisan forum for consensus building among diverse interest groups. The Health Policy Center's fundamental mission is to improve the health status of all Georgians through research, policy development, and program design and evaluation. Strategically located in the Andrew Young School of Policy Studies at Georgia State University, Center staff collaborates with university faculty and representatives of numerous organizations to assist in formulating policy at the state and national levels on health care quality, access, and cost.

The GHPC has produced many Child Policy Briefs that address oral health and access to care for children. In May 2001, the Georgia Department of Human Resources contracted with the GHPC to produce the qualitative and quantitative report, *Kids and Dental Providers in Georgia: The Gap between Supply and Demand*^{1,2}. The August 2002 *Evaluation of the Georgia Oral Health Prevention Program* provided further documentation of oral health prevention activities in each of the dental public health districts and an assessment of local level oral health program needs. Through subsequent DHR contracts, the quantitative portion of the evaluation report was updated with calendar years 2001, 2002, and 2003 Medicaid data analysis and Public Health information.

This current report produces the latest update available with calendar year 2004 Medicaid claims data analysis of services provided to Medicaid and PeachCare enrolled children under age 19. This report provides data documenting progress made in providing oral health access to care for low and middle-income children and illustrates continuing challenges. The presented results provide useful information to state and local oral health providers and advocates for program planning and decision-making.

Methodology

The tables and figures produced for this report are based on analyses of calendar year 2004 Medicaid claims data by Georgia Health Policy Center (GHPC) staff and additional tables provided by the Department of Human Resources (DHR), Division of Public Health (DPH), Family Health Branch (FHB), Oral Health Section (OHS).

The following figures were produced by the Georgia Health Policy Center from CY2004 Medicaid claims data analyses: Figures 1, 2, 3, 4, 5, 6, 7, 8, 9, and Maps 2-7. Information on eligibility for the Free and Reduced Lunch Program for figure 7 was provided by the Georgia Department of Education, Office of Policy and External Affairs, Data Collection and Reporting Unit.

Figure 10 was produced by the GHPC from tables provided by the DHR, DPH, FHB, Oral Health Section. Figure 11 was produced by the DHR, DPH, FHB, Oral Health Section. Both, figures 10 and 11 were created with information provided by the Georgia Board of Dentistry. Map 1 was provided by the DHR, DPH, Office of Health Information and Policy.

For Figures 1, 8, and 9 county and district level PeachCare and Medicaid child counts were queried directly from the 2004 Medicaid claims data. The statewide total is a separate query directly from the claims data and takes into account the fact that children move among health districts. The “all programs total” is a separate query directly from the claims data and takes into account that children may move between Medicaid and PeachCare programs due to changes in parents’ income status.

For Figure 2, individual county and district counts of Medicaid and PeachCare enrolled dental providers are not intended to total to the statewide count. Dentist counts were queried directly from the 2004 Medicaid provider file. The statewide count takes into account that dentists may practice in more than one health district. Dentists practicing in more than one district are counted only once in the statewide total.

Rounded numbers are used throughout the report for consistency and to highlight key data information.

Preface: How to Use the Data

Funding for this publication is provided through the Georgia Department of Human Resources (DHR), Division of Public Health (DPH), Family Health Branch (FHB), Oral Health Section (OHS) and a Health and Human Resources (HRSA) grant; States Oral Health Collaborative Systems (Georgia Access to Dental Services/GADS III, federal fiscal years (FFY) funding for 2006 and 2007).

Public Health Oral Health Surveillance activities provide information that is not readily available from other resources. These activities include population surveys, assessments, and analysis of data to provide measurements of access to oral health care.

This publication is a collaborative and contracted project between Georgia State University's Georgia Health Policy Center (GHPC) and the DHR Oral Health Section. The data provided are a measurement of Medicaid and PeachCare dental claims submitted by dental providers statewide, documenting prevention and treatment services provided to Medicaid and PeachCare enrolled children ages 0 through 18 years old. These public health service data provide an assessment of access to oral health/dental care through publicly funded insurance programs.

Data provided in this publication are intended for use by public policy leaders and decision makers; the professional and academic dental community, and collaborative partners and advocates. This dental service information provides support for building and strengthening public oral health program infrastructure, increasing dental treatment service availability; and to support community collaborations that increase access to care for underserved populations in Georgia.

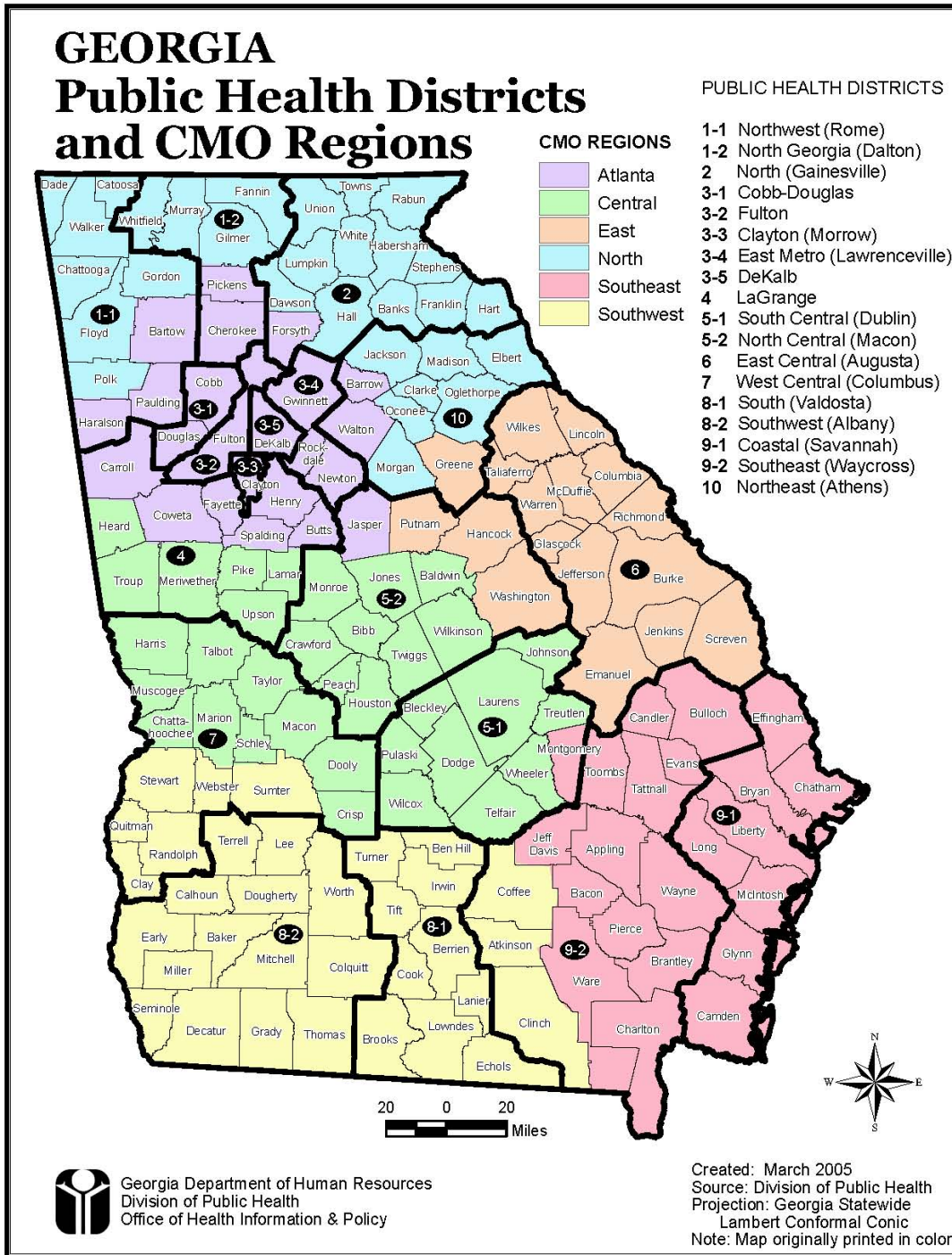
Executive Summary

Detailed tables outlining calendar year 2004 (CY2004) Medicaid/PeachCare service utilization are contained in the pages that follow. A summary of notable statewide observations is presented below. This information is provided to assist public program planning, statewide infrastructure building, and to support community collaborations that increase access to care.

- Dental service claims were filed for 50 percent of PeachCare enrolled children and 34 percent of Medicaid enrolled children statewide in CY2004.
 - ◆ The highest percentage of PeachCare enrolled children (55%) receiving services was reported in the Athens region.
 - ◆ The highest percentage of Medicaid enrolled children (38%) receiving services was reported in the Augusta region.
- CY2004 statewide dental service claims were reported for 38 percent of children enrolled in PeachCare and Medicaid combined. Healthy People 2010 Oral Health Objective 21-10 sets the nationwide target at 56 percent.
- CY2004 combined statewide dental service claims were reported for 47 percent of PeachCare enrolled children and 31 percent of Medicaid enrolled children for preventive care.
 - ◆ The highest percentage of PeachCare enrolled children receiving preventive care (51%) was reported in the Athens region.
 - ◆ The highest percentage of Medicaid enrolled children receiving preventive care (35%) was in the Augusta region.
- Restorative dental service claims were filed for eleven (11) percent of PeachCare enrolled children and nine (9) percent of Medicaid enrolled children statewide in CY2004.
 - ◆ The highest percentage of PeachCare enrolled children receiving restorative care (15%) was reported in the Dublin region.
 - ◆ The highest percentage of Medicaid enrolled children receiving restorative care (10%) was in the Albany region.
- CY2004 statewide dental service claims for preventive care were reported for 35 percent of children enrolled in PeachCare and Medicaid combined. The Healthy People 2010 Oral Health Objective 21-21 sets the nationwide target at 57 percent.
- CY2004 statewide dental service claims for restorative care were reported for nine (9) percent of children enrolled in PeachCare and Medicaid combined.
- Clayton County has the highest percentage of licensed (54 in CY2004) dentists that are both “Participating” (85% or 41) and “Active” (58% or 28) in the Medicaid and PeachCare programs.³
- Clayton County has the lowest ratio of dentists per 1,000 population (.18), with Fulton County having the highest ratio (.88 per 1,000).
- Dalton and LaGrange Districts have the highest ratios of dental hygienists (.84). per 1,000 population.

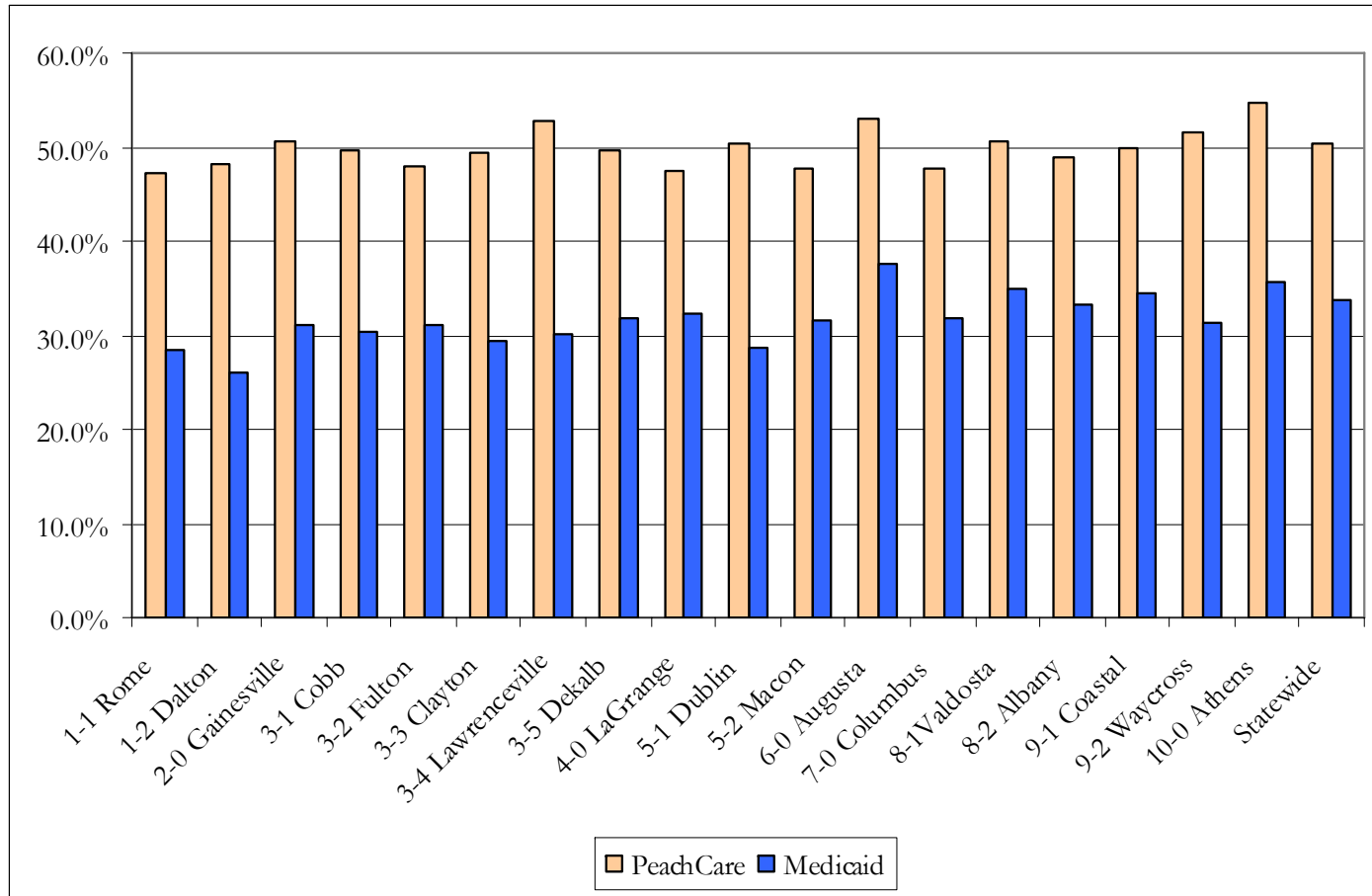

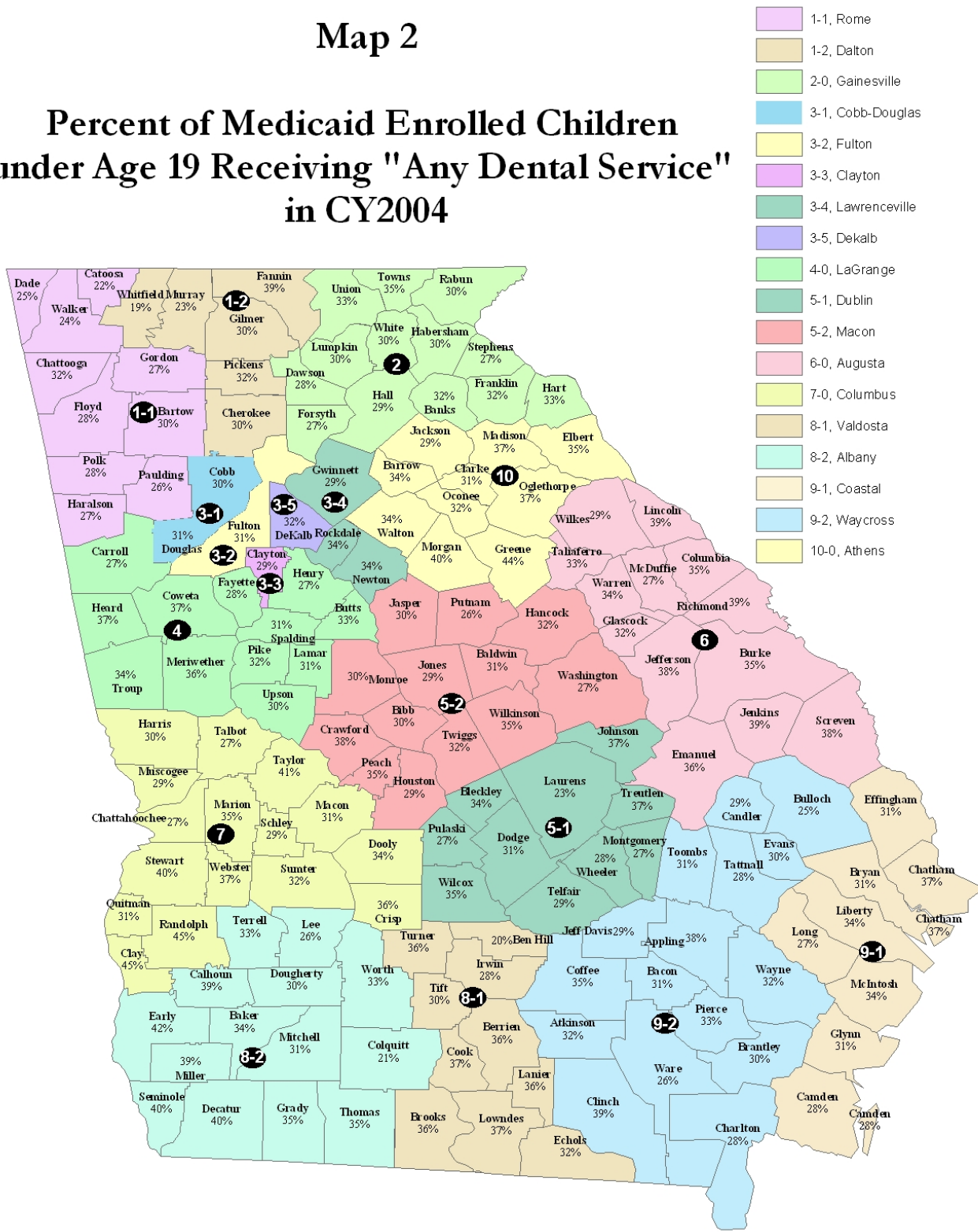

Percent of PeachCare Enrolled Children under Age 19 Receiving "Any Dental Service" in CY2004

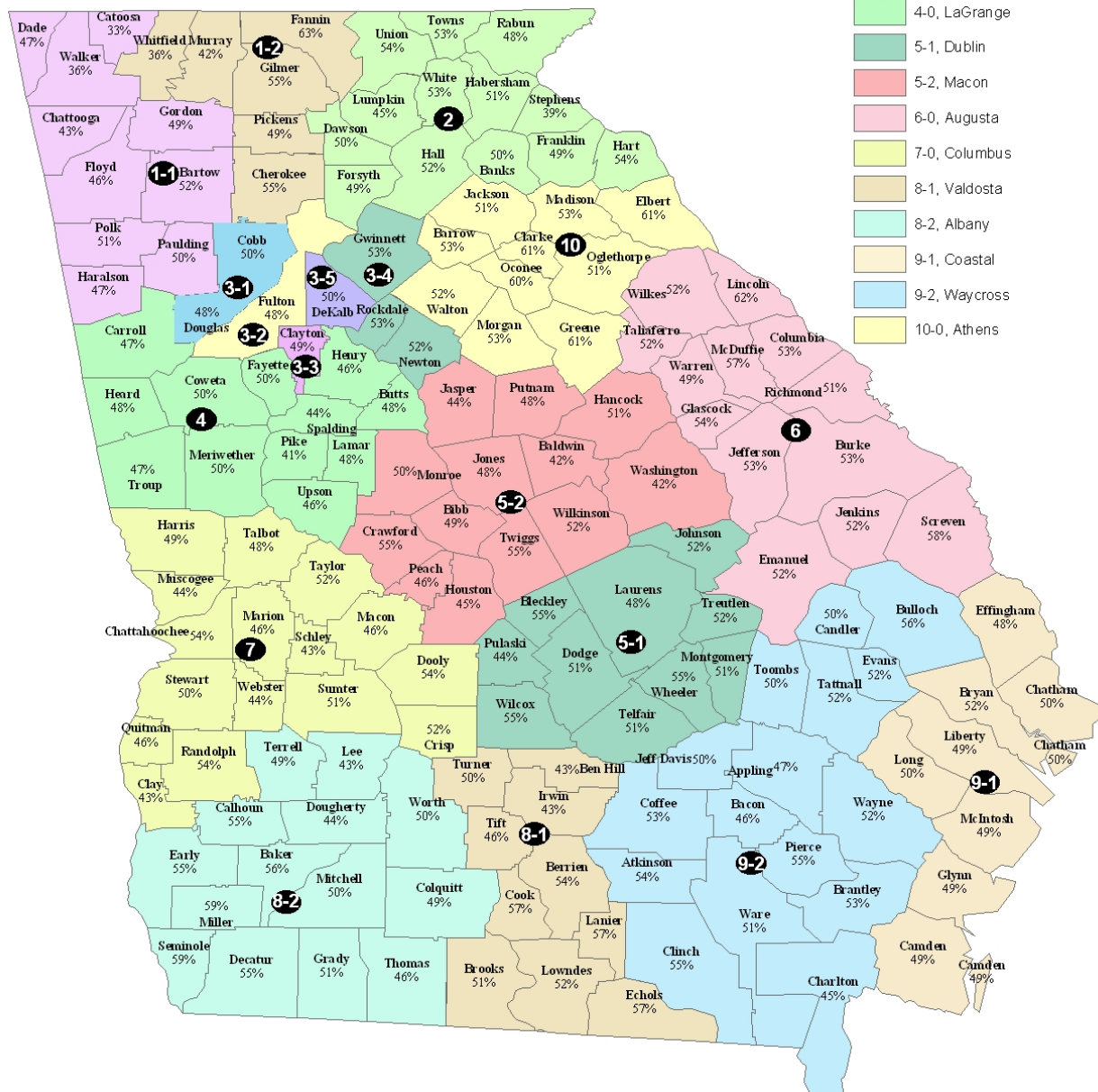

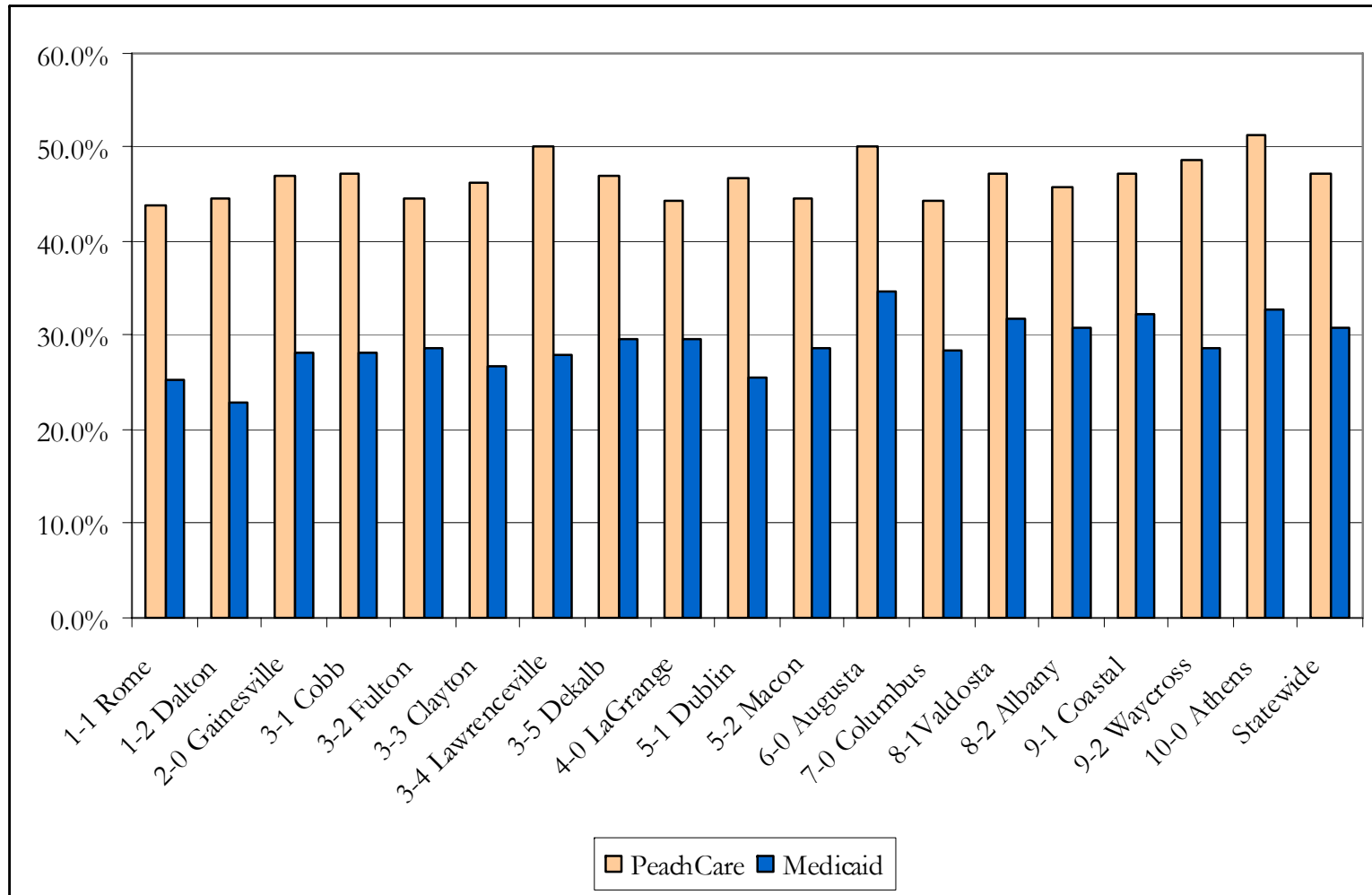

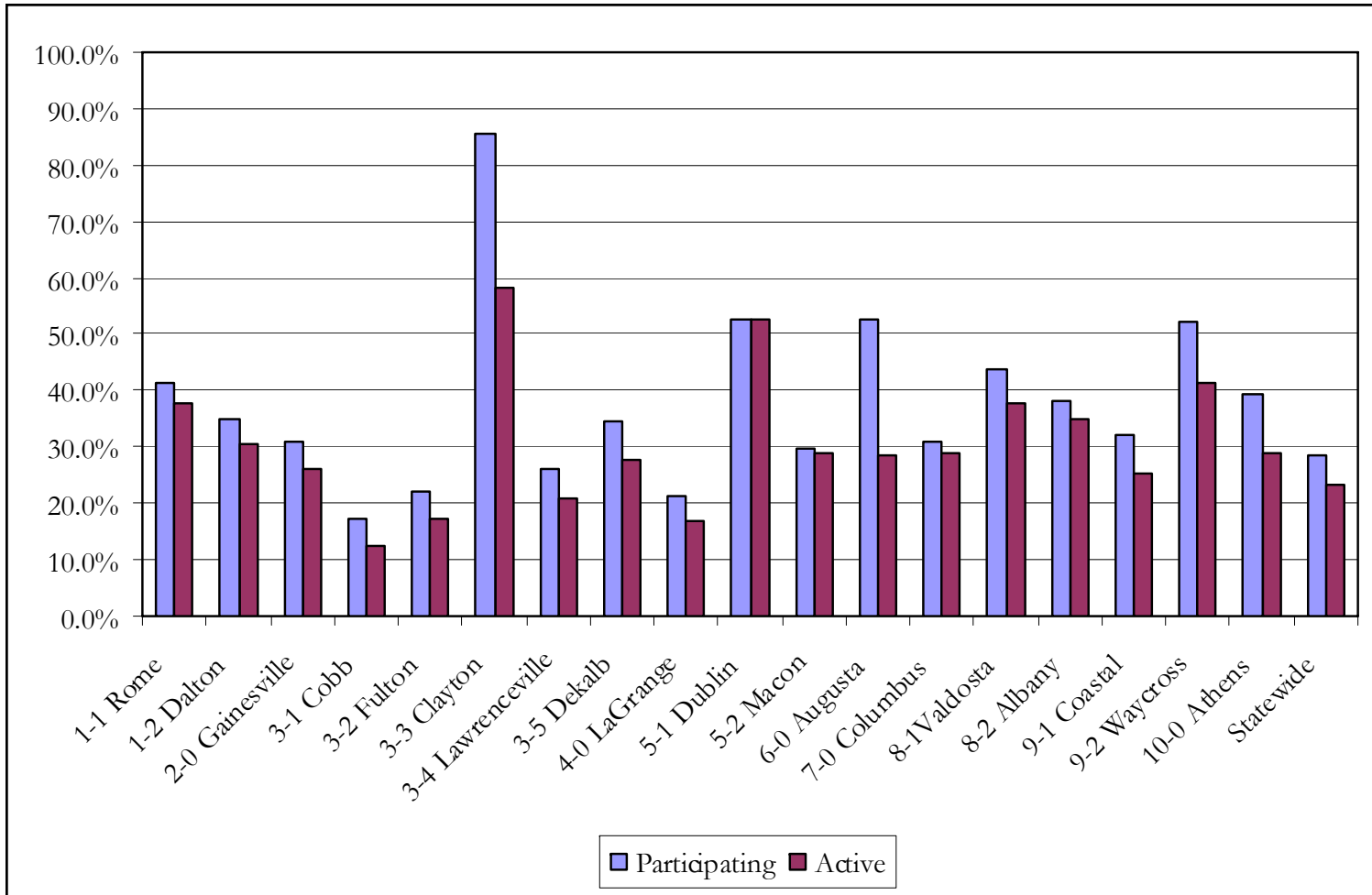

CY2004

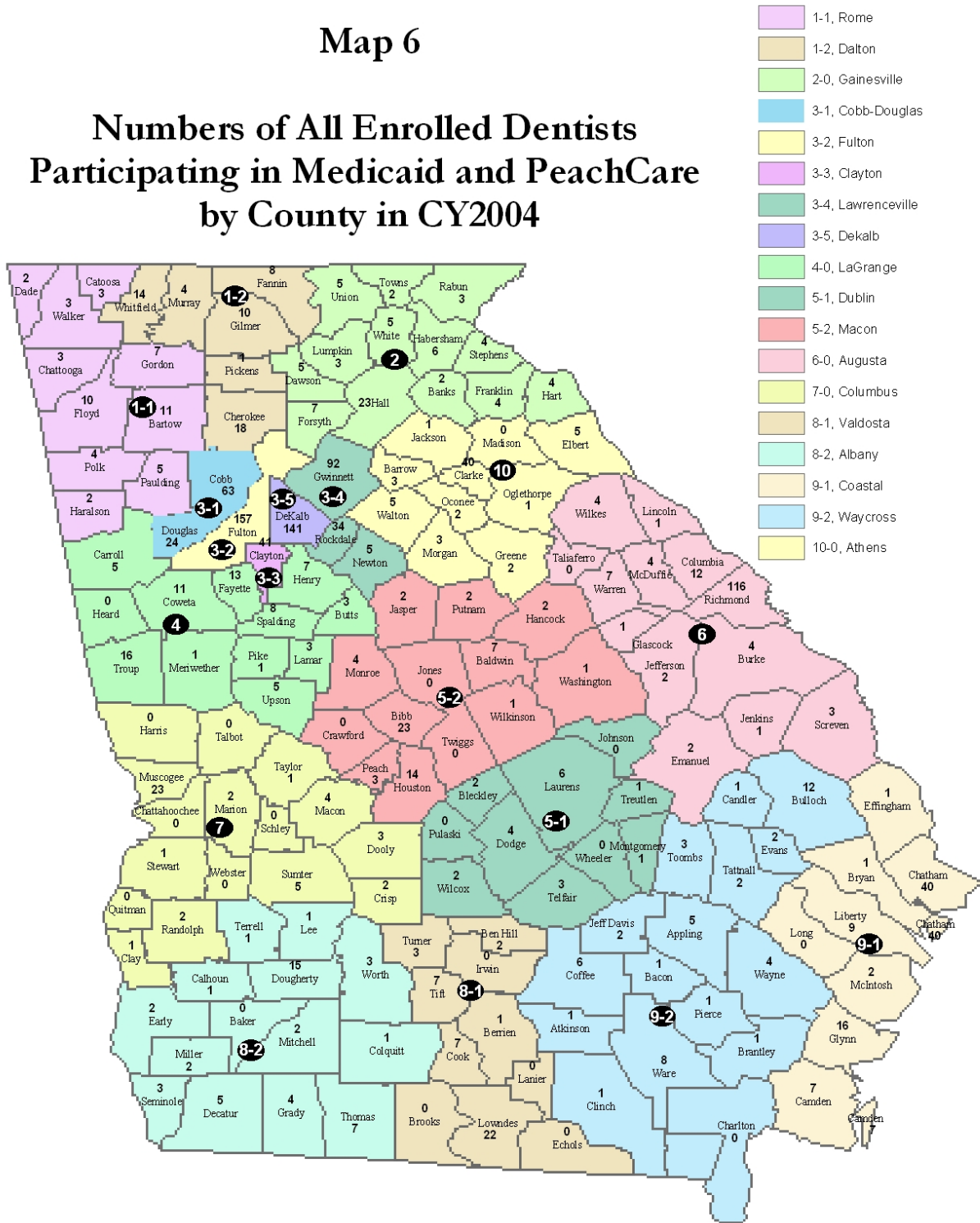

Numbers of All Enrolled Dentists Active in Medicaid and PeachCare by County in CY2004

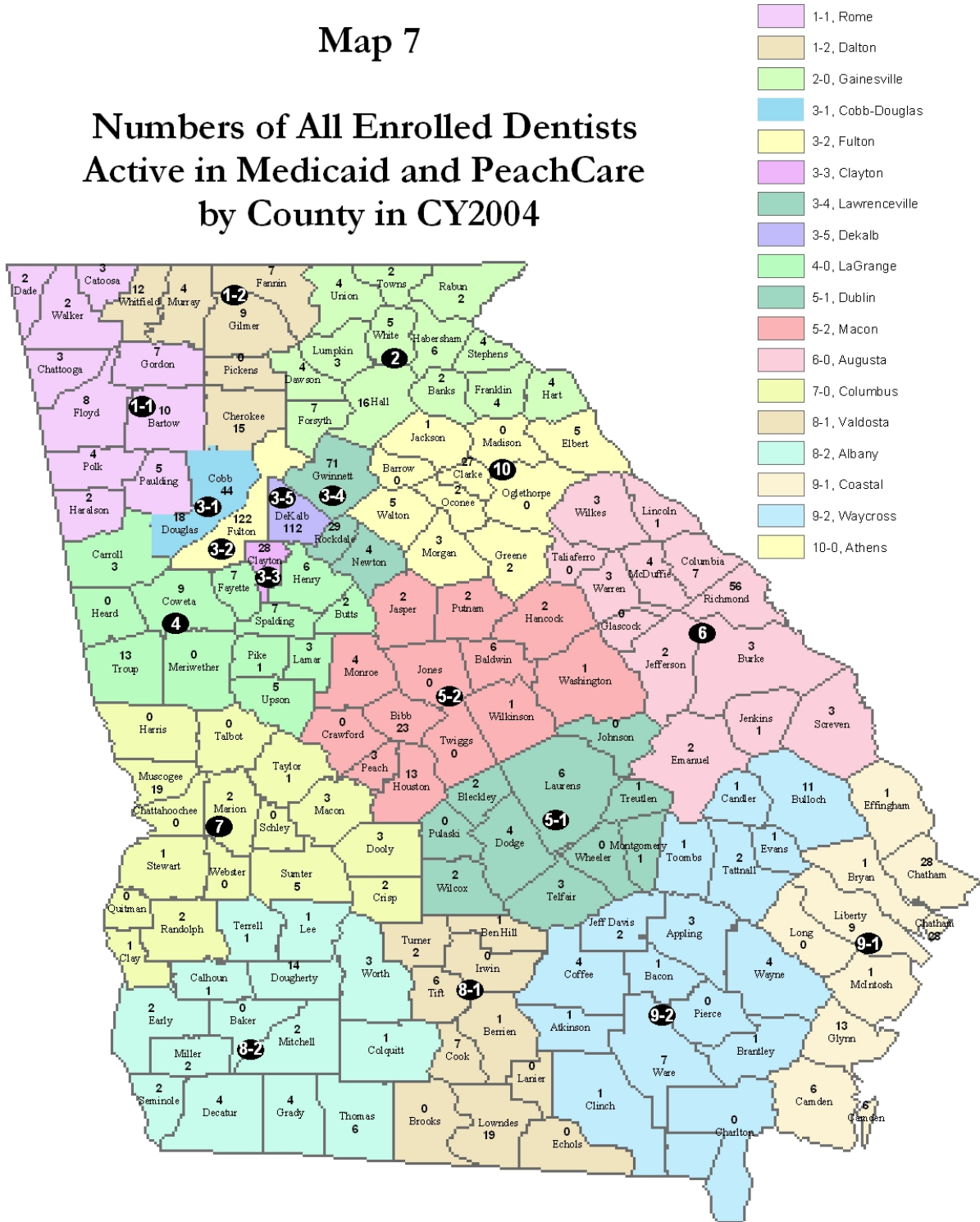
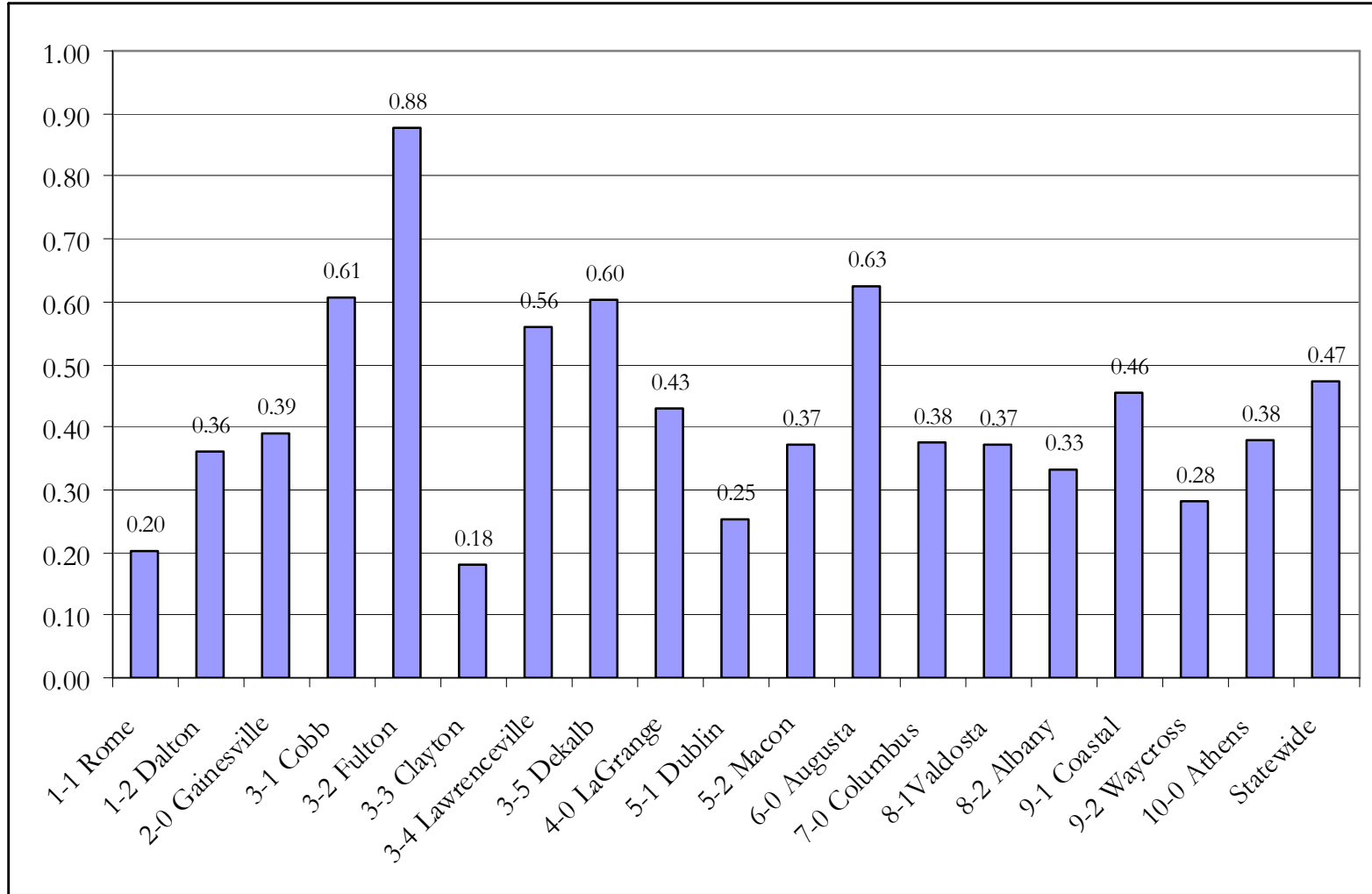
