### **Abstrak**

Rising average temperatures the surface of the earth is the result of increased greenhouse gas emissions, as; carbon dioxide, methane, dinitro oxide, hydrofluorocarbons, perfluorocarbons, and sulfur hexafluoride in the atmosphere. These emissions are mainly generated from processes burning fossil fuels (petroleum and coal) and their aftermath deforestation and forest burning.

## **2. METHOD**

- a. Triangulate various data sources of information, using it to examine the evidence of the source and build a consistent justification for the subject.
- b. Membership checks are used to determine the accuracy of qualitative results by returning the final report or specific description or topic to the participants and determining whether those participants feel correct.
- c. Communicate results using rich, thick descriptions.
- d. Clarifying bias means what the researcher brings to the study.
- e. Also, provide negative or inconsistent information against the subject.
- f. Spend a long time in the field.
- g. Use peer reporting to increase account accuracy.
- h. Review the entire project using an external auditor

In this study, the researcher uses a triangulation technique. Triangulation can be defined as using more than one data collection method in the study of some aspects of human behavior. Therefore, triangulation techniques mean that researchers use more than one technique to collect data to gain validity. ## **2.4 Theoretical triangulation**

Loetsch and Haller (1964) say if forests can influence climate or water cycles, or provide protection for livestock and wildlife. Forests in addition to being a natural ecosystem that is home to and habitat for flora and fauna, forests that have lots of trees which are the main role in the largest oxygen supplier on earth are forests, because forests are the lungs of the world. But the more forests are converted, the more trees are cut down.

*“At first Anna just gaped in amazement. Then she wondered whether her mum had taken leave of her senses. There was no room in the garden for a swimming pool. But Mum insisted there was plenty of room for a pool, and she knew because she was measuring it. Of course they would have to dig up the fruit trees ” (Gaarder, 2015: 100-101)*

From the above quote it is explained that Ms. Anna wants to make a swimming pool but by cutting down her fruit trees, because there is not enough land and so that is enough to make it then by cutting down the trees. This is in line with the logging or land use change that occurs on earth, it will have a negative impact on ecosystems and human life. where the forest will be increasingly narrowed because the trees are cut down it will also have a small foot of water that can be absorbed, so that it will also be able to make natural disasters, such as floods and landslides.

### 3.1.3 Disasters

Disaster is a fearful thing for humanity and all living things on this earth. The definition of disaster according to Law Number 24 of 2007 concerning Disaster Management states that the definition of a Disaster is an event or series of events that threaten and disrupt people's lives and livelihoods caused, both by natural factors and or non-natural factors as well as human factors resulting in human

casualties , environmental damage, property losses, and psychological impact.

Smaller rainforests. Fewer plants on the mountains. Fewer coral reefs. Fewer glaciers and ski runs. Fewer animals...” (Gaarder, 2015: 53)*

From the Anna’s statement above, it is explained that the earth has abundant natural wealth which can be utilized for all living things on this earth. However, uncontrolled utilization of natural resources will make natural resources run out quickly, so that future needs will not be fulfilled.

### **3.2 The Effect of Natural Destruction (Global Warming) on the State of the World**

The main cause of global warming itself is the combustion that occurs from fossil fuels, such as coal, petroleum, and natural gas which release carbon dioxide (CO<sub>2</sub>) and other gases. From the explanation above, in the novel *The World According to Anna* describes the impacts that occur as a result of global warming, which includes an increase in the content of carbon dioxide (CO<sub>2</sub>) in the earth's atmosphere.

*“Enormous quantities of carbon are stored in plants and animals, in the sea and oil, in coal and gas. This carbon is just longing to be oxidised and released into the atmosphere.” (Gaarder, 2015: 56)*
