

The Case for Good Practices

We are the VP of Equity Diversity and Inclusion and VP of Programs for LMDA, Jenna Rodgers and Phaedra Michelle Scott. As racialized people in a theatre sector that is rushing to embrace diversity, we are often asked to serve as part of adjudication teams or selection committees for playwriting competitions, or calls for applications. Having done this a number of times, and often as the only racialized person in the room, we came together in the spring of 2018 to brainstorm ideas of 'best practices' for script applications for organizations and institutions as an additional resource for dramaturgs. Our goal was to develop a document that looked at the nuts and bolts of script application policies to paint broad strokes of what we believed to be as the most equitable and inclusive version of receiving scripts. To create a document that could be used as a tool for organizations and institutions looking to reinvigorate their script application processes.





As our conversations progressed, 'best practices' evolved into 'good practices' as we realized that there is no 'one size fits all' practice for script application policies/procedures. The guide we developed can be found here: <u>Good Practices</u>.

The guide hosts a wide range of ideas including how organizations and institutions can put out calls, solicit readers, run adjudication sessions and lead the script application process. This guide was developed by gathering policies from theaters and new play development organizations, and from our own individual experiences running and developing script application processes.

One sticky point for both of us was the notion of 'blind' applications. After much robust conversation, our recommendation is that application processes consider phasing out this practice. Part of what we grapple with as contemporary theater makers is the question: Who has the right to tell what story? Helping your adjudication team make informed decisions can help them be better equipped to answer this question.

Removing writers names from application processes can help eliminate bias, *but it also removes important identity markers*that may speak to cultural appropriation, putting the company in a potentially awkward situation of selecting scripts that may have negative implications in production. This could be mitigated in a number of ways: by having a diverse group of readers, by being very specific in your call for playwrights, or by removing 'blind' applications altogether. In both of our anecdotal experiences, we find that keeping the name of the writer helps more than hinders the application process.

While eliminating anonymous script applications may not be in the best interest of some organizations, we hope that by creating these guidelines we can give members an alternative view on what practices could look like. Ultimately, we hope that these good

practices inspire ideas to rejuvenate or rethink institutional processes.

Phaedra Michelle Scott is a dramaturg based in New York City. Her work primarily focuses on the intersection between story structure, race, class and myth. As a dramaturg, she has developed works at Playwrights Realm, MCC Theater, Huntington Theater Company, Cleveland Play House, Salt Lake Acting Company, Utah Shakespeare Festival among others. She is the resident dramaturg of the New Harmony Project and Black Theater Commons. Phaedra is VP of Programs with the Literary Managers and Dramaturgs of the Americas, and is the recipient of the Bly Creative Capacity Grant, and the Frederick Douglass Fellowship through the CV Starr Center Study of the American Experience for her study on August Wilson's Pittsburgh Cycle. She is a fan of horror, sci-fi and folklore. www.phaedrascott.com

Jenna Rodgers is a mixed-race Dramaturg/Director based in Moh'kins'tis (Calgary), on Treaty 7 Territory. She is the founding Artistic Director of Chromatic Theatre – a company dedicated to producing and developing work by and for artists of colour. She is the Dramaturg for the Playwrights Lab at the Banff Centre for Arts and Creativity, and is a passionate arts equity advocate, an active member of the Consent and Respect in Theatre (CART) collective; the Vice President of Equity, Diversity and Inclusion for LMDA; and the Board Chair for Theatre Alberta. Jenna is a 2018/19 NTS Artistic Leadership Resident, and a graduate from the 2019 cohort of the Banff Centre's Cultural Leadership Program.
