5. Administrative/Subcommittee Reports

a. President Administrative Report

Dr. Glassman welcomed new members to CUPB and acknowledged returning members. He reported that the upcoming election is the main thing going on in Springfield at this time. IBHE has put together a funding formula group for public universities. The group includes people from each of the public universities. Thus far, Dr. Glassman, VP Gatrell, Interim VP McCann and Ms. Anselment are attending the meetings. Interim VP McCann is still working on the budget. The enrollment figures are wonderful, but we still have to be very conservative when spending funds.

b. Vice President of Academic Affairs Administrative Report

UPI reached a tentative agreement at the end of July. Two dean searches will begin this fall for the College of Business and Technology and for the College of Health and Human Services.

c. Interim Vice President of Business Affairs Administrative Report

Interim VP McCann provided a current look at where the budget stands for FY19. In FY19 EIU received \$3M less than in FY18. The Board of Trustees has not approved the final FY19 budget but did provide authorization for FY19 expenditures. Interim VP McCann will provide FY18 and FY19 budget updates at the CUPB meeting on October 5.

d. Interim Vice President of Student Affairs Administrative Report

Interim VP Drake reported on the summer camps and conferences program. This summer a 10-year contract for Girls State was signed and last year a 10-year contract for Boys State was signed. Interim VP Drake talked about happenings on campus at the beginning of the semester.

e. University Advancement Administrative Report

A search for the VPUA will begin this fall. Alumni events were held in Effingham, Champaign, Arcola, Tuscola, and Olney. Homecoming is scheduled for October 20. Currently, University Advancement has three fulltime development officers.
