1. **Call to order and introductions** – Peggy Brown called the meeting to order at 2:00 p.m.

College of Health and Human Services (CHHS)
Dean Ersin presented information about CHHS FY20 budget. She discussed the College’s priorities and interprofessional/interdisciplinary education, scholarship, diversity, and operational excellence.

 - i. **President Administrative Report**

The President’s area subcommittee met and Steve Daniels reported that the Governor’s budget proposal is tied to the graduated income tax referendum that will be on the ballot in the fall election. He also reported that the President testified before the Senate Appropriation Committee on February 26 regarding the FY21 budget request.
 - ii. **Vice President for University Advancement**

The University Advancement subcommittee met and Ryan Hendrickson reported that the Ledger 1 and 2 budgets are looking good through the end of the fiscal year. The number of donors is up and University Advancement is working on

donor retention. Several alumni and donor events are planned through the end of the fiscal year. EIU Giving Day is April 22, 2020.

iii. Vice President for Academic Affairs

The Academic Affairs area subcommittee met and Kristin Duffin reported that the year-to-date budgets are on target. The new deans for the College of Education and the College of Arts and Humanities have been hired.

iv. Interim Vice President for Business Affairs.

The Business Affairs subcommittee met and Peggy Brown provided the FY20 Line Item Status Report for appropriated funds as of 1/31/20. Vice President McCann is assuming the FY21 budget appropriation will be the same as last year.

v. Interim Vice President for Student Affairs

The Student Affairs subcommittee met and Mark Bluhm reported that they reviewed the Housing & Dining budget and the Textbook Rental Survey. The subcommittee also reviewed the org status reports across the VPSA areas. The spring concert will be announced next week.
