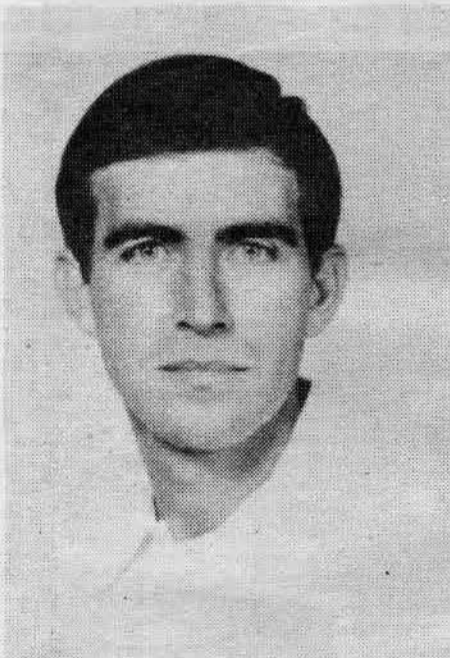

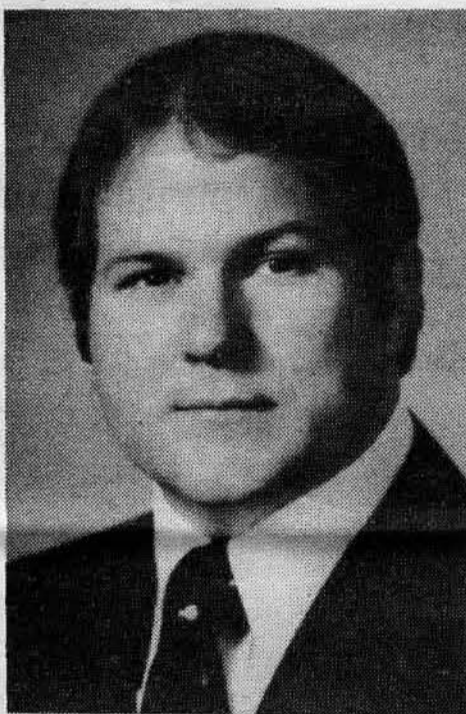

ASA PRESTON GREEAR (79), has received his Master of Divinity Degree from Baptist Seminary in New Orleans, LA.

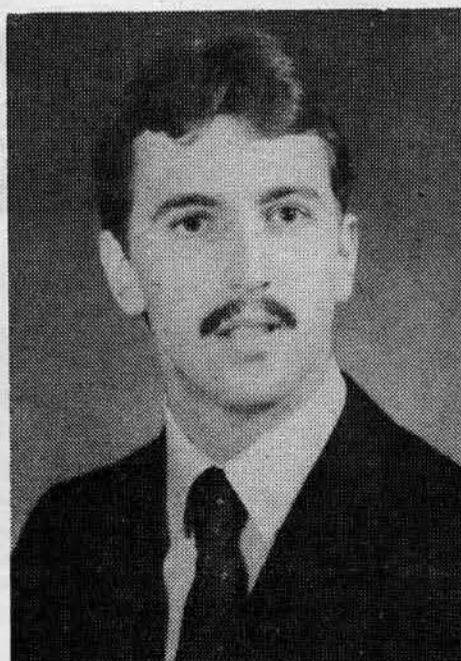

SUSAN CORNETT NOBLE (79), is the Director of Public Relations at Lees Junior College in Jackson, KY.

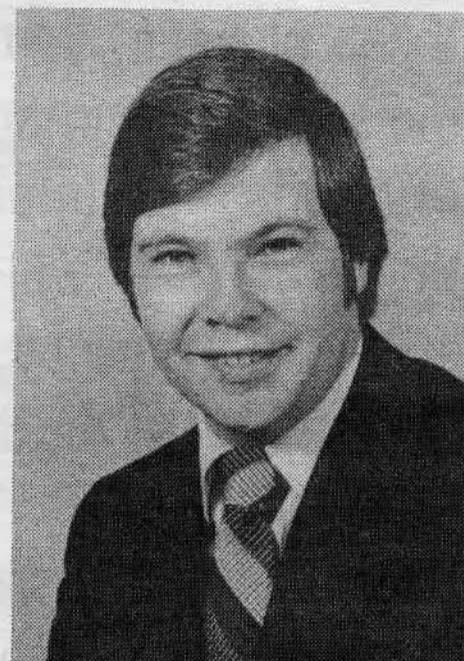

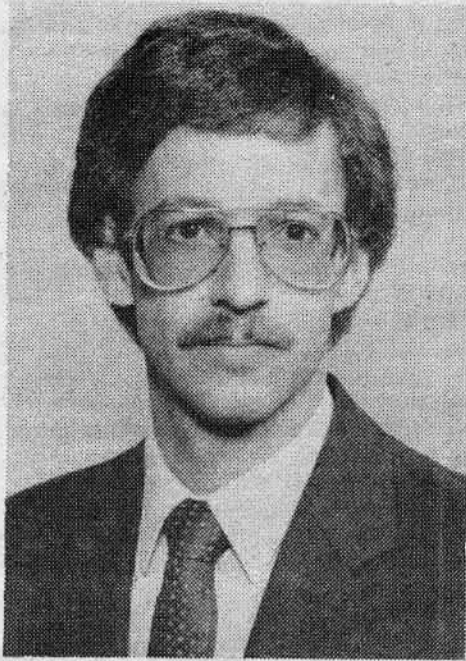

Private Giving Increases

Private giving to Morehead State University increased by 26 percent during 1981-82 to a total of \$338,239.36, it has been announced.

MSU President Morris L. Norfleet and Dr. C. Louise Caudill of Morehead, national chairperson of MSU's 1981-82 Annual Giving Campaign, reported that the previous year's total of \$267,887.40 had been exceeded by \$70,351.96 and that the number of donors had increased from 531 to 903.

"In view of economic conditions during last year's campaign, these totals represent a solid vote of confidence in the future of the University and, more importantly, demonstrate the love and support of our alumni and other friends," Dr. Norfleet and Dr. Caudill said in a joint statement.

Dr. Caudill said she was particularly impressed by the growth in the number of donors, especially the increase in individuals from 442 to 806. The number of corporate, foundation and other donors advanced from 89 to 97.

Dr. Norfleet noted that the gift totals, in accordance with national standards, do not include \$133,033.89 given directly to MSU students by

Akers Featured

A watercolor painting by an alumnus of Morehead State University has been selected for one of the oldest and most famous annual art exhibits in the country.

Gary Akers, a Floyd County native, painted "Woodrow's Room" at the Borders Brothers Farm in Boone County. The painting was accepted this spring for the American Watercolor Society's 115th annual exhibition in New York City.

"Woodrow's Room" also was selected for inclusion in the American Watercolor Society's traveling exhibition. The 50-painting display will tour major art museums and galleries throughout the U.S. this year.

In addition, Akers' work is featured in the June issue of "American Artist." A six-page article by Dr. Booth, "Gary Akers: Paintings from the Borders Brothers Farm," includes several photographs of the artists paintings. "American Artist" is the nation's largest art magazine. Akers will be featured in five other national publications this year.

Akers, who received his bachelor's degree in 1972, finished a master's degree with an emphasis in painting and drawing at MSU in 1974.

While studying for his master's, Akers worked as a graduate teaching assistant. He also was an MSU art instructor during the summer of 1975.

Akers has been working as a professional artist for seven years. During this time, he has produced 16 limited edition prints in numbers of 300 or more, along with hundreds of sketches, watercolors and a large number of works in egg tempera.

The artist has also placed more than 15,000 pieces of his work in the hands of collectors. He is represented by his own studio, as well as galleries in Louisiana, Mississippi and Maryland.

MSU And Martiki Mining Form Partnership

Officials of Martiki Mining Corp. and Morehead State University have announced a joint research and demonstration project to determine the feasibility of using surfaced-mined land for agriculture production.

"We are joining hands here with the University and its outstanding agriculture faculty to develop a model farming operation which hopefully will allow thousands of acres of surface-mined land in Eastern Kentucky to be used profitably in the future for agricultural purposes," said Michael H. Vallez, vice president for East Kentucky operations of MAPCO, Inc., parent firm of Martiki.

MSU President Morris L. Norfleet described the proposed Martiki-Morehead State Mountaintop Agricultural Complex as "a great opportunity for the University to cooperate with the mining industry to help this region's reclaimed land become the agricultural frontier of Kentucky."

He added:

"From an academic perspective, this joint venture will provide our students and faculty members with an ideal laboratory for applied research into the adaptability of various agricultural enterprises to reclaimed land."

Vallez announced that Martiki will spend about \$250,000 this year for

construction and operation of the first phase with MSU planning and managing the entire project under a 15-year lease arrangement.

The 250-acre site is off Wolf Creek in Martin County, about nine miles southeast of Inez.

Plans call for the eventual development of swine, poultry and beef cattle facilities and for cultivation of row crops, orchard crops, greenhouse flowers and vegetables and forest for commercial wood products and wildlife habitat.

In addition to agriculture, the project also will involve MSU's students and faculty members in mining, reclamation and energy studies, according to Dr. Charles M. Derrickson, dean of the School of Applied Sciences and Technology.

U.S. Rep. Carl D. Perkins and State Natural Resources Secretary Jackie Swigart were among the more than 80 dignitaries attending the announcement ceremony at the grassy mountaintop site.

Mr. Bruce Wilson, MAPCO's Senior Vice President, said, "In light of increasing national concern over the loss of prime farmland and its potential impact on food production, we are confident that the success of this project will show that a stable economic system, based on agriculture, can flourish in these mountains after the mineral resources have been removed."

1981-82 Faculty Awards

A geologist specializing in coal mine safety research and a noted historian and author were the recipients of Morehead State University's top faculty awards for the 1981-82 school year.

Dr. David K. Hylbert, professor of geoscience, was selected to receive the "Distinguished Researcher Award" and the "Distinguished Faculty Award" recipient was Dr. John Kleber, professor of history and director of the Honors Program.

Dr. Hylbert, a member of the MSU faculty since 1963, holds bachelor's and master's degrees from Ohio University and a doctorate from the University of Tennessee. He has received more than \$200,000 in state and federal grants for student-centered research into the geological causes of roof failures in Eastern Kentucky coal mines. Dr. Hylbert's work has made him one of the top researchers in the field of coal mine safety.

A member of the MSU history faculty since 1968, Dr. John Kleber holds a bachelor's degree from

Bellarmine College and both a master's and doctorate from the University of Kentucky.

In addition to his teaching and scholarly activities, the 41-year-old historian has served as a member of the Committee of Faculty Organizations, University Senate, General Education Ad Hoc Committee, Committee on Faculty Grievances and Ethics, founder of Rho Eta Chapter of Phi Alpha Theta and chairperson of the subcommittee on educational programs for the Southern Association of Colleges and Schools.

As director of the Honors Program, Dr. Kleber has developed its offerings from a two-year to a full four-year program.

He is a native of Louisville.

The faculty award was established in 1963-64 by the MSU Alumni Association and the research prize was created in 1978-79 by the University's Committee of Faculty Research.

New Program In Para-Legal Studies

A new, four-year program in para-legal studies soon will be available at Morehead State University.

Scheduled to begin this fall, the program will train students to work with attorneys as para-professionals.

Typical duties include researching real estate titles and court cases, interviewing clients, taking depositions and writing briefs.

"We surveyed attorneys in Eastern Kentucky and found a need for paralegals," said Dr. Jack Bizzel, head of MSU's Department of Government and Public Affairs, who will coordinate the new program.

"Attorneys throughout Kentucky and in surrounding states have expressed interest in hiring para-

legals," Dr. Bizzel said, adding that the demand nationwide is projected to increase more than 130 percent over the next 10 years.

Three new classes have been created for the program. They are Introduction to Paralegalism, Legal Research and Writing, and Trial Practice and Preparation. In addition, students will train during the summers with local attorneys.

"This is one of the real strengths of our program," said Dr. Bizzel.

Also in the program are courses in government and business. A minor in business administration is recommended to prepare students for law office management, as well as para-legal work.

FATHER TO DAUGHTER LETTER

A letter on leaving for college

My dearest Robin,

At long last, the time has finally come, a time that you and your mother and I have looked forward to for weeks and months and years. We have hoped for it, prayed for it and planned for it — this week when you would leave home the first time and try your wings as a college student. Now that it is finally here, I admit I have reached it with mixed emotions.

What seemed like something far in the future when you first started seriously thinking about what you would do beyond high school has arrived with almost lightning speed. The magnitude of it all has been evidenced recently by our careful consideration of financial resources, the paper work in getting you admitted, accumulating the material requirements you would need and having frank discussions about the changes you could anticipate in your life in the future.

I was surprised and pleased by the zeal with which you explored the college market, as you made your final decision on a school. You were methodical and careful in your selection, asking questions that I probably did not think of when I was your age, demanding answers which satisfied your objectives. While there have been times your mother and I needed to be reminded of your maturity, there were times (such as this one) when you assured us that you really had things under control.

For 18 years we have attempted to instill certain values in you. For the most part, we would not alter the things we have tried to teach, perhaps only clothing them in contemporary forms. Not everything we aspired for you "took"; but then, we were not always the best examples, either. Looking back on it, perhaps no parent is completely satisfied with the way he has raised his sons and daughters, but if he tried and failed and learned from some of the mistakes he has made, perhaps both child and parent have learned.

You are our first born and thus the first to begin this pilgrimage to college. We can't tell you everything to look out for; a quarter of a century has gone by since we walked that pathway, and so much has changed since then. The pressures we faced will, I am sure, be decidedly greater for you. Perhaps some of them won't even exist. But there will be much harder ones to cope with. If drug problems were a part of campus life when I was in college, I was oblivious to it. While sexual permissiveness has always existed, I suppose, it certainly was never something one boasted about then. In fact, there appeared to be very little of it then. The percentages today are staggering.

For the very first time in these 18 years you'll truly be on your own — beginning this week and, I suppose, for the rest of your life. What you do with your life from this point is up to you.

Your mother and I will not be there to get you up in the morning to be sure you are on time for class; to urge you to study and do your assignments to the best of your ability; to encourage you to refrain from cheating, lying, stealing or breaking school rules; to give you a pep talk before you start out on a date; to place our moral values on you in the areas of smoking, drinking, drugs and sex; to take you

to church and BSU; to teach you to spend money wisely; to encourage you to be considerate of others; and to see that you are safely in your own bed at a reasonable hour every night.

But a higher power will be with you, every morning, every day, every night of your college career. As you go, we put our trust and faith in him, asking that he will watch over you, protect your, guide you and help you feel his presence in the uncertainties you will face.

We're not relinquishing our love for you, and our constant concern for you as you go. Rather, we are transferring much of the load we have carried for you to God, asking him in his providential wisdom to keep you in his perfect will. We hope you'll turn to that source frequently in the days and weeks and months and years to come as the answer for the problems you face.

We love you very much. We are proud of you now, and we will continue to pull for you in all the days that are yet to be.

Executive Council Meets

May 8, 1982

The meeting was called to order at 2 p.m., with the following in attendance: President James P. Pruitt, President-Elect Merl Allen, Dr. James Smiley, Glenna Campbell, Joyce LeMaster, Dr. Wayne Morella, Tony TenBarge, Myron Doan, Jeff McEldowney, David Bolt, Bill Phelps, Linda Bussell, and Mike Dowdy.

President Pruitt delivered the invocation, then asked Don Young for the treasurer's report. Mr. Young reported a balance of \$8,940 in the alumni account and there had been no major expenditure during the last month. A motion was made by David Bolt to accept the report. It was seconded by Bill Phelps. Motion carried.

A motion was made by Bill Phelps to accept the minutes of the last meeting as they were, having been sent to each council member prior to this meeting. It was seconded by David Bolt. Motion carried.

The committees were then asked to report:

Constitution Committee. The final draft of the Constitution was distributed. After discussion of some minor changes, Dr. Smiley moved that the Council approve it with the changes made. It was seconded by David Bolt. Motion carried. President Pruitt then commended Bill Phelps and Linda Bussell for their efforts in helping to make the Frankfort reception successful, and their work on the Constitution.

Deferred-Giving Committee. David Bolt reported that he had met with members of his committee and prepared a "Management and Development Guide," hopefully, so goals and objectives for next year could be finalized. He stated that contact with students remain the goal and if anyone had any suggestions to let him know. He then distributed the guidelines for the use of the Alumni Center and moved that these be adopted. Motion was seconded by Merl Allen. Motion carried.

David Bolt also reported that four insurance companies had responded to the deferred-giving inquiry and plans were being made to have these companies represented at a future council meeting.

Homecoming Committee. Myron Doan reported that the results were in from the "Homecoming theme" nominations. The four choices were discussed, then Myron moved that "A Western Hoe-Down" be selected. Student Relations. Wayne Morella, on behalf of Terry Blong, moved that \$500 be allotted to pay for the snacks for dorms for finals week and items for the senior picnic. Motion was seconded by David Bolt. Motion carried.

Wayne Morella then moved that the Alumni Association camera be procured from the Admissions Office, to sell it if its not workable, and buy a new one, and be used to take pictures at the senior picnic. Motion was seconded by Bill Phelps. Motion carried.

Publications. Joyce LeMaster reminded the Council she was still waiting for suggestions for this year's Alumni Annual. President Pruitt was asked to write an article telling of the innovations and accomplishments during his term.

Bill Phelps then moved that the membership and address list of the Alumni Association be used specifically and only by Morehead State University and the Alumni Office.

Motion was seconded by David Bolt. Motion carried.

David Bolt then stated that Keith Kappes asked that the alumni Executive Council consider the future of the Morehead Alumni Foundation, Inc., that it could be activated and the name changed, or make recommendations as to other changes/uses of the Foundation. David then moved that President Pruitt appoint a board for the Foundation and establish a meeting date in order that something could be decided in regard to the Foundation. Motion was seconded by Tony TenBarge. Motion carried. President Pruitt then stated he would call a meeting of the Morehead Alumni Foundation, Incorporated today, immediately following the Alumni Association Executive Council meeting.

Dr. James Smiley then informed the Council of the two activities on campus, being planned for this week: Snacks in the residence halls for finals week and a picnic for graduating seniors. He also asked that Don Young, Wayne Morella and Jeff McEldowney be recognized for their help. Wayne Morella added that Terry Blong should not be left out of the list.

Dr. James Smiley then proposed that the Council make a special effort to commend the speech team for coming in 5th in National Competition and include the accomplishments of Rachel Holloway. He suggested that Don Young be asked to draft this resolution. The motion was seconded by Glenna Campbell. Motion carried.

President Pruitt then presented the program for the Council for Advancement and Support of Education International Conference and recommended that the President-Elect and Director of Alumni Relations be sent to this conference and that the Association pay their total expenses. He stated that his attendance at last year's conference was very valuable and he felt the information gained at this conference would be well worth the expenditure. Wayne Morella then suggested the conference fee for four additional people be paid if they were willing to pay their own expenses. President Pruitt then asked if he would put this in the form of a motion.
