Ralph A. Beeton is President's Dinner Speaker

Ralph A. Beeton, chairman of First Virginia Bankshares Corporation, is the featured speaker at Bridgewater College's President's Dinner, November 5, in the Kline Campus Center Dining Hall.

Mr. Beeton is also chairman of the Registered Bank Holding Companies, a world association of bank holding companies, and a trustee of the Virginia Foundation for Independent Colleges, of which Bridgewater is a member. He is on the Governor's Transportation Council and a past president of the Virginia Bankers Association.

The President's Dinner honors members of the Benefactors and Investors Giving Clubs who provide significant support to the College through their generous philanthropy.

New Dean Appointed

Jean M. Yerian, newly-appointed assistant dean for student development, is approaching her new job with a great deal of interest and enthusiasm. In late summer she was anxiously awaiting the arrival of the new students and the return of the former ones, so that she could begin to learn to know them — their needs, interests, hopes, and plans. She intended to do this by participating alongside the students with an emphasis on counseling and openness of feelings and goals. "Community living and learning to live with people," she said, "is one of the strong features of a residential school."

She is still feeling her way around, and says, "I feel like a great big sponge right now — looking and learning. I feel my contributions will be greater later on." Mrs. Yerian also feels that it's very important to listen and to be really interested in what another person is saying, a quality the students will appreciate in the new dean as she takes her place in the campus community.

Dean Yerian holds an A.B. degree from Duke University, and an M.A. from Ohio State University in student personnel work in higher education. She also took a year long graduate course at Trinity College in Dublin, Ireland, studying Anglo-Irish literature of the 19th and 20th centuries in conjunction with a Rotary Graduate Fellowship.

Her experience includes student personnel work at Ohio University, teaching and counseling at LaFayette College in Fayetteville, N.C., and serving as veteran affairs coordinator for Fayetteville Technical Institute. She also worked as a learning lab consultant for the Dean of Students at Valdosta State College in Valdosta, Ga. She and her husband, Sherman, and their four-year-old son, Brendan, live in Bridgewater.

Pinion Players Present *The Best Man*

The Best Man, a political drama by Gore Vidal, will be presented by the Pinion Players in Cole Hall on Parents' Weekend, October 28-30, 1976. The play is set inside the back room of a Philadelphia convention where two presidential candidates compete for their party's nomination in a merciless political battle. The play has been called an incisive, perceptive study of the American presidential election process, "a high-tension conflict of wits loaded with laughs."

Over fifty students are working on the play, which will be presented less than a week before election day in November under the direction of Ralph MacPhail, Jr.

New Office on Career Planning



Dr. Martha Thornton, former associate dean for student development, has moved to a new position as coordinator for career planning. She will still have teaching responsibilities in the Philosophy and Religion Department, and also will be available to assist students in career planning from her office in the P & R House.

In discussing her plans for the coming year, Dr. Thornton said that she will work primarily with freshmen and sophomores, but will be available to all students. She hopes to have a series of informal discussions, bringing together area alumni and students interested in the vocational field represented by the alumnus. She will also be giving vocational tests to those students who want them. These tests help the students look at their interests, values, experiences, and skills in order to see a vocational direction.

Dr. Thornton said, "I think of a career as what one is going to do with one's life, rather than a specific job upon graduation. The self-analysis, coupled with the career information we have available, will give the student a basis for both short and long range career goals." She is in the process of developing a career's library for student use. Some of the titles now in her library include: *What Can I Do with a Major In . . .?*, *Career Search*, *After College . . . What?*, and *Occupational Outlook Handbook*.

Dr. Thornton also hopes to work closely with department heads, letting them know what she is trying to do, so they both can work with a student who may be undecided about his or her vocational direction. The placement office, under Clem Bess's direction, will still assist students with job placement, and Dr. Thornton says, should not be confused with the career planning she is doing.

Brethren Students Visit

"Why Attend Bridgewater, Your Church-Related College?" was the question discussed by a panel of students with moderator David L. Metzler, chaplain and professor of philosophy and religion, at a gathering of Church of the Brethren high school youth visiting Bridgewater during Brethren Youth Day, September 18. The students spoke of the close feeling of community they have at Bridgewater, being a person who is known to other students, faculty, and staff. They noted that there is a religious community available and that values and ideals are affirmed. Though the cost of attending Bridgewater is higher than that of attending state schools, they felt that aid programs offered by Bridgewater helped to offset that cost differential.

Also on hand to welcome the students was president Wayne F. Geisert and Vern Fairchilds, director of admissions. Small group discussions followed the panel discussion on other aspects of college life — admission requirements, financial aid, student life, career planning, and the academic program.

Following lunch in the Kline Campus Center, the students attended the afternoon football game before heading home.

High school students from the West Marva District were unable to attend due to a scheduling conflict. They were invited to come to a similar program on Oct. 2nd.

8 by '80 on Schedule - Challenges Remain

A total of \$2,323,123 in cash and pledges has been committed to the First Century Completion Fund as of September 22nd.

National chairman of the 8 by '80 program, James L. Keeler, trustee and alumnus, has been assisted in this development effort by the 8 by '80 committees working with the College's constituencies. Serving as chairman of the Alumni Gifts Committee is W. Wallace Hatcher, president of Lantz Construction Co., Broadway, Va. Chairman of Church Gifts is Frank C. Rittenhouse, president of Aluminex, Inc., of Timonium, Md. Harold H. Hersch, a Manassas, Va. attorney, is chairman of the Estate Planning Committee. Garland F. Miller, president of Dominion Manufacturing Co. of Bridgewater, is bringing leadership to the Giving Clubs Committee. William H. Groseclose, executive vice president of Rockingham National Bank, Harrisonburg, is chairman of the Major Gifts Committee.

A growing nucleus of dedicated volunteers is joining with committee chairmen to broaden the base of support for the College and to seek to achieve the financial goals of the current \$8 million dollar campaign. These efforts have resulted in marked annual increases in gift income, the major portion of which is directed to the support of the educational program — current operations, including student financial aid, faculty salaries, book acquisitions — and the building of the endowment fund.

It is only by continued and increased annual support that the First Century Completion Fund will be successful. As the current academic year gets underway, letters are going out to the College's constituencies seeking this much-needed support. Although the 8 by '80 development effort is on schedule, many challenges lie ahead.

Homecoming - Oct. 16

A new feature of Homecoming, October 16, is a special Alumni Homecoming Center in the Multipurpose Room of Rebecca Hall. The Center will be open all day with coffee and doughnuts provided in the morning from 9:00 a.m. to 11:00 a.m., from the end of the football game until 5:30, and in the evening from 8:30 to 11:00. Alumni wishing to visit with former professors will meet them at the Center rather than in front of the gym as has been done in previous years.

Other receptions during the day are an open house and coffee hour sponsored by the home economics department in Moomaw Hall from 10:00 to 12 noon, and a drop-in reception on the Cole Hall stage from 4:00 to 5:00 for past members of the Curtain Club and Pinion Players.

The Pritchett Museum will be open for visits from 10:00 to 12:00. The Rev. Jacob F. Replogle, '37, has rejoined the Bridgewater College staff as its new director.

The traditional Homecoming parade with class and club floats, the Queen and her court, bands and dignitaries will begin at 12:30 on Dinkel. Heading west it will turn south on Main and proceed back to the campus on College Street, ending in time for the 2:00 p.m. football game with Liberty Baptist College on Jopson Field.

Special reunion dinners have been planned for the classes of '56, '61, '66, '71, and '75. Following dinner in the Kline Campus Center Dining Hall, the chorale and stage band will present a combined concert at 7:30 in Cole Hall. These two groups of talented student musicians are greatly in demand for civic, school, alumni, and campus programs.

Martin Named Visiting Scholar

Dr. John W. Martin was selected to participate in the Visiting Scholars program at Duke University sponsored by the Lilly Foundation. Twenty natural scientists from small liberal arts colleges in the tri-state area surrounding North Carolina met at Duke during the summer for a seminar on Ecological and Environmental Concerns. Experts from several disciplines presented papers on environmental problems in their areas. In December Dr. Martin will return to Duke for one week to study and prepare materials appropriate for inclusion in his courses at Bridgewater. In March he will return for an additional two weeks to participate in conferences and seminars pertaining to his field of interest with some time devoted to teaching methods and techniques. In April 1977 the group will reassemble for a field trip to the Duke Marine Laboratory at Beaufort, N.C. and to several industries in the area.

Bender Joins Faculty

Paul J. Bender joined the mathematics department faculty in September. Dr. Bender holds a B.S. degree in physics from Albright College in Reading, Pa., and also holds M.S. and Ph.D. degrees in mathematics from Ohio University in Athens, Ohio.

He has been a teaching assistant at Ohio University and has done research work on the optimization theory in applied mathematics while working toward his doctorate. As part of his experience, he introduced a computer assisted modular course in elementary algebra and was a mathematics instructor in Upward Bound, a summer program sponsored by the federal government for academically deprived Appalachian high school students.

Dr. Bender's military service includes an army tour of duty in the United States and Korea as a microwave technician, operating and repairing fixed station and transportable microwave, UHF and VHF radio equipment.

He is a member of Phi Kappa Phi National Honor Society, the American Mathematical Society, and the Mathematical Association of America.

He and his wife, Marlene, have two young sons, Paul and Daniel.

NUTRITION NOW

Mary LeMar, assistant professor of home economics, is one of the co-chairmen of NUTRITION NOW, a newly-organized group of Harrisonburg-Rockingham home economists interested in promoting nutrition and health education in the community.

Other NUTRITION NOW members who are home economics graduates of the College are Christine Miller Haer, '73, and Rikki Kulzer Hollen, '73.

The group sponsored a maternal nutrition forum in March and will be sponsoring HEALTH FAIR '76 at the Alumni Gymnasium on October 15. The HEALTH FAIR will have exhibits, films, and will provide health screening for persons interested.



Chemistry's Fun

In June Dr. Lowell Heisey, chairman of the chemistry department, served as one of the resource leaders for the Rockingham County-Harrisonburg Recreation Dept. "Fun Day." He gave demonstrations and let the children run experiments in chemistry — making nylon thread, blowing soap bubbles, working with super magnets, exploding hydrogen-filled balloons. The purpose of this program was to give the children interesting things to do in the summer and to provide vocational information.

Pre Med Grads Accepted

The three 1976 pre-med graduates at Bridgewater, all women, were accepted in medical school and are on their way to careers in the medical profession. Elizabeth Mumper, daughter of Dr. James Mumper, chairman of the department of history, and Mrs. Leone Mumper, secretary in the computing center, didn't start out as a pre-med major, and "had some catching up to do" when she made her late decision to enter a science field. She has been accepted at the Medical College of Virginia, and is "leaning toward obstetrics or pediatrics," but wants to be exposed to all possibilities before she makes up her mind.

Virginia Martin, daughter of Dr. John Martin, professor of chemistry, and Betty Blough Martin, '44., is also attending the Medical College of Virginia. Virginia decided on a medical career during high school, but hasn't definitely decided on a specialization.

The other graduate, Dena Hixon, daughter of Mr. and Mrs. R.D. Hixon of Hancock, Md., entered the University of Maryland Medical School. She was a summa cum laude graduate of Bridgewater with a major in biology, and is also keeping her options open as to a specialized area of medicine.

Sappington Publishes New Book

Dr. Roger E. Sappington, professor of history, is the compiler and editor of a book, *The Brethren in the New Nation*, published in July by the Brethren Press in Elgin, Ill.

This 500-page source book contains original materials related to the history of the Brethren from 1785-1865, depicting the denomination as a growing, expanding group of Christians. The Brethren believed in remaining apart from society, Dr. Sappington notes. "Perhaps their approach should be described as nonconformity, since the Brethren were convinced that a Christian ought to be different from a non-Christian and that this difference ought to be manifested outwardly."

They were different from many people in the United States because they spoke out against slavery, refused to participate directly in government, refused to take oaths, sought exemption from military service, and dressed plainly. In the general expansion that took them from their original settlement in Pennsylvania, to North Carolina, Kentucky, Ohio, Indiana, and on west, they established churches where they went.

Dr. Sappington, an authority on Church of the Brethren history, has written seven books, as well as having contributed chapters and articles to religious and historical journals.

Mengebier Teaches Gifted

Dr. William C. Mengebier, chairman of the biology department, taught for the fourth year in a row at the Governor's School for the Gifted held at Mary Baldwin College for four weeks in June and July. He taught physiology and zoology to the specially selected high school students and conducted an interest group in the military history of World War II. The students take two courses for credit, one special interest course, and recreation in a schedule that runs for 16 hours a day.

Dr. Mengebier also addressed a Virginia Vocational Home Economics Education Conference in Richmond August 4 on the special needs of the gifted student.

Sharon Butterbaugh, professor of home economics, addressed the conference on "A Look at Home Economics Careers."

Professors are Promoted

Four professors received promotions this spring. Named full professors were: Dr. Jim Reedy, chairman of the department of health and physical education; Dr. Gary L. Tyeryar, associate professor of English; and Dr. Donald R. Witters, associate professor of psychology. Professor W. Steve Watson, Jr., assistant professor of philosophy and religion, was promoted to the rank of associate professor.

Replogle is Museum Director

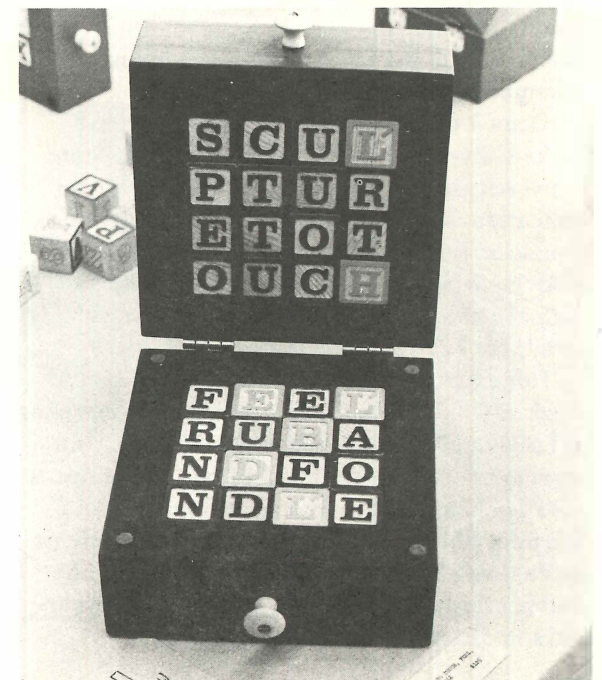
The Rev. Jacob F. Replogle, '37, has rejoined the Bridgewater College staff as director of the Pritchett Museum on a part-time basis. He and Mrs. Replogle have moved back to their home on College View Drive from Mount Joy, Pa., where, for the past eight years, he was pastor of the Florin Church of the Brethren. Mr. Replogle held pastorates in Stuarts Draft and Dayton, Virginia; Chicago, Ill.; and Baltimore, Md. before accepting the position of executive secretary of the alumni association and director of development at Bridgewater in 1956. He continued as director of alumni affairs until 1968, when he and Mrs. Replogle moved to Pennsylvania. Mrs. Replogle was a library assistant in the Alexander Mack Library for several years, and was associated with Elizabethtown College in that same capacity.

Mr. Replogle is looking forward to his work with the Pritchett Museum collection. He would like to set up some living history demonstrations that would use the old tools, weaving and cobbler's equipment in an educational and informative way.

The Museum is on the first floor of Cole Hall, but, it is hoped, will be moved to the old gymnasium, so that it may be better displayed, sometime in the not too distant future. The Museum contains items collected by the Rev. Reuel B. Pritchett and includes such things as the teething bottle used by the Pritchett children, slag glass, coins, books and Bibles, guns, clothing, porcelain, Indian artifacts, early hand tools, and memorabilia of U.S. presidents. Also in the collection are items donated by persons who have formerly been associated with the College.

Watson Teaches Tennis

Professor Steve Watson, department of philosophy and religion, accepted a summer position with the Staunton City Recreation Department teaching tennis. Professor Watson has been playing tennis since he was eight years old and holds more than 50 tournament titles including the number one position championship in the Southern Conference. He is three time winner of the men's singles in the Staunton Leader Tournament and three time winner of the men's singles in the Shenandoah Valley Invitational Tournament. He and Dr. Jim Reedy, chairman of the department of athletics, took the men's doubles championship in 1975 and Prof. Watson and his partner, Jerry Wampler, took the men's doubles championships in the 1976 Valley Invitational Tournament.

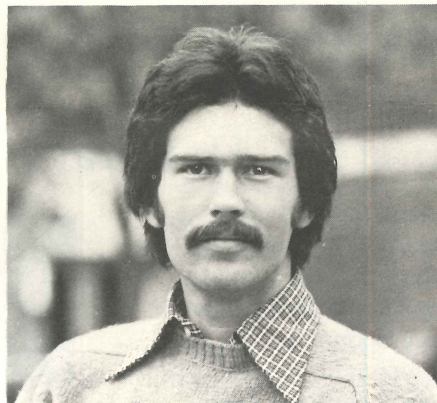

Dr. Flory Receives Special Recognition

Dr. Walter S. Flory, Jr., Bridgewater College trustee and alumnus of the class of 1928, has been invited to lecture on "Chromosomes in Evolution," for an international seminar to be held in Calcutta, India, in October. Dr. Flory, who is Babcock Professor of Botany at Wake Forest University, was also an invited lecturer in 1968 for an international seminar in Calcutta on "The chromosome — its structure and function." He has previously attended international meetings in botany, horticulture, and genetics in this country and in Paris, Montreal, Edinburgh, and Tokyo.

Special recognition has come to Dr. Flory most recently as he was named a Bicentennial "Honorary Fellow" of the Royal Horticultural Society of Wisley, England. He is also to be the 1978 William Herbert Medalist of the American Plant Life Society.

Dr. Flory, a member of Phi Beta Kappa, holds M.A. and Ph.D. degrees from the University of Virginia. He took a post-doctoral year of study at Harvard University in botany and plant cytogenetics. He holds membership in many scientific societies and is a member of the executive committee of the Highlands Biological Station of the University of North Carolina, a regional field station of the Southern Appalachians serving 15 member institutions. He has been a research consultant to the Fairchild Tropical Garden in Miami, a botanical consultant to the Virginia Museum of Science in Richmond, and was director of the Reynolda Gardens in Wake Forest from 1964-76.

FOOTBALL

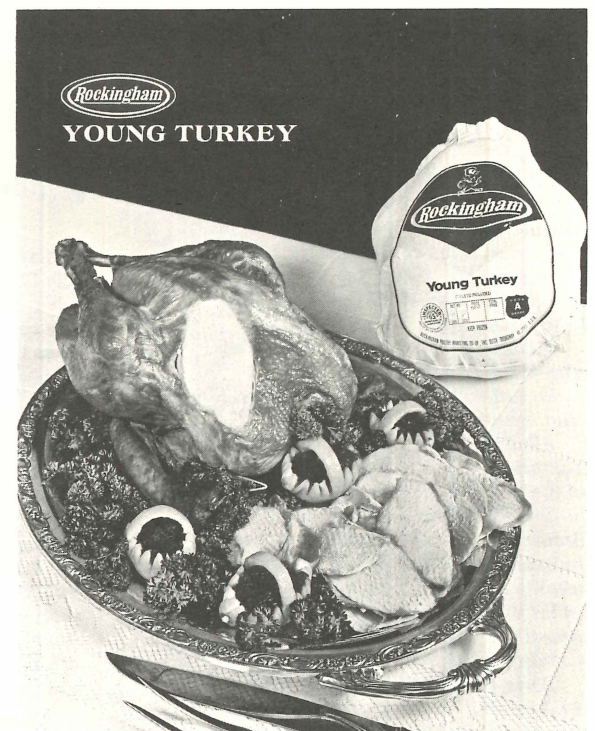
