### Timeline Literature Review

- She remembers Medicare Fraud being a huge issue due to the Balanced Budget Act (BBA) in 1997. This created caps on private practitioners in practice, which impacted hospitals, graduate medical education, and access to health care (Important Events in Occupational Therapy by Decades, n.d.)
- According to Dillon (2001), leaders must lead through serving others and their needs. Dr. Lazzarini implements this type of leadership everyday as she educates students and serves as founding chair for a professional program.



### Methodology

Participant Selection: The participant was selected from a participant list compiled through purposive sampling by the project directors. Informed consent was obtained prior to the interview and the project was approved by the UND Institutional Review Board and because of the study design the formal IRB process was waived.

Interview Schedule: The semi-structured interview was guided by an interview scheduled developed using the Kawa Model. The student researchers to modified the interview questions as needed for each individual interview.

### Data Analysis

The interview was recorded and transcribed verbatim by the interviewers and initial thoughts and feelings were recorded. The Kawa Model was used as a guide for data analysis.
The interviewers then analyzed the transcription to find codes. From codes, three categories emerged. The researchers then identified key themes from each of the categories, and then patterns. A final assertion was created to summarize the finding and to capture the overall meaning.

## Findings

#### **Professional Journey**

- Dr. Lazzarini's background in mechanical engineering provided a foundation to enhance her understanding and knowledge of OT, resulting in a passion for ongoing growth and development.
- She is adamant about being involved in the profession and serving as a leader in everyday practice and taking advantage of opportunities at the national level.
- Dr. Lazzarini is proud to have partnered with Claudia Allen in working with the Allen's Cognitive Levels.
- She is proud to have traveled to different countries to promote complexity science an teach OT.

#### Aspects of OT

- Initially when learning crafts, she did not appreciate the impact this would have on her future practice, she emphasized the importance of activity analysis in modifying crafts to be client centered.
- The practice of OT is influenced by geography and cultural values, she stressed the importance of using media that is representative of the background of the client.
- Dr. Lazzarini expressed the importance of accountability and following the code of ethics when providing and billing for services.
