### PLAN FOR THE ANNUAL MEETING

The 1927 meeting of our Bar Association is but three months away. The program committee is faithfully at work, and we have every reason to believe that this program will be up to the high standard set by those of past sessions of the Association. The meeting this year will be in Grand Forks the early part of September, beginning either the 6th or 7th, and continuing for two days. Announcement of the exact days will be made very soon.

May I urge the members of the Bench and Bar of the State to recognize the importance, in fact, the necessity, of a large attendance. If the Bar Association is to render the service that it should render, to its members and to the State, there must be representative and widespread attendance at these meetings. It appears to me, therefore, that the matter can not be too strongly stressed; although I well know that the remarkable progress made along that line during the past three years, and the recognition that has come by reason thereof, would seem to make any direct appeal from me, as President, superfluous.

It is in appreciation of the fact, however, that good work, which has brought gratifying and worthwhile results, easily may be nullified, at least made less valuable, through failure to continue co-ordinated effort, and that the Association, as well as the individual members thereof, would soon come to deplore any slackening of effort or interest, that one in a position of official responsibility becomes fearful of not having, as well as ambitious to have, the basic operating mechanism measure up to past standards; hence my very earnest and urgent appeal to the members of the Association at this early date for the planning of summer work and vacation to the end that each and all may find time to spend two days at the 1927 annual meeting.
