ABSTRACT

ACUTE AND CHRONIC COBALT TOXICITY IN *DUGESIA DOROTOCEPHALA*

Limited data are available regarding cobalt toxicity for water quality criteria and risk assessment evaluation for freshwater organisms. These experiments were performed to establish median lethal concentrations from short term studies and to identify the most sensitive sublethal effect in a long term study in a flatworm species, *Dugesia dorocephala*. Another study was conducted to elucidate the relationship between calcium, magnesium and cobalt toxicity in *D. dorocephala*. During 4 and 7 day studies, median lethal concentrations of cobalt increased with total hardness indicating a protective effect. Calcium was shown to be more protective than magnesium in the presence of cobalt. A 60 day study showed fissioning rate, a process essential for maintenance of the *D. dorocephala* population, to be the most sensitive endpoint. A lowest observable adverse effect concentration (LOAEC) of 1 mg Co/L (nominal) was incorporated into the calculation of an acute to chronic ratio (ACR), an important metric for risk analysis accounting for sublethal effects that may occur by mechanisms different from lethal ones. A NOAEC (no observable adverse effect concentration) was not determined because significant effects were observed at the lowest cobalt concentrations tested (<1 mg Co/L). Without an exact NOAEC, the ACR values established in this study represent the upper and lower bounds of the acute to chronic ratio for cobalt in *D. dorocephala*.

I. INTRODUCTION

The toxicity of cobalt to freshwater organisms is relatively poorly known. Cobalt, the 33rd most abundant element in the Earth's crust (ATSDR 2004), has natural and anthropogenic sources of exposure to the environment. The ecological risk assessment and development of water-quality criteria for cobalt are currently hampered by insufficient knowledge about the toxicity of cobalt to freshwater organisms (DeSchampelaere et al. 2008).

Dugesia dorotocephala, a freshwater, asexual flatworm, is an important species to aquatic ecology (Kenk 1980). They model vulnerable systems of higher animals and may have the potential to become a sentinel species for toxicity in the environment. This work was conducted to establish acute LC₅₀ cobalt values in *D. dorotocephala* at varying levels of hardness, to establish valid sublethal endpoints in chronic studies and to evaluate the role of calcium in cobalt toxicity.

II. LITERATURE REVIEW

I. Cobalt

Cobalt is a naturally occurring element that appears in the periodic table between iron and nickel. Pure cobalt is a silver gray, insoluble solid with one stable isotope, ^{59}Co (Greenwood and Earnshaw 1997). Cobalt commonly occurs in three valence states: elemental cobalt, +2 and +3 (Greenwood and Earnshaw 1997, Kim 2006). Cobalt (II) is stable in aqueous solutions and is the major form of cobalt found in simple salts (Greenwood and Earnshaw 1997). Cobalt (III) is a strong oxidizing agent and is unstable in aqueous solutions (Greenwood and Earnshaw 1997). Cobalt (III) has biochemical importance forming a coordination complex with four pyrrole rings to result in an essential mammalian vitamin, vitamin B₁₂ (Lehninger et al. 2005). See Table 2.1 for the properties of elemental cobalt.

Of the 26 known radioactive isotopes of cobalt, ⁵⁷Co and ⁶⁰Co are the two most important. The most commonly used source of gamma radiation is ⁶⁰Co (Mahara and Kudo 1981). Radioactive cobalt can be released to the environment as a result of nuclear research and development, nuclear accidents, operation of nuclear power plants, and radioactive waste dumping in the sea or in radioactive waste landfills (Mahara and Kudo 1981). On the Environmental Protection Agency's National Priority List, which identifies the most seriously contaminated hazardous waste sites in the nation, ⁶⁰Co is present at 13 of the 1,636 sites (ATSDR 2004).

Sources:

As the 33rd most abundant metal in the Earth's crust at a concentration of 25 mg/kg, cobalt is found naturally in the soil, seawater, surface and ground water (Smith and Carson 1981, p. 21). Cobalt occurs at an average concentration of 45-48 mg Co/kg in basaltic rocks, 4-

147 mg Co/kg in schists, 19–20 mg Co/kg in clays and 1.2 mg Co/kg in sandstone and limestone (Smith and Carson 1981, p. 21). Presumably, cobalt substitutes for Fe(II) and Mg(II) ions in many minerals which results in mining in an attempt to concentrate the cobalt content (Smith and Carson 1981, p. 22). Cobalt is associated with arsenic, antimony, lead, nickel, silver, iron, zinc and copper ores and as arsenides, sulfides and oxides in mineral form (Kim 2006, Smith and Carson 1981, p. 22). Natural atmospheric deposition from windblown soil, seawater spray, volcanic eruptions, and forest fires contribute to the atmospheric cobalt emissions in the environment at an estimated 6,100 tonnes per year (Nriagu 1989).

Elevated levels in soils and water are observed as a result of anthropogenic activities such as mining, applying phosphate fertilizers, disposing of cobalt-containing wastes and atmospheric deposition from activities such as the burning of fossil fuels and smelting and refining of metals (Smith and Carson 1981, p. 422). Anthropogenic sources of cobalt include fossil fuel and waste combustion, vehicular and aircraft exhausts, processing of cobalt and cobalt containing alloys, copper and nickel smelting and refining, and the manufacture and use of cobalt chemicals and fertilizers derived from phosphate rocks (Smith and Carson 1981, p. 407).

Use:

The United States is the world's largest cobalt consumer (USGS 2010). Cobalt's metallurgical application in materials such as superalloys is commonly used by the military (USGS 2010). Cobalt is easily magnetized and can retain its magnetism under a wide range of environmental conditions (Young 1948). Cobalt is therefore also useful in magnetic alloys which resist corrosion and wear (ATSDR 2004). It is used to increase strength for cutting tools, to add pigmentation to paints, glass and ceramics, as the main component of paint driers and to serve

as catalysts in chemical reactions such as desulfurization processes used by the oil/gas industry (ATSDR 2004). A growing use of cobalt is in Ni-Cd batteries and lithium ion cells (ATSDR 2004) which are used in cell phones, computers and hybrid vehicles. Gamma rays from ^{60}Co are used to treat cancer, to sterilize instruments and food-borne pathogens and to extend the shelf-life of food by delaying ripening (ATSDR 2004). The gamma rays can also destroy harmful organisms in sludge, water and wood (ATSDR 2004).

Exposure:

Exposure to cobalt occurs through four media: water, soil, food and air (Kim 2006). Atmospheric cobalt is associated with particulate matter at levels below one ng Co/m³ at unpolluted sites and in open-ocean environments (Smith and Carson 1981, p. 32, Kim 2006). In source areas, cobalt concentrations may exceed 10 ng Co/m³ but the highest recorded atmospheric level, 48 ng Co/m³ was recorded near a nickel refinery in England (Smith and Carson 1981, p. 32).

Water

In ambient, uncontaminated environments, the cobalt concentrations are generally below 5 µg Co/L (Nagpal 2004). Surface and groundwater cobalt concentrations of <1 µg Co/L are found in pristine areas and can be up to 10 µg/L in urban areas (Smith and Carson 1981, p. 428). Concentrations may be higher in mining and agricultural areas. Levels in an Arizona creek near a copper mine and smelter were recorded at 4500 µg Co/L and 6500 µg Co/L was found in a Missouri river which receives mining and milling effluent (Smith and Carson 1981, p. 428). Mean seawater concentrations of 0.078 and 0.39 µg Co/L were observed in the Caribbean Sea and Indian Ocean respectively (Hamilton 1994). The National Community Water Supply Study found an average 2.2 µg

Co/L in drinking waters but up to 107 µg Co/L have been reported (Smith and Carson 1981, p. 425). Rainwater samples were found to have levels ranging from 0.045 µg Co/L to 2.9 µg Co/L (Smith and Carson 1981, p. 428).

Soil

Found in greater abundance than cadmium, molybdenum and lead, the average U.S. soil sample contains 7.2 mg Co/kg (Kim 2006). Soils containing 0.5–3 mg Co/kg are considered deficient for the required intake by ruminants (Kim 2006). Airports, ore smelting facilities, ore deposits, mines, highway traffic or other industrial sites may contain elevated soil concentrations up to 12,700 mg Co/kg (Abraham and Hunt 1995, Smith and Carson 1981, p. 26). Unpolluted freshwater sediments generally contain less than 20 mg Co/kg, similar to cobalt-sufficient soil, but polluted lake and river sediments can contain up to 133 mg Co/kg (Smith and Carson 1981, p. 28, 38).

Cobalt sorbs to particles and may settle into the sediment or may be sorbed directly by the sediment (ATSDR 2004). It may precipitate from overlying water as carbonates and hydroxides or with mineral oxides (ATSDR 2004). Cobalt may also sorb to humic acid substances in water (ATSDR 2004). Cobalt can also be transported in the dissolved form or as suspended sediment by rivers to lakes and the sea or by ocean currents (ATSDR 2004, Smith and Carson 1981, p. 34). Environmental factors such as pH, redox potential (Eh) and the presence of chelating agents will affect the fate and transport of cobalt: At a lower pH, more cobalt will be present in soluble forms and it will have greater mobility

(Smith and Carson 1981, p. 33, 532, 582, ATSDR 2004). Cobalt adsorbs strongly and rapidly to soil and sediment, in which it is retained by metal oxides, minerals and natural organic matter (ATSDR 2004).

Plants

As a result of the presence of cobalt in the soil and sediment, it has been detected in living plants as well at a mean level of 0.48 µg Co/g (Bowen 1966). Grasses normally contain 0.20–0.35 µg Co/g but in deficient soil, concentrations average 0.02–0.06 µg Co/g (Hamilton 1994). The copper flower plant (*Haumaniastrum robertii*), can actually hyperaccumulate cobalt at a mean level of 4,304 mg Co/kg dry weight (Brooks 1977). Cobalt has been shown to affect the growth and metabolism of plants depending on several factors including complexation with other minerals and physical conditions such as pH, temperature and salinity (Palit et al. 1994). Toxic effects on plants include inhibited active transport of ions, photosynthetic inefficiency, change in morphology, impaired DNA replication and RNA synthesis, and alteration of the sex of plants (Palit et al. 1994). Stimulated algae growth has been seen at low concentrations of Co⁺² suggesting that cobalt chloride may be used effectively as a trace metal (Ahluwalia and Kaur 1988).

Food

Food represents the largest potential source of cobalt exposure for humans (Kim 2006). The Centers for Disease Control and Prevention recommends a daily intake of 0.1 µg Co/day (ATSDR 2004). Grains and cereals have the highest cobalt content followed by potatoes, fish, sugar and coffee (Smith and Carson 1981, p. 60). The estimated intake from food is 5–40 µg Co/day, most of which is inorganic cobalt (Kim 2006). However,

studies reported a wide range of concentrations in these foods. Several studies have identified cobalt in unfiltered coffee effusions at an average level of 0.93 mg Co/kg dry coffee in one study (Smith and Carson 1981, p. 60). Cooking and canning may cause a loss of cobalt from the fresh food (Smith and Carson 1981, p. 60). Up to 10% of cobalt can be lost by roasting and grilling, 90% by stewing and boiling and 70% by canning (Smith and Carson 1981, p. 60). The foam-stabilizing additives for beer production contain cobalt at a maximum authorized concentration of 1 mg Co/L due to the fatal cases of cardiomyopathies as a result of the synergistic action between alcohol and cobalt at higher concentrations (Smith and Carson 1981, p. 61, 69).

Air

Cobalt, as particulate in the air, will return to land or surface water as wet or dry deposition depending on size, density and meteorological conditions (ATSDR 2004). Particles greater than 2 μm in diameter may deposit within 10 km from the point of emission but finer particles may travel further (ATSDR 2004).

Concentration Factors:

Aquatic concentration factors describe the level of cobalt in an organism compared to that in water. Marine zooplankton have concentration factors (CFs) ranging from 1,000 to 10,000 (Smith and Carson 1981, p. 58, 802). Rooted freshwater plants have CFs less than 10 which suggest the absorption occurs through the roots in the cobalt-enriched sediment (Smith and Carson 1981, p. 59, 802). Freshwater algae, with CFs from 400 to nearly 2 million, reflect the effect of their large surface-to-volume ratio on accumulation (Smith and Carson 1981, p. 58, 802). Insects and insect larvae show very high CFs, up to 100,000, possibly due to adsorption on the exoskeleton of adult insects and the exposure of larvae living in sediment (Smith and Carson

1981, p. 58, 802). Freshwater fish and fish muscle CFs range from 10 to 1,000 (Smith and Carson 1981, p. 58, 802). Overall, the higher an organism is in the food chain, the lower the CF (Smith and Carson 1981, p. 803). Some variables that influence concentration factors include the high surface-to-volume ratio of plankton species which favors adsorption, absorption via ingestion of food particles by invertebrates and absorption via the gills in aquatic vertebrates (Smith and Carson 1981, p. 58).

Essential Nutrient:

Cobalt forms a unique carbon–metal bond in vitamin B₁₂, an essential nutritional molecule. This vitamin is not synthesized by plants or animals but rather by a few microorganisms. This vitamin is essential to convert methylmalonyl coenzyme A to succinyl coenzyme A, an intermediate of the citric acid cycle, and the formation of s-adenosylmethionine, an essential cofactor for methylation reactions. The most common congeners of vitamin B₁₂ (cobalamin) have three portions to the molecular structure (Hillman 1996). The first two portions are the corrin ring system of coenzyme B₁₂ which coordinates to cobalt and a dimethylbenzimidazole ribonucleotide. One of four groups complete the molecule and form the corresponding congener: cyanide, hydroxyl, methyl or 5-deoxyadenosyl (Hillman 1996). Cobalt⁺¹ complexes with 5'-deoxyadenosine through a weak covalent bond. This bond is easily broken with exposure to visible light and produces a radical and Co⁺². Cobalt⁺³, when complexed with a hydroxyl group in the sixth coordination position instead of 5-deoxyadenosine, can be reduced by a reductase enzyme and NADH to cobalt⁺² and further to cobalt⁺¹ (Lehninger 2005, Stryer 1988). The two active forms of this coenzyme necessary are the

deoxyadenosine and methyl forms. However, the cyano and hydroxyl forms are the more commonly encountered forms which are converted to the active forms (Hillman 1996, Lehninger 2005, Stryer 1988).

Ruminants are completely dependent on the microflora within the rumen for vitamin B₁₂ synthesis and require more cobalt from the diet than nonruminants. Ruminants use vitamin B₁₂ to convert propionate, their primary energy source to glucose. The estimated cobalt requirement is 0.07–0.10 mg/kg diet. The estimated intake of cobalt for nonruminants such as pigs and chicks is only 0.01–0.02 mg/kg diet because nonruminants require preformed vitamin B₁₂ to meet their metabolic needs (Swenson 1977, Van Soest 1994).

Cobalt deficiencies have been associated with several diseases. An autoimmune disease in humans, pernicious anemia, produces insufficient amounts of a factor required for vitamin B₁₂ absorption (Lehninger 2005). Several wasting diseases, including bush sickness, salt sickness, Grand Traverse disease, Mairoa dopiness and Morton Mains disease, have been reported globally as a result of cobalt insufficiencies in cattle and sheep (Young 1948).

Cobalt deficient herbage occurs as a result of cobalt deficient soil which can be corrected by applying cobalt-infused fertilizer or concentrated salt licks (Smith and Carson 1981, p. 25, Young 1948). When iron is present, cobalt and iron mutually antagonize the absorption of each other due to the greater affinity cobalt has in the transport system of the intestine (Thomson et al. 1971).

Toxicology:

Cobalt toxicosis is not likely to occur in nonruminants unless environmental contamination of feed or water occurs (National Research Council 2005). Cobalt toxicosis in animals is very rare because concentrations of cobalt normally present in animal diets are much lower than those needed to cause toxicosis (National Research Council 2005). However, errors in mineral supplement formulation in ruminants, for example, could result in cobalt toxicosis (National Research Council 2005). The LD₅₀ in rats for CoCl₂·6H₂O is 42.4 mg Co/kg (ATSDR 2004). When fed an iron-sufficient diet, 50 mg Co/kg diet did not affect weight gain but 100 mg Co/kg diet did (Huck 1975). Myocardial damage in adult rats (Morvai et al. 1993), testicular degeneration in male rats and mice (Corrier et al. 1985), impaired fetal development in mice and rats (Szakmary et al. 2001) and increased mortality in pregnant rabbits have all been reported (Szakmary et al. 2001). One suggested mechanism involves oxidative damage to the purine and pyrimidine bases of DNA caused by cobalt (II) exposure (Kasprzak et al. 1994). Vitamin E and selenium offered protection against cobalt-induced cardiomyopathy (Van Vleet et al. 1977).

Cobalt toxicity has been noted in humans. Cardiac damage in beer drinkers progressed from dyspnea and hypotension to death in more than 40% of the cases. Irregular histologic findings were noted not only in the heart but also in the thyroid (Smith and Carson 1981, p. 69).

Cobalt toxicity was observed as a result of treatments for anemia in humans prior to 1970 which included a daily dose of cobalt up to 200 mg Co/day. This practice was suspended due to the onset of goiters and classical hypothyroidism signs that developed as early as six weeks after cobalt therapy began. Iodine uptake was suppressed by 20 to over 90%. Other

symptoms including nausea, neurogenic deafness, anorexia, dermatologic conditions and tinnitus were also documented in humans receiving cobalt anti-anemia therapy (Smith and Carson 1981, p. 69).

Hypoxia inducible factor (HIF), a transcription factor, leads to angiogenesis and stimulation of erythropoietin. Under normoxic conditions, hydroxylase enzymes add a hydroxyl group to the alpha subunit of HIF on a conserved proline residue. When hydroxylated, the von Hippel-Lindau (VHL) protein binds to the alpha subunit which initiates proteasomal degradation. When the alpha subunit is not hydroxylated, as in hypoxic conditions, dimerization of the other subunit, HIF beta, occurs and translocates to the nucleus where transcription of angiogenic, anaerobic glycolytic and erythropoietic proteins begins (Klaassen 2008, p.91). Cobalt has been shown to inhibit VHL by blocking the VHL binding site on the alpha subunit or by replacing iron in the hydroxylase enzyme thus inactivating the enzyme (Yuan et al. 2003, Epstein et al. 2001). In addition, the antioxidant ascorbate is essential to stabilizing the iron⁺² in hydroxylase. It has been demonstrated that when cells are exposed to cobalt, less ascorbate is absorbed. This deficiency likely favors iron oxidation leading to inactivation of the enzyme (Salnikow et al. 2004).

Cobalt has been shown to cause toxic effects in primary murine glial cells including mitochondrial damage. This lead to the release of apoptogenic factors leading to apoptosis of the cell. Cobalt, similar to hypoxia, also stimulated the expression of HIF-1 α regulated genes (Nip3 and iNOS) and depleted ATP production. Thus, metabolic and neurotoxic effects have been documented at concentrations of 0.2–0.8 mM cobalt⁺² (Karovic et al. 2007). Neurotoxic effects, specifically memory deficits, were also observed in ex-factory workers who were diagnosed with hard metals disease as a result of cobalt exposure (Jordan et al. 1997).

Cobalt toxicity has been evaluated in aquatic organisms including microalgae, protozoa, invertebrates, fish and amphibians. The *Onchorynchus mykiss* (rainbow trout) LC₅₀ was lower compared to other freshwater fish such as *Pimephales promelas* (fathead minnow). A flatworm species in the same genus as the species used in the studies for this thesis, *Dugesia tigrina*, had a 96-hour LC₅₀ between the rainbow trout and fathead minnow (Table 2.2).

The LC₅₀ values were based on a testing time of 96 hours. Hardness was determined in the dilution water. The contribution of cobalt to the total hardness was not accounted for when the exposure solutions were prepared.

Cobalt is either dissolved as cobalt carbonate or as cobalt (II) ions under most environmental conditions (Tipping et al. 1998). However, bioavailability appears to depend on the water chemistry and the concentration of calcium ions (Diamond et al. 1992). Therefore, when the hardness was varied, the 24-hour LC₅₀ for *Ceriodaphnia dubia* increased from 2.4 to 5.3 mg Co/L as the hardness increased (Diamond et al. 1992). Using a gill-cobalt binding model, calcium competition and dissolved organic matter complexation were the most important factors preventing cobalt from binding at the gills in a series of natural water tests in *O. mykiss*. Calcium at 17 µM allowed cobalt to bind but inhibited binding at 90 µM (Richards and Playle 1998). The data based on binding affinities indicate that cobalt binds to gill sites more weakly (log K =5.1) than other metals such as cadmium (log K=8.6), lead (log K=6.0) and zinc (log K=5.3-5.5) (Niyogi and Wood 2004).

II. Planaria

Dugesia dorotocephala, freshwater planaria, are bilaterally symmetrical metazoans of the phylum Platyhelminthes (Figure 1). These invertebrates are unsegmented, acoelomate, and possess well-defined anteroposterior and dorsoventral axes (Adell et al. 2010). Along the AP axis, the anterior cephalic region containing the brain and a pair of eyespots, a central region with a pharynx and a ventral mouth opening, and a posterior tail region can be distinguished (Adell et al. 2010) (Figure 1). They are best known for their ability to regenerate complete animals from fragments of their own bodies in seven days, a generally short time frame (Adell et al. 2010). The inclusion of planaria in a screening scheme would provide improved sensitivity in detecting toxicity because planaria generally respond to lower levels of contamination than do other species (Kapu and Schaeffer 1991). They can also be included in a higher tier because they may exhibit complex responses including inhibition and stimulation of reproduction, teratogenesis and tumorigenesis (Best and Morita 1982).

Freshwater planaria are important components of the aquatic ecology of relatively unpolluted streams. They were incorporated in the biological assessments for water quality in Europe. The sensitivity varies between species of planaria from very sensitive to mild sensitivity

to pollution in waters but generally are intolerant of heavy metal salts (Kenk 1980). They model many of the toxicologically vulnerable systems of higher animals and may represent an economical organism for toxicity screenings and bioassays (Best 1981, Best and Morita 1982).

This species occurs in nature as both sexual and asexual forms. The transformation of asexual worms into sexual ones has been observed under conditions that simulate the drying up of a pond (H.S. Ramsdell, unpublished observations). Morita and Best describe a distinct circadian rhythm of fissioning under the influence of normal photoperiods in asexual *D. dorocephala*. This process, essential for maintaining and increasing their population, is difficult to observe because fissioning occurs at night and is completed in three to four minutes. Initially, a body constriction appears at the site where fissioning will occur; the rostral portion of the body contracts and then pulls away from the caudal portion which adheres to the surface of the container. The constricted region becomes narrower as it stretches. This process continues until the stretched area ruptures. Finally, the rupture closes up when the circular body wall muscles contract. After fissioning is completed, regeneration takes place to yield two complete, but smaller, planaria (Morita and Best 1993). These observations suggest that fissioning primarily involves neuromuscular events which are regulated by neurotransmitters or neuromodulators within the central nervous system (Morita and Best 1993, Best et al. 1969).

Fissioning was a process previously believed to occur as a result of mucus or some other substance being released into the water from the planarian. Instead, a system of population feedback control has actually been identified. In the presence of other planaria, the brain exerts an influence (probably neurohormonal) to suppress fissioning which decreases with axial distance from the brain. The suppression is contingent on population density and thus is a part

of a feedback system for adjusting the rate of reproduction to population density. A reduced population density would lead to increased rates of fissioning whereas higher population densities suppress fissioning (Best et al. 1969).

III. Studies Reported In This Thesis

The ecological risk assessment and development of water-quality criteria for cobalt are still currently hampered by insufficient knowledge about the toxicity of cobalt to freshwater organisms (DeSchamphelaere et al. 2008). Therefore, this work was conducted to establish acute LC₅₀ cobalt values in *D. dorocephala* at varying levels of hardness, to establish valid sublethal endpoints in chronic studies and to evaluate the role of calcium in cobalt toxicity.

III. MATERIAL AND METHODS

I. Culture Maintenance

Asexual *Dugesia dorocephala* were maintained in large white enameled dishpans that contained moderately hard reconstituted culture water. Eighteen liters of culture water were prepared at a time in a carboy using ultraviolet-treated water from Horsetooth Reservoir in Fort Collins, CO. To adjust hardness from the soft Horsetooth Reservoir water to moderate hardness, calcium sulfate (Mallinckrodt Analytical Reagent), magnesium sulfate heptahydrate (EM Science), potassium chloride (Fisher Scientific) and sodium bicarbonate (Fisher Scientific) were added. Aeration was applied for 12–24 hours to allow for complete dissolution of the salts, thorough oxygenation and equilibration of the solution with atmospheric carbon dioxide. After three uses of a given carboy or a six month period had passed, the carboy was disinfected by allowing a 5% bleach solution to sit in the carboy for thirty to forty minutes followed by extensive rinsing with Horsetooth Reservoir water followed by Type 1 water (ASTM 1999).

Planaria were collected from a tributary of the Cache La Poudre River in Bellvue, CO and acclimated over a two-week period by transitioning their water to the laboratory culture water. The planaria were transferred to culture pans and only handled with a small wet paintbrush to minimize stress and potential injury. All of the culture pans were covered with pieces of lightweight plastic fitted with holes to allow for air exchange and to prevent debris falling into the pans.

Once acclimated to the water, the planaria were divided by size in different culture pans to discourage cannibalism and promote growth. They were fed organic beef liver 1–2 times a week. The pan water was changed between four and 24 hours after feeding. The planaria were placed in new culture pans with the aid of a piece of plastic screen approximately every four to six weeks or earlier if algae had overgrown in the pans. The photoperiod, 16:8 hours light:dark, was maintained with an automatic timer.

II. Experimental Methods

All experiments were conducted in glass crystallizing dishes with a diameter of 105 mm containing 50 mL of the desired exposure solution. The replicates were randomly stacked with their respective concentrations after each water change to minimize the effect of variation in light intensity from the overhead light. An empty crystallizing dish was placed on top of each stack for protection and to limit dehydration.

Glassware used in a study was detergent-washed, rinsed five times with tap water, three times with ultra-pure water followed by an acid rinse of 10% hydrochloric acid. Three final rinses with Type 1 water prepared the glassware for the study (ASTM 1996).

Cobalt concentrations were prepared from a stock solution (either 625 or 400 mg Co/L) made with Type 1 water using $\text{CoCl}_2 \cdot 6\text{H}_2\text{O}$ (Mallinckrodt Analytical Reagent). The highest concentration for each study was prepared using the stock solution and a match water. The match water was formulated using calcium sulfate and magnesium sulfate to achieve the required hardness values while accounting for the hardness contribution of cobalt. Dilution water, prepared to match the desired overall hardness for each study, was used for the serial dilutions to the lower concentrations. Match and dilution waters were prepared separately for

every study. In an experiment where total hardness was maintained but cation concentrations varied, separate dilution and match waters for each test were prepared in individual containers. In this manner, test solutions were formulated such that hardness was held constant while cobalt concentrations varied. An initial seven-day mortality study was conducted without hardness matching.

Planaria, 10–15 mm in length, to be used for a study were segregated into a separate pan four or seven days prior to the start of the study in the appropriate dilution water in the hardness to be used during the study. Feeding occurred three days prior to the start of the study.

Observations were recorded prior to a water change if one was scheduled to occur that day, typically within three hours of the time of day when the study began. Observations took place under a magnifying light and a dissecting microscope using a paintbrush to manipulate the planaria if necessary. Morphology, behavior, and any abnormalities were recorded.

In studies when behavioral assessments were performed, tactile response, righting reflex and swimming speed were evaluated. Tactile response was measured by recording the time elapsed for a planarian to regain forward motility after being subjected to a touch stimulus. The planarian was observed for up to 60 seconds. If there was no movement by this time, the result was scored as “60 seconds.” The righting reflex was evaluated by measurement of the time to regain normal forward motility after the body was inverted using a small paintbrush. As with the tactile response, failure of the planarian to achieve forward motility within one minute was scored as “60 seconds.” Swimming speed was measured by counting the number of lines on a two centimeter by two centimeter grid crossed during a two-minute time interval. The same

planarian, one per replicate and randomly chosen by the observer, was used for the three assessments. Without a convenient method for identifying individual planaria, behavioral assessments at other time points may not have been done using the same planarian.

After observations, feedings would take place if required by the study design. A small piece of raw beef liver was placed in each dish. The remaining food was removed four to six hours later and the exposure solution renewed. Exposure solutions prepared within thirty minutes of use were added from a graduated cylinder as soon as the old water was removed. Vacuum filtration and a micropipette tip were used to remove the old water from each dish.

Water chemistry parameters were measured on the newly prepared dilutions and on a composite sample of old exposure solutions removed from dishes during exposure solution renewal, using meters generally calibrated on a daily basis. Temperature, conductivity, pH and dissolved oxygen were recorded for both new and composited old samples but ammonia was only analyzed in the composited old water samples. Subsamples of the new and/or old solutions were preserved at each water change with 1% trace metals grade nitric acid (Fisher Scientific). After every water change, the dishes were restacked randomly within each concentration and placed under the light source with a 16:8 light:dark photoperiod. The following table (3.1) presents the methods used to determine the specific parameter.

III. Short Term Studies

Mortality studies were performed with 96 and 168 hours of exposure. A standard test period for many aquatic species is 96 hours (ASTM 1996). Previous toxicity testing using *D. dorocephala* in this laboratory has demonstrated a pronounced increase in mortality in periods between 96 and 168 hours (H.S. Ramsdell, unpublished observations). Samples of the new exposure solution dilutions were collected and preserved once at the beginning of each study. Samples of the composited old waters were collected and preserved after each water change. When fissioning occurred during an acute study, it was recorded but no segregation of fragments was performed.

Prior to the renewal of exposure solutions, mortality and morphology were recorded. Exposure solutions were renewed on the third and fifth days of seven day studies. Exposure solutions were renewed daily in four day studies. Three behavioral assessments were conducted on the final day of each test.

IV. Long Term Study

A sixty day study was conducted to determine a nonlethal endpoint sensitive to cobalt exposure. Three endpoints were assessed: behavioral responses, fissioning and regeneration rates. Behavioral assessments were made every two weeks. Daily checks for fissioning events were performed and if an event had occurred, the head and the tail fragment were segregated in separate dishes. Segregated fragments were evaluated daily to see if regeneration was complete. If so, each fragment returned to the exposure dish from which the fragments had been removed. The daily checks were all made between 0700 and 1100.

Mortality and morphology were recorded twice weekly prior to the renewal of the exposure solutions for the planaria in the crystallizing dishes and those that were segregated as well. Feeding occurred once a week after observations followed by the test renewal four to six hours later. Samples of the new exposure solution dilutions were collected and preserved once a week and composited old exposure solutions samples were prepared twice a week for later ICP-AES analysis.

V. Cation Studies

An initial range finding study took place with just one replicate to determine the impact of calcium and magnesium concentrations on cobalt mortality. In a subsequent experiment, at a fixed concentration of 10 mg Co/L and an overall target hardness of 100 mg CaCO₃/L, the calcium and magnesium ratios were varied for a seven day mortality study. Observations took place daily after the initial 48 hours and behavioral assessments occurred at test termination. Samples of the new exposure solutions were preserved once at the beginning of the study.

Composited old samples were collected when test solutions were renewed which occurred on the third and fifth day of the seven day study.

VI. Analytical Chemistry

Samples preserved with 1% nitric acid were analyzed using inductively coupled plasma-atomic emission spectrometry (ICP-AES) (Table 3.2). Blank samples and two standard concentrations per element (calcium, cobalt and magnesium) were evaluated during every analysis.

VII. Statistics

The LC₅₀ values from the short term studies were determined using the trimmed Spearman-Kärber Method and Probit analysis using US EPA Toxicity Data Analysis Software Version 1.5 (1994). The Probit method is used if there are two or more non-control concentrations that have partial mortalities. The Spearman-Kärber method is used when one partial mortality exists among non-control concentrations or when the Probit method is inappropriate due to the chi-square value calculated by the software.

Long term data including mortality, fissioning, behavioral and regeneration, were analyzed. Proportion data were transformed using the arcsine square root for statistical tests. One way and two way ANOVAs, paired T tests and Tukey's Method were calculated or performed using R Version 2.13.1 (R Development Core Team 2008).

IV. RESULTS

The results of five experiments explored the various endpoints related to cobalt toxicity. Three short term studies identified mortality-related values as the main effect. They were conducted in two time frames: 7 days (Studies #1 and 2) and 4 days (Study #3). Study #1 had varying levels of total hardness. Studies #2 and 3 had fixed total hardness levels. Data from three behavioral assessments was evaluated also in Studies #2 and 3.

One long term study, #4, identified relevant sublethal endpoints including fissioning and regeneration rates and behavioral assessments. Survival of intact worms, those that did not fission, and of the fragments, head or tail, were also evaluated. Finally, Study #5 showed the mortality that was observed when cobalt and total hardness were held at a fixed concentration but the ions comprising total hardness, calcium and magnesium, varied.

4.1 Study #1

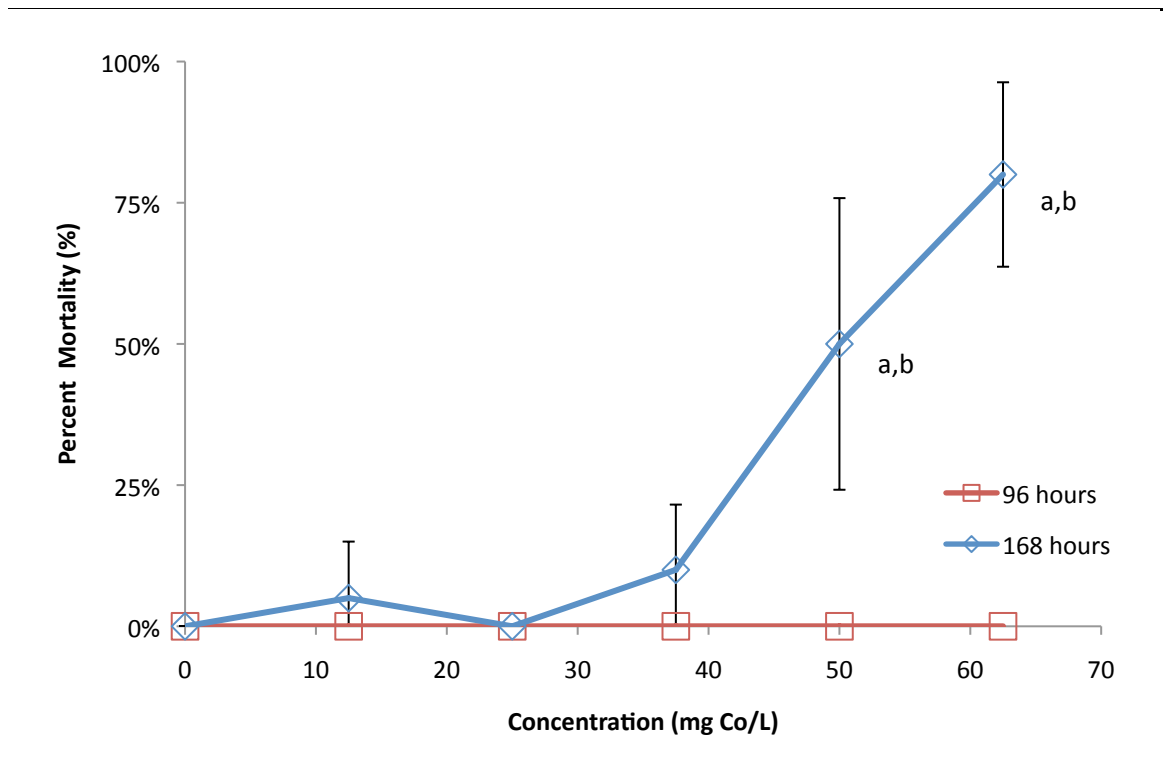


Figure 4.1.a. Mortality after the initial 96 hours and at 168 hours in Study #1

A 7 day mortality study using *D. dorotocephala* was performed. The initial 96 hours of exposure resulted in no mortality but 80% mortality was observed in the highest cobalt concentration by the seventh day. No mortality occurred in the dilution water, the concentration that contained no cobalt, throughout the study. Mortality was significantly increased at concentrations of 50 mg Co/L and above (Tukey, $p < 0.0009$) (Figure 4.1.a.). A 7 day median lethal concentration (LC_{50}) of 50 mg Co/L was calculated for Study #1 (Trimmed Spearman-Kärber).

Based on the nominal concentrations and titration of the dilution water, the calculated total hardness range was 217- 323 mg CaCO₃/L. The CoCl₂ stock solution (made up in Type 1 water) was added to achieve the desired Co concentration. Due to the contribution of Co⁺² to hardness, each level of Co exposure solution had a different total hardness (Table 4.1.a). As noted below, this could be expected to result in calculation of a higher LC₅₀ value as a consequence of the protective effect of higher hardness.

The ranges reported in Table 4.1.b. were compiled from the data of both new and old exposure solutions. The reported hardness and alkalinity concentrations were determined from titrations performed with dilution water only. The highest ammonia value, 5.04 mg/L, was noted in the composited old exposure solution of the control on the third day. On that same day, the highest dissolved oxygen and pH values of all the composited samples were also recorded in the control as well.

Water chemistry values were measured in new and old exposure solutions. Mean values were computed on days 3, 5 and 7. 4.2 Study #2

In order to account for the influence of hardness on Co toxicity to planaria, a 7 day mortality study using *D. dorotocephala* was performed at three different total hardness levels. Calculated total hardness, including the contribution of Co^{+2} , was held constant by preparing working Co^{+2} stock solutions in a hardness “match” water formulated with calcium and magnesium salts such that the total hardness would be at the desired level. Dilution of the hardness-matched working stock solutions with reconstituted water with the same hardness value thus resulted in each exposure concentration having the same total hardness. Analysis of exposure solutions for Ca, Mg and Co by ICP-AES was used to verify actual total hardness values. Mortality and median lethal concentrations (LC_{50}) were calculated. Three different behavioral responses were also recorded.

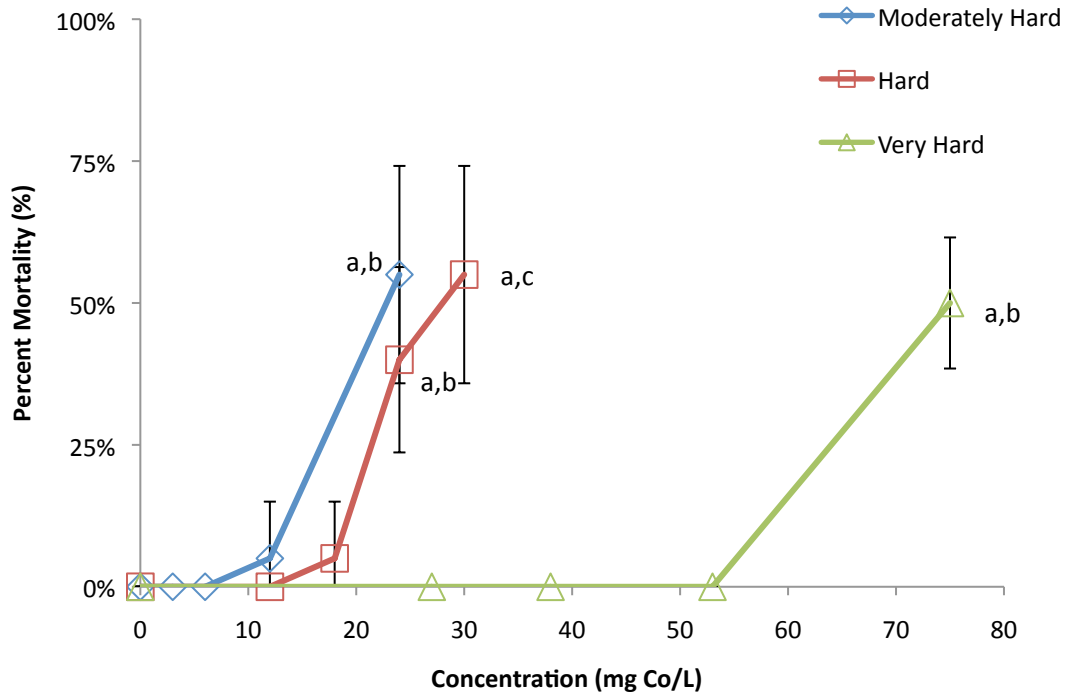


Figure 4.2.a. Mortality at 96 hours, Study #2

After the initial 96 hours, the highest cobalt concentration at each level of hardness resulted in approximately 50% mortality (Figure 4.2.a.). For planaria that underwent fissioning during the study, mortality was assessed based on survival of only the head fragments. Complete mortality occurred in the higher Co exposure groups by 168 hours at all three levels of hardness (Figure 4.2.b.). Hardness alone did not significantly contribute to the mortality either at 96 or 168 hours (Two-way ANOVA, $p > 0.05$). When the effect of the cobalt concentration was accounted for in the statistical analysis of each level of hardness, the interaction of these two factors significantly contributed to the observed mortality at 96 and 168 hours (Two-way ANOVA, $p < 0.0001$).

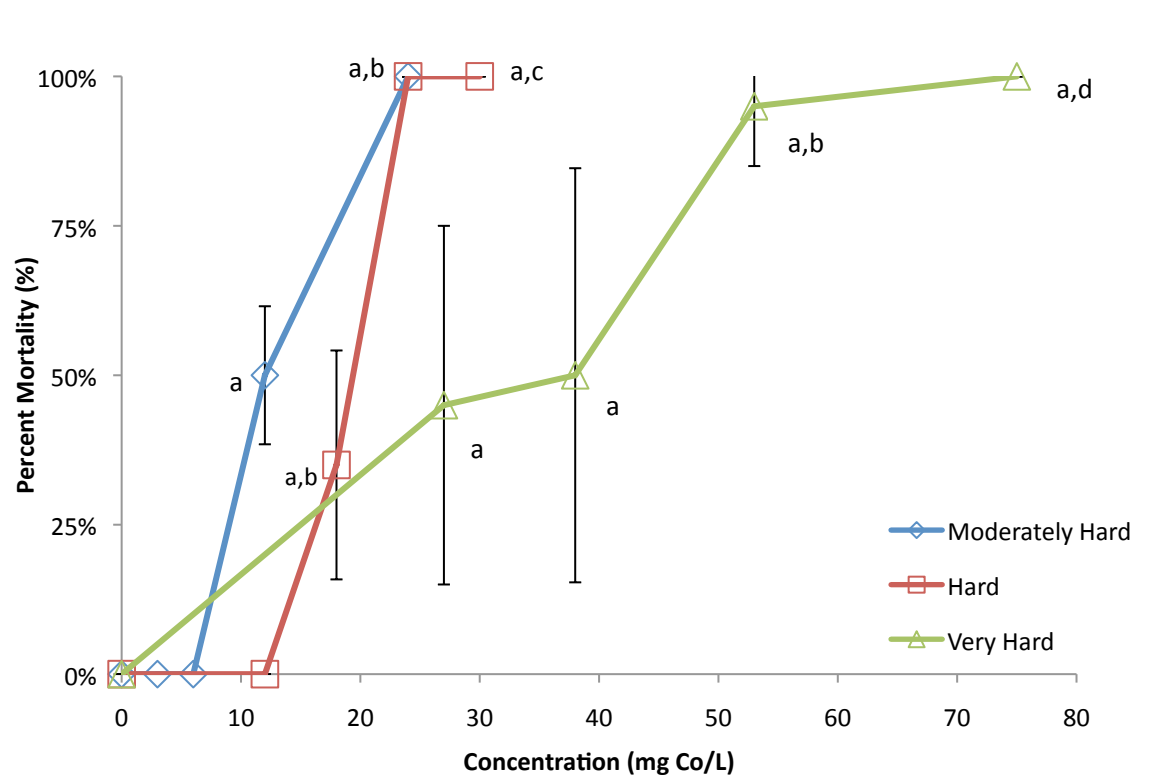


Figure 4.2.b. Mortality at test termination (168 hours), Study #2

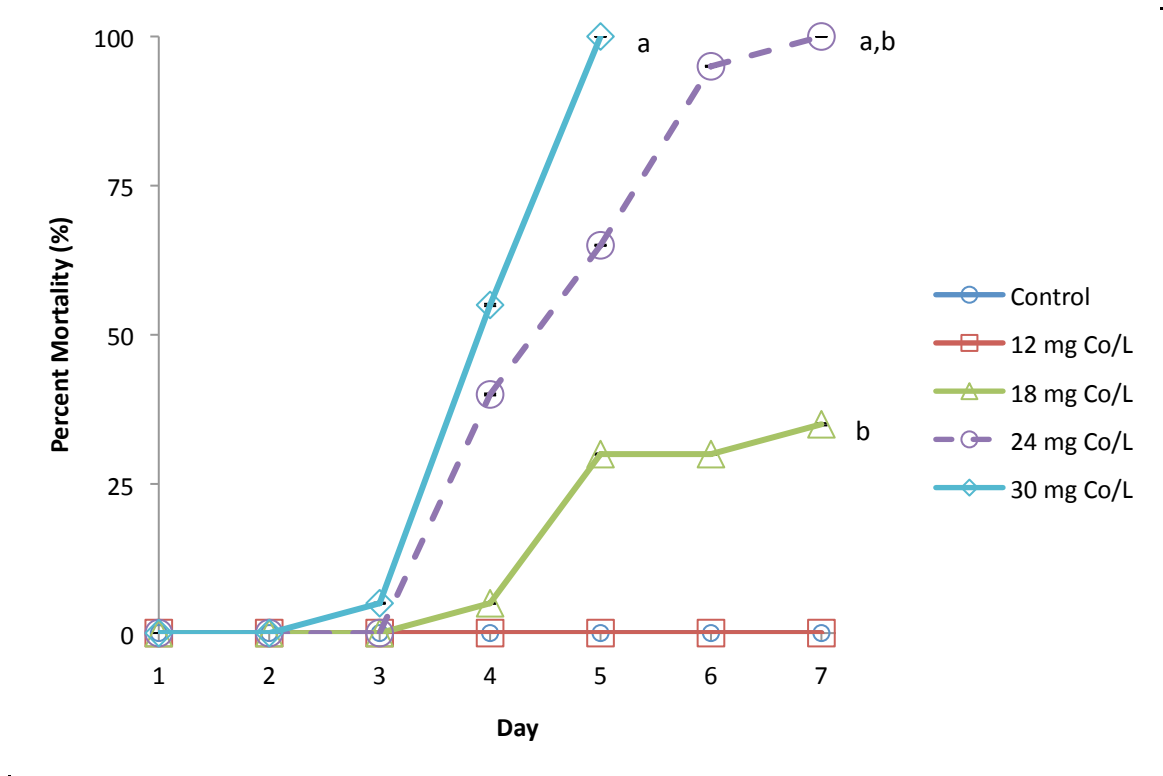


Figure 4.2.c. Mortality by day at varying cobalt concentrations for hard water exposure solutions, Study #2

The temporal effect at a total hardness of 180 mg CaCO_3/L is shown in Figure 4.2.c. By 120 hours (five days), all planaria were dead at the highest concentration, 30 mg Co/L. At 24 mg Co/L, complete mortality required 168 hours (seven days). Time was significant (Two-way ANOVA, $p = 0.008$) but when cobalt concentrations were also taken into account, the interaction of time and cobalt levels had a higher level of significance with respect to mortality (Two-way ANOVA, $p < 0.0001$).

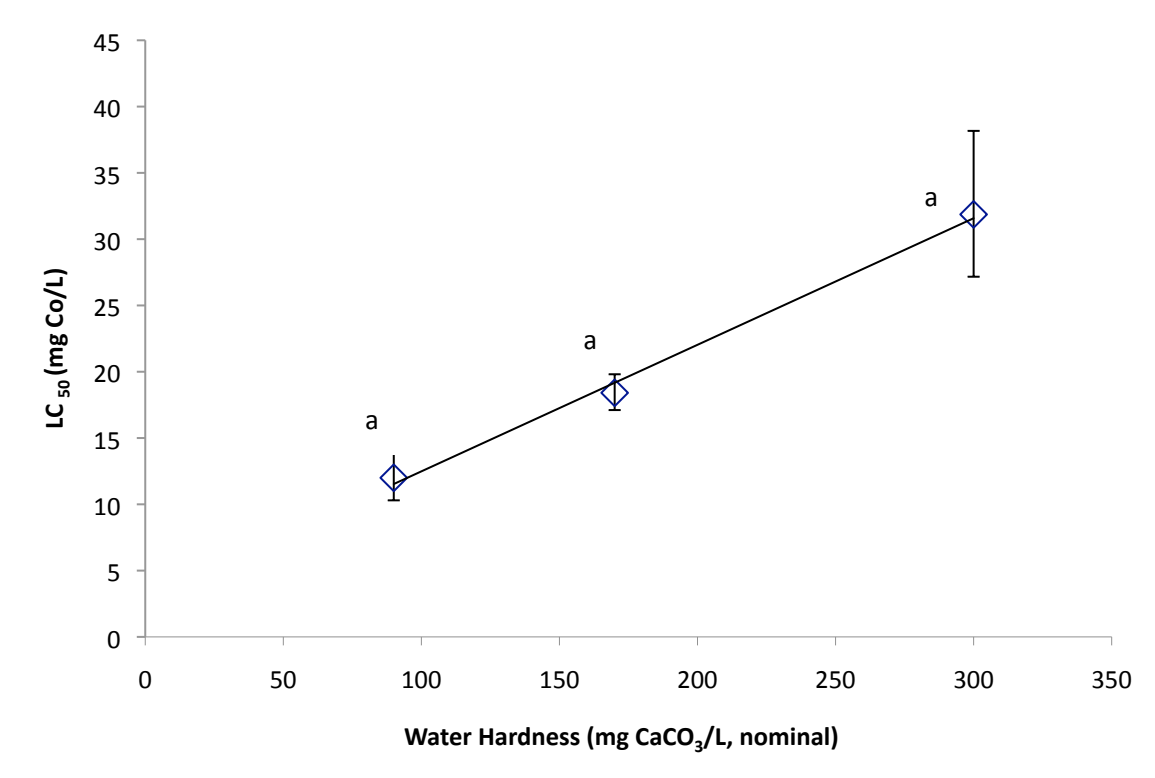


Figure 4.2.d. Cobalt toxicity (LC₅₀) to Planaria at Different Water Hardness Levels, Study #2

At the moderate level of hardness, the LC_{50} was 12 mg Co/L (Spearman-Kärber Method) based on the original data (no transformation). As hardness increased, the LC_{50} values also increased to 18 and 32 mg Co/L in hard and very hard water respectively (Spearman-Kärber and Probit, respectively) (Figure 4.2.d.). All of these concentrations were significantly different from each other because the Least Significant Difference intervals do not overlap (Table 4.2.a.)

Three behavioral assessments, tactile response, righting reflex response and swimming speed, were measured at test termination (168 hours) at all levels of hardness tested. One planarian was randomly selected from each surviving replicate. As the concentration of cobalt increased and more adverse effects were observed (ruffled edges, lesions, mortality etc), fewer planaria were available for these assessments. Toxicity decreased when the swimming speed was higher but increased when the time for the tactile or righting reflex responses took longer.

Moderately Hard

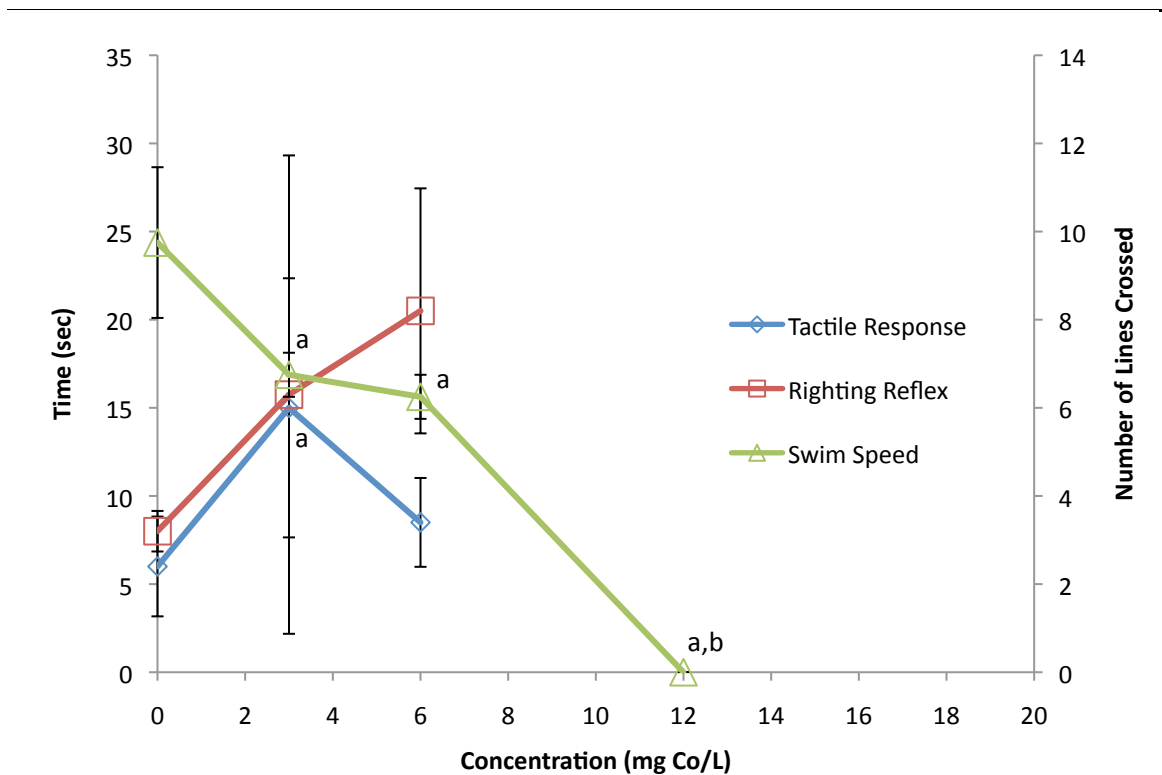


Figure 4.2.e. Three behavioral assessments performed in Study #2 at nominal total hardness of 100 mg CaCO₃/L (moderately hard)

The tactile response at 3 and 12 mg Co/L were significantly different compared to the control (Tukey, $p < 0.05$) (Figure 4.2.e.). The righting reflex response was significantly delayed at 12 mg Co/L relative to the control (Tukey, $p < 0.0001$). Both tactile and righting reflex responses were significantly longer at 12 mg Co/L compared to 3 and 6 mg Co/L (Tukey, $p < 0.0001$). Swimming speed was significantly reduced in a concentration-related fashion in all of the exposure solutions with available subjects (3, 6 and 12 mg Co/L) (Tukey, $p < 0.0001$).

Hard

The two timed behavioral responses were significantly affected at 12 and 18 mg Co/L relative to the control (Tukey, $p < 0.0008$) (Figure 4.2.f.). Similar results were observed in the swimming speed as well at the same concentrations.

Very Hard

The tactile and righting reflex responses were significantly different from the control (Tukey, $p < 0.02$) (Figure 4.2.g.). The swimming speed was significantly reduced relative to the control at 27, 38 and 53 mg Co/L (Tukey, $p < 0.0005$) due to the immobility of the planaria.

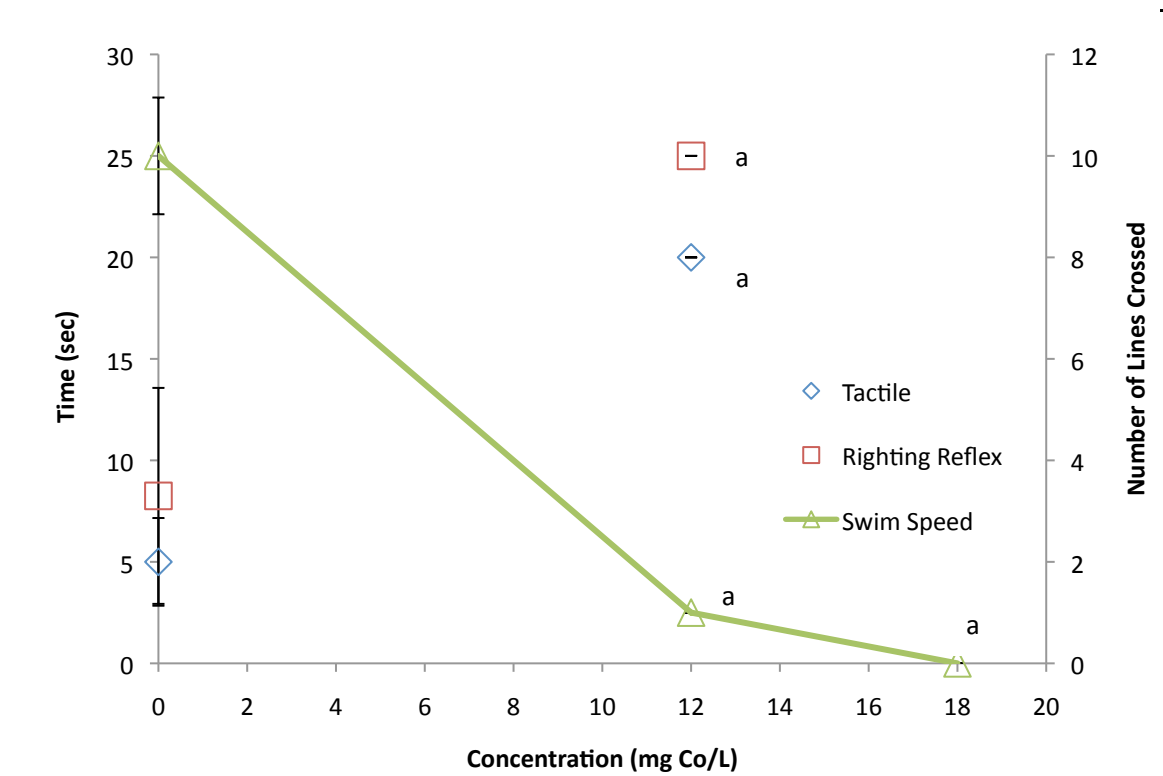


Figure 4.2.f. Three behavioral assessments performed in Study #2 at nominal total hardness of 180 mg CaCO₃/L (hard)

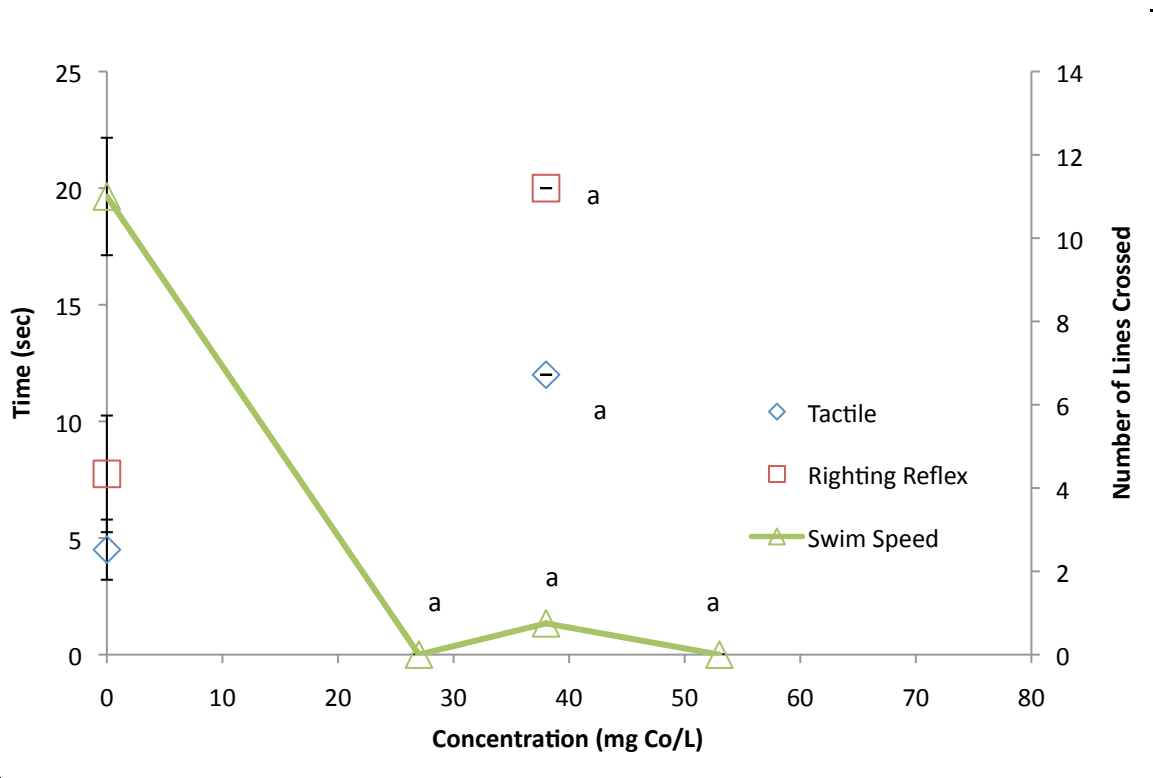


Figure 4.2.g. Three behavioral assessments performed in Study #2 at nominal total hardness of 320 mg CaCO₃/L (very hard)

Swimming Speed:

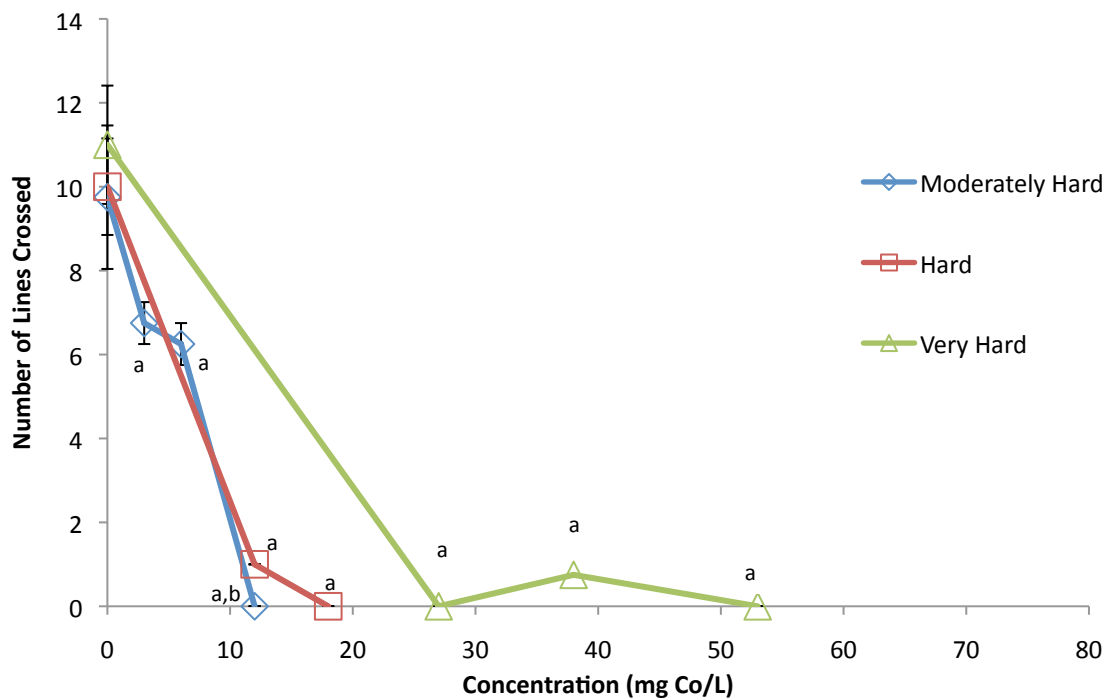


Figure 4.2.h. Swimming speed in all three levels of hardness, Study #2

The swimming speed was analyzed for all three hardness levels because this assessment had the greatest response in all the concentrations. Hardness alone did not significantly reduce the swimming speed but Co concentration and hardness together explained the decreased response (Two-way ANOVA, $p < 0.001$) (Figure 4.2.h.). Every concentration of cobalt experienced a significant reduction from the control and the planarian at 12 mg Co/L was significantly slower compared to 3 and 6 mg Co/L (Tukey, $p < 0.004$).

Water chemistry values for this study are listed in Table 4.2.b. Initial titrations of the dilution and match waters were within 10% of the nominal concentrations. The measured hardness range was within 11% of the mean value. The pH, conductivity, and alkalinity increased as hardness increased.

4.3 Study #3

Another mortality study was performed at the standard acute aquatic testing duration of 96 hours (ASTM 2007) using higher cobalt concentration ranges to achieve a greater level of mortality at the earlier time point. The hardness contribution of cobalt was accounted for in this study as well. Mortality and median lethal concentrations (LC_{50}) were calculated and three behavioral responses were recorded as in Study #2.

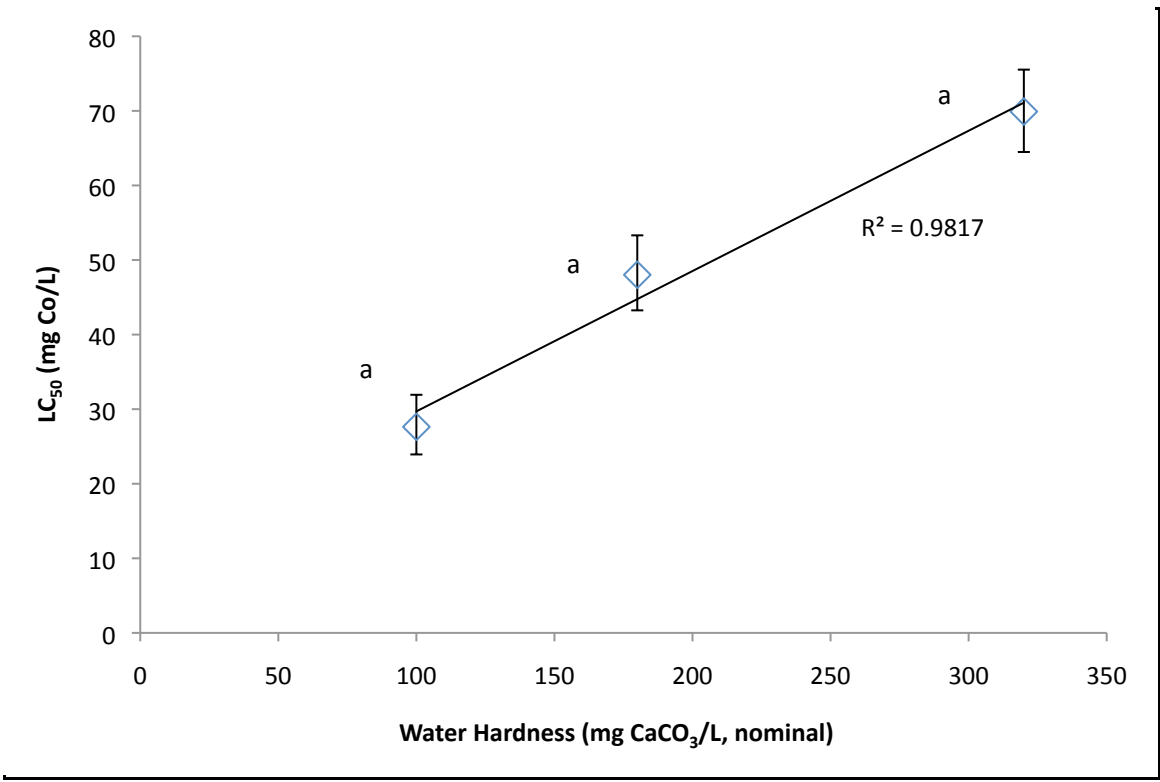


Figure 4.3.a. Median lethal cobalt concentrations to planaria at different water hardness levels, Study #3

Median lethal concentrations were calculated for each total hardness level. At a moderate level of hardness, the LC_{50} was 28 mg Co/L (Probit). As hardness increased, the 96 hour LC_{50} values also increased to 48 and 70 mg Co/L in hard and very hard water, respectively (Spearman-Kärber and Probit, respectively) (Figure 4.3.a.). Two different statistical methods were used because there were two patterns of mortality. The Probit method is used if there are two or more non-control concentrations that have partial mortalities. The Spearman-Kärber method is used when only one non-control concentration has a partial mortality or when the Probit method is inappropriate due to the calculated chi-square value. Based on the Least Significant Difference (LSD) intervals, these three LC_{50} values are all significantly different from each other (Table 4.3.a.). They are all also significantly different from their respective 168 hour LC_{50} values calculated in Study #2 (Figure 4.3.b.).

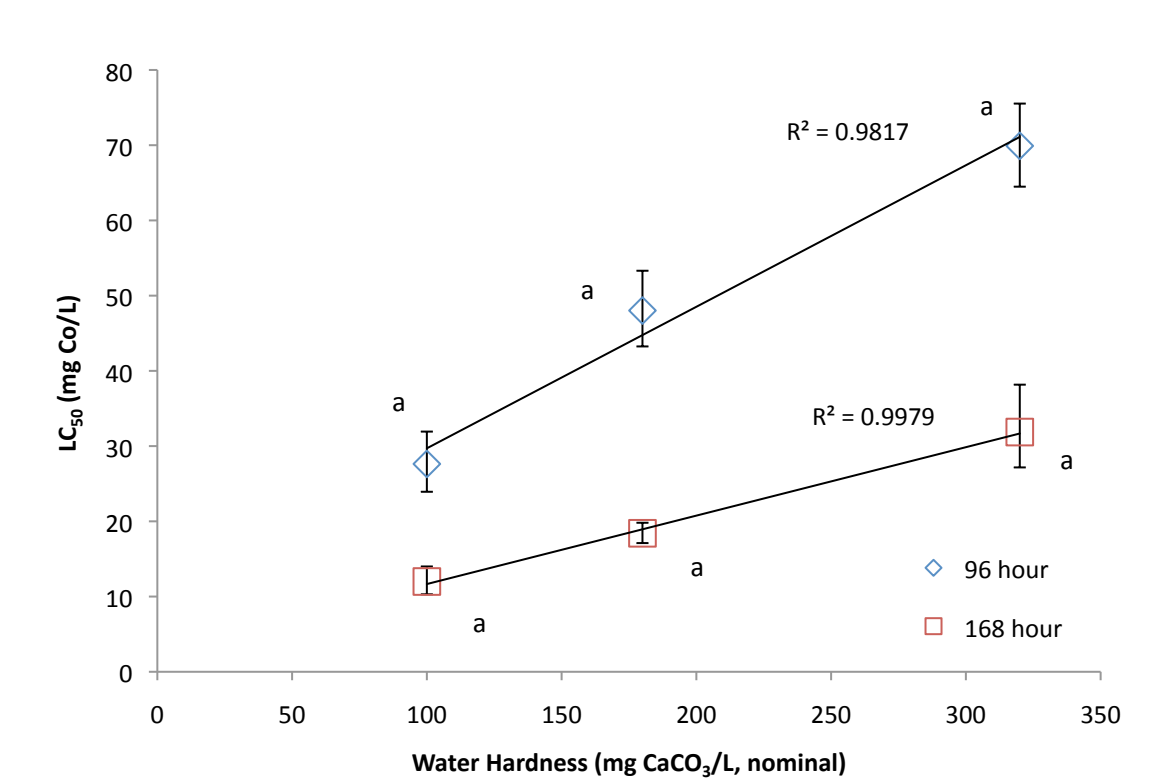


Figure 4.3.b. A comparison of LC₅₀ values from Study #2 and Study #3

Three behavioral assessments: tactile response, righting reflex response and swimming speed were measured at test termination (96 hours) in each hardness level. One planarian was randomly selected from each surviving replicate. Similar to Study #2, as the cobalt concentration increased, fewer planaria were available for these assessments.

Moderately Hard

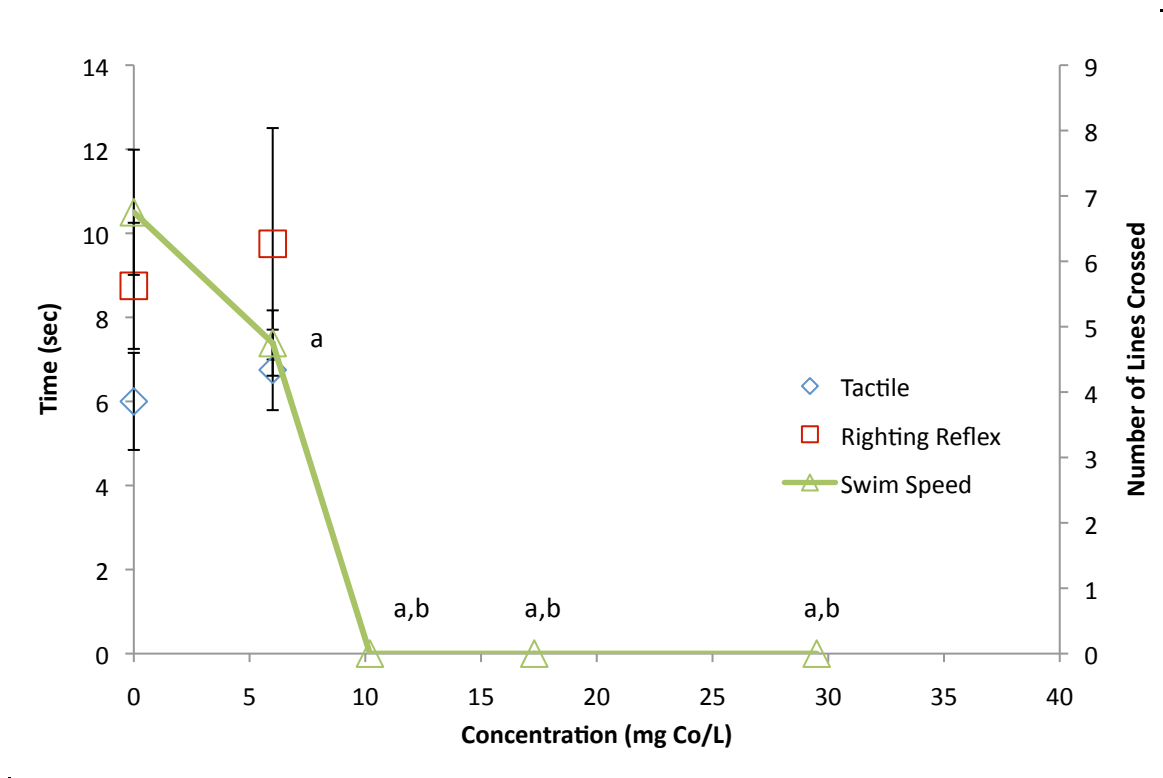


Figure 4.3.c. Planarian behavioral responses in moderately hard water (nominal, 100 mg CaCO₃/L) in Study #3

The tactile and righting reflex responses at 6 mg Co/L were not significantly different from the control (Tukey, $p > 0.5$) (Figure 4.3.c). Planaria in the other concentrations, 10.2, 17.3 and 29.5 mg Co/L were immobile during the one-minute observation time. (These data are not displayed on the graph.) The responses at these three concentrations of cobalt are significantly different from the control and 6 mg Co/L (Tukey, $p < 0.0001$). The swimming speed was significantly reduced compared to the control for all exposure solutions, 6, 10.2, 17.3 and 29.5 mg Co/L (Tukey, $p < 0.0002$). At 10.2, 17.3 and 29.5 mg Co/L, swimming speeds were significantly different from 6 mg Co/L (Tukey, $p < 0.0001$).

Hard

The tactile response was not significantly different in the two lowest exposure levels, 12 and 19 mg Co/L, compared to the control (Tukey, $p > 0.05$) (Figure 4.3.d.). At the remaining concentrations, 30.7 and 49.2 mg Co/L, tactile response times exceeded the one-minute observation time due to immobility and were significantly increased compared to the control (Tukey, $p < 0.0001$). Planaria responses to the righting reflex assessment were significantly different from the control at 12 and 19 mg Co/L (Tukey, $p < 0.0001$). Planaria in the two higher concentrations, 30.7 and 49.2 mg Co/L, also exceeded the one-minute observation time due to immobility and were significantly

different from the control, 12 and 19 mg Co/L (Tukey, $p < 0.0001$). The swimming speed was not significantly decreased at 12 mg Co/L compared to the control (Tukey, $p = 0.96$) but swimming speed in the remaining concentrations were significantly different from the control (Tukey, $p < 0.0001$). At 19, 30.7 and 49.2 mg Co/L, swimming speeds were significantly different from 12 mg Co/L as well due to immobility (Tukey, $p < 0.02$).

Very Hard

The tactile response was significantly impaired in all of the exposure levels with surviving planaria (50, 63.5 and 80.7 mg Co/L) compared to the control (Tukey, $p < 0.03$) (Figure 4.3.e.). The righting reflex responses were different (Tukey, $p < 0.0001$) from the control in all of the concentrations except the lowest, 50 mg Co/L (Tukey, $p > 0.06$). At 63.5 and 80.7 mg Co/L, the planaria did not move during the one-minute observation time allotted for the tactile and righting reflex assessments and were thus significantly different from the responses at 50 mg Co/L (Tukey, $p < 0.0001$). The swimming speed was reduced significantly in the three cobalt concentrations compared to the control (Tukey, $p < 0.0001$).

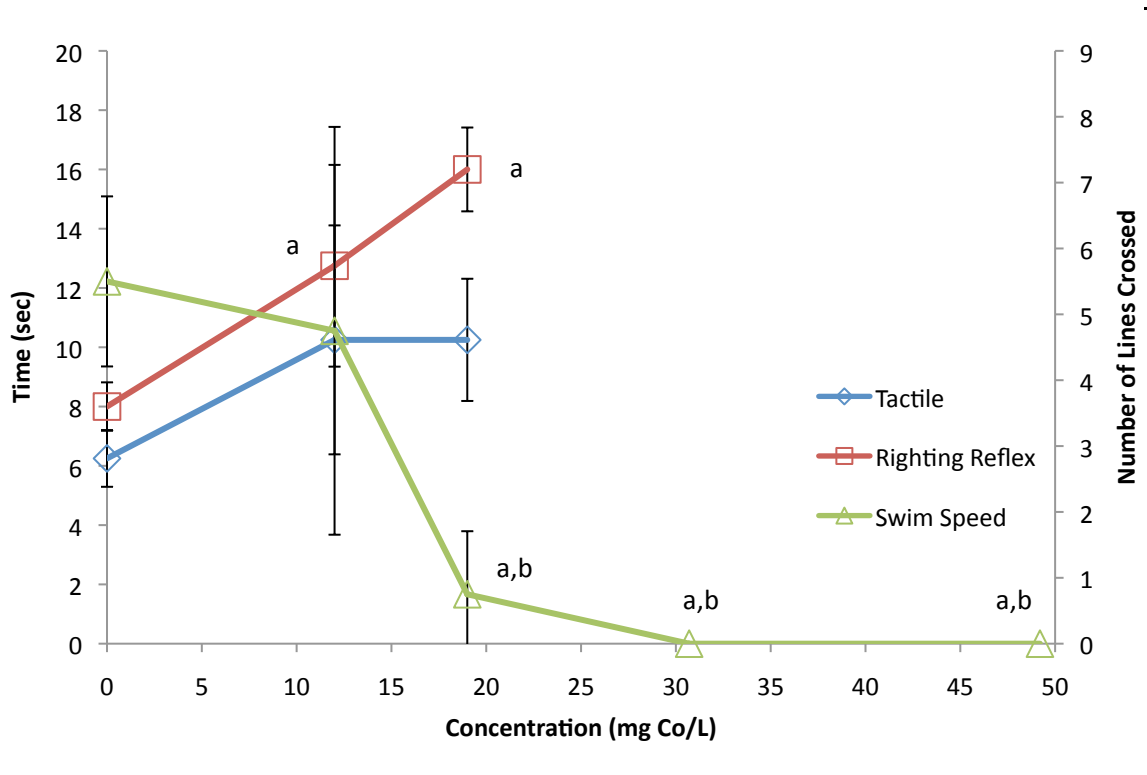


Figure 4.3.d. Planarian behavioral responses in hard water (nominal, 180 mg CaCO₃/L) in Study #3

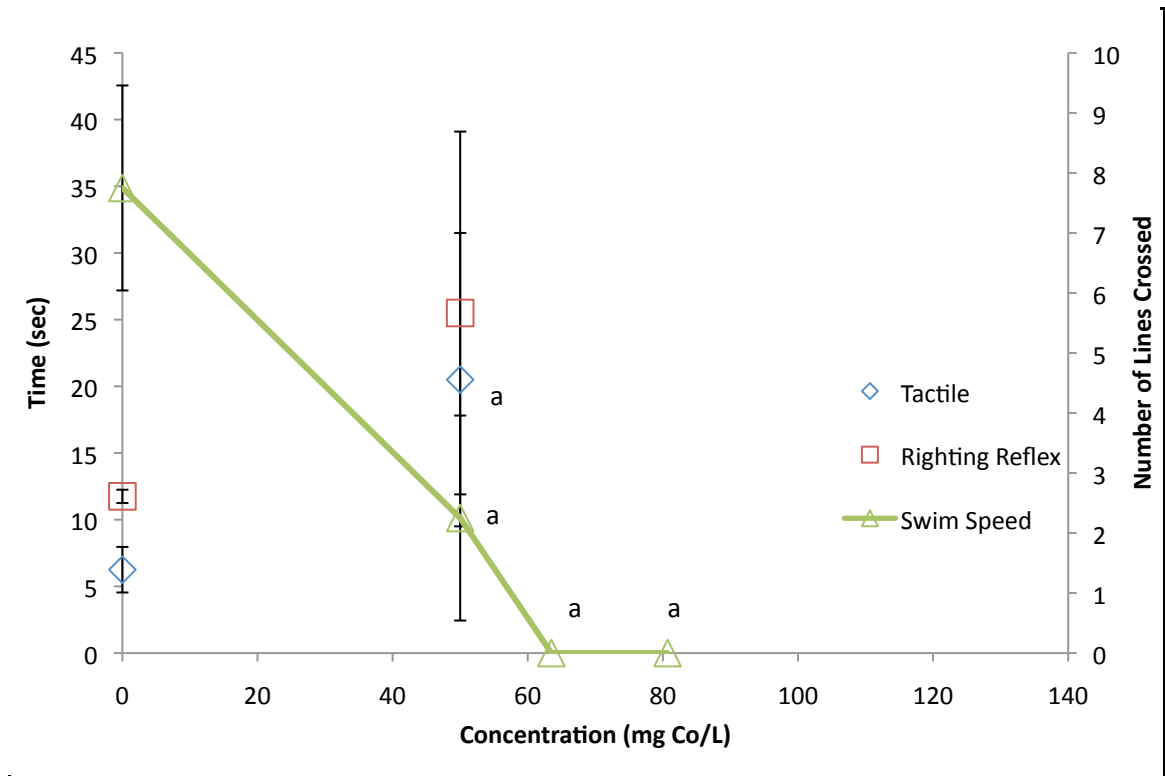


Figure 4.3.e. Planarian behavioral responses in very hard water (nominal, 320 mg CaCO₃/L) in Study #3

The measured cobalt concentrations were compared to the nominal concentrations in Study #3 (Table 4.3.b.). Initial exposure solution samples were preserved once at the beginning of the test and old water samples were preserved daily for ICP-AES analysis. The reported mean values include both the initial and old exposure solutions. No significant variation in the concentrations was found in any level of hardness (Paired t-test, $p > 0.07$). Variation in measured concentrations (except as noted below) was less than 13 % and mean values were within 13% of the nominal ones. One outlying value at 63.5 mg Co/L (very hard water) cannot be explained by any chemical nor biological reason. One possibility would be due to an error committed by the technician during the preservation process. The statistical conclusion is the same whether or not this value is included.

The water chemistry values (Table 4.3.c), measured in initial and old exposure solutions, collected daily at each water change, show trends similar to those in Table 4.2.b. in Study #2.

The pH values and conductivities generally increased as the hardness level increased. The ammonia concentrations remained low and the dissolved oxygen concentrations were at least 75% of saturation. The measured hardness was within 9% of the mean value for moderately hard water, 24% for hard water and 15% for very hard water.

4.4 Study #4

Based on the results from studies #1-3, a 60 day chronic study was conducted at the most sensitive hardness level, moderate hardness, to assess sublethal effect of cobalt on planaria. Total hardness, including the contribution of cobalt, was held constant by preparing a working stock of cobalt solution in a hardness “match” water prepared based on the desired total hardness. Observations and water changes were performed twice weekly. Once a week, the planaria were fed organic beef liver for four to six hours. Observations on these days were made prior to the feeding times and water changes occurred after the feeding time ended. A daily check was performed to segregate any fragments if a fissioning event had occurred. Mean mortality over the entire study was calculated based on the number of intact planaria. Mortality of the segregated fragments was also assessed. The number of fissioning events and the time it took for a head or tail fragment to regenerate was analyzed. A head fragment is defined as a planarian that needed to regenerate a new tail following fissioning and a tail fragment is a planarian that must regenerate a new head. Behavioral assessments were performed as well.

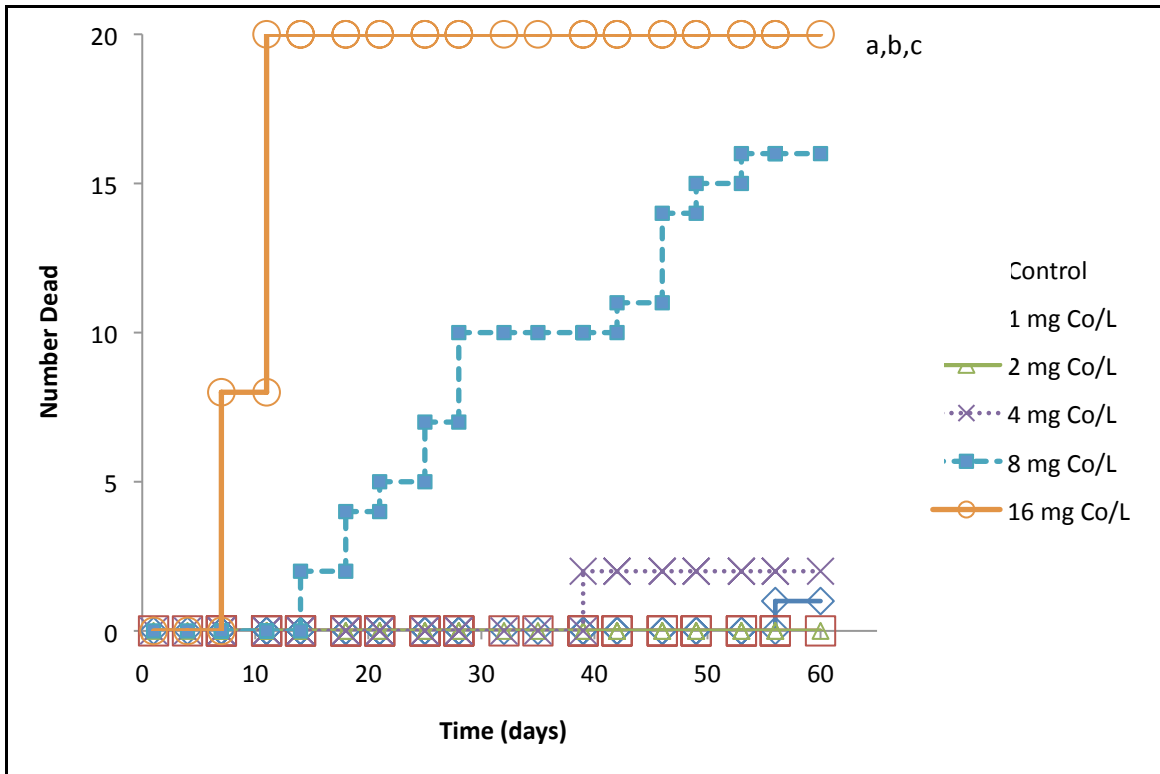


Figure 4.4.a. Planaria mortality by day, Study #4

Complete mortality occurred at the highest concentration, 16 mg Co/L, by the eleventh day of the study (Figure 4.4.a.). Partial mortality was observed at 4 and 8 mg Co/L and no mortality occurred at the two lowest concentrations (1 and 2 mg Co/L). Based on four replicates, only the mortality that was observed at 8 and 16 mg Co/L was significantly different from the control and lower concentrations (Tukey, $p < 0.0001$). Therefore, 4 mg Co/L was the highest concentration that caused no effect on mortality and 8 mg Co/L was the lowest concentration that was observed to have an effect on mortality.

Reproduction is critical for species sustainability and *D. dorotocephala* must fission to maintain and increase their population density. Fissioning events were significantly reduced within the first 28 days of the study and also during the entire length of the study (0-60 days) (Table 4.4.a.). During the initial 28 days, the mean number of fissioning events, based on four replicates, at 1, 2 and 4 mg Co/L was significantly different from the control (Tukey, $p < 0.04$).

During the entire length of the study, the number of fissioning events at 1, 2, 4 and 8 mg Co/L were all significantly different from the control (Tukey, $p < 0.0001$). Thus, the lowest observable adverse effect concentration (LOAEC) in this study was 1 mg Co/L.

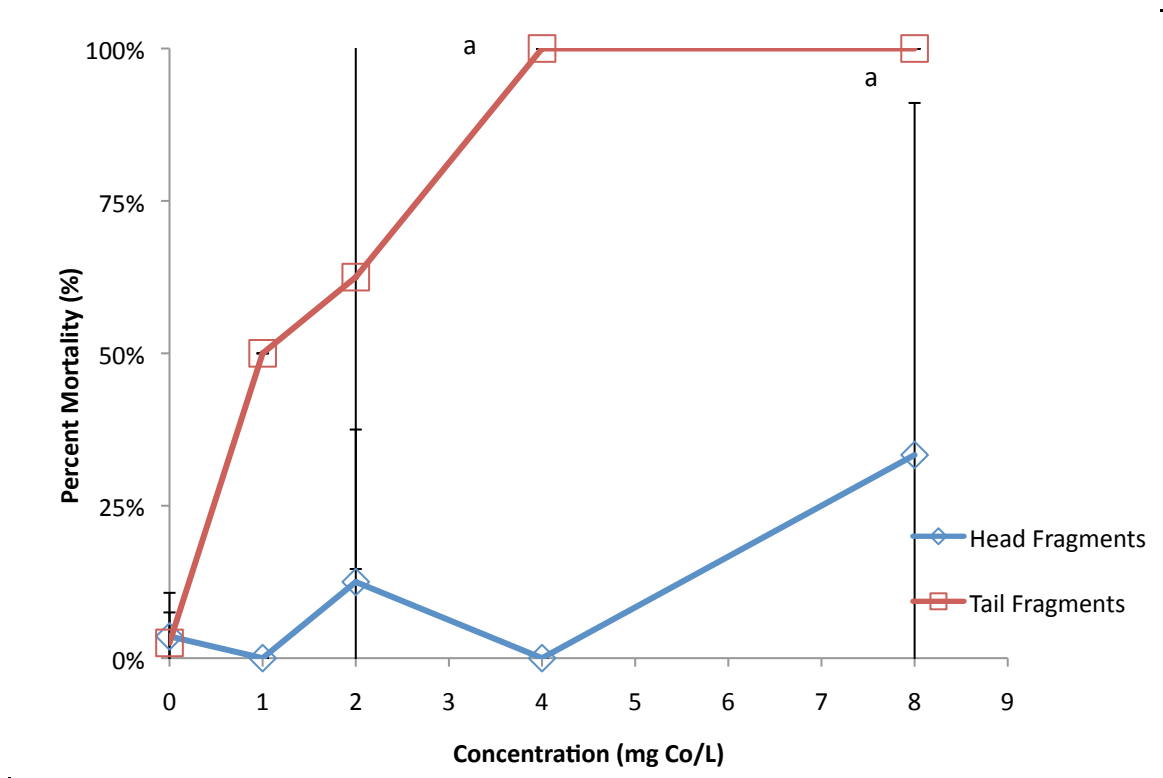


Figure 4.4.b. Percent mortality of head and tail fragments, Study #4

Head fragment mortality in the cobalt exposure solutions was not significantly different compared to the fragment mortality in the control but there was a difference in mortality of the tail fragments (linear regression, $p = 0.12$ and < 0.01 respectively) (Figure 4.4.b.). Significant increase in tail fragment mortality was observed at 4 and 8 mg Co/L compared to the control.

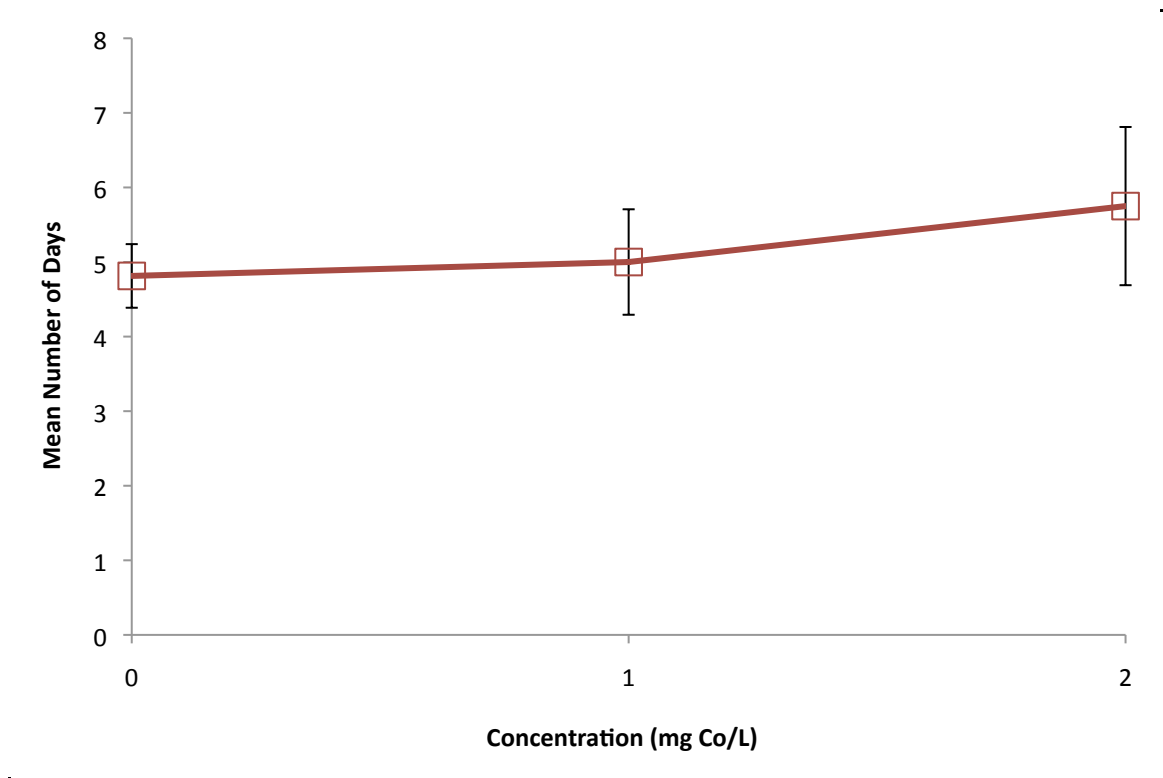


Figure 4.4.c. Regeneration of a head in tail fragments in Study #4

Regeneration of the head fragments occurred more frequently than of the tail fragments. Fewer tail fragments actually survived. The time for a head regeneration at 1 and 2 mg Co/L was not significantly different from the control (One-way ANOVA, Tukey, $p > 0.16$) (Figure 4.4.c.). However, the time for tail regeneration of a head fragment was significantly different (One-way ANOVA, $p < 0.0002$) (Figure 4.4.d.). At 8 mg Co/L, the tail regeneration rate was significantly different from the control and all of the lower concentrations (Tukey, $p < 0.003$).

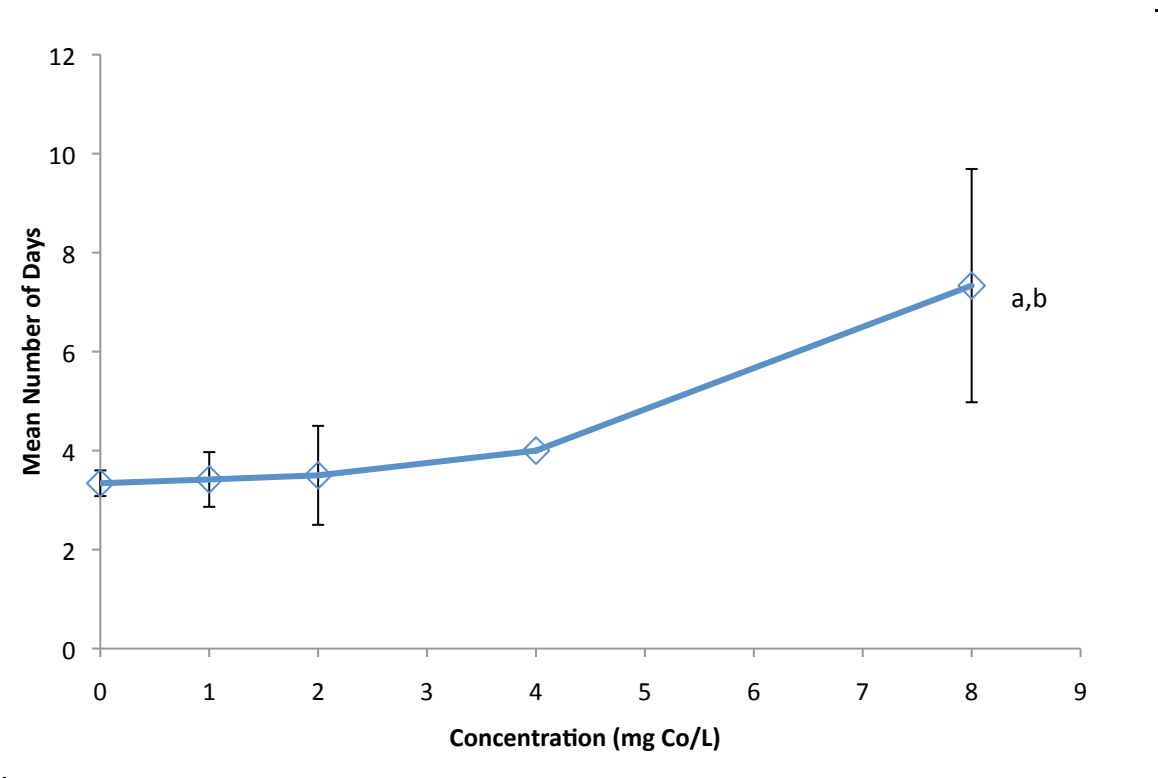


Figure 4.4.d. Regeneration of a tail in head fragments in Study #4

Three behavioral assessments, tactile response, righting reflex response and swimming speed, were measured every two weeks and at test termination (days 7, 21, 35, 49 and 60). One planarian was randomly selected from each surviving replicate. As the concentration of cobalt increased and more adverse effects were observed (ruffled edges, lesions, mortality etc), fewer planaria were available for these assessments.

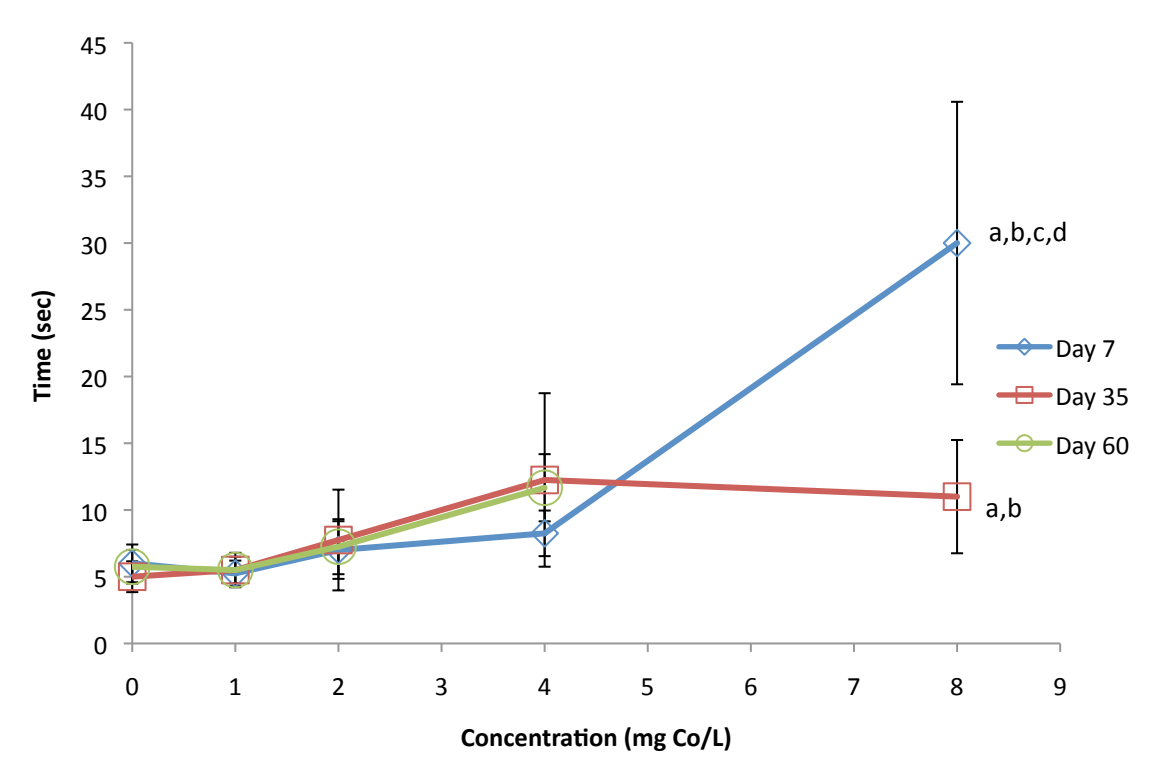


Figure 4.4.e. Planarian behavioral assessment in Study #4: Tactile Response

In all three assessments, the number of days that passed during the study did not influence the results. The exposure to cobalt significantly affected the responses (Two-way ANOVA, $p < 0.001$). There were no statistical differences in the tactile (Figure 4.4.e.) or the righting reflex (Figure 4.4.f.) responses at the three lowest concentrations (1, 2 and 4 mg Co/L) (Tukey, $p > 0.05$). At 8 mg Co/L, the planarian exceeded the one-minute observation time for the tactile and the righting reflex responses on days 49 and 60. At 4, 8 and 16 mg Co/L, the swimming speeds were significantly different from the control (Tukey, $p < 0.0003$). At 4 mg Co/L, the swimming speed was also significantly different from planaria exposed to 1, 2, 8 and 16 mg Co/L (Tukey, $p < 0.0001$). At 8 and 16 mg Co/L, the swimming speed was lower than at 1, 2 and 4 mg Co/L (Tukey, $p < 0.0001$) (Figure 4.4.g.). The lowest concentration where no effect on swimming speed was observed was at 2 mg Co/L but the lowest effective concentration was 4 mg Co/L for tactile and righting reflex responses (Figure 4.4.h.).

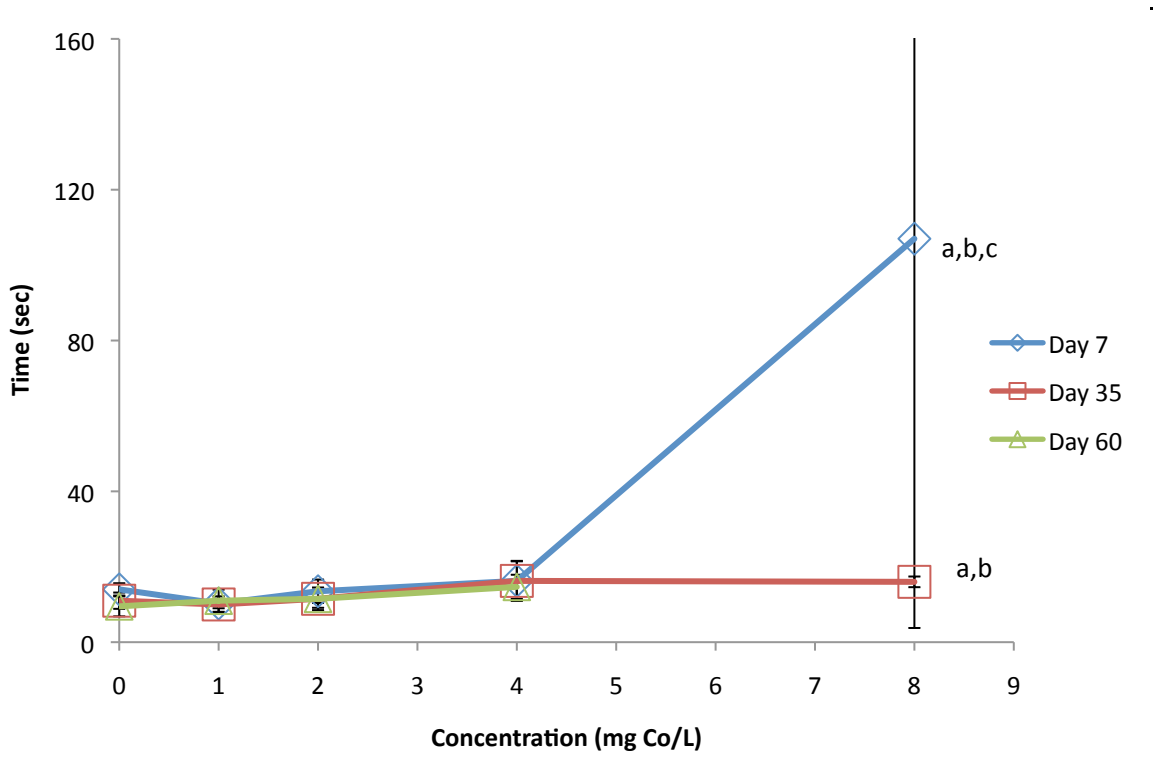


Figure 4.4.f. Planarian behavioral assessment in Study #4: Righting Reflex Response

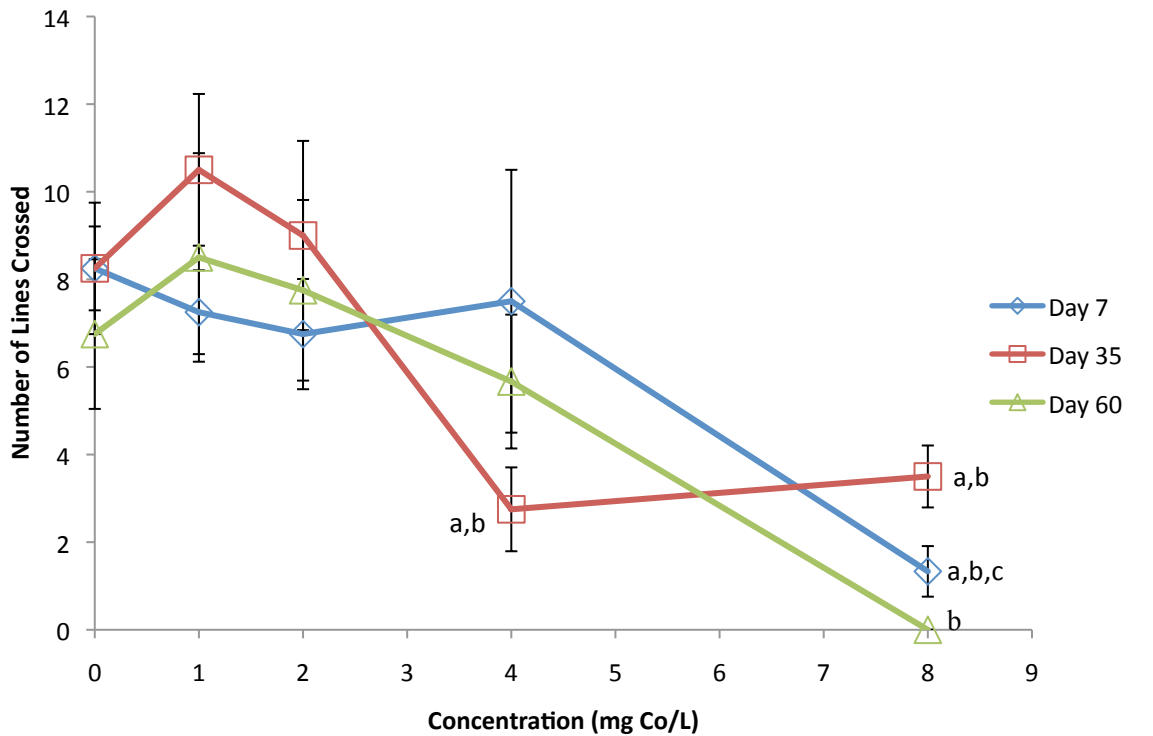


Figure 4.4.g. Planarian behavioral assessment in Study #4: Swimming Speed

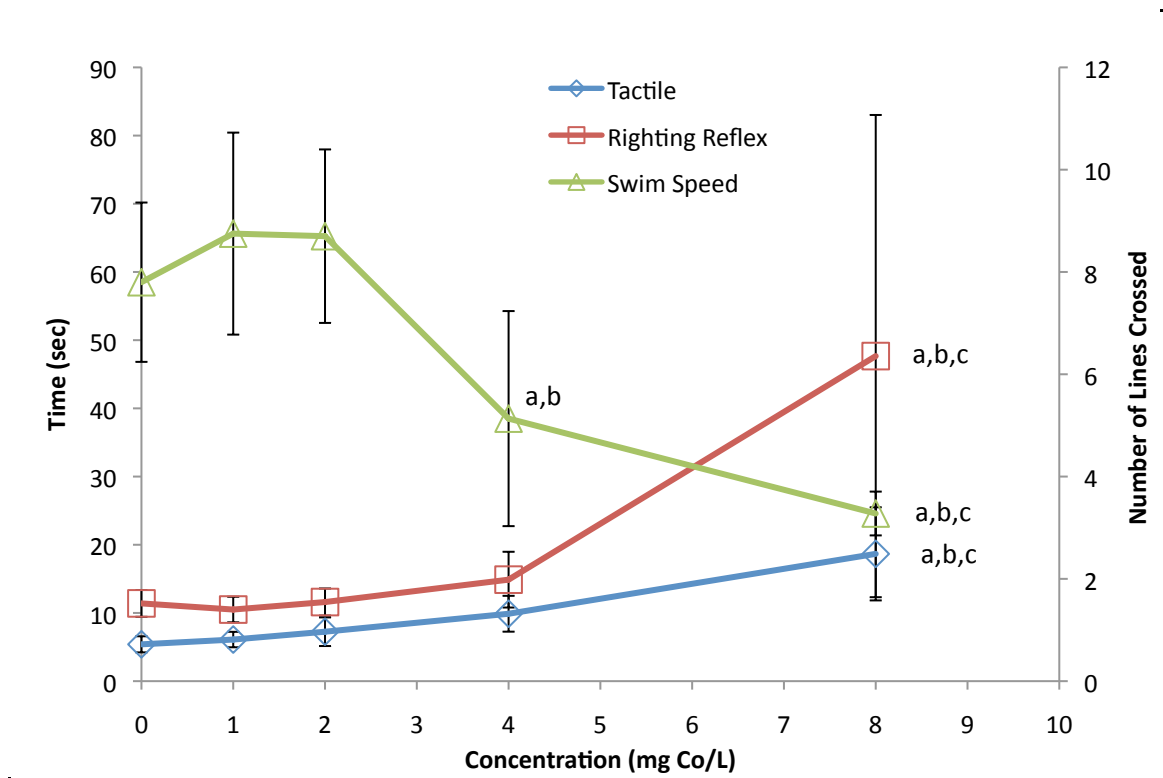


Figure 4.4.h. Mean responses of three planarian behavioral assessments on days 7, 21, 35, 49 and 60, Study #4

The water chemistry values in Table 4.4.c. vary slightly more in the pH, dissolved oxygen, conductivity and hardness compared to the moderate level of hardness in studies #2 and #3. The initial titrations of the dilution and match waters were within 10% of the nominal concentrations. The measured hardness was within 17% of the mean value.

4.5 Study #5

To better understand the role of hardness in cobalt mortality, a 7 day mortality study was conducted with varying calcium and magnesium concentrations, with total hardness maintained at a constant level (100 mg CaCO₃/L) and a single cobalt concentration of 10 mg Co/L. To verify the total hardness effect, an extra exposure group at 180 mg CaCO₃/L and 10 mg Co/L was included at the standard cation concentrations: 0.576 mmol Mg/L and 0.399 mmol Ca/L. To ensure the calcium and magnesium levels were not too high or too low to sustain planaria, concurrent controls were performed at a moderate hardness level without cobalt (Test A Control and Test B Control).

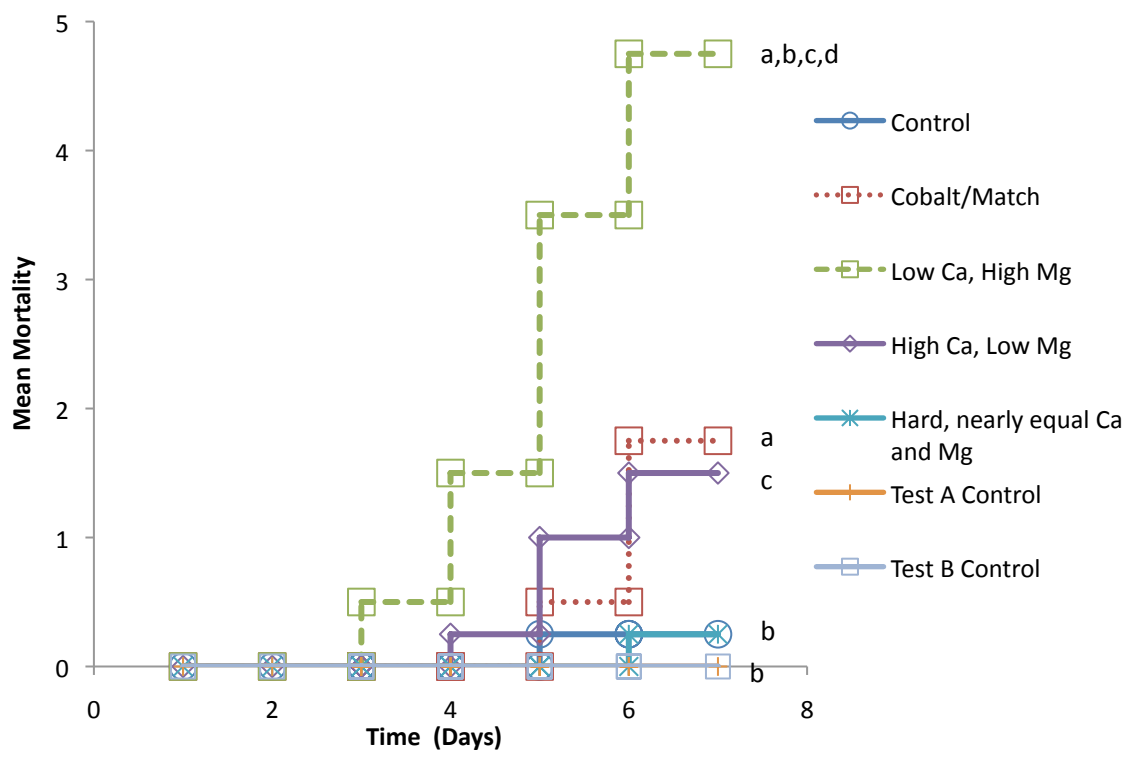


Figure 4.5.a. Mean mortality of planaria at varying cation concentrations, Study #5

Complete mortality did not occur in this study but Test A (low Ca, high Mg) showed the greatest amount of toxicity. This exposure had significantly reduced survival compared to every other control or exposure solution (Tukey, $p < 0.04$) (Table 4.5.a.). Mortality occurred first in this exposure group (low Ca, high Mg) as well (Figure 4.5.a.). Mortality was observed in the dilution control water (5%) but was not significantly different compared to the concurrent controls (Test A Control and Test B Control). The exposure solution that contained the standard concentrations of calcium and magnesium taking into account 10 mg Co/L (Cobalt/Match) had significantly different mortality from the dilution control water (Tukey, $p < 0.04$). Test B (high Ca, low Mg) achieved mortality that was significantly different compared to Test B Control (Tukey, $p < 0.04$). A mean of 10.0 mg Co/L and standard deviation 0.87 was measured in the preserved exposure samples by ICP-AES.

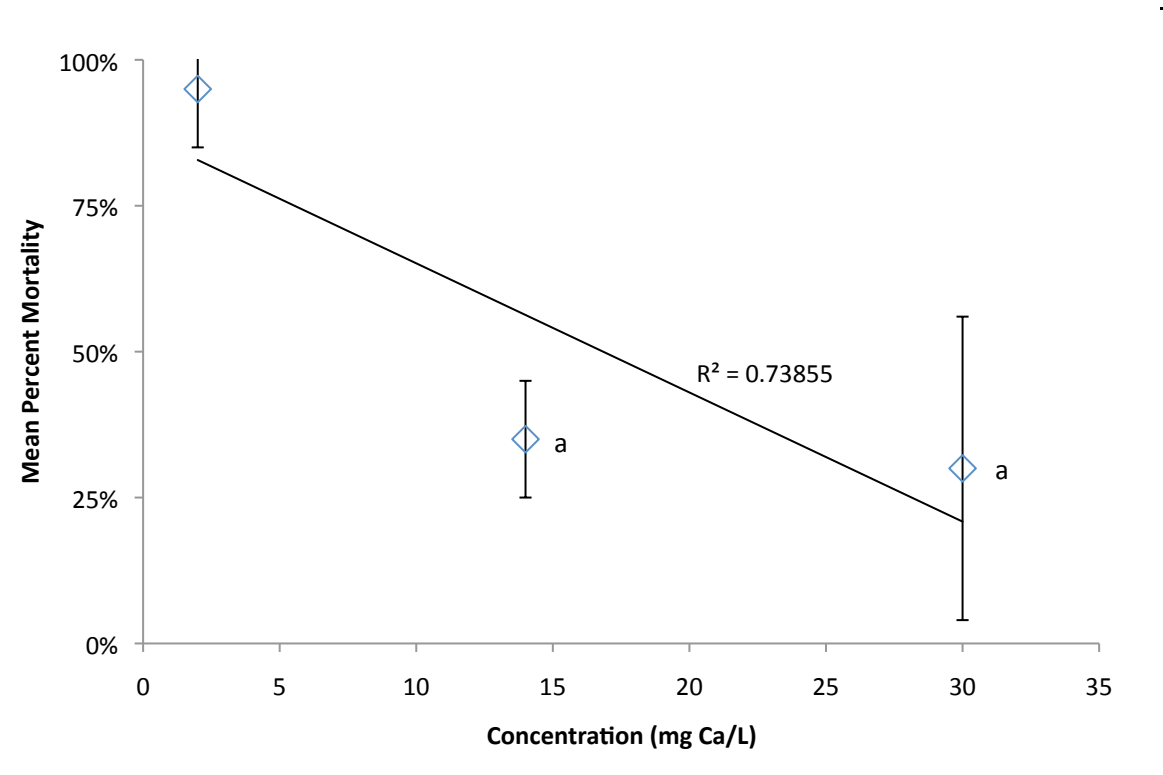


Figure 4.5.b. Mean percent mortality and calcium concentrations, Study #5

Mean percent mortality decreased as calcium concentrations increased (Figure 4.5.b.).

When calcium was low (2 mg Ca/L), significant mortality occurred compared to the mortality when calcium concentrations increased to 14 and 30 mg Ca/L (Tukey, $p < 0.04$). There was no

significant difference in mortality between the higher calcium concentrations (14 and 30 mg Ca/L) (Tukey, $p > 0.97$).

Water chemistry values for Study #5 are presented in Table 4.5.b. Except for ammonia, temperature and dissolved oxygen, all of the chemistry values increased as hardness increased. The measured hardness range was within 6% of the mean value.

V. DISCUSSION

The results of these experiments have identified lethal and relevant sublethal endpoints related to cobalt toxicity in the planarian, *D. dorotocephala*. Median lethal concentrations increased with total hardness indicating a protective effect regardless of the length of the study. Very hard water exhibited the lowest amount of toxicity in the presence of cobalt. Because total hardness is directly correlated to calcium concentrations, similar trends in mortality were seen in the acute and cation studies. As total hardness or calcium concentrations increased in the presence of cobalt, less mortality was observed. Calcium was shown in the cation study to be more essential of the two ions primarily responsible for hardness in uncontaminated waters (calcium and magnesium) in the presence of cobalt consistent with the biotic ligand model of the interaction with metal ion toxicity in aquatic organisms. (Di Toro 2001, McDonald 1989). The presence of more calcium ions may result in competition for the same binding site as cobalt ions.

I. Water Quality Parameters

Water chemistry values were consistent among the different hardness levels. Temperature fluctuated no more than the recommended 3°C differential (ASTM 1996) within each study. The range for all of the studies, 16-20°C, may have been too wide and could have altered the outcome by affecting the sensitivity to the effects of cobalt. However, in a sludge

worm, *T.tubifex*, temperature had little influence on acute cobalt toxicity (Rathore and Khangarot 2002). Future cobalt studies should be conducted with *D. dorocephala* to evaluate their response to temperature variations.

II. Fissioning

Suppression in planarian reproduction was the most sensitive endpoint of toxicity when exposed to cobalt in a chronic time frame. This could ultimately influence the survival of *D. dorocephala*. Despite concentrations of cobalt in environmental waters generally being less than 5 µg Co/L, cobalt has been found at levels up to 27 mg Co/L in industrial and mining areas (Nagpal 2004).

III. Behavioral Assessments

Considering all of the sublethal endpoints that were evaluated in these studies, planarian behavioral responses were the less sensitive to cobalt exposure. Limited data were collected, restricting the power of the tests. This could be studied in the future with more replicates and concentration levels to better evaluate the behavioral effects associated with cobalt toxicity. Variation between observers in the interpretation of the responses persisted despite limiting the number of observers involved in conducting the tests. Also, it was not possible to select the same planarian each time behavioral assessments were performed. That particular planarian could have been stronger or weaker compared to the rest of the population in the dish or could have perished. There is no way to determine if the selected planarian for each assessment was representative of effects at that exposure concentration. Stressors such as a declining population in a dish could have influenced the results. Finally, some planaria could

perform in the tactile and righting reflex tests but would not perform during the swimming assessment. This resulted in unequal sample sizes between the behavioral evaluations and weakened the interpretation of the results.

Future work may include segregating individual planaria for behavioral assessments for a given day and attempting to identify a potential time of the day when less stress (for example, stress from reproduction) would be occurring. Morita and Best (1984) describe a distinct influence of a photoperiod on fissioning. Based on their observations, fissioning rates increased with less than one hour of light. Thus, behavioral assessments may be altered if performed at night. Development of a way to follow the same worm throughout the exposure study would be ideal as well. Finally, increasing the number of replicates may allow for more data collection and a better detection of behavioral effects.

IV. Acute to Chronic Ratio

Establishing an acute to chronic ratio (ACR) for *D. dorotocephala* would be useful to estimate the maximum acceptable toxicant concentration (MATC) for other species of which only acute toxicity data are available (Kenaga 1982, EPA 1999). The practicality of estimating chronic toxicity from acute data is essential for agencies performing ecological risk assessments.

Chronic testing at moderate hardness for 60 days yielded a lowest observable adverse effect concentration (LOAEC) of 1 mg Co/L and a NOAEC (no observable adverse effect concentration) less than 1 mg Co/L based on the most sensitive endpoint, fissioning rate. This produced the lower bound of the ACR of 28 (Table 5.1.). Applying the concentration of cobalt as measured in the dilution water by ICP-AES, 0.0086 mg Co/L, the upper bound of the ACR was calculated to be 301. This background concentration of cobalt can be used because one would

not expect to have a much lower concentration of cobalt than that in an ambient water. Also, this value is more indicative of cobalt concentrations that have been observed in the environment (Nagpal 2004).

As seen with the ACRs from other cobalt toxicity studies, the length of the short term test greatly influences an ACR. For example, an ACR for cobalt toxicity in *Daphnia magna* was 162, using acute data from a 48 hour study and 2.1 using 3-week LC₅₀ data (Kenaga 1981). Therefore, an ACR should be used cautiously with respect to species and time. A standard testing length should be followed for that particular species or one in a similar genus. An ACR in *D.magna* for iron was 2 (Kenaga 1981). For nickel, the element next to cobalt on the periodic table of elements, an ACR in *D.magna* was 15 but 48 for *P.promelas* (Kenaga 1981). The final ACR for cobalt toxicity in *Dugesia dorocephala*, using the standard testing length of 96 hours for *D.tigrina* (ASTM 1996), was 28. If, however, the 168 hour LC₅₀ value (12 mg Co/L) is used, the ACR value would be 12.

V. Mechanisms and Implications For Higher Organisms

In Niyogi and Wood's (2004) review of the development of the biotic ligand model, they describe the effect on respiration (in gills), when fish are exposed acutely to cationic metals, as being much less compared to the inhibitory effect on ion transporters. Copper and silver blocked sodium uptake while cadmium, zinc and cobalt blocked calcium uptake. A similar mechanism is proposed in *D. dorotocephala* exposed to cobalt. A disruption in the osmotic gradient of the planaria through inhibition of the absorption of essential cations may explain the observed acute toxicity. According to the mortality data in this thesis, as calcium increased, mortality decreased. Thus, a calcium transporter may be a likely target that cobalt inhibits.

The pathways to produce energy for a cell are disrupted by cobalt (Smith and Carson 1981, p. 66). Several identified pathways in the regeneration of planaria (Adell et al. 2010) could be disrupted by cobalt. Also, because cobalt induces a hypoxic-like state in humans, a similar condition may occur when planaria are exposed to cobalt. A hypoxic environment could trigger pathways yet to be identified involved with survival.

Toxicity testing in higher mammals would not be beneficial due to the rarity of cobalt toxicosis. The diseases that have developed over time due to cobalt insufficiencies would warrant a better understanding of the mechanism of cobalt toxicity in mammals. Similarly, a more precise mechanistic view of the biotic ligand model for aquatic vertebrates and invertebrates would be useful. Investigation of the biochemical mechanisms observed in higher organisms would be of interest to understand the processes involved in cobalt toxicity in planaria.

VI. Limitations

Some potential problems were noted during these studies. The ICP-AES data showed a mean background cobalt concentration in the control of 8.6 $\mu\text{g Co/L}$ in the 60 day chronic study. This background exposure could have influenced the results as the planaria would have been pre-exposed to cobalt at this low level.

Another potential source of cobalt exposure to planaria, presumably in the form of vitamin B₁₂, was from the beef liver they were fed. This dietary contact may have affected their tolerance or sensitivity to the exposure solutions during the course of a study. A future study may consider an alternative food source investigating the dietary accumulation of cobalt in the planaria.

Another limitation was the individual variation in observations. A lab technician could have recorded behavioral or regenerative characteristics somewhat differently compared to another technician working on the project. This was minimized by identifying one person to conduct all the observations for a particular endpoint in a study, if possible.

The method to determine hardness differed by approximately ten percent depending on the two different methods used: calculation from ICP-AES data and standard colorimetric indicator titration. Future work could consider hardness analysis by ICP-AES, due to the heightened sensitivity, throughout the course of a study rather than after it has been terminated to evaluate ion concentrations. However, for the convenience of identifying the range of hardness during the study, titration values provide a good estimate to the actual total hardness concentrations.

VII. Future Work

In the future, different salts could be used to assess the effects of different anions on the planaria. This pertains to the salts used for making the reconstituted water and the salt used to make the cobalt stock solution. Further, the calcium and magnesium studies should be repeated with a broader range of concentrations and replicates to permit more thorough modeling of the role of cations in cobalt toxicity.

Coexposure to cobalt and other elements or compounds has been shown to reduce or increase absorption. Amino acids containing sulfur such as cysteine have been suggested to form stable complexes with cobalt reducing its availability for absorption (Southern and Baker 1981). Coexposure to cobalt during iron deficiencies competitively inhibits iron absorption but increases cobalt absorption (Thomson et al. 1971). Cobalt exposure during zinc deficiencies increases zinc availability (Chung et al. 1988). Cobalt decreases ascorbate resulting in hypoxic stress (Salnikow et al. 2004).

Experimental methods could be changed to assess certain endpoints more effectively. To ascertain regeneration data more accurately, post-pharyngeal sectioning experiments with cobalt solution exposure could be done. The timing of regeneration could be controlled more stringently and no confusion would be made between a dysmorphic head or tail region versus a fissioning event.

Using natural waters instead of synthetic or reconstituted water may be useful to understand the role of dissolved organic matter in planarian cobalt toxicity. In a study that analyzed cobalt and gill binding in *O. mykiss*, cobalt did not accumulate on or in the trout gills in a natural water and cobalt-spiked water due to calcium competition and DOM complexation (Richards and Playle 1998).
