The six of us decided to pull in every inch of resource we can muster to start a manufacturing company. We register the company as a private limited company under the name Hasrat Muda Sdn Bhd. consisting of the following members:-

This means that the company is fully owned by bumiputras. We see the condition as an advantage when we are legally obligated to pay only 75% of the corporate tax for the first 5 years.

We have applied our own manufacturing license by submitting our proposal to the ministry of entrepreneur development and cooperation. Our manufacturing plan is located at the Petaling Jaya industrial site, where the manufacturing plant is under the pollution Act control. Our manufacturing waste should be controlled to the proper sewage system.

We plan set up our office and factory in No 3, Jalan 227, section 51A, Petaling Jaya, Selangor because it has strategic connections between businesses, clients and physical resources. Located within the range of local

highway exits, the factory has intermediate access to almost every major capital of the countries. With that advantage the company has high probability for expansion.

The premises are rented because we cannot afford to own one yet. So are our equipments. We opt to hire purchase most of them. The area is already an established manufacturing ring including renowned corporations. So we figure we can use the characteristics to our advantage. We are planning to compete and have some share in most vehicle battery market including cars, bikes, truck, trailers et cetera. Another reason we choose to start the business is because this industry is currently monopolized by the non-bumis.

If all goes well, we are going to produce the batteries with minimal dependence on semi-processed material. This means that we buy raw material and use our own facilities to create a sellable products.

Concluding with advantages above we believe the business has potentials to monopoly the business over Asian or even the world market.
