



## **EXECUTIVE SUMMARY**

### **UDH INC.**

This business proposal presents an overview of business description, activities and goals for UDH.INC within three (3) years forecasted business period. Our company start up the business in Johor Bahru, which is a developing city. Our mission is to innovate products that reduce a significance amount of cost and energy. Our company guarantees that our product is an eco-friendly product as our vision is not only to provide technology to people but also creating technology that could conserve energy. UDH Inc. operating at Taman Johor Jaya, Johor Bahru from Monday to Friday for 10 hours (8 a.m – 6 p.m).

UDH Inc. aims to penetrate the market with 15 percent (%) of market share among its main competitors which are Harvey Norman Malaysia, Haes Highland Electric SDN BHD and HB Hygiene SDN BHD with averaging forecast of RM 305,881.50 monthly and it would generate about RM 3670578.00 sales revenue in the first year.
