AN ANALYSIS OF HYPHEN COMPOUND WORDS IN THE NOVEL THIRTEEN REASON WHY BY JAY ASHER

ABSTRACT

This study was aimed to identify the words that can be found and described as hyphen compound words in the novel Thirteen Reason Why by Jay Asher, and the most compound words are appear in Thirteen Reason Why Novel by Jay Asher. A qualitative method with the content analysis was applied in this study. The object of this study was compound words. For the data collection, it was used the techniques such as data collection, data reduction, data display, and conclusion drawing. This study was validated by using triangulation. Base on the analysis in Novel Thirteen Reason Why by Jay Asher, the findings showed that there is 27 words as hyphenated compound.

INTRODUCTION

Language is an important thing in human's life. Through language, people can express their ideas and their opinions about something to another people. Then, through language people can supply their needs. Thus, humans will not able to continue their life properly and

regularly without language. Language has smallest parts called words. Words are always evolving day by day because people need words as a tool for expressing their ideas. Words are always evolving with the developing of human civilization. A new word can be borrowed from other languages or created from existing words. People always use it to build a sentence, but they do not know where do actually those millions words come from. People as the users of language sometimes do not think about how a language is formed. There are millions of words now used by people. Every time people get more and more new words unless they know the way it happens.

The writer tries to find out the mechanisms or processes of word formation and finally can be used in human's life. Besides, word form has deep relation with meaning. The meaning of the new word form is influenced by the process of creating a word. This process is usually called as word formation process. In short, word formation is the creation of new words. There are many kinds of word formation, such as compounding, blending, conversion, back-formation, eponym, borrowing, and so forth.

In this study, the writer focuses only on Compounding words in the Novel *Thirteen Reason Why by Jay Asher*. According to O'Grady and Guzman (1997:139) English orthography is not consist in representing compounds since they are sometimes written as single word, sometimes with an intervening hyphen, and sometime as separate word. The problem statement of the study are: The purpose of the study are: to identify the words that can be found and described as hyphen compound words in the novel *Thirteen Reason Why by Jay Asher*.

In linguistics, morphology is the study of word structure as stated by (Katamba, 1993:19). According to O'Grady and de Guzman (1997) who stated that from all units of linguistics analysis, the word is the most familiar. While words are originally accepted as being the smallest units of syntax, in most languages words can relate to other words by rules. The rules are formed from smaller units and how those smaller units interact in speech by comprehended the speaker in each case with reflect specific patterns in the way words. Therefore, morphology is the branch of linguistics that studies about words with such patterns of word formation across and within languages, and attempts to define formal rules reflective of the knowledge of the speakers of those languages.

According to Plag (2003), compounds are the combination of two words to form a new word and are the most productive type of word formation process in English. The creations of compound words depend on the creativity that language user have chosen. Compounding word is not only about creating news words, but also creating new meaning.

According to O'Grady (1997: 139) English orthography is not consistent in representing compounds since they are sometimes written as single words, sometimes with an intervening hyphen, and sometime as separate words. The combination of some lexical categories, such as nouns (N), adjective (Adj), verb (V) or preposition (Pre) in which the right most morpheme is called as the head that determines the category of a compounding. Compound words can be written in three ways; 1) Open Compound, 2) Close Compound and 3) Hyphen Compound.

Language is a communicating system with form and meaning relationship to each other. The form cannot be separated from their meaning. The meanings of the compound words is relate in such a way that a new meaning comes out which is different from the meanings of the words in isolation. Related to Ullmann (1972:81) every compound contains words which are arbitrary and opaque, without any connection between sound and sense, and others which are at least to some degree motivated and transparent. From the explanation above, there are the meaning of compound into two classification, there are transparent meaning and opaque meaning.

In this study, the writer uses descriptive qualitative method. According to Creswell (1994:27), data collection procedures in qualitative research involve to four basic types, those are observations, interviews, visual images, and documents. The objects of the study are compound words in the novel *Thirteen Reason Why*. The data of this study are in the form of sentences containing compound word, and the source of data is novel *Thirteen Reason Why by Jay Asher*.

FINDINGS & DISCUSSION

The objects of the study are compound words in *Thirteen Reason Why* novel. The discussions present the analysis of hyphen compound words found in the object of the study.

Findings

There are 27 hyphen compound words that can be found in *Thirteen Reason Why* novel by Jay Asher, such as;

Discussions

The writer discusses the hyphen compound words using Merriam Webster Online Dictionary, Cambridge English Online Dictionary and Oxford Dictionary.

1) Rolled-up

Inside the shoebox is **rolled-up** *tube of bubble-wrap.* (pg.10)

The word "Rolled" is originally from the word roll who has lexical meaning move in a particular direction by turning over and over on an axis. Whereas the word "up" has lexical meaning towards a higher place or position. The meaning cannot be transparently identified from its constituent parts (opaque meaning). It does not mean that compound word "rolled-up" is a move into a higher place. The word "rolled-up" based on the context of the sentence above means items that are folded or threaded into a round shape.

2) Bubble-wrap

Inside the shoebox is rolled-up tube of **bubble-wrap**. (p.10)

The meaning of a word "bubble" is a noun which has a lexical meaning a thin sphere of liquid enclosing air or another gas. The word "wrap" means cover or enclose in paper or soft material. Those words joining into "bubble-wrap" which the meaning can be determined from the meaning of its parts (transparent meaning). The lexical meaning of "bubble-wrap" is plastic packaging material in sheets containing numerous small air cushions designed to protect fragile goods.

3) Right-hand

Each tape has a dark blue number painted in the upper **right-hand** corner, ... (p.10)

The word "right" on the compound word "right-hand" is adverb, which is the meaning on or to the right side. Meanwhile, the word "hand" means the end part of a person's arm beyond the wrist, including the palm, fingers, and thumb. Those words joining into "right-hand" which the meaning can be determined from the meaning of its parts (transparent meaning). The lexical meaning of "right-hand" is the region or direction on the right side of a person or thing.

4) Upside-down

Nearby, a plastic bucket sits **upside-down** on footstool. (p.13)

The word "upside" has lexical meaning an upward movement of share prices. The word "down" means toward or in a lower physical position. Those words joining into "upside-down" which the meaning can be determined from the meaning of its parts (transparent meaning). The lexical meaning of "upside-down" is the upper part where the lower part should be; in an inverted position.

5) Felt-tip

The outside of the envelope said: SAVE THIS-YOU'LL NEED IT in red felt-tip marker. (pg.14)

The word "felt" has lexical meaning a type of thick, soft cloth made from a pressed mass of wool and hair. Whereas the word "tip" has lexical meaning the usually pointed end of something. The meaning cannot be transparently identified from its constituent parts (opaque meaning). Those words joining into "felt-tip" which the meaning can be determined from the

meaning of its parts (transparent meaning). "Felt-tip" means a pen that has a writing point made of felt.

6) Going-away

Because I wanted to talk to Hannah so many times after Kat's going-away party, (p.27)

"Going" is the gerund form from the word "go" which means an act of leaving a place, and the word "away" has a lexical meaning to or at a distance from a particular place, person, or thing. Based on the sentence above, those words joining into "going-away" has the meaning cannot be transparently identified from its constituent parts (opaque meaning). The lexical meaning of "going-away" is marking or celebrating a departure.

7) Lip-gloss

I'll take strawberry **lip-gloss** any day. (p.26)

The word "lip" has lexical meaning either of the two fleshy parts which form the upper and lower edges of the opening of the mouth. The word "gloss" means toward or shine or lustre on a smooth surface. Those words joining into "lip-gloss" which the meaning can be determined from the meaning of its parts (transparent meaning). The lexical meaning of "lip-gloss" is a cosmetic applied to the lips to provide a glossy finish and sometimes colour.

8) Average-looking

But for an average-looking guy, so many girls are into Justin. (pg.22)

The word "average" has lexical meaning an amount, standard, level, or rate regarded as usual or ordinary. The word "looking" means an act of directing one's gaze in order to see someone or something. Those words joining into "average-looking" which the meaning can be determined from the meaning of its parts (transparent meaning). The lexical meaning of "average-looking" is when a man or a woman, is neither especially attractive nor especially ugly.

9) Wrist-grabbing

I've seen his wrist-grabbing stunt before. (pg.42)

The word "wrist" has lexical meaning the joint connecting the hand with the forearm. The word "grabbing" is originally from the word grab which means grasp or seize suddenly and roughly. Those words joining into "wrist-grabbing" which the meaning can be determined from the meaning of its parts (transparent meaning). Based on the sentence above, the meaning of "wrist-grabbing" is gripping a wrist.

10) Drawn-out

Two short, **drawn-out** words. (pg.47)

The word "drawn" is the past participle from the word draw. Based on the context on the sentence above, the meaning of draw is to take something out of a container or your pocket. The word "out" means used to show movement away from the inside of a place or container. Those words joining into "drawn-out" which the meaning cannot be transparently identified from its constituent parts (opaque meaning). The lexical meaning of "drawn-out" is to extend beyond a minimum in time.

11) Made-up

It's a knife in my back because you would rather believe some made-up rumour than what you knew to be true. (pg.55)

The word "made" is originally from the word makewho has lexical meaning produced in the stated way or place. Whereas the word "up" has lexical meaning towards a higher place or position. Those words joining into "made-up" which the meaning can be determined from the meaning of its parts (transparent meaning). Based on the context of the sentence above, the meaning of "made-up" is report has been invented and is untrue.

12) Victim-blamers

Good question, victim-blamers. But it wasn't that easy. (pg.65)

The word "victim" has a lexical meaning someone or something that has been hurt, damaged, or killed or has suffered, either because of the actions of someone or something else, or because of illness or chance. Meanwhile, the word "blamers" means the person who blames. Those words joining into "victim-blamers" which the meaning can be determined from the meaning of its parts (transparent meaning). The meaning of "victim-blamers" is

when the victim of a crime or any wrongful act is held entirely or partially responsible for the harm that befell them.

13) Extra-long

Hannah takes an extra-long pause. (pg.74)

The word "extra" is adverb which has a lexical meaning beyond the usual size, extent, or degree. Meanwhile, the word "long" is adjective which means an extending for a considerable distance. Those words joining into "extra-long" which the meaning can be determined from the meaning of its parts (transparent meaning). The meaning of "extra-long" is beyond the usual size, amount, or extent.

14) Cross-reference

You fill out a survey, a computer analysis your answers, then it **cross-conferences** with the other surveys. (pg.91)

The compound word "cross-reference" is noun which has a lexical meaning a notation or direction at one place (as in a book or filing system) to pertinent information at another place. The word "cross-reference" define into word cross and reference. The word "cross" means to move, pass, or extend across something. Meanwhile, the word "reference" is he act of referring or consulting. Those words joining into "cross-reference" which the meaning can be determined from the meaning of its parts (transparent meaning).

15) Drop-off

At the end of the counter, closest to the door, was the drop-off box... (pg.94)

The word "drop" has a lexical meaningthe quantity of fluid that falls in one spherical mass. Meanwhile, the word "off" is to indicate physical separation or distance from a position of rest, attachment, or union. Those words joining into "drop-off" which the meaning cannot be transparently identified from its constituent parts (opaque meaning). The meaning of "drop-off" based on the context of the textisto take something, esp. by car, to a particular place.

16) Fund-raiser

It was a **fund-raiser** for Cheer Camp. (pg. 105)

The word "fund" has a lexical meaning a sum of money or other resources whose principal or interest is set apart for a specific objective. Meanwhile, the word "raiser" has lexical meaning a thing that increases the amount, level, or strength of something. Those words joining into "fund-raiser" which the meaning cannot be transparently identified from its constituent parts (opaque meaning). The meaning of "fund-raiser" based on the context of the textisa person employed to raise funds.

17) Real-world

Each day, we had a brief reading assignment full of statistics and **real-word** examples. (pg.117)

The word "real" is having objective independent existence. Whereas the word "world" has lexical meaning the earthly state of human existence. Those words joining into "real-world" which the meaning can be determined from the meaning of its parts (transparent meaning). Based on the context of the sentence above, the meaning of "real-world" is existing or occurring in reality: drawn from or drawing on actual events or situations.

18) Ice-cold

Ice-cold droplets cling to my skin and run my wet fingers across my eyelids. (pg.120)

The word "ice" means frozen water, and the word "cold" means having a relatively low temperature or one lower than normal or expected. "Ice-cold" which the meaning can be determined from the meaning of its parts (transparent meaning). Based on the context of the sentence above, the meaning of "ice-cold" is extremely cold.

19) Self-written

The day my **self-written** note went missing, I stood outside the classroom door started talking to someone I'd never spoke with before. (pg.125)

The compound word "self" is noun which has a lexical meaning an individual's typical character or behaviour. Meanwhile, the word "written" means made or done in writing. Those words joining into "self-written" which the meaning can be determined from

the meaning of its parts (transparent meaning). The meaning is a writing done by an individual.

20) Star-late

If my love were a star-late at night, only light. (pg.133)

The word "star" means a natural luminous body visible in the sky especially at night, and the word "late" means coming or remaining after the due, usual, or proper time. "Star-late" which whichthe meaning cannot be transparently identified from its constituent parts (opaque meaning). Based on the context of the sentence above, the meaning of "star-late" is disappeared away, not present or included when expected or supposed to be and not return.

21) Give-away

If Ryan found it, he'd scratch out the **give-away** names and scan it for use in an upcoming gazette. (pg.138)

"Give" means to offer something to someone, or to provide someone with something, and the word "away" has a lexical meaning to or at a distance from a particular place, person, or thing. Based on the sentence above, those words joining into "give-away" has the meaning can transparently identified from its constituent parts (transparent meaning). The lexical meaning of "going-away" is the act of giving something away free.

22) Someone-proud

Ryan must have told **someone-proud** that his collection made it into the curriculum. (pg.143)

The word "someone" is pronounused to refer to a single person when you do not know who they are or when it is not important who they are. Meanwhile, the word "proud" has lexical meaning feeling pleasure and satisfaction because you or people connected with you have done or got something good. Those words joining into "someone-proud" which the meaning can transparently identified from its constituent parts (transparent meaning). The meaning of "someone-proud" based on the context of the textisa person who made someone else feel satisfied.

23) Key-chain

He touches the **key-chain** dangling in the ignition (pg.147)

The word "key" is a usually metal instrument by which the bolt of a lock is turned. Meanwhile, the word "chain" has lexical meaning a set of connected or related things usually made by metal. Those words joining into "key-chain" which the meaning can transparently identified from its constituent parts (transparent meaning). The meaning of "key-chain" is a device that is used to hold keys and that usually consists of a metal ring, a short chain, and sometimes a small decoration.

24) Over-reaction

Which explains my over-reaction, Clay. (pg.154)

The word "over" in this compound word is adjective, which has ameaning having or showing an excess or surplus, and the word "reaction" means a response to some treatment, situation, or stimulus. "Over-reaction" which the meaning can be determined from the meaning of its parts (transparent meaning). Based on the context of the sentence above, the meaning of "over-reaction" is respond to something with too strong an emotion or with unnecessary or excessive action.

25) Wipers-gripping

And you stare through your windshield, through the wipers-gripping the wheel. (pg.184)

The word "wipers" has a lexical meaning something (such as a towel or sponge) used for wiping. Meanwhile, the word "gripping" is to hold the interest of strongly. Those words joining into "wipers-gripping" which the meaning cannot be transparently identified from its constituent parts (opaque meaning). The meaning of "wipers-gripping" based on the context of the textisa long tool in the wheel, thin piece of rubber on a metal frame that moves back and forth and pushes water, snow, etc.

26) Mini-mart

When I reach the station, I tuck my hurt hand into my pocket and pull open the glass door of the mini-mart. (pg.196)

The word "mini" meanssmall in relation to others of the same kindand the word "mart" means a coming together of people to buy and sell. "Mini-mart" which the meaning can be determined from the meaning of its parts (transparent meaning). Based on the context of the sentence above, the meaning of "mini-mart" is a store that sells food and sometimes other goods, but is not as big as a supermarket.

27) Band-Aids

I find a clear bottle of rubbing alcohol and a small box of **Band-Aids**, drop a few bucks on the counter, and ask for a key to the restroom. (pg.196)

The word "band" means a strip serving to join or hold things together and the word "aids" not a kind of disease, but it become from word aid which means the act of helping someone. "Mini-mart" which the meaning can be determined from the meaning of its parts (transparent meaning). Based on the context of the sentence above, the meaning of "Band-Aids" is a small adhesive strip with a gauze pad for covering minor wounds.

CONCLUSION

Based on the finding and discussions that have been done, it can be concluded that there are 27 hyphen compound which appeared in the novel *Thirteen Reason Why by Jay Asher*. Furthermore, there are two types of meaning found in the data of the novel *Thirteen Reason Why by Jay Asher*, they are transparent meaning andopaque meaning. The transparent meaning is the most dominant than opaque meaning found in the novel *Thirteen Reason Why by Jay Asher*.
