### **Event Summary**

The NSU Shepard Broad College of Law will host a CLE Program, via Zoom platform, on November 5, 2020.

The conference is entitled *Federal Practice Preview Series: Health Law Edition*, and will run from 11:30 a.m. to 1:00 p.m.

This program will focus on the current climate of health law and the necessary steps used through federal practice to adjust to the ever-changing atmosphere of new legislation. Attendees will learn about the various paths within the practice, about emerging new laws, outreach and training, and how to become involved in the federal practice of health law. The presenters will explain what you need to get started, what different types of experiences and exposure might be helpful in entering the field and instruct you on maintaining ethics by knowing and following the Federal Rules of Civil Procedure and Model Rules of Professional Responsibility.

By utilizing key tips and strategies, you will learn how to position yourself for a strong career in federal practice by learning about the different avenues of health law and how to effectively represent clients in this field of law. Discussions will include a general overview of health law, the impact of COVID-19 in conjunction with health law, and the enactment of new laws and statutes created. This program is for students, new and seasoned attorneys alike.

Consistent with CLE Accreditation Standard 5.01(a)(1), this program is designed to have significant intellectual or practical content aimed at increasing or maintaining the attorney's professional competence and skills as a lawyer through the focus on a wide range of the technological advancements and the effects of these innovations on patients. ### **SPEAKER BIOS**



### Kathy Cerminara, NSU Professor of Law

Professor Kathy Cerminara bridges the medical and legal professions with her work on patients' rights in the end-of-life decision-making arena. She co-authors the nationally known treatise, The Right to Die: The Law of End-of-Life Decisionmaking and is a reviewer for several medical and medical-legal journals. At the Nova Southeastern University Shepard Broad College of Law, she is a full professor. She is also an affiliate faculty member at NSU's Dr. Kiran C. Patel College of Allopathic Medicine.

Professor Cerminara teaches Torts; Health Policy, Bioethics & Quality of Care; Administrative Law; Civil Procedure; Bioethics; and other health-law-related courses. She also created and was the

initial director of the online Master of Science in Health Law program for non-lawyers. In 2017, she received a Scholars Award for innovative interprofessional work with the Broward County Mental Health Court.



### Carlos H. Arce, Lubell & Rosen

Carlos Arce is a partner at Lubell & Rosen, a Florida based general law firm. Mr. Arce practices in the area of health law and commercial litigation. Federal law applies to 80% of his practice.
