DESCENDANTS OF STEPHANUS HAWORTH.

Since 1906 I have been trying to locate in the branch of the family to which they belong, the descendants of one Stephanus Haworth, who was bor at, or near Philadelphia December 9, 1759, and up to this writing I have been unable to do so. I am almost satisfied that he is a descendant of George, the youngest son of the emigrant, but I have not the undoubted proof at my command to make a positive statement concerning the matter. A search of the Friends Records, of Lucks County, Pa. would, no doubt, settle the matter completely and would throw much light on the earlier history of the Haworth family, inclusing that of the Wrights, also.

I have decided to publish all the papers I have concerning this family, and perhans some of my readers can tell us more about them.

On the 15th of June, 1906, a letter was received from Er.John W. Haworth, of Aurora, Nebraska, in which he said:
"I will send you in a few days, a record of our family as far back as I can trace them." This letter, and subscription to RECORD was duly acknowledged and in Jily following the below better, accompanied by a chart of the family, was received.

Aurora, Rebr. , July 16, 1906

Dear Sir:

Enclosed find our family record, as farback as I can trace it at present. Perhans I could find something later, if this is not complete enough. I have herrd my father (George White Haworth speak of moving from Pennsylvania and moved to

Muskingdom County, Ohio, near Zanesville. They had a carriage to die in, and some of the neighbors thought them "toney or stuck up", as there were few carriages in those days. My father owned and run a woolen factory at Leabanon Indiana, during the war. He afterward owned and run a flour mill near Thorntown, Indiana, moving to Mebraska in 1882.

After receiving the above letter and crart of the family, and finding that Er. Maworth had traced his genealogy back to Stephanna Haworth, who was h rn Dec.9, 1759, probably in Bucks Jounty, Pennsylvania, and not being able to locate the said Stephanus in any line of the family, I accordingly wrote him a long letter, asking many questions, which it seems, he could not answer, and he turned my letter over to his sister, from whom I received the following letter:

Aurora, Neb. Nov.20,1906.

Dear Sir:

Ly, brother, John W. Haworth, handed me your letter; al so, some copies of the Haworth Mecord. I do not t ink our family is a new branch, but of the old, original Pennsylvania branch. Ly great grand-father, Stephen, or Stephenus Haworth, was born in Princylvaniavx Philadelphia in 1759, and died and was buried there in 1825.

My grand-father and all his children, except two, were born in Philadelphia. They moved from there in 1836, to Rural Dale, Ohio. I can go back no farther than this. My grand-father John Haworth, had sisters; but I am inclined to believe him

an only son. One sister was Ann. Married William Kearns; had no children. Bothare now dead. Mary married George White; and that is the reason my father and jis sister were named White and two other sisters, Ann. There were other sisters, one of whom married a weaver; one, a Reifsnider; another, a Laurence; Some of the Weavers row live at Indianapolis, Indiana, The Reifsniders are still in Philadelphia.

Hy grand-father, John Haworth, , was born July 3, 1792; married Tusannah Longshore, who was born in Eucks County, Penn.

You ask what had become of the children of John Haworth. All are dead, except Stephen L. whose address is Zanesville, Chio Mrs. Elizabeth A. Harlan, Rural Dale, Chio and Mrs. Sarah A. Trim ble, also of Rural Dale. My Aunt, Mrs. E. A. Harlan, always lived with my grand-parents, and she might know more of the family than anyone else.

You asked my brother what had become of his brothers and sisters. Hary E. died in infancy; Sarah S. married E.W. Fall, and was widowed in 1895, leaving no children; Elizabeth H. married John Wiley. Widowed in 1897; no children; Catherine, unmarried. Edwin died in infancy.

Caroline F. Stevens died in 1897. We have always known that our ancestors care over with William Penn, but carrot trace back farther than 1775. I hope that you can help us out.

After the receipt of this letter I wrote Ers.Fall, asking her to make a thorough search for the mssing links which would connect these Records to that of the Emigrant: and in

Dear Sir:

Acrording to request, I have been writing to my pso ple, and have found hat my grand-father had two brothers, warner and Stephen. My grandfather was born in 1792, and these brothers may have been born a little earlier or later than this date. If some of the children, or grand-children of these brothers of my grand-father can be found they may be able to trace our family back farther than I have been able to do.

I have written my aged Aunts, in Chio; and what I have learned from them I have filled out in the chart and will return it to you. This is the best that I can do at this time.

As soon as I can possibly do so I will no down to the Pennsylvania Historical Society and see if there were any Taworths who emigrated on the ship "Welcome" with Wr.Penn.

 full from 1682 on. They may be seen at FRIENDS

 LIBRARY, Sixteenth & Cherry Streets.
- 3. The Pernsylvaria Archives contain no names of citizens of Great Britain who who landed here: only aliens. A partial list of massengers on the Welcome, the first ship in which Penn care to Fennsylvaria was compiled and is printed in Hemoirs of the Historical Society of Pennsylvania, Vol.1, ampendix, which is to be seen at the Pennsylvania historical Society, Imirteenth and Locist Streets. Among the names sent me by kr.Warris from the Pennsylvania Circotory was Mrs.Ella S. Laurence. I wrote her, asking for information, , thinking perhaps I could find

the Laurence families who had descended from Hannah, the daughter of Stephanus. Here is her answer:

Philadelphia, June 2, 1907.

Dear Sir:

my mother asked me to answer your letter to her.

We regret that we cannot assist you in your work. We feel that there is no connection between our family, and that of the Havorths. Ly father was Joseph Laurence, a native of Portugal. To far as I know. His only relative in this country who died many years ago, leaving no children.

In some of the records of the descendants of this Stephanus Haworth which have been sent me, it is stated that he had a son, John, born at Mt. Holly, M.J., July 3, 1792. Early in the month of May I wrote the Post Master at Mt. Holly, asking if there were any laworths now living at, or near the town: also, if there was a Quaker church at, or near the town as early as 1792 and if the records of such church were yet in existence. On the 16th of May the below letter was written me by the Post Master: Mt. Holly, M.J., May 16, 1907.

Dear Sir:

our letter of recent date I referred to Chas. H. Engle

who says he will look the matter up for you. He is an old resident of the town and a member of the Friends Church 219 Garden Street. If you wish, you could correspond with him.

Ancordingly, on the 18th of May I wrote Mr.Engle, remeating the same questions, together with others I had reviously asked the lost Master , and on the 25th following the below letter was received from Min:

Mt. Folly, H.J., 5-23-1907.

Respected Friend:

In reply to thy inquiry, will report that the present Friends Leeting House was erected in 1775, there having been one, or more prior to that date. The population of this town is about 6,000. The records of this Monthly Meeting began in 1775 and are very voluminous. They are kept in a fire-proof safe in the meeting house, of which I am custodian. I have examined the records of the the member-ship of this meeting, which goes back be yound the year of 1775; also, the records of marriages from 1675, and record of births from same date; also record of deaths from 1775, and I cannot find the name, Naworth therein. I have not examined the Linute Look of the konthly meeting, as that would take days to read: but I do not believe that the name would appear.

I have examined the records of deeds, wills, and inventories of Counties county in the office here, but nowhere found the name of Haworth.

It would appear from the above letter that no haworth has ever lived at, or near Mt.Holly; otherwise, their name would have been recorded in some of the records above mentioned. All of the older Haworths were members of the Society of Friends, and this particular branch of the family were well supplied with this world's goods; consequently, had they lived in the county where in Mt.Holly is located, their names would have been on the records of the County. Ly correspondent must have been mistaken in believing that John, the son of Stephanus, was born at Mt.Holly, M.J.

If some of the children, or grand-childrenof these brothers of my grand-father can be found they may be able to trace our family back farther than I have been able to do.

I have written my aged Aunts, in Chio; and what I have learned from them I have filled out in the chart and will return it to you. This is the best that I can do at this time.

Your letter of 6th received this A.F. You will note on the back of this sheet the names and addresses of people registered in the Philadelphia, 1907, Directory by the name of Laurence. There is but one by the name of Laurence. There are no Refshiters, but quite a few Reifsheiders and Reifshyders.

As seen as I can possibly do so I will go down to the Pennsylvania Historical Society and see if there were any Paworths who emigrated on the ship "Welcome" with Wm.Penn.

In some of the records of the descendents of this Stephanus Haworth which have been sent me, it is stated that he had a
son, John, born at Mt. Holly, M.J., July 3, 1792. Barly in the month
of May I wrote the Post Marter at Mt. Holly, asking if there
were any laworths now living at, or near the town; also, if
there was a quaker church at, or near the town as early as 1792
and if the records of such shurch were yet in existence. On the
16th of May the below letter was written me by the Jost Master:
Mt. Holly, M.J., May 16, 1907.

Dear Sir:

It would appear from the shove letter that no Haworth has ever lived at, or near Mt.Holly; otherwise, their name would have been recorded in some of the records above mentioned. All of the older Haworths were members of the Society of Friends, and this particular branch of the family were well supplied with this world's goods; consequently, had they lived in the county where in Mt.Holly is located, their names would have been on the records of the County. My correspondent must have been mistaken in believing that John, the son of Stephanus, was born at Mt.Holly, M.J.

I have examined the records of the the member-ship of this meeting, which goes back be yould the year of 1775; also, the records of marriages from 1675, and record of births from same date: also record of deaths from 1775, and I cannot find the name, haworth therein. I have your name, from the Pennsylvania Historical Society in response to a request for a recommendation of some perso, able to assist me in locating a Pennsylvania ancestor.

I wish to identify Susannah Susannah Longshore, who married John Haworth, of Pennsylvania. According to grave-stone records, John Haworth was born in Pennsylvania July 3, 1792, and died Aug. 4, 1870 at Blue Rock, Chio, and is buried there. Süsannah Longshore was born in Bucks County, pennsylvania November 17, 1789, and died May 1, 1877, at Blue Rock, and is buried there.

I feel certain that if I can identify her father I can find her in Mr. Justice's book on "The Wilson and Allied Families, which I have examined.

I believe there is nothing in the Quaker church records about the marriage of John Haworth and Susannah Longshore. I have had a me extensive correspondence on the point. I judge the only thing to do is to search the Will Books for a mention of "My daughter, Susannah Longshore Haworth, or possibly the civil marriage lists for counties in which John and Susannah may have resideds at the time.

You will need to discriminate; John Haworth is not an uncommon name in the family, and the John, of whom I write, had a number of cousins.

I have a pretty complete record of the male line. Stephanus Haworth, John's father, was born at Buckingham, Bucks Co. December 9 1759. He was accepted as a member of the Darby Monthly Meeting in 1778; but in the following

year was disowned for joining the militia. Stephanus Ha-worth's wife, Rebecca Warner, Their children were:

John, Ann, Stephen, Mary, Warner, Sarah, Guila (or Gilliam)

and Hannah. I thought these names might, possibly, be of help to you.

I would be obliged if you would let me know when the cost of the search reaches \$10.00 so that we can discuss whether we should go farther into the maxter question.

I have your letter giving details of the information you want regarding Susanna Longshore.

As a first step I have gone through all the material I have on hand to make sure if I have any such data. I think I have little that you do not already have.

"George the Immigrant" went to the Valley of Virginia, viz: Stephanson, Absolom, James and John. In 1738-7-2 Stephanus told the meeting (Buckingham Meeting) that he and his brother Absalom had settled about 50 miles beyond Opeckon monthly meet. ing, and requested certificate to that meeting. Later Stephanus and his youngestbrother (John I think) returned to Penna. evidently around Darby, since telephones were later discovered by Darby meeting.

Was John married to Susarnah Longshore at Buckingham Meeting: If so, I can get in touch with friends there and ask them to look up Susannah for me; or have you already done that?

I have two friends here ho have a great deal of Haworth data that I have not yet some over, and I will get in touch with them at once.

Thanks for the information about T.W.Peyton's beingg seriously ill. I had not heard from him in answer to my letter early in December; and his illness, of course, accounts for that

I would appreciate it greatly if you would see some of the other Peytons there and see if you could get this informa tion for me.

I am descended from Thomas Peyton, who settled in Mason County, Ky. (formerly Bourbon Co.) After the Rev. War, on a land grant for his services during that war. He care from Westmoreland Co., Va. and was the youngest son of the third marriage of his father--whose name I do not have.

Thos. W. Peyton, of your city is descended from Camt.

Thos. Vest Teyton, of Alexandria, Va., who married three times.

I am trying to learn if the youngest son of the third marriage of this Thos. West Peyton, of Alexandria might be my Thos, of Mason Co., Ky. In other words, did T.W.Peyton, of Alexandria have a youngest son, Thomas, who settled in Ky. after the Mey.War: I find it difficult to state these complicated ancestral lives clearly, but perhaps I have put it as clearly and simply as possible.

My father published "Falmer Genealogy" in 1914 with the last entries practically up to 1912. In looking at the index in this book I find by a strange co-incidence, the only Haworth has es to be those of John and Susanna. The first Falmer settler, John, had one son and several daughters; and two of the daughters married brothers by the name of Trimble; and in the Trimble division of the book I find the following entry:

Page 752-James Trimble, born February 20, 1817; died February 9, 1895; Married Sarah Ann Haworth November 5, 1840 (daughter of John and Susanna Haworth, born July 19, 1820; resided at Rural Pale, Muskingur County, Ohio.

Children:

Lary Frances, born August 18, 1842.

Angeline K., " Nay 4, 1844; died 1894x 1894.

Eliza Jane, " Aug. 27, 1846, died 1847,

At the time of the mublication of this book, four of these children, and the mother, were still living; and, as these

entries were made at least 26 years ago it is possible that some of them are still living. The published record gives no mention of the maiden name of Susanna Haworth, but it is possible that some of the family whose home was, amparently, at Rural Dale, Luskingum County, Ohio might be able to furnish some clues.

I am not personally acquainted with any genealogist of sufficient experienceliving in this vicinity to take the matter up here, although the Librarian of our distorical Society, Ars. Elsie 1. Jones, is willing to look up our Society's records. However, it seems to me that as the Longshore name is not a Delaware County family, , there is not such liklihood of any records of that name being here: but I can ask our Librarian to see if she can find anything. The only place where found the name "Hannah" in the Haworth family occurs in Delaware County in connection with John Haworth, and the information is so meager that, so far, I have been unable to learn whether her name may have been Susanna or whether she was the wife or daughter of John Haworth.

Back in 1938 we had some correspondence about Su sannah Longshore, who married John Haworth, both in Pennsylvania You hunted for her in Delaware County, but was unable to find her. I am still looking for her, and hope you can take up the search again.

Will you please let me know when the cost reaches ten dollars so we can examine the situation and see what to do from that point, on.

John was born in Pennsylvania July 3, 1792, and died Aug. 4, 1870, at Blue Rock, Chio, where he is buried. Susannah Longshore was born in Pennsylvania, Bucks County, November 17, 1789, and died at Blue Rock May 1, 1877 and is buried there.

I think the Middletown meeting books have been well combed, and nothing has turned up which would indicate who might have been Susannah's father; but I would like every other Bucks County source to be examined.

By a process of elimination in Mr. Justice's book, "Wilson and Allied Pamilies", I think it quite possible that Susannah might have been a daughter of Abner Longshore, son of

Euclydes and Cusenna Van Horn Longshore, b. circa, 1762, disowned by Middletown in 1784, date of death not known. Would his Will not be recorded in Bucks County?

Dear Mr. Haworth:

I was glad to receive your interesting inquiry of february 29th, relative to Susannah Longshore, and mending remly, thought I would see what I could find on the subject, but the mediminary search has yielded little, indeed. There is a sketch of the family in the publications of the Eucks County Historical Society, Volume VI, but it doesn't help us yet. I find that the only Longshores listed in the Philadelphia City Librariesx Directories at about the time the Haworth family must have settled there (that is, John and Susannah) are a widow, Rachel, (whom I cannot yet identify) and one Jolly Longshore, who seems to have returned to Eucks County to marry, about 1815.

Perhaps it would help if you would let me have the names of the children of John and Susannah (Longshore) Haworth. Certain names were characteristic in the Longshore farily, notably, Euclydes. If you find that Susannah named a son that we may be able to place her without difficulty. The fact that there is no trace of this couple in Friends' records seems to me to prove that they were not regarded as kembers by the Meeting, although they may have attended Keeting, as

many did. There were many degrees of friendliness. Sometimes persons who had been ruled out of Meeting continued to attend, although the Meeting chased to take account of them officially, and so, there is no record.

I have no regular fee for this kind of work, but make a charge of \$1.00 per hour, and request the climbt to state how many hours he would like for me to spend. In this way, the client regulates the amount of the charge, which is thus proportioned to the actual amount of work. Family, of Bucks County, so far as nossible, from the materials at hand here in the Library, and will give you the result, which, however, is not yet conclusive as regards your particular problem. As Robert Longshore, the immigrant, seems to have had but one son, Buccydesdes will begin with the latter who founded the family, in Bucks County. And as the spelling of this name varies a good deal, I am using one form throughout.

I see less reason for believing that you descend from Abner, than for thinking that you are of the line of Thomas, of Middletown, or even of his brother, James' line.

The reasons for this will develop as we proceed.

Holidays have delayed my reply to your letter of December 20, but I have been working on the case, and can now report on ground covered, although with little result.

First, I examined deed records. Ujder name, Haworth, Susanna, grantee deeds yielded a sheriff's deed poll of 1827, of which I give an abstract below. Parties mentioned in this a conveyance were Sasanna Haworth and John Haworth, which at first made it appear a matter of importance, but close insection of the rather lengthy text fauled to discover mention of the exact relation-ship between these two, or of their relationship to the Mary Haworth, also named in the recital. But the grantor deeds developed a conveyance in 1851 by one Susanna Haworth sinster and, as the properties conveyed are those granted by the Sheriff's deed of 1827, the two Susannas are shown to be identical, and not the one wanted. (Phila. Deed Book GWC 101 pp 99, 95.).

In 1850, there is also a conveyance of real estate to one Gusanna Haworth, or Northern Liberties, <u>single woran</u>.

(Ibid. 66 p. 41.).

Under Haworth, John, I examined grantor deeds for conveyance by John Haworth and wife, thinking the rife's name

might not have been indexed senarately. I found one such conveyance, but the volume referred to could not be located on the shelves; so must be in the hands of the copyist or the binder-the utterly slip-shod methods of the Department prevent my knowing which. We will keep this volume in mind, as it is berely possible it may contain a deed by John Haworth and wife Susanna that will furnish a clue to her parentage, although the probabilities are not great.

If I delay too long in remorting further on this matter please remind me. There is no telling how long it may take to copy such a volume.

The only other deed in which John Haworth was a grantor was an agreement about a meadow, in 1801. No wife joined in that case. (Phila. Deed Book RLL 30, p. 185.)

My examination of the indexes covered the periods 1815-52 (grantor), and 1809-52 (grantee), based on the facts that Susanna Longshore, up to 1821, but without result.

Next came <u>Wills</u>. As the Genealogical Society has abstracts of all Philadelphia wills up to 1825, which have already been examined, I covered the Index at City hall from 1835 to 1870, running all given names. There was not a single bong shore will listed. I found Longmore and Longmire and verified them from the Will Books.

The Orphan's Court Index I examined to 1852. The name Longshore did not appear.

This is a very disappointing report, but it seems to me we are looking in the wrong place, and that Eucks County would be the more likely localisty in which to seek Susanna's

parentage. However, if Mrs. Ely has already covered that territory, there can be no object in doing it again.

I should be glad of any suggestions you may have to make.

I have your letter of January 18th, in reference to a search of Bucks County records in connection with the problem of parantage of Susanna Longshore.

Possibly it would bewell for either you or I to write Mrs. Ely, asking her just what she has done in the matter. And she is so convenient to the Court House and its records that it might even be better to have her do the work than for me to make the trip to Dowlestown on the slim chance of discovering something.

As to the meeting records, the Genealogical So ciety has either photostats or abstracts of practically all the Friends records lof Bucks Co, and I have covered them, all. In fact, my report of Earch 88, 1944, had to do almost entire ly with Eucks County records, including abstracts of wills up to 1825. Susanna might have been mentioned in a will subsequent to 1825, but it is doubtful. At any rate, while leing disposed of, there remains only the deed records and the Ornhan's Court records.

As to a possible will of Abner Longshore, my information is that we have a list of Eucks County records (not abstracts) extending to the 1840s, but I will refresh my

I believe we have been, indeed, looking in the wrong place, but I wish to thank you for looking so diligently.

I have re-examined my letter files, and find that Mrs. Ely did get around to searching the Bucks Courty Court Records. A letter of August 4, 1943, , the last I find from her,, ** stated she would go to the Court House. Her letter is not quite specific about the Meeting Records, which, she said are deposited in various bank vaults: and, after searching the Court records, if you find nothing you might consider labooking into the Meeting records, or ancient newspapers, or what-have-you.

I note that you do not believe that Susannah Long shore was a dauthter of Abner; but it seems to me to be possible, if not probable, that on the basis of dates and the process of elimination of other Longshores; and I would be obliged if you would bunt up Abner's will and his wife's. Abner's mother was Susannaa Longshore, and he might have named one of his daughters for her. His wife was Sarah Powers.

iguage the John you found in the Northern Liberties was a consin of the John for whom we seek. I have noted that he had a daughter named Tusannah. His wife was Mary Norton. He prosnered somewhat, and left his tracks all over initedelphia, and he has caused me a great deal of trouble. The Joh in whom we are interested also also had an Uncle, John, and his grand-father was John; but dates help untargle these.

By all merns, go into bucks County thoroughly.

We may find something there.

I have a great lot of unsorted, miscellaneous memoranda and notes; but when I get to going through them my brains get foggier and foggier. Inevitably, a lot of misinformation gets into material of this sort, and I have my share of that, too. I think, some day I will throw a lot of them out, but no one can never tell.

You will have in mind, I hope, to send me statements of your fees from time to time. I would not like to get too far behind my obligations to catch up with them at vill.

The enclosed is my report in full for your pay-. ment of five dollars, covering five hours of research work done in the Muskingum County, Chio, Probate Court records; also, one mur of reaearch done done in the County Recorder's office. The findings of this work led to the clue I mentioned, which is as follows: After reading of Sarah Boyd's deed to her family, I called on a Lr. Longshore in this city, wh informed me that his (deceased) father was David, the son of David (mentioned as an heir in Sarah Boyd's deed and that he recalled hearing his father tell of a great Aunt, Susan, who lived down over the hill and to whom he (David, 2d) would often go for a gift of her homemade cookies. Mr. Longshore informs me that he thinks there is ar old, family Bible somewhere: but he does not know in whose posession. We has offered to inquire about it and also to ask a cousin (there are only he and his brother, and two cousins of this family still living) if there are any other family records or traditions, that he might give me copies of to forward to you.

This would seem to be the Susanna Hongshore whom you are searching record of since a great sunt of David, Sr. would be a sister of Sarah Hoyd's husband, Euclydes Longshore and about nine or ten years younger than her brother's vife, Sarah. I am anxious to hear again from Mr. Longshore (he has promied to) (let me hear as soon as he has located any records) and will be happy to forward all information he may gave, to you at once.

In great/ Exce you which a further search made of records in the Probate, or Common Pleas records or Public Libraries County Histories I shall be glad to serve you in the search.

I have given your Haworth-Longshore problem my undivided attention, and have been unable to determine the par entage of Susan Longshore, the difficulty seeming to be that the records to which I have access in my points of contact are about the same that Mr.Barker would have access to, in Philadelphia. I have examined the Bucks County records quite thoroughly in my numerous searches on this lineage: and the marriage of John Haworth and Sarah Longshore seems not to be available.

I do not concur i n what Mr.Barker thinks about the the search being about Bowlestown, since Doylestown is about thirty miles from Middletown Meeting, both places being East and West, Middletown Meeting being about thirty miles east of Doylestown.

It is always so difficult to trace families when they do not own property; for title searches are always sources for locating the particular locality in which they reside.

Middletown Meeting of Friends, of which Susannah was a Lember, is in the extreme South-eastern section of Bucks County, and is thirty miles from Middletown Meeting and not near the Philadelphia Tounty line.

I examined the County Court records here when making your search some time ago; and, since Susannah was a member of Middletown Meeting, I naturally suppose that she

resided in that vicinity. In her marriage to John Haworth she doubtless married out of Meeting, unless made an apology for so ding to the Meeting she would have been disowned. I will again look into the Friend's records for other, and additional records have been copied since I made your search.

Ever since I have had your inquiry I have kept it under observation, and have followed occasional leads in Quaker records that have come to light: but so far, without success. However, I will again look into the matter in the data that has accumulated since last working on the problem. The Longshore family has always been a problem, for so little has come to light. You will hear from me when I have made renewed effort to help solve since of these problems for you.

Of the children of John and Mary Haworth of Haverford I have only the following histories:

George-named in Will of Mary Haworth of Haverford, Widow, 1605

Mahlon-apprenticed to John Haworth of Philadelphia in the winter of 1772/3 his certificate was removed to Philadelphia Mo Mtg for the Northern District. In 1775 he received certificate to Uwchlan Mo. Mtg. (on the Pottstown pike north of West Chester). Not traced farther.

John-was in Darby for five years, 1796 - - 1801. With his wife, Elizabeth, and children: George, Sarah, Rebecca, Lydia & William, he removed to Chester in 1814; but returned to Haverford (Radnor) in 1823.

Sarah-mentioned in will of Mary Haworth as Sarah Weaver. Stephanus-sent to Darby for his apprenticeship in 1779, he lost his membership there but I do not have the date. He was married probably about 1790 to a young woman of Northern District Mo. Mtg. in Philadelphia. Her name was Rebecca Warner, but I did not find the minute stating the marriage. In 1795 she made acknowledgment and resumed her membership in that meeting. By her certificates of removing their history can be traced. During the eight years follow-ing they were at Medford, N. J.; in Goshen(probably Newtown Square); Chester; Bradford and New Garden, Pa. By 1804 they had removed to East Nottingham (Oxford) where they remained three years, then back to Northern District in

Philadelphia where they were the next ten years. Again in Chester Co. at West Grove in 1817 they remained five years, returning to Philadelphia in 1822. The last time her name appears is in Philadelphia Minutes in 1824. inly one of their children was a member of Friends, Mary, who married George White from New Jersey, in 1809. Other children were John; who married Susanna Longshore and Rebecca Haworth Jr.; probably others.

Jonathan-no historn known.

Jane-went to Philadelphia in 1783, perhaps to live with some relatives. In 1785 she was in Southern District Meeting, Philadelphia. In the will of Mary Haworth, Jane Allen is named.

Rachel-about 1800 she married Aaron Tool and soon removed to Canadda, and these were great grandparents of Herbert Hoover. Mary-is named in her mother's will as wife of Elisah Hoopes. Elizabeth in this will is wife of Mordecai Lewis. There was also Moses-but I have no history of him. Many minutes in Haverford (Radnor) meeting were not looked up.

A will of Patience Haworth of Haverford is at Media, proved in 1821, naming married daughters; she may have been widow of George.

My notes on your Longshore ancestry are quite sketchy.

Abner is listed as one of eleven children of Duclydes Longshore, Jr and his wife. (Name uncertain. She may theve a Cox or a Susannah Van Hore). The date given for Muclydes marriage iis 1760; so, Susannah haworth, born in 1789 might have been Abner's daughter, so far as the date is concerned. It is lso noted that Abner married one Sara Powers; that he enlisted with the militia in 1783; and that his son John, settled in Cincinnati.

Abner, I believe, had an Aunt Susannah (his steprother's sister Susannah Gillam Rinton).

No indeed, I am not a professional genealogist. I wish I were... As it is, while I am very interested. I find it all quite confusing.
